23RD NAVAJO NATION COUNCIL -- Third Year, 2017

AN ACTION

RELATING TO THE NAABIK'ÍYÁTI' COMMITTEE AND THE NAVAJO NATION COUNCIL: CONFIRMING THE APPOINTMENT OF LETANYA THINN, AS THE STUDENT REPRESENTATIVE, TO THE COMMISSION ON NAVAJO GOVERNMENT DEVELOPMENT FOR A TERM OF TWO YEARS

SECTION ONE. AUTHORITY

- A. The Navajo Nation established the Naabik'íyáti' Committee as a Navajo Nation Council standing committee and as such empowered Naabik'íyáti' Committee to recommend all resolutions to the Navajo Nation Council on matters within the Committee's jurisdiction pursuant to 2 N.N.C. § 701(A)(3).
- B. The Naabik'íyáti' Committee exercises legislative oversight authority over the Commission on Navajo Government Development and the Office of Navajo Government Development. 2 N.N.C § 970.
- C. The Commission shall consist of 12 members confirmed by and serving at the pleasure of the Navajo Nation Council. 2 N.N.C. § 972(A).

SECTION TWO. FINDINGS

- A. The Commission on Navajo Government Development is an "entity created by the Navajo Nation Council with quasi-independent authority to accomplish the Council's project of instituting reforms necessary to ensure an accountable and responsible government." 2 N.N.C. § 970.
- B. One member shall be nominated by the Student Body Government of the Diné College; the nominee shall be a student at Diné College and serve so long as said nominee is a full-time student at Diné College, but no longer than two (2) years from the date of confirmation by the Navajo Nation Council. 2 N.N.C. § 972(A)(6).
- C. LeTanya Thinn was nominated and supported to represent Diné College as the student representative to the Commission on

- Navajo Government Development. Associated Students of Diné College Resolution is attached as Exhibit A.
- D. The Diné College Board of Regents approved LeTanya Thinn as the Diné College Representative to the Commission on Navajo Government Development. Diné College Board of Regents Resolution is attached as Exhibit B.
- E. The Office of Navajo Government Development respectfully requested the Navajo Nation Council confirm the appointment of LeTanya Thinn to serve on the Commission on Navajo Government Development. Letter from the Office of Navajo Government Development is attached as Exhibit C.
- F. Ms. LeTanya Thinn's resume is attached as Exhibit D and her letter of interest is attached as Exhibit E.
- G. The appointment of LeTanya Thinn shall be no longer than two (2) years from the date of confirmation. 2 N.N.C. § 972(A)(6).

SECTION THREE. APPOINTMENT

The Navajo Nation, pursuant to 2 N.N.C. § 972(A)(6), hereby confirms the appointment of LeTanya Thinn, as the student representative, as a member of the Commission on Navajo Government Development, for a term of two (2) years from the date of confirmation.

The Commission is also expected to review the current central Navajo government and make recommendations for reform. The representative of the Diné College Student Senate will to be apart of the Commission to gain experience on Navajo Government and reform initiatives.

NOW THEREFORE BE IT RESOLVED THAT:

- 1. The Associated Students of Diné College-Tsaile Campus hereby approves Vice President LeTanya Thinn to fulfill the seat on the Navajo Government
- 2. The President of the Associated Students of Diné College is hereby authorized, directed and empowered to do all things necessary to effectuate the purpose of this resolution.


