to approve \$296,211 from the Sihasin Fund to DCD for the purchase of a new motor grader for the Pinedale Chapter.



**RELATING TO THE BUDGET AND FINANCE COMMITTEE, THE
RESOURCES AND DEVELOPMENT COMMITTEE, THE NAABIK'ÍYÁTI'
COMMITTEE, AND TO THE NAVAJO NATION COUNCIL; APPROVING
\$296,211 FROM THE SÍHASIN FUND FOR A NEW MOTOR GRADER FOR
PINEDALE CHAPTER; APPROVING THE RELATED EXPENDITURE PLAN**

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council with the responsibility to "review and recommend to the Navajo Nation Council the budgeting, appropriation, investment and management of all funds." 2 N.N.C. §301(B)(2).
- B. The Resources and Development Committee is a standing committee of the Navajo Nation Council with oversight authority over all 110 Navajo Nation Chapters, as well as community development matters. 2 N.N.C. §500(C) and 26 N.N.C. §102.
- C. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council that considers all proposed final actions by the Navajo Nation Council. 2 N.N.C. §164(A)(9).
- D. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §102(A). As such, the Council may approve appropriations from the Navajo Nation's Síhasin Fund.
- E. 12 N.N.C. §2502, as amended by CJA-03-18, states the purpose of the Navajo Nation Síhasin

1 Fund ("Sihasin Fund") as follows:

2 §2502 Purpose

3 A. The purposes of this Fund are to provide financial support and/or financing for:

- 4 1. The planning and development of economic development and regional
5 infrastructure supporting economic development and community
6 development, including such infrastructure as, but not limited to, housing,
7 commercial and government buildings, waterline, solid waste management
8 development, powerline Projects, and transportation and communication
9 systems, within the Navajo Nation; and . . .

10 B. For the Purpose in §2502(A)(1), Fund expenditures for infrastructure shall not
11 be limited by 12 N.N.C. §1310(F) or TCDCJY-77-99.

12 C. Leveraging the Fund by way of guaranteeing loans, match funding, direct
13 funding in part, and other weighted uses of the Fund, including loan financing
14 from the Fund, for the purposes in §2502(A)(1), shall be favored over direct
15 funding in whole.

16 F. The Sihasin Fund provides that "Fund Principal" shall consist of all deposits made to the
17 Sihasin Fund and that "Fund Income" shall consist of all earnings (interest, dividends, etc.)
18 generated and realized by the Fund Principal, and that Sihasin Fund Income shall be
19 deposited in, and added to, the Fund Principal until such time as a Fund Expenditure Plan is
20 duly approved. 12 N.N.C. §2504 and §2505(C).

21 G. The Sihasin Fund also provides that "Fund Principal and Income shall not be expended
22 except pursuant to a Fund Expenditure Plan consistent with the purposes set forth in §2502
23 of this Chapter and adopted by a two-thirds (2/3) vote of all members of the Navajo Nation
24 Council." 12 N.N.C. §2505(A).

25
26 **SECTION TWO. FINDINGS**

27 A. Pinedale Chapter is requesting \$296,211 from the Sihasin Fund for the purchase of a new
28 motor grader for the Chapter. The grader they have been using is over 15 years old, frequently
29 needs repairs and maintenance, and needs to be replaced. **EXHIBIT A.**

30 B. The Chapter has provided a detailed price quote for the proposed purchase. **EXHIBIT B.**

1 C. Approving the \$296,211 for the Chapter's proposed purchase of a new motor grader satisfies
2 the purpose of the Síhasin Fund because such purchase pertains to "community
3 development" and "transportation systems" at the Pinedale Chapter, as listed in 12 N.N.C.
4 §2502(A)(1).

5 D. Approving the \$296,211 for the Chapter's proposed purchase of a new motor grader satisfies
6 the preference for leveraging of funds in 12 N.N.C. §2502(C), because the State of New
7 Mexico, Indian Affairs Department has approved \$100,000 for this purchase. **EXHIBIT C.**

8 E. The Pinedale Chapter has passed a resolution supporting and recommending the request for
9 the \$296,211 in Síhasin funds for the motor grader purchase. **EXHIBIT D.**

10 F. The new motor grader will enable the Pinedale Chapter to better serve Chapter residents and
11 nearby communities with road maintenance, homesite preparation, agricultural grading
12 services, and other needs.

13 G. The Navajo Nation therefore finds the approval of the requested Síhasin funds to be in the
14 best interests of the Navajo Nation and the Navajo People.

15
16 **SECTION THREE. APPROVING \$296,211 FROM THE SÍHASIN FUND FOR A NEW**
17 **MOTOR GRADER FOR PINEDALE CHAPTER; APPROVING**
18 **THE RELATED EXPENDITURE PLAN**

19 A. Pursuant to 12 N.N.C. §2505(A), the Navajo Nation hereby approves \$296,211 from the
20 Síhasin Fund for the purchase of a new motor grader for the Pinedale Chapter, as explained
21 in **EXHIBITS A-D**. The Navajo Nation hereby approves the related Expenditure Plan as set
22 forth in **EXHIBIT B** and **EXHIBIT C**.

23 B. The Navajo Nation Controller shall determine whether the source of the approved Síhasin
24 funds will be from Fund Principal or Fund Income or a combination of both.

25 C. The Síhasin funds allocated for the Expenditure Plan approved herein may be further
26 leveraged by bond or loan financing pursuant to the Navajo Nation Bond Financing Act, at
27 12 N.N.C. §1300 *et seq.*, as amended, using Síhasin Fund earnings for repayment and
28 financing costs upon the recommendation of the Budget and Finance Committee and
29 approval by a two-thirds (2/3) vote of all members of the Navajo Nation Council.

30 D. The Síhasin funds approved herein shall be provided to the Division of Community

1 Development ("DCD") within ten (10) business days following the effective date of this
2 Action. DCD shall then promptly implement the Expenditure Plan approved herein by
3 purchase and arranging for delivery of the new motor grader to the Pinedale Chapter.

4 E. To fully protect the Navajo Nation from any claims or liability, prior to delivery of the motor
5 grader to the Chapter, DCD shall verify: (1) proper insurance coverage for the motor grader
6 with appropriate damage, collision, and liability coverages, as set by New Mexico law; and
7 (2) proper training of any person(s) who will be operating the motor grader, as generally
8 practiced or regulated in New Mexico.

9 F. The Pinedale Chapter shall be responsible for all operation, maintenance, storage, and repair
10 costs associated with the motor grader.

11 G. The approved Síhasin funds shall be used strictly for the Expenditure Plan approved herein,
12 and DCD shall be responsible for ensuring compliance with the approved Expenditure Plan,
13 as well as all mandates set forth in this Action.

14 H. If the purchase of the motor grader is not completed by September 30, 2023, the approved
15 Síhasin funds shall revert to the Síhasin Fund, unless otherwise determined by the Resources
16 and Development Committee and the Naabik'íyáti' Committee.

17 I. With respect to any and all unspent Síhasin funds that remain after completion of the
18 purchase of the motor grader (savings), promptly upon completion of purchase DCD shall
19 transfer all savings to the Office of the Controller ("OOC") and OOC shall then immediately
20 deposit such savings back into the Síhasin Fund principal.

21 J. The Síhasin Fund may be reimbursed in the amount of the allocation approved herein, using
22 funds available to the Navajo Nation from any and all state and federal sources, including
23 Congressional appropriations under the American Rescue Plan Act of 2021 or other COVID-
24 19-related relief, if the expenditure for the Pinedale Chapter described herein is deemed eligible
25 under the legal scheme governing such funding.

26 27 **SECTION FOUR. EFFECTIVE DATE**

28 This Action and the related Expenditure Plan shall become effective pursuant to 12 N.N.C.
29 §2505(A) and 2 N.N.C. §221(B).
30

1 **SECTION FIVE. SAVING CLAUSE**

2 If any part of this Action is invalidated by the Supreme Court of the Navajo Nation, or by any
3 Navajo Nation District Court without appeal to the Navajo Nation Supreme Court, the
4 remainder of this Action shall be the law of the Navajo Nation.

RELATING TO CAPITAL EXPENDITURES; MAKING APPROPRIATIONS FROM
THE GENERAL FUND AND OTHER STATE FUNDS; AUTHORIZING
EXPENDITURES FROM CERTAIN FUNDS AND BALANCES; PROVIDING FOR
THE ISSUANCE OF SEVERANCE TAX BONDS AND APPROPRIATION OF
SEVERANCE TAX BOND PROCEEDS FOR CERTAIN PROJECTS PREVIOUSLY
AUTHORIZED BY LAW AND TO CERTAIN FUNDS AS PROVIDED BY
SECTIONS 7-27-10.1 AND 7-27-12.5 NMSA 1978 (BEING LAWS 2003,
CHAPTER 134, SECTION 1 AND LAWS 2010, CHAPTER 10, SECTION 9,
AS AMENDED); PROVIDING FOR THE ISSUANCE OF SUPPLEMENTAL
SEVERANCE TAX BONDS AND APPROPRIATION OF SUPPLEMENTAL
SEVERANCE TAX BOND PROCEEDS AS PROVIDED BY SECTION 7-27-12.2
NMSA 1978 (BEING LAWS 2001, CHAPTER 338, SECTION 2, AS
AMENDED); ESTABLISHING CONDITIONS FOR THE REVERSION OF
UNEXPENDED BALANCES; MAKING APPROPRIATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
SECTION 1. GENERAL FUND APPROPRIATIONS--LIMITATIONS--
REVERSIONS.--

A. Except as otherwise specifically provided by
law, the unexpended balance of an appropriation made in this
act from the general fund shall revert:

- (1) no later than September 30 following:
 - (a) the end of fiscal year 2024 if the

RESOLUTION OF THE PINEDALE CHAPTER RESOLUTION NO. PDC-2023-06-081

A RESOLUTION REQUESTING, SUPPORTING, AND RECOMMENDING TO THE 25TH NAVAJO NATION COUNCIL, AND THE OFFICE OF PRESIDENT AND VICE-PRESIDENT TO UTILIZE SIHASIN FUND IN THE AMOUNT OF \$296,210.88 TO PURCHASE A NEW 140JOY-BR MOTOR GRADER FOR THE PINEDALE CHAPTER

WHEREAS. Pursuant to 26 N.N.C., Section 3 (A) the Pinedale Chapter is a duly recognized certified chapter of the Navajo Nation Government, as listed at 11 N.N.C., part 1, section 10. Pursuant to 26 N.N.C., Section 1 (B) Pinedale Chapter is vested with the authority to review all matters affecting the community and to make appropriate corrections when necessary and make recommendations to the Navajo Nation and other local agencies for appropriate actions; and

WHEREAS. The Pinedale Chapter currently has three heavy equipment, a 2008 Caterpillar 140M Motor Grader, a 2008 Caterpillar 420E Backhoe, and a 2020 Caterpillar 420 backhoe. Two of the three heavy equipment currently are over 15 years old and need replacement. Since 2008, the Pinedale Chapter has been providing public and private services to community members, and the Navajo people with heavy equipment need; and

WHEREAS. The Pinedale Chapter provides free services for burial, funeral, outhouse digging, and monthly road clearances. The Chapter provides paid services to private requests such as land clearance, and smaller projects within 10 miles of the Pinedale Chapter. Since 2018 the chapter has provided these paid services at costs to the public at \$35 per hour for backhoe and \$40 per hour for motor grader; with a \$5 increase in 2021; and

WHEREAS. There is a substantial increase in cost for repair and maintenance of the two older equipment as supported by the attachment to this resolution indicating the total amount paid from 2017 to today. In 2022 the Pinedale Chapter approved a resolution to include purchasing a new motor grader in its State of New Mexico ICIP (Infrastructure Capital Improvement Plan). During this past 60-day State of New Mexico Legislative session, the Pinedale Chapter successfully lobbied the State Legislature and Governor to support funding for a new motor grader. The State of New Mexico through the Capital Outlay Fund allocated \$100,000 towards the purchase of a new motor grader, under House Bill 505. Further the chapter has also researched possibly trading in the heavy equipment, but it was recommended to not trade-in due to less value of the old backhoe and motor grader.; and

WHEREAS. The Pinedale Chapter reached out to the sole area vendor for Caterpillar and requested a quote for a new 2023 140JOY-BR Motor Grader totaling \$369,285.07. *See attached.* With the approved funding of \$100,000 from the State of New Mexico, the Pinedale Chapter is still needing \$269,285.07. Below is the total amount requested from the Navajo Nation Sihasin Fund with the additional 10% contingency to request for the purposes of price increase in purchasing the equipment:

WHEREAS. It is therefore requested by the Pinedale Chapter to request the 25th Navajo Nation Council to approve a matching fund in the amount of \$296,210.88 which includes a 10% contingency cost that will be applied to the increase in cost to purchase the equipment. That the need is vitally important to continue to provide direct services to the Pinedale Chapter. And to further stipulate that there is a need for new motor graders to maintain public access roads to residents within Pinedale and throughout the region to the Mariano Lake and Churchrock communities. To further state for the record that the Pinedale Chapter does provide services to regional communities when requested.

NOW THEREFORE IT BE RESOLVED THAT the Pinedale Chapter approves resolution requesting, supporting, and recommending to the 25th Navajo Nation Council, and the Office of President and Vice-President to utilize Sihasin Fund in the amount of \$296,210.88 to purchase a new 140JOY-BR Motor Grader for the Pinedale Chapter.
