BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Navajo Nation Council established the Health, Education and Human Services Committee as a Navajo Nation Standing Committee. 2 N.N.C. § 400 (A).

SECTION TWO. FINDINGS


- A. The Health, Education and Human Services Committee shall consist of six members. 2 N.N.C. § 400 (B).
- B. The Health, Education and Human Services Committee's Chairperson and Vice-Chairperson shall be selected by a vote of the Committee. 2 N.N.C. § 184 (A).

SECTION THREE. CONFIRMING CHAIRPERSON AND VICE-CHAIRPERSON

The Health, Education and Human Services Committee of the Navajo Nation Council, pursuant to its authority under Navajo Nation law, hereby confirms Honorable Daniel E. Tso as Chairperson and Honorable Charlaine Tso as Vice-Chairperson.


