RESOLUTION OF THE NAVAJO NATION COUNCIL

23RD NAVAJO NATION COUNCIL-THIRD YEAR, 2017

AN ACTION

RELATING TO NAABIK'ÍYÁTI' COMMITTEE AND NAVAJO NATION COUNCIL; APPROVING AND CONFIRMING THE NOMINATION OF CRYSTAL J. CREE TO THE NAVAJO GOVERNMENT DEVELOPMENT COMMISSION

BE IT ENACTED

SECTION ONE. AUTHORITIES

- A. Pursuant to 2 N.N.C. § 164 (A)(9), a proposed resolution that requires final action by the Navajo Nation Council must be assigned to the Naabik'íyáti' Committee before it is considered by the Navajo Nation Council.
- B. The Navajo Nation Council, pursuant to 2 N.N.C. §972 (A), confirms appointments to the Navajo Government Development Commission.

SECTION TWO. FINDINGS

- A. The Commission on Navajo Government Development consists of twelve (12) Navajo members confirmed by and serving at the pleasure of the Navajo Nation Council. 2 N.N.C. § 972 (A).
- B. Pursuant to 2 N.N.C. §972 (A)(7), "Commission members shall be chosen from among individuals who have demonstrated scholarship, a strong sense of public interest, knowledge of Navajo history and cultural heritage, spiritual leadership, leadership in the Navajo government and abilities likely to contribute to the fulfillment of the duties of the Commission." 2 N.N.C. § 972 (D).
- C. Once appointed, members of the Commission on Navajo Government Development are confirmed by and serve at the pleasure of the Navajo Nation Council pursuant to 2 N.N.C. § 972 (A).
- D. Pursuant to 2 N.N.C. § 972 (A)(7), "[o]ne member shall be nominated by the Health, Education, and Human Services Committee; the nominee shall be a graduate student from any accredited college or university, such member shall serve so long as said nominee is a full-time graduate student, but no

longer than two years from the date of confirmation by the Navajo Nation Council."

- E. Crystal J. Cree has been nominated by the Health, Education and Human Services Committee, resolution attached as **Exhibit** A.
- F. Crystal J. Cree is currently a Masters Degree candidate enrolled in the Indigenous and Tribal Nation Building, Leadership, Management and Administration graduate certificate and Masters in Public Administration program through Northern Arizona University. See Exhibit A.

SECTION THREE. CONFIRMATION

The Navajo Nation, pursuant to 2 N.N.C. § 972(A)(4), hereby confirms the nomination of Crystal J. Cree to serve and fill the graduate student from any accredited college or university position on the Navajo Government Development Commission. Crystal J. Cree shall serve a term consistent with the requirements of Navajo Nation law in respect to this action of the Council.

AN ACTION

RELATING TO HEALTH, EDUCATION AND HUMAN SERVICES COMMITTEE; NOMINATING CRYSTAL J. CREE TO THE COMMISSION ON NAVAJO GOVERNMENT DEVELOPMENT

SECTION ONE. AUTHORITY

A. Pursuant to 2 N.N.C. § 972 (A)(7), one member shall be nominated by the Education Committee of the Navajo Nation Council; the nomination shall be a graduate student from any accredited college or university, such member shall serve so long as said nominee is a full-time graduate student, but no longer than two years from the date of confirmation by the Navajo Nation Council.

SECTION TWO. FINDINGS

- A. The Commission on Navajo Government Development is an "entity created by the Navajo Nation Council with quasi-independent authority to accomplish the Council's project of instituting reforms necessary to ensure an accountable and responsible government." 2 N.N.C. § 970.
- B. The Commission shall be responsible directly to the Council with respect to overall activities. 2 N.N.C. § 970.
- C. The Intergovernmental Relations Committee (now called Naabik'íyáti' Committee) shall have legislative oversight authority. 2 N.N.C. § 970.
- D. The Commission shall consist of 12 members confirmed by and serving at the pleasure of the Navajo Nation Council. 2 N.N.C. § 972(A).
- E. Ms. Crystal J. Cree expressed her interest in serving on the Commission on Navajo Government Development as a nominee by the Health, Education and Human Services Committee, letter of interest is attached hereto as Exhibit A.

- F. Ms. Crystal J. Cree is currently a Master's Degree candidate enrolled in the Indigenous and Tribal Nation Building, Leadership, Management and Administration graduate certificate and Masters in Public Administration program through Northern Arizona University, resume attached hereto as Exhibit B.
- G. The Health, Education and Human Services Committee nominate Ms. Crystal J. Cree to serve on the Commission on Navajo Government Development.

SECTION THREE. NOMINATION

The Health, Education and Human Services Committee, pursuant to 2 N.N.C. § 972(A), hereby nominate Ms. Crystal J. Cree to serve on the Commission on Navajo Government Development.
