

OF GARRET SILVERSMITH AS THE EXECUTIVE DIRECTOR
OF THE NAVAJO DIVISION OF TRANSPORTATION**

BE IT ENACTED:

SECTION ONE. AUTHORITY

A. The Resources & Development Committee is a standing committee of the Navajo Nation Council with oversight authority over the Navajo Division of Transportation. 2 N.N.C. §500, 2 N.N.C. §501(C)(1).

B. Proposed resolutions requiring final action by the Navajo Nation Council shall be assigned for review by the Naabik'iyáti' Committee. 2 N.N.C. §501(C)(1).

C. The Navajo Nation Council has the authority to confirm division director appointments upon recommendation from the appropriate oversight committee. 2 N.N.C. §102(F).

D. According to the revised Plan of Operation for the Navajo Division of Transportation, approved in Resolution No. CAP-13-13, the Executive Director of the Navajo Division of Transportation is appointed by the Navajo Nation President and the Navajo Nation Council confirms such appointment. See NDOT Plan of Operation (revised), Section III(A)(2).

1 **SECTION TWO. FINDINGS**

2 A. The Navajo Nation President has appointed Garret Silversmith as the Executive Director of
3 the Navajo Division of Transportation. **EXHIBIT A.**

4 B. As provided in the NDOT Plan of Operation, the appointed Division Director of NDOT is
5 confirmed by the Navajo Nation Council, and serves at the pleasure of the Navajo Nation
6 President. NDOT Plan of Operation (revised), Section III(A)(2) approved in CAP-13-13.

7 C. Garret Silversmith is well-qualified to serve as the Executive Director of NDOT. His letter
8 of interest and résumé are attached hereto as **EXHIBIT B.**

9 D. The Navajo Nation Council has reviewed the professional credentials of Garret Silversmith,
10 and finds that confirming the President's appointment of Garret Silversmith as the Executive
11 Director of the Navajo Division of Transportation is in the best interest of the Navajo Nation.

13 **SECTION THREE. CONFIRMING THE PRESIDENT'S APPOINTMENT OF**
14 **GARRET SILVERSMITH AS EXECUTIVE DIRECTOR OF THE**
15 **NAVAJO DIVISION OF TRANSPORTATION**

16 A. The Navajo Nation Council hereby confirms the appointment of Garret Silversmith as the
17 Executive Director of the Division of Transportation. This confirmation shall remain
18 effective for as long as Garret Silversmith occupies the position of Executive Director.

19 B. The Navajo Nation Council acknowledges that Garret Silversmith serves at the pleasure of
20 the Navajo Nation President. NDOT Plan of Operation (revised), Section III(A)(2) approved
21 in CAP-13-13.

23 **SECTION FOUR. EFFECTIVE DATE**

24 This Action shall become effective pursuant to 2 N.N.C. §102(F) and 2 N.N.C. §221(C).

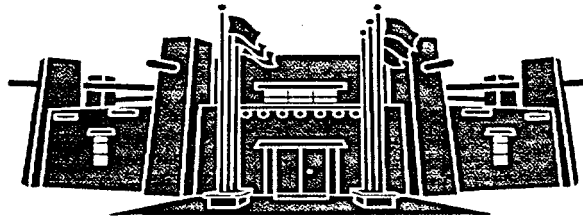





This tribal take over of a Federal Highway Program requires a major overhaul; this man and his administration is failing their duties where Federal Regulations and Guidelines are involved. This Division requires a revamped system that systematically updates Tribal Roads assessments Not piecemeal projects under Tribal Council pressure. This Division Director does not effectuate Federal requirements.

A person in this position must know the Federal Budget guidelines without Question or a Second Guess. As with any Federal program take over there is a tremendous downfall where the Tribal Process becomes impeded by Tribal Council pressure to which a Policy Statement MUST be devised to deter political influence.

As a Division tasked with the Tribal Roads Maintenance, where is the Solid Minerals Leasing component of this Quasi-maintenance program? These employees work daily as a bureaucratic nightmare, Not a service program. The NN must begin their assessment of demands; asphalt roads WILL require the change in landscape; mountains and hills will be leveled, resource sites will create depressions. WHICH community is offering up solid materials for this effort to make this happen? Grazing Permit holders hold projects hostage. There are no efforts by this Division since its inception to tackle this underlying natural resource requirement to function as a true 'Roads Maintenance' Division. They do not pursue the obvious.

There is no confidence in this Division Director, NO confirmation.

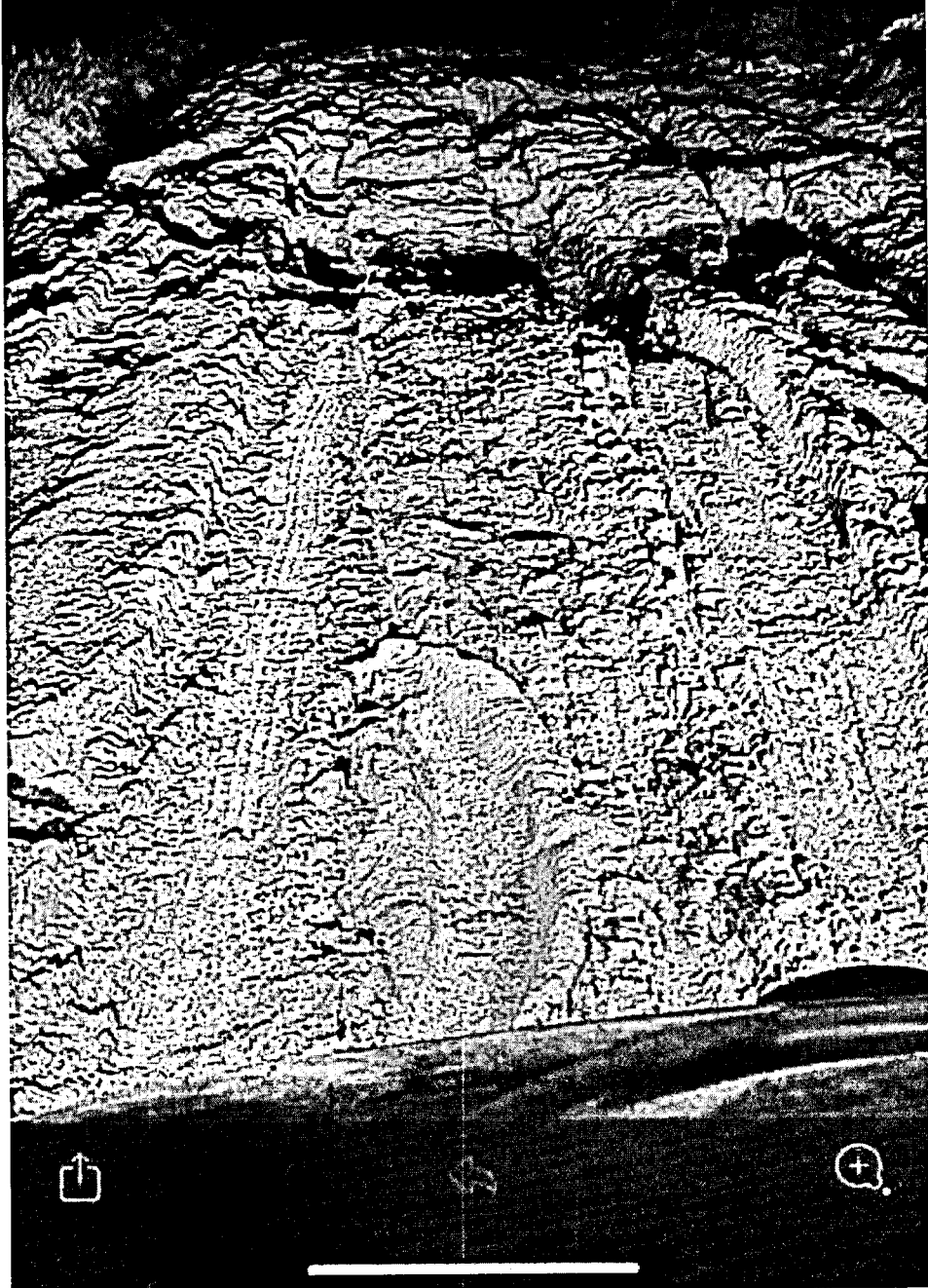




