



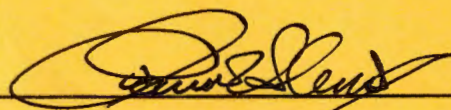
24th NAVAJO NATION COUNCIL LEGISLATION SPONSORSHIP WITHDRAWAL

SECTION ONE. AUTHORITY

- A. The Resources and Development Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 500 (A) (2015).
- B. The Navajo Engineering and Construction Authority shall operate under the legislative oversight of the Resources and Development Committee of the Navajo Nation Council. 5 N.N.C. § 1973.
- C. The Resources and Development Committee of the Navajo Nation Council grants final confirmation of appointments to entities under the authority of the Committee requiring appointments. 2 N.N.C. § 501 (B)(9).

SECTION TWO. FINDINGS

- A. The management board for Navajo Engineering and Construction Authority shall be appointed by the President of the Navajo Nation and confirmed by the Resources and Development Committee. See 5 N.N.C. §§ 1973, 2 N.N.C. § 501 (B)(9).

1 B. Pursuant to 5 N.N.C. § 1973(D), "[i]ndividuals with experience and/or education in the
2 engineering, construction, architectural, legal, accounting, management, or other
3 construction related field shall be given preference for appointment to the Board."

4 C. Members of the Board serve a term of four (4) years.

5 D. Pursuant 5 N.N.C. § 1973, the Navajo Nation President appoints Pete K. Atcitty as a
6 member of the Board of Directors. *See Exhibit A* (Letter of Interest), **Exhibit B**
7 (Resume) and **Exhibit C** (Recommendation from Navajo Nation President).

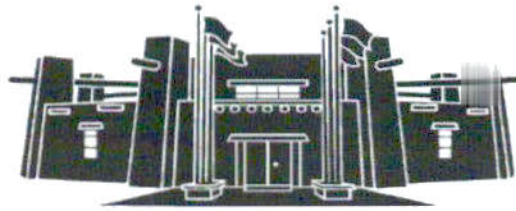
