SECTION ONE. AUTHORITY

- A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102 (A).
- B. The Naa'bik'íyáti' Committee is a standing committee of the Navajo Nation Council. The Committee reviews all legislation requiring final action by the Navajo Nation Council. 2 N.N.C. §§ 164 (A)(9), 700 (A) (2012). *See also* CO-45-12.
- C. The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 400(A). The Committee exercises oversight authority over the [Department] of Health. 2 N.N.C. § 401(C)(1), § 1607. *See also* CO-50-14.

SECTION TWO. FINDINGS

- A. The Health Director of the Department of Health shall be appointed by and serve at the pleasure of the President of the Navajo Nation and confirmed by the Navajo Nation Council. 2 N.N.C. §1605. *See also* CO-50-14.

1 B. The establishment of the Department of Health and the duties of the Health Director
2 are outlined at 2 N.N.C. § 1601 *et seq.*

3 C. The Navajo Nation President appointed Dr. Jill Jim as the Health Director of the

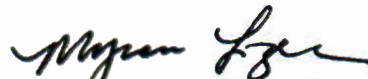
Dear Dr. Jim,

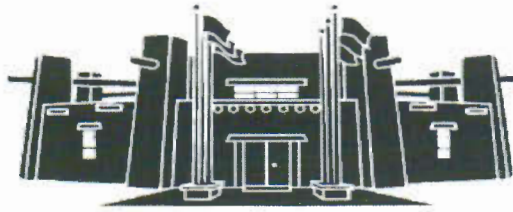

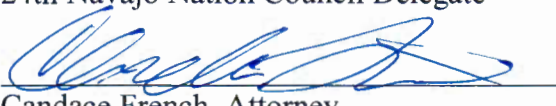

If you approve, please sign as "Primary Sponsor" and submit it to the Office of Legislative Services where the proposed resolution will be given a tracking number and referred to the Office of the Speaker. If the proposed legislation is unacceptable to you, please contact me at the Office of Legislative Counsel and advise me of the changes you would like to make to the proposed resolution.
