## SECTION ONE. AUTHORITY

A. The Sabik' iffy anti' Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. $\S 700(\mathrm{~A})$.
B. The Naabik'iyáti' Committee serves as the oversight committee for the Office of Legislative Services. 2 N.N.C. $\S 701(A)(5)$.
C. Pursuant to 2 N.N.C. $\S 185(\mathrm{~A})$ an oversight committee may reallocate funds appropriated by the Navajo Nation Council to a division or program over which the committee has oversight and shall approve a reallocation by two-thirds ( $2 / 3 \mathrm{rds}$ ) vote.

## SECTION TWO. FINDINGS

A. The Office of Legislative Services, Legislative Branch, is requesting a reallocation of funds in the amount of $\$ 57,000$ from the Business Unit Number 101033 to

Business Unit Number 101019. See Office of Management and Budget's Budget Revision/Reallocation Request form attached as Exhibit A.
B. Navajo Nation Legislative Branch's Office of Legislative Services requires a reallocation of funds to pay for staff travel, additional office supplies, telecommunications, and other operating costs. $I d$.

## SECTION THREE. APPROVAL OF REALLOCATION

A. The Naabik'íyáti' Committee hereby approves the budget reallocation in the total amount of $\$ 57,000$ from Business Unit Number 101033 to Business Unit Number 101019, to cover budget deficiencies as set forth in the budget reallocation documents hereto attached as Exhibit A.
