## RESOLUTION OF THE RESOURCES AND DEVELOPMENT COMMITTEE 23<sup>rd</sup> Navajo Nation Council --- Third Year, 2017

#### AN ACTION

## RELATING TO RESOURCES AND DEVELOPMENT; AMENDING THE "NAVAJO SAND AND GRAVEL LEASE AND ACCESS ROAD RIGHT-OF-WAY" LEASE BETWEEN THE NAVAJO NATION AND APACHE COUNTY DISTRICT I, AS PREVIOUSLY APPROVED BY RESOLUTION RDCO-53-13

#### BE IT ENACTED:

#### Section One. Authority

The Resources and Development Committee of the Navajo Nation Council is empowered with oversight authority over land and the power to grant final approval for non-mineral leases and rightsof-way within the Navajo Nation. 2 N.N.C. §§ 500 (C), 501 (B)(2)(a).

#### Section Two. Findings

- A. The Resources and Development Committee approved Resolution RDCO-53-13 "Approving a Sand and Gravel Lease and an Access Road Right-of-Way for Apache County District I" (Agreement). See Exhibit "A"
- B. The term of the Agreement is 5 years, effective the date the Agreement is approved by the Secretary of the Interior (Bureau of Indian Affairs). See Exhibit "B" at Section 1.
- C. As of this date the Agreement has not been approved by the Bureau of Indian Affairs nor has the Agreement been acted on by Apache County District I or the Navajo Nation.
- D. The road work as planned by Apache County District I with the materials covered by this Agreement will involve improvement of roads within the Navajo Nation.

- E. Insofar as the road work as planned by Apache County District I with materials covered by this Agreement will involve improvement of roads within the Navajo Nation and therefore be for the benefit of the Navajo Nation, the Resources and Development Committee finds it in the best interest of the Navajo Nation to approve the amendment to the Agreement waiving all fees and royalties as stipulated in the Agreement at Section 2. See Exhibit "B" at Section 2
- F. Insofar as the road work as planned by Apache County District I with materials covered by this Agreement will involve improvement of roads within the Navajo Nation and therefore be for the benefit of the Navajo Nation, the Resources and Development Committee finds it in the best interest of the Navajo Nation to approve the amendment to the Agreement reducing the performance and reclamation bond amount as required by the Agreement at Section 4 from \$225,000 to \$90,000. See Exhibit "B" at Section 4

### Section Three. Approval

- A. The Resources and Development Committee hereby approves the following amendments to the Agreement as found at Exhibit "C":
  - All fees and royalties as specified in Section 2 of the Agreement are hereby waived;
  - 2. The performance and reclamation bond amount as required at Section 4 of the Agreement is hereby reduced from \$225,000.00 to \$90.000.00.
- B. The Resources and Development Committee hereby approves "Amendment Number One (1) To the Navajo Nation Sand and Gravel Lease and Access Road Right-of-Way Agreement Between the Navajo Nation and Apache County District 1." as found at Exhibit "C".
- C. All other terms and conditions of the Agreement remain unchanged.
- D. The President of the Navajo Nation is hereby authorized to execute all documents intended to fulfill the intent of this resolution.

### AN ACTION RELATING TO RESOURCES AND DEVELOPMENT; APPROVING A SAND AND GRAVEL LEASE AND AN ACCESS ROAD RIGHT-OF-WAY FOR APACHE COUNTY DISTRICT I

#### BE IT ENACTED:

#### Section One. Findings

The Navajo Nation hereby finds the following with respect to this resolution:

- The Resources and Development Committee is a Standing Committee of the Navajo Nation Council and is authorized to approve sand and gravel leases and permits on the Navajo Nation; and
- 2. Apache County District I, address is P.O. Box 1952, Chinle, Arizona 86503, desires to enter into an agreement for a sand and gravel lease (Lease) and access road right-of-way (Exhibit "1"); and
- 3. The Lease and the right-of-way are located in the vicinity of Teecnospos, Apache County, Arizona. The Lease and the right-of-way are described in maps marked Exhibit "A" and "B" respectively. The Lease occupies 36.294 acres more or less and the right-of-way consists of 5.84 acres more or less; and
- The Mining and Reclamation Plan is attached as Exhibit "C"; and
- 5. Apache County District I has submitted an Environmental Assessment Report and Findings of No Significant Impact issued by the Bureau of Indian Affairs (Exhibit "D"); and

6. The consent of the affected land users have been obtained by the Navajo Land Department and are attached hereto as Exhibit "E".

#### Section Two. Approvals

- The Navajo Nation hereby approves a sand and gravel lease and an access road right-of-way for Apache County, District I (Exhibit "1"); and
- 2. The location of the lease and the right-of-way for the access road is shown on maps attached as Exhibit "A" and "B", respectively; and
- 3. Apache County District 1 shall abide by all the terms and conditions stipulated in Exhibit 1 and adhere to the Mining and Reclamation Plan (Exhibit "C"); and
- 4. The President of the Navajo Nation is hereby authorized to execute all documents intended to fulfill the intent of this resolution.



## NAVAJO NATION SAND AND GRAVEL LEASE AND ACCESS ROAD RIGHT-OF-WAY

THIS AGREEMENT for a Sand and Gravel Lease (Lease) is made and entered by and between the Navajo Nation and <u>Apache County District I</u>, herein called the Lessee and whose address is at P.O. Box 1952, Chinle, Arizona 86503.

Definitions:

Sand & Gravel means: Borrow (Earth.) Sand and Natural or Processed Gravel

Department means the Navajo Nation Minerals Department.

Navajo Nation (Nation) means the Navajo Tribe of Indians.

*Secretary* means the Secretary of the U.S. Department of Interior or his/her designated representative.

*Performance bond* means a surety bond, collateral bond or self-bond or a combination thereof, by which a lessee assures faithful performance of all the requirements of this lease and mining and reclamation plan.

*Reclamation* means those actions taken to restore mined land as required to a postmining land use approved by the Department.

NABIK'IYATI' Committee means the NABIK'IYATI' Committee of the Navajo Nation Council.

*Resources and Development Committee* means the Resources and Development Committee of the Navajo Nation Council.

*Slope* means average inclination of a surface, measured from the horizontal, normally expressed as a unit of horizontal distance to vertical distance.

Stabilize means to control movement of soil, or areas of disturbed earth by modifying the geometry of the mass, or by otherwise modifying physical or chemical properties, such as by providing a protective surface coating.

Ton means 2000 pounds.

Water table means the upper surface of a zone of saturation.

The Navajo Nation hereby grants Lessee a Lease right to extract sand and gravel from the north half of Section 35 and the south half of Section 26, Township 41 N, Range 29 E, Gila and Salt River Meridian, Apache County, State of Arizona. The area encompassed by the lease is 36.294 acres, more or less. The location and legal description are shown in Exhibit <u>"A"</u>. The access road is 2,542.86 feet more or less, and is shown in Exhibit <u>"B"</u>.

1. The Lease shall be valid for a period of five (5) years effective the date it is approved by the Secretary. This date shall be known as the Effective Date of the Lease.

2. Payments to the Nation by the Lessee:

(i) The Lessee shall pay an annual advance royalty for each lease year. The first payment in the amount of Thirteen Thousand Three Hundred and Forty-five Dollars (\$13,345.00) is due within ten (10) days of the Effective Date. Subsequent annual advance royalty payments are due on or before each anniversary of the Effective Date. The annual advance royalty payment shall be credited against production royalties only during the year for which the advance royalty has been paid.

(ii) A royalty at the rate of \$1.40 per ton for each ton of sand and gravel material removed from the Lease premises. The royalty payment shall be made on a monthly basis within fifteen (15) days following the month for which the royalty is due.

(iii) Lessee shall annually pay \$3,326.40 for the access road right-of-way.

(iv.) The subsequent annual advance payments, the royalty rate and the annual right-of-way payment shall be subject to annual adjustments on each anniversary of the Effective Date. The adjustments shall be based upon the increase in the Consumer Price Index (CPI), U.S. City Average for All Urban Consumers. The CPI for March 2011 shall be used as the base for all adjustments.

3. Mining and Reclamation Plan: The Lessee shall abide by the mining and reclamation plan (Exhibit  $\underline{C}$ ). The Lessee shall incorporate all recommendations and changes mandated by the Navajo Nation and the DOI in the mining and reclamation plan submitted by the Lessee. The final slopes shall not exceed 4 (horizontal): 1 (vertical). The majority of the plant species will be native to the area. The Lessee shall ensure that no poisonous and noxious vegetation are allowed to grow in the leased area. The Lessee shall ensure that the final post-mining topographic plan does not allow water to collect in the leased area and no impoundment shall be left. No water shall be discharged off the leased area without written authorization from the Navajo Nation and all federal agencies having jurisdiction. There shall be no drilling and blasting.

4. Bond: The Lessee shall furnish a performance and reclamation bond for Two Hundred and Twenty-five Thousand Dollars (\$225,000.00). The Lessee shall maintain this bond at all times even if the Lease expires or is terminated. The bond shall only be released with the written consent of the Navajo Nation and the approval of the DOI. The Navajo Nation shall provide its written consent for the DOI to release the bond only after the expiration or termination of the Lease and after Lessee has fulfilled all its obligations, including payments to the Nation and reclamation, under the terms and conditions of this Lease. The bond may also be increased by the Navajo Nation and/or the DOI. The Navajo Nation will only seek to increase or decrease Lessee's bond in the event that 1. Lessee's Mining and Reclamation Plan is amended; 2. Lessee fails to comply with the Mining and Reclamation Plan; or 3. specific on the ground circumstances require such an increase. The Lessee shall request a bond release to DOI only after the expiration or termination of the Lease and Lessee has fulfilled all its obligations, including payments to the Nation and reclamation, under the terms and conditions of this Lease.

5. Water Use Permit: Lessee shall not use Navajo Nation water without a water use permit from the Navajo Nation Water Resources Department.

6. Records and Reports: The Lessee shall maintain accurate records of all sand and gravel material extracted, stockpiled, sold and removed from the Lease and the royalty due and paid to the Navajo Nation. A copy of the records shall be provided to the DOI and the Navajo Nation Minerals Department (P.O. Box 1910, Window Rock, AZ: 86515) on a monthly basis within fifteen (15) days following the sale month. The material shall be weighed before removal from the site. The scale shall be certified. Monthly production reports shall be filed even if there was no sale of material.

7. Method of Payments: All required payments under Section 2 of this Lease shall be made to the Department, in lawful money of the United States. A copy of the payments shall be provided to the DOI.

8. Disposition of Minerals and Surface: The Navajo Nation expressly reserves the right to use, lease or otherwise dispose of the minerals not covered by this Lease and the surface of the lands embraced within this Lease under existing laws and laws hereinafter enacted. Lessor further reserves the right to grant additional leases for the extraction and removal of sand and gravel or for any other purposes from the lands described herein. Such disposition and use shall be subject to the prior rights of the Lessee herein to use of so much of the said surface as is necessary in the extraction and removal of sand and gravel described in accordance with this Lease.

9. Diligence: The Lessee shall exercise diligence in the conduct of its mining operation and the land described herein shall not be held for speculative purposes, but in good faith for the extraction of sand and gravel and shall begin operation within one (1) month of the Effective Date.

10. No work shall commence until the mandatory mine health and safety training has been provided to the workers pursuant to 30 CFR, Part 46. The Lessee shall maintain the required training plan pursuant to the provisions of 30 CFR, Part 46. The Department shall be listed in the training plan if the Lessee wants the Department to conduct the training.

11. The Lessee shall obtain a mine identification number from the United States Mine Safety and Health Administration.

12. The Lessee may develop, use and occupy the area under the Lease for the purpose of removing sand and gravel material. The Lessee may not develop, use or occupy the area under the Lease for any other purpose without the prior written approval of the Nation and the Secretary. Such approval of the Nation may be granted upon conditions or withheld at the sole discretion of the Nation. The Lessee may not develop, use or occupy the area under the permit for any unlawful purpose. Any unlawful use of the land within the Lease shall render the Lease void at the option of the Nation and/or the Secretary.

13. Sand and gravel material shall not be used for projects outside the Nation unless it is expressly authorized by the Resources and Development Committee of the Navajo Nation Council.

14. In all activities conducted by the Lessee within the Navajo Nation, the Lessee shall abide by all laws and regulations of the Nation and of the United States, now in force and effect or as hereafter may come into force and effect, including but not limited to the following:

- a. Title 25, Code of Federal Regulations, Parts 162 and 169;
- b. Title 30, Code of Federal Regulations, Parts 46 and 56;
- c. The Navajo Nation Mine Safety Code 18 N.N.C. § 401;
- d. All applicable federal and Nation antiquities laws and regulations, with the following additional condition: In the event of a discovery, all operations in the immediate vicinity of the discovery must cease and the Navajo Nation Historic Preservation Department must be notified immediately. As used herein, "discovery" means any previously unidentified or incorrectly identified cultural resources, including but not limited to archaeological deposits, human remains, or location reportedly associated with Native American religious/ traditional beliefs or practice.
- e. To the extent allowed by applicable law, the Navajo Preference in Employment Act, 15 N.N.C. §§ 601 <u>et seq.</u>, the Navajo Nation Business Opportunity Act, 5 N.N.C. §§ 201 <u>et seq.</u>, and

- f. The Navajo Nation Water Code, 22 N.N.C. § et seq., Lessee shall apply for and submit all applicable permits and information to the Navajo Nation Water Resources Department, or its successor.
- g. Applicable regulations of the Navajo Nation Tax Code.

15. The Lessee shall ensure that the air quality of the Nation is not unduly degraded during operations by violating federal and Nation's applicable laws and regulations.

16. The Lessee shall clear and keep clear the lands within the Lease area to the extent compatible with the purpose of the Lease, and shall dispose of all vegetation and other materials cut, uprooted, or otherwise accumulated during any surface disturbance activities.

17. The Lessee shall at all times during the term of the Lease and at the Lessee's sole cost and expense, maintain the land subject to the Lease and all improvements located thereon and make all necessary reasonable repairs. Lessee shall not be responsible to make necessary reasonable repairs resulting from any damages caused by the Navajo Nation, its employees and any entity to which the Navajo Nation has granted a lease or right-of-way pursuant to Section 8. above.

18. The Lessee shall obtain prior written permission to cross an existing permit or lease areas, if any, from the appropriate parties.

19. The Lessee shall be responsible for and promptly pay all damages when they are sustained, from actions the Lessee causes.

20. The Lessee shall indemnify and hold harmless the Nation and the Secretary and their respective authorized agents, employees, land users and occupants against any liability for loss of life, personal injury and property damages arising from the development, use or occupancy or use of area under the Lesse by the Lessee.

21. The Lessee shall not assign, convey, transfer or sublet in any manner whatsoever, the lease or any interest therein, or in or to any of the improvements on the land subject to the lease, without the prior written consent of the Nation and the Secretary. Any such attempted assignment, conveyance or transfer without such prior written consent shall be void and of no effect. The consent of the Nation may be granted, granted upon conditions or withheld at the sole discretion of the Nation.

22. The Nation may recommend termination of the Lease by DOI for violation of any of the terms and conditions stated herein.

23. At the termination of the Lease, the Lessee shall peaceably and without legal process deliver up the possession of the premises, in good condition, usual wear and tear excepted. Upon the written request from the Nation, the Lessee shall provide the Navajo, at the Lessee's sole cost and expense, with an environmental audit assessment of the

premises at least thirty (30) days after completion and notification to the Nation that all required reclamation has been performed.

24. Holding over by the Lessee after the termination of the Lease shall not constitute a renewal or extension thereof or give the Lessee any rights hereunder or in to the land subject to the Lease or to any improvements located thereon.

25. The Nation and the Secretary shall have the right, at any reasonable time during the term of the permit, to enter upon the premises, or any part thereof, to inspect the same and any improvements located therein. The Nation and Secretary have further right to audit all payments due to the Nation.

26. By acceptance of the grant of Lease, the Lessee consents to the full territorial legislative, executive and judicial jurisdiction of the Nation, including but not limited to the jurisdiction to levy fines and to enter judgments for compensatory and punitive damages and injunctive relief, in connection with all activities conducted by the Lessee within the Navajo Nation or which have a proximate (legal) effect on persons or property within the Nation.

27. By acceptance of the grant of the Lease, the Lessee covenants and agrees never to contest or challenge the legislative, executive or judicial jurisdiction of the Nation on the basis that such jurisdiction is inconsistent with the status of the Nation as an Indian nation, or that the Navajo Nation government is not a government of general jurisdiction, or that the Navajo Nation government does not possess full police power (i.e., the power to legislate and regulate for the general health and welfare) over all lands, persons and activities within its territorial boundaries, or on any other basis not generally applicable to a similar challenge to the jurisdiction of a state government. Nothing contained in this provision shall be construed to negate or impair federal responsibilities with respect to the land subject to the Lease or to the Nation.

28. Any action or proceeding brought by the Lessee against the Nation in connection with or arising out of the terms and conditions of the Lease shall be brought only in the Courts of the Nation, and no such action or proceeding shall be brought by the Lessee against the Nation in any court of any state.

29. Nothing contained herein shall be interpreted as constituting a waiver, express or implied, of the sovereign immunity of the Nation.

30. Except as prohibited by applicable federal law, the law of the Nation shall govern the performance and enforcement of the terms and conditions contained herein.

31. The terms and conditions contained herein shall extend to and be binding upon the successors, heirs, assigns, executors, administrators, employees and agents, including all contractors and subcontractors, of the Lessee, and the term "Lessee" whenever used herein, shall be deemed to include all such successors, heirs, assigns, executors, administrators, employees and agents.

32. There is expressive reserved to the Nation full territorial legislative, executive and judicial jurisdiction over the area under the Lease and all lands burdened by the Lease, including without limitation over all persons, including the public, and all activities conducted or otherwise occurring within the area under the Lease and all lands burdened by the Lease shall be and forever remain Navajo Indian Country for purposes of Navajo Nation jurisdiction.

33. The Lessee is required to maintain and submit a certificate issued by an insurance company authorized to do business in the United States, and on the Navajo Nation, certifying that the applicant has a public liability insurance policy in force for the mining and reclamation operations pursuant to this Lease. Such policy shall provide for personal injury and property damage protection in an amount adequate to compensate any person injured or property damaged as a result of the mining and reclamation operations, including the use of explosives. Minimum insurance coverage for bodily injury and property damage shall be \$ 500,000 for each occurrence and \$1,000,000 aggregate.

(a) The policy shall be maintained in full force during the term of the Lease and the liability period necessary to complete all reclamation requirements under the Plan.

(b) The policy shall include a rider requiring that the insurer notify the Department and DOI whenever substantive changes are made in the policy including any termination or failure to renew.





## AMENDMENT NUMBER ONE (1) TO THE NAVAJO NATION SAND AND GRAVEL LEASE AND ACCESS ROAD RIGHT-OF-WAY AGREEMENT BETWEEN THE NAVAJO NATION AND APACHE COUNTY DISTRICT 1

**THIS AMENDMENT NUMBER ONE (1)** to the Navajo Nation Sand and Gravel Lease and Access Right-of-Way Agreement Between the Navajo Nation and Apache County District 1 (Agreement) is made and entered by and between the Navajo Nation and Apache County District 1 herein called the Lessee and whose address is at P.O. Box 1952, Chinle, Arizona 86503.

WHEREAS, the Agreement states at Section 1 "The Lease shall be valid for a period of five (5) years effective the date it is approved by the Secretary. This date shall be known as the Effective Date of the Lease." And;

WHEREAS, the signatures of both Parties to the Agreement were completed on October 31, 2013. And;

WHEREAS, the Agreement has never been approved by the Secretary, the term of the lease has not yet begun to run.

**NOW THEREFORE**, the Parties hereby agree to the following amendments to be made part of the Agreement and subsequently submitted to the Department of the Interior, Bureau of Indian Affairs for required approval:

## Amendment to Section 2. Payments to the Nation by the Lessee:

a

- (i) The Lessee shall pay an annual advance royalty for each lease year. The first payment in the amount of Thirteen Thousand Three Hundred and Forty-five Dollars (\$13,345.00) is due within ten (10) days of the Effective Date. Subsequent annual advance royalty payments are due on or before each anniversary of the Effective Date. The annual advance royalty payment shall be credited against production royalties only during the year for which the advance royalty has been paid.
- (ii) A royalty at the rate of \$1.40 per ton for each ton of sand and gravel material removed from the Lease premises. The royalty payment shall be made on a monthly basis within fifteen (15) days following the month for which royalty is due.
- (iii) Lessee shall annually pay \$3,326.40 for access road right-of-way.
- (iv) The subsequent annual advance payments, the royalty rate and the annual rightof-way payment shall be subject to annual adjustments on each anniversary of the Effective Date. The adjustments shall be based upon the increase in Consumer Price Index (CPI), U.S. City Average for All Urban Consumers. The CPI for March 2011 shall be used as the base for all adjustments.

In consideration that the work being performed by Apache County District 1 under this Agreement benefits Navajo Nation roads, all fees and royalties are waived.

## Amendment to Section 4. Bond:

The Lessee shall furnish a performance and reclamation bond for Two Hundred and Twenty-five Thousand Dollars (\$225,000.00) Ninety Thousand Dollars (\$90,000.00). The lessee shall maintain this bond at all times even if the Lease expires or is terminated. The bond shall only be released with the written consent of the Navajo Nation and the approval of the DOI. The Navajo Nation shall provide its written consent for the DOI to release the bond only after the expiration or termination of the Lease and after Lessee has fulfilled all its obligations including payments to the Nation and reclamation, under the terms and conditions of this Lease. The bond may also be increased by the Navajo Nation and/or the DOI. The Navajo Nation will only seek to increase or decrease Lessee's bond in the event that 1. Lessee's Mining and Reclamation Plan is amended; 2. Lessee fails to comply with the Mining and Reclamation Plan; or 3. Specific on the ground circumstances require such an increase. The Lessee shall request a bond release to DOI only after the expiration or termination of the Lease and Lessee has fulfilled all its obligations, including payments to the Nation and reclamation, under the terms and conditions of this Lease.

The above Amendments to Section 2 and Section 4, respectively, represent the total changes to the Agreement as intended by this document Amendment Number One (1).

#### BE IT ENACTED:

#### Section One. Findings

The Navajo Nation hereby finds the following with respect to this resolution:

- The Resources and Development Committee is a Standing Committee of the Navajo Nation Council and is authorized to approve sand and gravel leases and permits on the Navajo Nation; and
- 2. Apache County District I, address is P.O. Box 1952, Chinle, Arizona 86503, desires to enter into an agreement for a sand and gravel lease (Lease) and access road right-of-way (Exhibit "1"); and
- 3. The Lease and the right-of-way are located in the vicinity of Teecnospos, Apache County, Arizona. The Lease and the right-of-way are described in maps marked Exhibit "A" and "B" respectively. The Lease occupies 36.294 acres more or less and the right-of-way consists of 5.84 acres more or less; and
- The Mining and Reclamation Plan is attached as Exhibit "C"; and
- 5. Apache County District I has submitted an Environmental Assessment Report and Findings of No Significant Impact issued by the Bureau of Indian Affairs (Exhibit "D"); and

6. The consent of the affected land users have been obtained by the Navajo Land Department and are attached hereto as Exhibit "E".

#### Section Two. Approvals

- The Navajo Nation hereby approves a sand and gravel lease and an access road right-of-way for Apache County, District I (Exhibit "1"); and
- 2. The location of the lease and the right-of-way for the access road is shown on maps attached as Exhibit "A" and "B", respectively; and
- 3. Apache County District 1 shall abide by all the terms and conditions stipulated in Exhibit 1 and adhere to the Mining and Reclamation Plan (Exhibit "C"); and
- 4. The President of the Navajo Nation is hereby authorized to execute all documents intended to fulfill the intent of this resolution.

## NAVAJO NATION SAND AND GRAVEL LEASE AND ACCESS ROAD RIGHT-OF-WAY

THIS AGREEMENT for a Sand and Gravel Lease (Lease) is made and entered by and between the Navajo Nation and <u>Apache County District I</u>, herein called the Lessee and whose address is at P.O. Box 1952, Chinle, Arizona 86503.

Definitions:

Sand & Gravel means: Borrow (Earth.) Sand and Natural or Processed Gravel

Department means the Navajo Nation Minerals Department.

Navajo Nation (Nation) means the Navajo Tribe of Indians.

Secretary means the Secretary of the U.S. Department of Interior or his/her designated representative.

*Performance bond* means a surety bond, collateral bond or self-bond or a combination thereof, by which a lessee assures faithful performance of all the requirements of this lease and mining and reclamation plan.

*Reclamation* means those actions taken to restore mined land as required to a postmining land use approved by the Department.

NABIK'IYATI' Committee means the NABIK'IYATI' Committee of the Navajo Nation Council.

*Resources and Development Committee* means the Resources and Development Committee of the Navajo Nation Council.

*Slope* means average inclination of a surface, measured from the horizontal, normally expressed as a unit of horizontal distance to vertical distance.

Stabilize means to control movement of soil, or areas of disturbed earth by modifying the geometry of the mass, or by otherwise modifying physical or chemical properties, such as by providing a protective surface coating.

Ton means 2000 pounds.

Water table means the upper surface of a zone of saturation.

The Navajo Nation hereby grants Lessee a Lease right to extract sand and gravel from the north half of Section 35 and the south half of Section 26, Township 41 N, Range 29 E, Gila and Salt River Meridian, Apache County, State of Arizona. The area encompassed by the lease is 36.294 acres, more or less. The location and legal description are shown in Exhibit <u>"A"</u>. The access road is 2,542.86 feet more or less, and is shown in Exhibit <u>"B"</u>.

1. The Lease shall be valid for a period of five (5) years effective the date it is approved by the Secretary. This date shall be known as the Effective Date of the Lease.

2. Payments to the Nation by the Lessee:

(i) The Lessee shall pay an annual advance royalty for each lease year. The first payment in the amount of Thirteen Thousand Three Hundred and Forty-five Dollars (\$13,345.00) is due within ten (10) days of the Effective Date. Subsequent annual advance royalty payments are due on or before each anniversary of the Effective Date. The annual advance royalty payment shall be credited against production royalties only during the year for which the advance royalty has been paid.

(ii) A royalty at the rate of \$1.40 per ton for each ton of sand and gravel material removed from the Lease premises. The royalty payment shall be made on a monthly basis within fifteen (15) days following the month for which the royalty is due.

(iii) Lessee shall annually pay \$3,326.40 for the access road right-of-way.

(iv.) The subsequent annual advance payments, the royalty rate and the annual right-of-way payment shall be subject to annual adjustments on each anniversary of the Effective Date. The adjustments shall be based upon the increase in the Consumer Price Index (CPI), U.S. City Average for All Urban Consumers. The CPI for March 2011 shall be used as the base for all adjustments.

3. Mining and Reclamation Plan: The Lessee shall abide by the mining and reclamation plan (Exhibit  $\underline{C}$ ). The Lessee shall incorporate all recommendations and changes mandated by the Navajo Nation and the DOI in the mining and reclamation plan submitted by the Lessee. The final slopes shall not exceed 4 (horizontal): 1 (vertical). The majority of the plant species will be native to the area. The Lessee shall ensure that no poisonous and noxious vegetation are allowed to grow in the leased area. The Lessee shall ensure that the final post-mining topographic plan does not allow water to collect in the leased area and no impoundment shall be left. No water shall be discharged off the leased area without written authorization from the Navajo Nation and all federal agencies having jurisdiction. There shall be no drilling and blasting.

4. Bond: The Lessee shall furnish a performance and reclamation bond for Two Hundred and Twenty-five Thousand Dollars (\$225,000.00). The Lessee shall maintain this bond at all times even if the Lease expires or is terminated. The bond shall only be released with the written consent of the Navajo Nation and the approval of the DOI. The Navajo Nation shall provide its written consent for the DOI to release the bond only after the expiration or termination of the Lease and after Lessee has fulfilled all its obligations, including payments to the Nation and reclamation, under the terms and conditions of this Lease. The bond may also be increased by the Navajo Nation and/or the DOI. The Navajo Nation will only seek to increase or decrease Lessee's bond in the event that 1. Lessee's Mining and Reclamation Plan is amended; 2. Lessee fails to comply with the Mining and Reclamation Plan; or 3. specific on the ground circumstances require such an increase. The Lessee shall request a bond release to DOI only after the expiration or termination of the Lease and Lessee has fulfilled all its obligations, including payments to the Nation and reclamation, under the terms and conditions of this Lease.

5. Water Use Permit: Lessee shall not use Navajo Nation water without a water use permit from the Navajo Nation Water Resources Department.

6. Records and Reports: The Lessee shall maintain accurate records of all sand and gravel material extracted, stockpiled, sold and removed from the Lease and the royalty due and paid to the Navajo Nation. A copy of the records shall be provided to the DOI and the Navajo Nation Minerals Department (P.O. Box 1910, Window Rock, AZ: 86515) on a monthly basis within fifteen (15) days following the sale month. The material shall be weighed before removal from the site. The scale shall be certified. Monthly production reports shall be filed even if there was no sale of material.

7. Method of Payments: All required payments under Section 2 of this Lease shall be made to the Department, in lawful money of the United States. A copy of the payments shall be provided to the DOI.

8. Disposition of Minerals and Surface: The Navajo Nation expressly reserves the right to use, lease or otherwise dispose of the minerals not covered by this Lease and the surface of the lands embraced within this Lease under existing laws and laws hereinafter enacted. Lessor further reserves the right to grant additional leases for the extraction and removal of sand and gravel or for any other purposes from the lands described herein. Such disposition and use shall be subject to the prior rights of the Lessee herein to use of so much of the said surface as is necessary in the extraction and removal of sand and gravel described in accordance with this Lease.

9. Diligence: The Lessee shall exercise diligence in the conduct of its mining operation and the land described herein shall not be held for speculative purposes, but in good faith for the extraction of sand and gravel and shall begin operation within one (1) month of the Effective Date.

10. No work shall commence until the mandatory mine health and safety training has been provided to the workers pursuant to 30 CFR, Part 46. The Lessee shall maintain the required training plan pursuant to the provisions of 30 CFR, Part 46. The Department shall be listed in the training plan if the Lessee wants the Department to conduct the training.

11. The Lessee shall obtain a mine identification number from the United States Mine Safety and Health Administration.

12. The Lessee may develop, use and occupy the area under the Lease for the purpose of removing sand and gravel material. The Lessee may not develop, use or occupy the area under the Lease for any other purpose without the prior written approval of the Nation and the Secretary. Such approval of the Nation may be granted upon conditions or withheld at the sole discretion of the Nation. The Lessee may not develop, use or occupy the area under the permit for any unlawful purpose. Any unlawful use of the land within the Lease shall render the Lease void at the option of the Nation and/or the Secretary.

13. Sand and gravel material shall not be used for projects outside the Nation unless it is expressly authorized by the Resources and Development Committee of the Navajo Nation Council.

14. In all activities conducted by the Lessee within the Navajo Nation, the Lessee shall abide by all laws and regulations of the Nation and of the United States, now in force and effect or as hereafter may come into force and effect, including but not limited to the following:

- a. Title 25, Code of Federal Regulations, Parts 162 and 169;
- b. Title 30, Code of Federal Regulations, Parts 46 and 56;
- c. The Navajo Nation Mine Safety Code 18 N.N.C. § 401;
- d. All applicable federal and Nation antiquities laws and regulations, with the following additional condition: In the event of a discovery, all operations in the immediate vicinity of the discovery must cease and the Navajo Nation Historic Preservation Department must be notified immediately. As used herein, "discovery" means any previously unidentified or incorrectly identified cultural resources, including but not limited to archaeological deposits, human remains, or location reportedly associated with Native American religious/ traditional beliefs or practice.
- e. To the extent allowed by applicable law, the Navajo Preference in Employment Act, 15 N.N.C. §§ 601 <u>et seq.</u>, the Navajo Nation Business Opportunity Act, 5 N.N.C. §§ 201 <u>et seq.</u>, and

- f. The Navajo Nation Water Code, 22 N.N.C. § <u>et seq</u>., Lessee shall apply for and submit all applicable permits and information to the Navajo Nation Water Resources Department, or its successor.
- g. Applicable regulations of the Navajo Nation Tax Code.

15. The Lessee shall ensure that the air quality of the Nation is not unduly degraded during operations by violating federal and Nation's applicable laws and regulations.

16. The Lessee shall clear and keep clear the lands within the Lease area to the extent compatible with the purpose of the Lease, and shall dispose of all vegetation and other materials cut, uprooted, or otherwise accumulated during any surface disturbance activities.

17. The Lessee shall at all times during the term of the Lease and at the Lessee's sole cost and expense, maintain the land subject to the Lease and all improvements located thereon and make all necessary reasonable repairs. Lessee shall not be responsible to make necessary reasonable repairs resulting from any damages caused by the Navajo Nation, its employees and any entity to which the Navajo Nation has granted a lease or right-of-way pursuant to Section 8. above.

18. The Lessee shall obtain prior written permission to cross an existing permit or lease areas, if any, from the appropriate parties.

19. The Lessee shall be responsible for and promptly pay all damages when they are sustained, from actions the Lessee causes.

20. The Lessee shall indemnify and hold harmless the Nation and the Secretary and their respective authorized agents, employees, land users and occupants against any liability for loss of life, personal injury and property damages arising from the development, use or occupancy or use of area under the Lesse by the Lessee.

21. The Lessee shall not assign, convey, transfer or sublet in any manner whatsoever, the lease or any interest therein, or in or to any of the improvements on the land subject to the lease, without the prior written consent of the Nation and the Secretary. Any such attempted assignment, conveyance or transfer without such prior written consent shall be void and of no effect. The consent of the Nation may be granted, granted upon conditions or withheld at the sole discretion of the Nation.

22. The Nation may recommend termination of the Lease by DOI for violation of any of the terms and conditions stated herein.

23. At the termination of the Lease, the Lessee shall peaceably and without legal process deliver up the possession of the premises, in good condition, usual wear and tear excepted. Upon the written request from the Nation, the Lessee shall provide the Navajo, at the Lessee's sole cost and expense, with an environmental audit assessment of the

premises at least thirty (30) days after completion and notification to the Nation that all required reclamation has been performed.

24. Holding over by the Lessee after the termination of the Lease shall not constitute a renewal or extension thereof or give the Lessee any rights hereunder or in to the land subject to the Lease or to any improvements located thereon.

25. The Nation and the Secretary shall have the right, at any reasonable time during the term of the permit, to enter upon the premises, or any part thereof, to inspect the same and any improvements located therein. The Nation and Secretary have further right to audit all payments due to the Nation.

26. By acceptance of the grant of Lease, the Lessee consents to the full territorial legislative, executive and judicial jurisdiction of the Nation, including but not limited to the jurisdiction to levy fines and to enter judgments for compensatory and punitive damages and injunctive relief, in connection with all activities conducted by the Lessee within the Navajo Nation or which have a proximate (legal) effect on persons or property within the Nation.

27. By acceptance of the grant of the Lease, the Lessee covenants and agrees never to contest or challenge the legislative, executive or judicial jurisdiction of the Nation on the basis that such jurisdiction is inconsistent with the status of the Nation as an Indian nation, or that the Navajo Nation government is not a government of general jurisdiction, or that the Navajo Nation government does not possess full police power (i.e., the power to legislate and regulate for the general health and welfare) over all lands, persons and activities within its territorial boundaries, or on any other basis not generally applicable to a similar challenge to the jurisdiction of a state government. Nothing contained in this provision shall be construed to negate or impair federal responsibilities with respect to the land subject to the Lease or to the Nation.

28. Any action or proceeding brought by the Lessee against the Nation in connection with or arising out of the terms and conditions of the Lease shall be brought only in the Courts of the Nation, and no such action or proceeding shall be brought by the Lessee against the Nation in any court of any state.

29. Nothing contained herein shall be interpreted as constituting a waiver, express or implied, of the sovereign immunity of the Nation.

30. Except as prohibited by applicable federal law, the law of the Nation shall govern the performance and enforcement of the terms and conditions contained herein.

31. The terms and conditions contained herein shall extend to and be binding upon the successors, heirs, assigns, executors, administrators, employees and agents, including all contractors and subcontractors, of the Lessee, and the term "Lessee" whenever used herein, shall be deemed to include all such successors, heirs, assigns, executors, administrators, employees and agents. 32. There is expressly reserved to the Nation full territorial legislative, executive and judicial jurisdiction over the area under the Lease and all lands burdened by the Lease, including without limitation over all persons, including the public, and all activities conducted or otherwise occurring within the area under the Lease and all lands burdened by the Lease shall be and forever remain Navajo Indian Country for purposes of Navajo Nation jurisdiction.

33. The Lessee is required to maintain and submit a certificate issued by an insurance company authorized to do business in the United States, and on the Navajo Nation, certifying that the applicant has a public liability insurance policy in force for the mining and reclamation operations pursuant to this Lease. Such policy shall provide for personal injury and property damage protection in an amount adequate to compensate any person injured or property damaged as a result of the mining and reclamation operations, including the use of explosives. Minimum insurance coverage for bodily injury and property damage shall be \$ 500,000 for each occurrence and \$1,000,000 aggregate.

(a) The policy shall be maintained in full force during the term of the Lease and the liability period necessary to complete all reclamation requirements under the Plan.

(b) The policy shall include a rider requiring that the insurer notify the Department and DOI whenever substantive changes are made in the policy including any termination or failure to renew.





We appreciate your valuable feedback on Apache County's Mining and Reclamation Plan for the Carrizo Mountain Pit. We relied on your comments to adjust the language of the plan and are optimistic that you will find the changes to your satisfaction. To assist you in reviewing the changes we incorporated in the plan I have summarized or explained the specific changes for your convenience. The various changes have been color coded for ease in finding in the document attached.

 Relating to comment #1 on your letter dated May 10, 2010, the following was determined: The Legal Description has been included in the packet in Section B MAPS AND PLANS AND SUPPORTING DOCUMENTS - Figure 4. Legal Description and Survey by Navajo Department of Transportation 3/28/2000 Apache County prefers keeping the access road 100' wide to allow flexibility in construction of the access road.

- Relating to comment #2 on your letter dated May 10, 2010, Section 2.2 Training had be corrected to ensure that the training of personnel is in accordance to 30 CFR Section 46.
- Relating to comment #3 on your letter dated May 10, 2010, Figure 9. Carrizo Gravel Pit Mining Operation Layout was added to the packet.
- 4. Relating to comment #4 on your letter dated May 10, 2010, Page 8 of the plan addresses the need for dust control and the need to obtain permits for water. Dust control is also discussed in the SWPPP in Appendix E. Water Permit for water to be hauled from San Juan River was issued to Apache County by Tribal Water Code and this permit will be extended as needed.
- 5. Relating to comment #5 on your letter dated May 10, 2010, The Table on page 3 and 4 of the packet has been updated to include estimated tonnages for County maintained Routes and an equal amount for the Navajo Department of Transportation TTIP.
- Relating to comment #6 on your letter dated May 10, 2010, Section 2.6.1 explains in greater detail the mining method anticipated in this pit.
- 7. Relating to comment #7 on your letter dated May 10, 2010, Figure 6 shows the pre-mining configuration of the existing proposed gravel pit and Figure 7 shows the projected post-mining contour maps. To find the volume material extracted from the gravel pit as-built contour will be needed to provide reliable information. Apache County is willing to have the pit re aerial photographed to determine accurate quantities and contours.
- 8. Relating to comment #8 on your letter dated May 10, 2010, Section 3.4 and Appendix D has been expanded to include greater clarity in the re-vegetation process, specifically section 3.4.4. Contact was made with the Navajo Department of Agriculture and Apache County personnel were assured that we have specified the proper seed mixture and density.
- Relating to comment #9 on your letter dated May 10, 2010, see Section B figures
   6 and 7.

- 10. Relating to comment #10 on your letter dated May 10, 2010, Appendix E: Storm Water Pollution Prevention Plan has been updated to include more specificity with regard to storm water controls. In Section II Controls of the plan Apache County will cut small outlets to allow water to leave the pit.
- 11. Relating to comment #11 on your letter dated May 10, 2010 Arrangement will be made with private consultants to measure the success of the re-vegetation due to the lack of qualified tribal personnel to performance the measurement. The Department of Agriculture's recommendation is to contact the Department of Soil and Water Conservation.

## A. GENERAL MINING PLAN

## **1.0 INTRODUCTION**

## 1.1 Project Purpose

Apache County District One of Chinle, Arizona, plans to reopen Carrizo Quarry Pit, which is an abandoned gravel pit covering 36.92 acres of land and located approximately 5.5 miles west of Teec Nos Pos, Arizona (Figure 1, Figure 2 and Figure 3). The purpose for reopening the gravel pit is to excavate and crush natural gravel deposits. The extraction and crushing of the gravel deposits will involve stripping and storing the topsoil, excavating, loading, crushing, and stockpiling the crushed material on site. Then the material will be transported out of the gravel pit for improvement of official Intergovernmental Agreement (IGA) county school bus routes in the northern part of Apache County District One. Also, the undertaking at the gravel pit will include the improvement of 0.45 mile of access road which will have a one hundred-foot (100 feet) corridor (Figure 5) and installation of a small culvert. The improvement of the access road will closely follow the existing dirt road to minimize the disturbance inside the corridor. The installation of the corrugated metal culvert in a small ravine will insure unrestricted flow of stormwater run-off under the access road to the gravel pit.

The mining operation under the proposed five-year lease will fully support the road plating activities in the northern part of Apache County District One within the jurisdictions of Teec Nos Pos, Red Mesa, and Sweetwater and Mexican Water chapters. Some crushed aggregate may have to be transported outside the four chapter boundaries to economically plate other school bus routes that have been approved by Intergovernmental Agreement between Apache County, Navajo Nation and Bureau of Indian Affairs. Future arrangement will be made to Navajo Division of Transportation of Window Rock for extraction of material from the pit and the arrangement will be in compliance with all federal and tribal requirements

There are 24.6 miles of bus routes (Routes C-479, C-474, C-471, C-478, C-477, C-534 and C-548) that need immediate improvement by plating the roadways with crushed aggregate and these bus routes are listed in the table below. The option of applying magnesium chloride to reduce the muddy and impassable roadway conditions during the inclement winter months will be considered after the plating operations are completed. Other IGA dirt roads will receive the same improvement and surface treatment once the following school bus routes are improved:

#### 1.2 Project Location and Description

The Carrizo Quarry Pit is situated 5.5 miles west of the community of Teec Nos Pos, Apache County, Arizona, along and south of Arizona State Highway 160 that runs from Tuba City to the junction of Highway U.S. 160-Highway 504 at Teec Nos Pos, Arizona. Highway U.S. 160 is located in the northern section of the Apache County District One within the Navajo Nation.

The proposed gravel pit is more specifically located in Township 41 North, Range 29 East; Gila and Salt River Meridian; north half (1/2) of Section 35 and south half (1/2) of Section 26, and the legal description and map are part of the attachments (Figure 4 and Figure 5). The proposed gravel pit is within the boundary of Teec Nos Pos Chapter, one of the chapters within of Shiprock Agency, Navajo Nation (Apache County, Arizona). The proposed gravel pit is located between 5530 and 5600 feet above mean sea level as shown on the 7.5' USGS quadrangle map of Cow Butte, Arizona (Figure 3).

#### 2.0 OPERATION PLAN

Apache County District One will operate the Carrizo Quarry Pit during the five-year lease to provide crushed material for the plating of official Intergovernmental Agreement (IGA) county school bus routes within the jurisdiction of Teec Nos Pos, Red Mesa, Sweetwater and Mexican Water chapters. Due to the scarcity of aggregate resources in the northern part of District One some crushed material from the proposed pit may be hauled to other official IGA school bus routes in other chapter areas for road improvement.

## 2.1 Overview

Carrizo Quarry Pit had been extensively excavated in the past and it has been stated by the local land users that the gravel pit had been used more than once for different projects. Deep depressions had been left in the gravel pit without any outlets for the storm water run-off and the stormwater run-off have been concentrating in puddles in the depressions inside the proposed gravel pit. Based on the poor condition of the abandoned gravel pit, past operators did not implement any pollution preventive measures and the disturbed areas were not reclaimed to permit unrestricted flow of the stormwater run-off out of the gravel pit.

People had started dumping trash near the northeastern edge of the proposed gravel pit and trash from the past mining operation is still scattered in isolated spots within the proposed gravel pit. Request has been made by the one of the local land users to have Apache County remove all the trash and backfill the sump prior to the commencement of the mining operation.

Apache County District One shall develop and implement a Storm Water Pollution Prevention Plan (SWPPP) for the mining operation. After the salvaging of the top soil and preparing the staging area in the operational area, Apache County District One will transport crushers with the conveyors and other equipment into the proposed gravel pit for the commencement of the extraction and crushing operation. It will take approximately six months of crushing to produce enough crushed material to

plate the four dirt roads (Routes C-479, C-471, C-477 and C-548) that require immediate attention. Mechanical problems and other down times are expected to slow down the crushing operation.

#### 2.2 Training

In compliance with 30 CFR Section 46, Apache County District One personnel have already taken the required 24-hour Mine Safety and Health Administration (MSHA) training session and other personnel have recently attended the annual 8-hour refresher course. As specified in the 30 CFR Section 46, all training will be conducted by approved trainers and the required training courses will be followed. As required by MSHA, all personnel working full-time at the gravel pit and other essential support staff visiting the gravel pit will be required to attend the mandatory training courses. Apache County District One personnel to be trained will include all heavy equipment operators, truck drivers, mechanics, maintenance workers, supervisors, and other essential support staff.

#### 2.3 Security

The existing survey property corners of the proposed gravel pit will be properly marked and safeguarded for easy reference when needed.

Only the approved parcel of land will be secured with a barbed wire fence to keep out wandering livestock and the fence will be maintained during the mining and reclamation stages of the mining operation by Apache County. The main entrance into the gravel pit will be secured with a metal gate to prevent illegal entry during non-working hours.

The meandering access haul road which merges with BIA Route N5049 will be left unfenced. An existing trail situated on the southeast side of the proposed gravel pit is being utilized by the local land users and this trail shall remain unfenced.

The sole entrance into the gravel pit from the east side will be closed and secured during non-working hours. Appropriate security measures shall be implemented to ensure deterrence of prohibited activities and vandalism of equipment. If necessary, Apache County District One shall employ security personnel to safeguard the crushed material and equipment.

#### 2.4 Storm Water Pollution Prevention Plan

This General Mining Plan does not specifically deal with the implementation of the federally required Storm Water Pollution Prevention Plan (SWPPP). The required Storm Water Pollution Prevention Plan is attached to the General Mining Plan for reference.

#### 2.5 0 Vegetation and Topsoil

The operational area, less than four (4) acres, will be cleared for the mining operation. All unnecessary disturbance and clearing will be kept to the minimum as part of the erosion control measures. The top soil with the vegetation will be windrowed, collected, stockpiled, stored and protected for future use in the reclamation of the gravel pit. Precautions shall be taken at all times to avoid wind and water erosion of the stockpiled top soil.

#### 2.5.1 Vegetation

Due to the nature of the existing soil, there is sparse vegetation within the proposed gravel pit. Disturbance of ground surface and clearance of vegetation shall be confined to the areas to be used for the staging area for the equipment and the operational area for the mining and extraction of the gravel deposits. The entire proposed gravel pit shall not all be cleared since the entire area might not be used within the time frame of the lease. Segments of the approved parcel of land will be cleared for excavation of material as needed.

All vegetation with the topsoil shall be stockpiled and protected for the duration of the mining operation and all vegetation shall be used in the reclamation operation. The sparse vegetation will be stockpiled along with the topsoil as described in Section 2.5.2 Topsoil.

## 2.5.2 Topsoil

The proposed gravel pit consists of alluvial deposits of large cobbles and course sand covered with aeolian deposition of uniform thickness. The topsoil with the vegetation will be windrowed, collected and stockpiled away from the operational areas. These topsoil stock piles will be clearly marked with signs (figure 9).

Presently, the undisturbed area of the proposed gravel pit has the topsoil material in its natural state. However, the disturbed surface areas of the gravel pit do not have any topsoil to be removed and saved. It is evidence; the past mining operations in the abandoned gravel pit did not implement land reclamation measures as presently required by tribal and federal regulations.

) The slopes of the disturbed areas are covered with heterogeneous mixture of gravelly materials that are not covered with any aeolian deposits or topsoil. The disturbed areas were not reclaimed by past mining operations prior to the closure of the gravel pit and so there is lack of topsoil and vegetation on the slopes and in the bottom of the proposed gravel pit. The fine soil or any topsoil in the gravel pit is not expected to encounter any loss due to removal by rain stormwater run-off since the depressions do not have any outlets for drainage off the proposed gravel pit. The deep depressions in the proposed gravel pit have been formed by the past usage and all stormwater run-off in the gravel pit concentrate in small puddles in the low areas.

## 2.6 Concept of Operation

All excavation of aggregate material for the crushing operation will be removed from the interior of the slopes and the crushed material will be stockpiled. All excavation will proceed from near the crushers and the excavation will proceed away from the crushers.

#### 2.6.1 Mining Method

The required SWPPP devices will be installed according to the attached plan. Once the stormwater run-off and sedimentation control devices are installed, a culvert will be installed in the small ravine for the preparation of the access road to the gravel pit. Then the operational mining area will be cleared and the topsoil will be stockpiled prior to commencement of the crushing operation as stated in Section 2.5.2 Topsoil.

Once all the SWPPP devices are installed and the clearance of the operational area accomplished, the crushers and conveyors will be set up in the proposed gravel pit. The staging area for the crushers and

)

the conveyors will be cleared with some minor leveling of the bottom of the gravel pit as needed. The crushers will be stationed in the most favorable location for easy loading of the aggregate material. Certain areas of the gravel pit have back slopes as high as thirty (30) feet with variable slopes and the slopes of the bank are as steeper than 2:1. There should not be any problem with the slope being unstable or the material sliding off to endanger the workers. The in-place material is not like a shifting sand with the angle of repose being a problem.

Since the gravel pit consist of gravelly material in unconsolidated condition, drilling equipment and explosive material will not be used for fragmentation of the natural deposit. Bull dozer will be used to rip and push the un-processed aggregate material closer to the primary crusher for easy loading. Front end loader will be used around the crushers and the dozer will be used when necessary.

The crushed material of the desired size will be stockpiled with the conveyor. The conveyors will be moved to favorable location when needed to stockpile the crushed material and the safe working height of the stockpile will be monitored for measurement of the stockpiled material (figure 9).

To implement the dust control during the crushing operation, a water truck will be available to feed water into the crushers on a continual basis. Dust pollution is not expected to be a major problem since the material in the proposed gravel pit is mostly granular sand with very limited fines plus the stony cobbles.

All heavy equipment will be parked in the operational areas of the gravel pit where the crushers and conveyors will be stationed. Only the crushed material will be stockpiled and stored on site and other materials will not be stored on the premise. No stationary fuel tank shall be located on the proposed gravel pit and all refueling will be done by mobile fuel trucks as needed to keep the crushers and generator in operation. No more than four personnel will oversee the crushing operation on a daily bases. Only the maintenance and repair work on the crusher and conveyor will be performed on site. All maintenance work on the hauling units will be performed in the county maintenance yard at Tee Nos Pos to avoid spillage of petroleum substances. Potable water and sanitary units will be provided for personnel working on the premise.

#### 2.6.2 Haul Road

Apache County plans to use an existing dirt road leading to the proposed gravel pit. The old dirt road has been archeologically cleared and surveyed with limits of 100 feet centered on the old road (figure 5). This old dirt road was used as a haul road in the past and the proposed access road will follow the old road that was once used. In this way Apache County will keep soil disturbance along the old dirt road to a minimum. The proposed access road branches off BIA Route N5049 near Arizona State Highway 160 on the southeast side. The existing dirt road meanders toward the proposed gravel pit and then it merges with another trail that meanders pass the gravel pit on the southeast side. The proposed access road will enter the proposed gravel pit from the east end of the proposed gravel pit.

With the exception of illegal dumping of trash and occasional visit to the general area, the existing dirt roads within the vicinity of the proposed gravel pit are not in use on regular bases. Activities at the gravel pit should not create any safety hazard to the local residents and livestock. Once the barbed wire fence is installed the wandering livestock will not be able to enter the mining area.

The access haul road will be maintained by grading and watering for dust control. As needed, additional erosion control devices will be installed to prevent the silt and sediment from being carried

along the ditches of the access haul road. Equipment shall not be permitted to get off the designated area for the access road and mining operation.

Proper signage shall be installed on U.S. Highway 160 to warn the motorists of traffic coming onto the highway from the gravel pit. There is enough clearance for safe sight distances on both sides of the turnoff to the gravel pit.

#### 2.6.3 Production

Once all the SWPPP devices are installed and the clearance of the operational area accomplished, the crushers and conveyors will be set up in the proposed gravel pit. The staging area for the crushers and the conveyors will be cleared with some minor leveling of the bottom of the gravel pit as needed. The crushers will be stationed in the most favorable location for easy loading of the aggregate material (figure 9). Certain areas of the gravel pit have back slopes as high as thirty (30) feet with variable slopes. Bull dozer will be used to rip and push the un-processed aggregate material closer to the primary crusher for easy loading. Front end loader will be used around the crushers and the dozer will be used when necessary.

Even though the height of the slopes in the excavated areas is as high as thirty (30) feet and with the existing slopes are steeper that 2:1, the undisturbed material in its insitu position is stable. The proposed gravel pit consists of alluvial deposits of large cobbles and course sand with aeolian material that has the property to hold itself together on the steep slope. The excavation of the insitu material will be performed in a way to ensure that the slopes are at least 4:1 or flatter. The finish slope needs to be left close to 4:1 so extensive work will not be performed during the reclamation of the gravel pit to flatten the slopes.

All heavy equipment will be parked in the working areas along with the stationed crushers and conveyors as shown in the plan (figure 9). Only the crushed material will be stockpiled and stored on site and other materials will not be stored on the premise. No stationary fuel tank shall be located on proposed gravel pit and all refueling will be done by mobile fuel trucks as needed to keep the crushers and generator in operation. No more than four personnel will oversee the crushing operation on a daily bases. Maintenance and repair work will not be performed on site to avoid spillage of petroleum substances. Potable water and sanitary units will be provided for personnel working on the premise.

.The sparse vegetation and top soil in the operational areas will be stripped as needed. When the clearing, grubbing and gathering of the topsoil is started, the sparse vegetation will not pose any problem in the disturbed area inside the proposed gravel pit. As much vegetation will be removed and stockpiled since the crushed material will only be used for road maintenance. The road maintenance material does not have strict specification that prohibits organic matters in the crushed gravel.

To implement the dust control during the crushing operation, a water truck will be available to feed water into the crushers as necessary. Dust pollution is not expected to be a major problem since the material in the proposed gravel pit is mostly granular sand with very limited fines plus the stony cobbles. All necessary permits for obtaining water will be acquired from the Navajo Department of Water resources prior to any water hauling and dust control activities.

The cut back slope of the gravel pit will be excavated and the material will be loaded into the primary crusher. Material will be stockpiled upon coming off the conveyor belts and it will be transported off the site when needed. Further crushing will be needed to produce adequate material to cover other school bus routes.

The crushed material of the desired size will be stockpiled with the conveyor. The conveyors will be moved to favorable location when needed to stockpile the crushed material and the safe working height of the stockpile will be controlled by the conveyor. The daily production of crushed material will be measured as it is stockpiled under the conveyor in a conical shape. Further, the amount of material being removed daily will be accounted for by keeping records of the number of one measurement is for the production and the other count is for the haulage off the site.

.If approximately 70 tons of crushed material is produced an hour, about 420 tons of crushed material will be produced within 6-hour of work in one day or at least 2,100 tons of crushed material will be produced within one week. It will take approximately four to six months to produce 31,780 tons of crushed material that will cover the four bus routes (C-479, C-471, C-477 and C-548) that need immediate attention. The total length of the four projects is 16.4 miles.

The crushing operation at Carrizo Quarry Pit will be temporarily discontinued during the winter months and in adverse weather conditions for safety reason. Mining operation at the proposed pit will be discontinued when other gravel pits become available. The mining operation will be continued as long as possible in Carrizo Quarry Pit before the expiration of the five-year lease (figure 8).

The equipment to be used for the crushing operation will not be changed. Other equipment for transporting crushed material out of the proposed gravel pit and the equipment to be used for routine maintenance and inspection of the daily activities will vary day to day. Transporting equipment will not be parked at the staging area with the crushers and conveyors in the evening or during the weekends unless security is on site. Motor vehicles will be taken back to the Teec Nos Pos sub-office on a daily bases.

## 2.6 Reporting

Apache County District One will purchase and install Truck Scales for the purpose of tracking the quantity of material leaving the pit. Weigh tickets will be collected daily by county personnel and will be totaled and recorded in an accounting spreadsheet. A copy of the weigh tickets and summary of spreadsheet will be provided to the minerals department as required. Scales will be certified by appropriate department of weights and measures.

#### 3.0 RECLAMATION PLAN

On December 14, 2010, one of the Apache County District One employees made a personal contact made with Leo Watchman of the Navajo Department of Agriculture and Judy Willeto (Range Conservationist) of Navajo Division of Natural Resource to discuss the reseeding mixture and seed density as requested by the Mineral Department of Navajo Nation. The employee was told that the attached Reclamation Plan titled as *Reclamation of Right of Ways, Equipment/Supply Yards, Access Roads, and Sand & Gravel Pits* was approved and provided by the Navajo Nation Department of Agriculture. The county employee was advised to the Reclamation Plan provided by Department of Agriculture. The attached plan was issued by the Department of Agriculture on September 1, 1998. All reclamation work by Apache County will be performed in accordance with the Navajo Nation Reclamation Plan. The disturbed areas within the proposed lease will be reclaimed in accordance with applicable laws, Department of Interior and requirements of Navajo Nation.

#### **3.1 General Concept of Reclamation**

In preparation for the final closure of the gravel pit, the general concept of the proposed reclamation operation is to make an effort to restore the disturbed gravel pit by using salvaged topsoil material, over burden, vegetative matters and reseeding operation. The disturbed areas will be reclaimed for future use as grazing land and the drainage pattern outside the gravel pit will not be disturbed. In the existing excavated areas there is no top soil and over burden to be salvaged and conserved for future use in the reclamation operation. It is to be particularly noted in advance, there will be a shortage of top soil to be spread on all the disturbed area due to the past operations.

#### 3.2 Backfilling and Grading

The attached Pre-mining Contour Map (Figure 6) shows the contour of the existing gravel pit. Based on the expected material to be excavated, crushed and removed from the gravel pit, the expected postmining topography of the pit is shown on the attached Post-mining Contour Map (Figure 7). As needed, back filling of the depressed areas shall be performed. The shaping and blending of the banks into the adjacent terrain will be performed prior to the commencement of the reclamation activities. The edges of the excavated areas will be rounded and then the excavated area will be graded to a slope of 4:1 or flatter to match to the existing terrain. Cat-walking with a dozer will be performed to retain and to promote stormwater run-off infiltration on the slopes.

#### 3.3 Drainage

The overall original drainage pattern was loss during prior mining operations and deep depressions were created in the gravel pit without any drainage off the site. Extra effort will be under taken to ensure that proper drainage provided where needed. The small earthen ridge on the north edge of the pit will be cut down to the bottom elevation of the gravel pit to make way for drainage out of the gravel pit. If there is a need for small channels then the channels will be cut to drain the stormwater out of the gravel pit before the reclamation operation is started.

#### 3.4 Re-vegetation

To prepare the disturbed area for the reseeding, the topsoil and the over burden will be spread on the disturbed areas and cat-walking with a dozer will be accomplished prior to the commencement of seeding operation. Again the Reclamation Plan issued by Navajo Department of Agriculture will be closely followed during the reclamation operation.

#### 3.4.1 Seedbed Preparation

Seedbed preparation and reseeding will be accomplished in accordance with the recommended reclamation plan from the Navajo Department of Agriculture. The seedbed preparation shall not be extended beyond the disturbed area within the gravel pit and the staging area used for the crushing and storage areas. Cat-walking with a dozer will be performed due to the very stony surface covered with cobbles and gravel. The cat-walked area will be watered down prior to the application of the seeds at the prescribed rate. The reseeding operation will be performed either in April-May, June–August or October-November to capitalize on the monsoon season and the winter precipitation.

#### 3.4.2 Seeding and seed Mixture

This part of the reclamation work shall consist of reseeding all areas which are denuded of vegetation and top soil due to all activities related to the mining operation. The bare areas that are very stony and covered with large cobbles will be cat-walked and watered down prior to broadcasting the specified seeds at the prescribed rate. The seeded area will be covered with weed-free straw mulch as recommended by Navajo Department of Agriculture. Another cat-walking of the slope will be performed to secure the seed and weed-free straw in the treated area. As recommended by Navajo Department of Agriculture the treated area will be watered down by spraying for the germination and growth of the seeds.

Since the soil is composed of loam, sand, sandy loam and gravel, the Table B that is suitable for the Northern Desert as prescribed by Navajo Department of Agriculture. The table shown below was taken out of the Reclamation Plan of the Navajo Nation.

#### 3.4.3 Roads and Trails

After all the reclamation work is completed in the gravel pit, a three-foot high earthen barricade will be constructed across the access road to prevent vehicle traffic from going into the gravel pit. From the turnout on BIA N5049, the haul road to the gravel pit will be plowed, disked and seeded with the prescribed seed mixture. All trails outside the perimeter of the gravel pit and the haul road will be left untouched. The Reclamation Plan (see attachment) by Navajo Department of Agriculture will be closely followed during the reclamation operation.

#### 3.4.4 Monitoring of the Seeded Area

Depending on the past month precipitation and the closure of the gravel pit, the seeding dates will be closely the recommended dates in the tribal reclamation plan. To ensure the success of the seeding operation the recommended seeding dates will be closely observed. The perimeter fence will be left in place to safeguard the seeded area and the reclaimed area will be monitored from seed germination to establishment of the plant maturity. A consultant may have to be hired to measure the success of the seeding and reclamation operation. The Navajo Nation will have final approval of the success of the re-vegetation.

#### 3.5 Protection of Re-vegetated Area

Presently, the proposed gravel pit has thin vegetation and livestock do not forage in the open area. The treated area within the gravel pit will be well protected by closing off the entrance into the proposed pit with the dirt barricade. To further protect the treated area the barbed wire fence will remain in place to keep the animals out of the area for at least six months.







Figure 1: General Location of Project









Figure 4: Survey Plat of Carrizo Quarry Pit





#### 1.0 Description of the Proposed Action

1.1 Project Description

The Teec Nos Pos Chapter and Apache County District 1 propose to re-open the 36.29 acres of Carrizo Sand & Gravel Quarry 5.5 miles west of Teec Nos Pos. Arizona. Under this proposal, Apache Conty will start mining the sand & gravel quarry utilizing the existing access road to the pit. The total acreage area of the sand & gravel quarry and the access road is 83.62 acres. The material is needed to paved and graveled existing roads within the chapter and surrounding areas to improve community roads and bus routes.

1.2 Purpose of and Need for Action

The Teec Nos Pos Chapter and Apache County District 1 would like to re-open the 36.29 acres of the Carrizo Sand & Gravel quarry for gravel material. The chapter and contractors will mine the entire acreage to remove and crush rocks for gravel. The sand and gravel will be used to upgrade and maintenance the community roads in Teec Nos Pos and surrounding arcas.

1.3 Location

The Teec Nos Pos Chapter House is generally located in Apache County, Arizona approximately 70 miles west of Shiprock, New Mexico. The legal location of the project of the project is in the Cow Butte, Arizona USGS 7.5 quadrangle map.

#### 2.0 Alternatives, Including the Preferred Action

2.1 Alternative  $\Lambda$  – No Action

Under this alternative, No Action will be taken. The existing sand and gravel pit will remain in size with minimal material. Due to lack of material, roads will continue to receive minimal road maintenance in the form of graveling the roads to eliminate as much of the rough areas as possible.

2.2 Alternative B – Extension of Existing Sand and Gravel Pit

The preferred alternative is to re-open the 36.29 acres of Carrizo Sand & Gravel Quarry, 5.5 miles west of Teec Nos Pos, Arizona. The acreage in the abandoned gravel pit will remain the same. The mining of the gravel pit will help with more material to be used to improve the roads within Teec Nos Pos community and surrounding areas.

#### 3.0 Description of the Affected Environment

The Final Assessment for the Carrizo Sand and Gravel Quarry, Teec Bos Pos, Arizona summarizes the affected environment which this addendum addresses. Please refer to the Final Environmental Assessment attached as Appendix A.

#### 4.0 Environmental Consequences of the Proposed Action

This section of the EA will be addressed by alternatives. Only the consequences of the propose improvement of the Sand and Gravel pit will be covered under Alternative A, B, and C.

#### 4.1 Alternative A – No Action

Other than limited disturbance of soil and temporary increase in noise during minimal maintenance grading activities, there will be no environment the environment under this alternative. The disturbance of the soil will temporarily affect the quality of the air.

#### 4.2 Alternative B – Extension of Existing Gravel Pit

There will be more disturbance of the environment under this alternative. The quality of the air will be temporarily impacted during the mining of the gravel pit and transporting and crushing of the rock material. Noise will be temporarily increased during the construction, but this should ease upon completion of the project. The is a possibility of hazardous waste or substance contamination to the environment from leaking equipment, storage, containers for fuel, lubricants and hydraulic fluids, and from storage facilities. The public traveling by the construction area need to be aware of, the danger of heavy equipments, being used for construction. The public needs to obey all signs posted along the road and near the pit.

4.3 Alternative C – Preferred Action

Under this alternative, there will be extensive removal of topsoil from the addition of the gravel pit. The removing of the soil and mining the area will affect the quality of the air. However this will cease when the project is completed. There will be a temporarily increase in noise from the heavy equipment mining the area. Again, this will ease down when the construction is completed. There is a possibility of hazardous waste contamination to the environment from leaking equipment, storage containers for fuel, lubricants and hydraulic fluids, and from storage facilities. The public traveling by the construction area needs to be aware of the danger of heavy equipment being used for construction.

#### 5.0 Mitigation Measures of Impacts to the proposed Action

This section will only address mitigations measures for alternative C - the preferred action.

5.1 Biological Impacts

Ì

The Final Environmental Assessment was completed in October 2000. The Navajo Nation Fish and Wildlife had listed Golden Eagle, Ferruginous Hawk, Mountain Plover, Southwestern Willow Flycatcher, Peregrine Falcon, Black-footed Ferret, Northern Leopard Frog, and Western seep fritillary as species of concern in the project area. A field survey was re-conducted and no specie was identified in the area.

Due to the high human activity within the Chapter tract, reclaiming disturbed areas by reseeding is not recommended. The high human traffic will probably not permit reclamation success.

Since this project is located in the Teec Nos Pos Chapter tract on a relatively a slope terrain area, the proposed activity will or may affect any "waters of the United States". Any pre-cautions will be taken to avoid any contamination by the runoff.

5.2 Physical Impacts

Proposed activities include the removal of several fect topsoil and removal of trees.

5.3 Hazardous Materials

To prevent the possibility of leakage of oils and other toxic and hazardous substances into the environment, all oils, fuels, lubricants, hydraulic fluids, etc., shall be kept in sealed storage containers or facilities that meet EPA regulations for preventing contamination of the environment. All construction equipment, containers, and facilities shall be inspected daily for leaks and spill. The contractor shall remove all leaking containers and equipments from the project site until the leak has been repaired and all spill cleaned up. All hazardous waste shall be disposed of by the contractor in accordance to EPA regulations and guidelines.

5.4 Waste Minimization and Pollution Prevention

To minimize wastage of resources, and to prevent pollution of the environment, the sponsor of this project shall specifically inform all contractors that waste shall be kept to a minimum. Any waste accumulated as a result of construction shall first be considered for recycle prior to proper disposal or destruction.

5.5 Cumulative Impacts

Mining more material from the pit will make more materials available for graveling most roads in the community of Teee Nos Pos and surrounding communities. As a result, a lot of soil had been disturbed and moved around in preparation of mining the pit.

#### 6.0 Conclusion regarding significance

Other than the noise and temporary inconvenience to the public, the quality of the air and possible soil contamination will be the only resources affected by this project. Regarding air resources, attentively watering the disturbed soil during construction will

mitigate this impact. Regarding the possibility of contamination to the environment from equipment leaking oil, hydraulic fluid, fuel, etc., and possible spills, daily inspections of equipment and facilities, and addressing problems as soon as they're encountered will lessen this possible impact.







### FINDING OF NO SIGNIFICANT IMPACT RE-OPENING OF CARRIZO QUARRY PIT AND ACCESS ROAD IMPROVEMENTS ENVIRONMENTAL ASSESSMENT DOCUMENT EA-00-127

## LOCATION: T41N, R29E, Sections 35 & 26, Unplatted Near Teec Nos Pos, Apache County, Arizona

The proposed action is the re-opening of the Carrizo Quarry pit and improvement of the access road near Teec Nos Pos, Apache County, Arizona, which will encompass 39.56 acres. The project is sponsored by Apache County, District 1, P.O. Box 111, Teec Nos Pos, Arizona, 86514.

The project environmental assessment (EA) was reviewed in the Navajo Regional Office, Branch of Environmental Services. Based on the information contained in the environmental assessment, and the mitigation measures specified in the document, it is determined that the project will not have a significant impact on the natural and human environment. Therefore, in accordance with the National Environmental Policy Act, Section 102 (2) (C), an environmental impact statement will not be required.

The following references, incorporated in the project environmental assessment document, serve as the basis for this decision:

1. Agency and public involvement was solicited, and environmental issues relative to the development of the quarry pit reopening and access road improvement project were identified. Alternative courses of action and mitigation measures were developed in response to environmental concerns and issues.

2. The EA disclosed the environmental consequences of the proposed action and two potentially viable alternatives including the "no action" alternative.

3. Once the project site has served its purpose, the area shall be reclaimed using native vegetation (EA, Part V.A, Land Resources).

4. Potential impacts to flood plains and wetlands by the proposed project have been evaluated in accordance with Executive Orders 11988 and 11990. The project area was surveyed on May 25, 2000. There are no riparian or aquatic habitats (EA, Part III.D.2.c). The described action will have no effect on flood plains, or other sensitive areas .

5. CWA 401 - In compliance with the Clean Water Act, as amended, the United States Environmental Protection Agency's "Final Action on the Nationwide Permit(NWP) Clean Water Act Section 401 Certification in Indian Country" was consulted. This project will be authorized under Nationwide Permit No. 14, which is one of the Conditional Water Quality Certifications issued by the U.S.E.P.A. on November 21, 1997. Application for water quality certification was submitted to the U.S.E.P.A, Region 9 (EA, Part V.B., Water Resources).

6. CWA 402(p) - In compliance with the Clean Water Act, as amended, Section 402(p), Storm Water Pollution Protection, a notice of intent for storm water discharges associated with construction activities shall be filed with the U.S. Environmental Protection Agency by the operator of the quarry pit (EA, Part V.B., Water Resources).

7. CWA 404 - In compliance with the Clean Water Act, as amended, application for Section 404 Determination was submitted to the U. S. Army Corps of Engineers. This project can be constructed under authority of Nationwide Permit No. 14, Road Crossings (EA, Part V.B., Water Resources).

8. In compliance with the National Historic Preservation Act of 1966, as amended, Section 106 Consultation, and 36 CFR 800.9 (b), a cultural resources assessment, including traditional cultural properties, was performed for the proposed project by the Navajo Nation Historic Preservation Department (NNHPD) which issued Cultural Resource Compliance Form (CRCF), NNHPD NO. HPD-99-927. The NNHPD determined that no historic properties will be affected by the proposed undertaking (see CRCF in Appendix C).

) In the event of a discovery [discovery means any previously unidentified or incorrectly identified cultural resources including, but not limited to, archaeological deposits, human remains, or locations reportedly associated with Native American religious/traditional beliefs or practices] all operations in the immediate vicinity of the discovery must cease, and the Navajo Nation Historic Preservation Department must be notified.

9. In compliance with the Endangered Species Act, informal consultation was held with the Navajo Nation Natural Heritage Program (NNNHP). In the consultation it was determined that the Navajo Fish and Wildlife Department (NFWD) "has no record of species of concern occurring on the project site". Two species of concern are known to occur within one mile of the project site. In addition, there are 8 species of concern with the potential to occur on the 7.5 minute quadrangle containing the project boundaries (Appendix A). A biological survey was conducted on May 25, 2000, to ascertain the existence of habitat for the T&E species of concern listed by the NFWD. A "No Effect " determination was recommended (Appendix B).

10. In accordance with the Resource Conservation and Recovery Act, Subtitle C, hazardous materials/waste shall be mitigated as described in the EA, Part V.E.

11. In accordance with the Resource Conservation and Recovery Act, Subtitle D, non-hazardous solid waste shall be mitigated as

described in the EA, Part V.D.

12. Cumulative effects are considered negligible.

13. In accordance with the President's Executive Order 12898 on Environmental Justice, impacts to minority and low-income populations and communities have been considered by the Regional NEPA Coordinator, as have impacts to Indian Trust Resources.

14. The re-opening of the quarry pit would allow gravel production locally for road improvements in the area, a plan which is supported by local residents and the school district.

#### l. Description of the Proposed Action

#### A. Project Description

Apache County proposes to reopen an existing gravel pit located approximately 5.5 miles west of Teec Nos Pos, AZ (Figure 1). Proposed action will entail the mechanical removal of existing natural gravel deposits. This deposit will be excavated, crushed, and the gravel stored on-site within the 36.29 acres pit area (Figure 2). This project will also include improvements to the one-half (½) mile access road. A culvert will be placed in one drainage along this access s road to insure the unrestricted flow of rain water run-off down established watersheds. A total of 83.62 acres was surveyed. The surveyed area includes the access road and areas approximately 300 feet beyond the gravel pit boundary.

#### B. Purpose and Need for Action

The purpose for reopening the gravel pit is to provide materials for improvement to county roads in the northern portion of Apache County. Residents and the local school district dislike the current condition of various county roads and bus routes. Material from this pit will be used to improve the roads and address these problems.

#### C. Lo cation

The Carrizo Quarry pit is located 5.5 miles west of the community of Teec Nos Pos, Apache County, AZ along and south of Arizona State Highway 160. The proposed project is located in Township 41N, Range 29E, Sections 35 and <u>36</u>; Gila and Salt River Meridian. Figure 3 shows the specific location of the Carrizo Quarry pit.

The Universal Traverse Mercator (UTM) Coordinate center for the Carrizo Quarry pit is N4087670m and E660590m. The UTM coordinates for the access road are: Point A(BOP)= N4087950m E661510m and Point B(EOP)=N4087950m E660960m.

#### II. Alternatives

#### A. Alternative A - No Action

Alternative A is the No Action alternative. Under this alternative the Carrizo Quarry Pit will not be reopend and materials would not be extracted from the existing pit. Apache County would continue to haul materials from other sources to improve roads over which they have stewards hip. This is not a preferable alternative due to the cost of transporting materials; a cost which could instead be used to repair and improve roads.

#### B. Alternative B - Preferred Alternative

Alternative B is the proposed reopening of the existing pit for the extraction of materials to be utilized toward improving various county roads and bus routes in this part of Apache County. This is the preferred alternative in that Carrizo Quarry Pit has already received extensive disturbance from previous pit operations. Use gravel from this quarry pit area would also be less expensive than hauling gravel from other sources.

#### C. Alternative C - Alternative Site

Alternative C would consist of selecting an undisturbed area in the same general vicinity for the purpose of mining previously undisturbed deposits. This alternative quickly becomes unfeasible in that it is illogical to damage an undisturbed area when a suitable, disturbed source already exists with adequate deposits for repairs and improvements of local roads.

#### III. Description of the Affected Environment

#### A. Land Resources

#### 1. Topography

The project area is located on the edge of a northeast/southwest trending bench. The proposed quarry pit is located along the edge of the bench where the terrain slopes down 36 degrees for approximately 75 feet. Drainage patterns trend in a south to north direction between the Carrizo Mountains and the San Juan River. Elevation ranges from 5,499 to 5,560 feet above mean sea level.

#### 2. Soils

The soil types consist of Quaternary alluvial deposits of thick, wide spread sand and gravel on gentle slopes and horizontal surfaces overlain by aeolian deposition and residuum from the underlying sandstone with wind blown deposits and colluvial formation from the shaly geology and eroding rock outcrops (*Cooley, et al 1969*).

#### 3. Geologic Setting & Mineral Resource

The primary geologic feature of the area is the Carrizo Mountains, a volcanic dome located approximately 3.0 miles to the south and east. The project area is located on the Four Corners Platform, a structural subdivision of the Colorado Plateau. Here, Jurassic and Cretaceous bedrock whose strata of the Morrison, Dakota, and Mancos Formations dip gently to the northeast(*Cooley, et al 1969*).

#### B. Water Resources

#### 1. Surface Water

The project area is located in the southern province of the Blanding Basin on the Colorado Plateau. Two major ephemeral drainages, Toh Dahstini Wash and Dry Farms Wash, drain into the San Juan River with a general south to north orientation(*Cooley*, et al 1969).

#### 2. Ground Water

Ground water is available from the Dakota Sandstone. There are no springs on or immediately adjacent to the proposed site. The nearest location is a natural flowing spring in Toh Dahstini Wash, situated approximately one-half (½) mile east of the eastern extension of the gravel pit access road.

#### C. Air Resources

#### 1. Quality & Visibility

Current effects on air quality and visibility in the general vicinity of the proposed project are; vehicle use of dirt roads, smoke from coal and wood burning stoves, blowing soil from the overgrazed range, and combustible fuel pollutants from vehicles using Highway 160.

#### 2. Climate

Teec Nos Pos climate is arid to semiarid. July through September are the rainiest months. Most of the summer precipitation results from brief and sometimes heavy thunderstorms. January is the coldest month: while July is the warmest. Average annual precipitation is 8.4 inches. Average maximum and minimum temperatures (annual) are 68.0°F and 42.0°F, respectively. Please refer to the climate summary attached as Appendix A for additional information. (*Western Regional Climate Center, wrcc@dri.edu*)

#### D. Biotic Resources

#### 1. Description of Ecosystem & Biological Communities

The Carrizo Quarry pit is located in an area which can be described as a semidesert grassland consisting of mixed grass-shrub vegetation community. This area consists of rolling hills covered with grass and shrubs. Dominant grass species in this area are blue grama grass (*Bouteloua gracillis*), downy brome (Bromus tectorum), galleta (*Hilaria jamesii*), and three-awn (*Aristida purpurea*). Dominant shrubs include gray rabbitbrush (*Chrysothamus nauseosus*), Broom snakeweed (*Gutierrizia sarothrae*), and Mormon tea (*Ephedra trifurca*)

#### 2. Wildlife

#### a. Terrestrial

Rodents are the dominant mammals in the semidesert grassland community where they feed on grasses, shrubs, insects and other invertebrates. There is no cover for large mammals, such as, mule deer, elk, or black bear. However, these mammals probably use drainages through this area to travel between the Carrizo Mountains and San Juan River basin where there are more suitable habitats.

Birds by far are more numerous through out this grassland community than any other vertebrates. There are no trees or shrubs for cover or nesting around the quarry pit. However, the drainages to the east and west of the project area, the foot hills of the Carrizo Mountains, and the San Juan River basin all provide cover and nesting sites. Even though the area around the quarry pit does not provide cover, the birds are greatly influenced by the production of nutrients the grassland habitat provides.

L izards and snakes are the dominant reptiles through out this area. There are no wetlands or water near the quarry pit to provide suitable habitat for amphibians.

Wildlife noticed around the quarry pit during field surveys include a Burrowing Owl (Athene cunicularia), Horned Larks (Eremophila alpestris), Turkey Vulture (Cathartes aura), Red-tailed Hawk (Buteo jamaicensis), Common Raven (Corvus corax), and Leopard lizard (Gambelia wislizenii).

#### b. Riparian/Aquatic

There are no riparian or aquatic habitats for species dependent on such habitat.

#### c. Threatened & Endangered Species

Source of information on "species of concern" to the Navajo Nation were obtained from a list provided by the Natural Heritage Program, Navajo Fish & Wildlife Department. The Navajo Fish & Wildlife Department "has no record of species of concern occurring on the project site". Species known to occur within one mile of the project site is the Loggerhead Shrike (*Lanius ludovicianus*). Additional species of concern with the potential to occur on the 7.5 minute USGS quadrangle map on which the project is located include: Golden Eagle (*Aquila chrysaetos*), Ferruginous hawk (*Buteo regalis*), Mountain Plover (*Charadrius montanus*), Southwestern Willow Flycatcher (*Empidonax traillii extimus*), Peregrine Falcon (*Falco peregrinus*), Black-footed ferret (*Mustela nigripes*), Northern leopard frog (*Rana pipiens*), and Western seep fritillary (*Speyeria nokomis nokomis*). Please refer to the biological evaluation attached as Appendix B.

#### 3. Vegetation

)

#### a. Terrestrial

The Carrizo Quarry Pit is located within semidesert grassland habitat consisting of mixed grass-shrub vegetation. This area consists of rolling grass and shrub covered hills incised by ephemeral drainages. Dominant grass species in this area are blue grama grass (*Bouteloua gracillis*), downy brome (Bromus tectorum), galleta (*Hilaria jamesii*), and three-awn (*Aristida purpurea*). Dominant shrubs include gray rabbitbrush (*Chrysothamus nauseosus*), Broom snakeweed (*Gutierrizia sarothrae*), and Mormon tea (*Ephedra trifurca*)

#### b. Riparian/Aquatic

There are no riparian or aquatic habitats for species dependent on such habitat.

#### c. Threatened & Endangered Species

The only specie of concern to the Navajo Nation known to occur within three miles of the Carrizo Quarry Pit is the Parish's alkali grass (Puccinellia parishii). Please refer to the biological evaluation attached as Appendix B.

#### E. Cultural Resources

#### 1. Traditional Cultural Properties, Historic, Religious Properties

Archaeologist from the Navajo Department of Transportation conducted a field survey of the C arrizo Quarry Pit and surrounding area on October 13, 1999. Approximately 83.62 acres were surveyed by walking the entire area. A copy of the Archaeological Inventory

Report Documentation Page is attached under Appendix C.

#### 2. Archaeological Resources

No historic/prehistoric cultural remains in the project area were noted by the Archaeology Section of NDOT.

#### F. Socioeconomic Conditions

#### 1. Environmental Justice

Since the gravel from the quarry pit will be used to improve roads through out this portion of Apache County, this proposed project will greatly enhance the well being of Native Americans living through the area.

#### 2. Employment & Income

A major employer is the Teec Nos Pos Boarding School with 30 personnel working during the academic year. The Navajo Nation, Arizona Department of Transportation, Arizona Department of Economic Security, Frank's Groceries, Teec Nos Pos Trading Post, and Apache County employ 27, 11, 9, 8, 8 and 6, respectively (*Chapter Images, 1996*).

#### 3. Demographics & Trends

The 1980 Census shows 1,250 people living in the Teec Nos Pos Chapter. 1990 Census counted 1,171 people. The latest published Census (1997) listed 1,259 people. Potential employment is very low throughout this area. Those who are able to work usually move to suburbs or cities for employment purposes. However, Teec Nos Pos will always be "home" to them and they will return regularly.

#### 4. Lifestyles, Cultural Values, Attitudes, Expectations

An agrarian lifestyle based on sheep and cattle ranching predominates in and around the general vicinity of the project. No traditional cultural properties exist in close proximity to the quarry pit. Thus, the general populace in this area support the use of materials from the pit for road upgrades.

#### 5. Indian Trust Resources

Indian trust resources in the area of Carrizo Quarry Pit consist of gravel and rangeland used for grazing sheep, cattle, and horses.

#### 6. Community Infrastructure

Teec Nos Pos Chapter is the community center. The Teec Nos Pos Boarding School, Arizo na Department of Transportation Department of Highway Maintenance, Arizona Department of Economic Security, Frank's Groceries, Teec Nos Pos Trading Post, Apache County School Office, Apache County Sheriff Office, Apache County/District 1 Substation and Teec Nos Pos Clinic are located in the Chapter. All of the facilities listed are located 5.5 miles east of the project area. Arizona State Highway 160 and a steel towered transmission line are located north of the project area.

#### G. Resource Use Patterns

#### 1. Hunting, Fishing, Gathering

The Carrizo Quarry Pit is located in the Navajo Department of Fish & Wildlife Management Unit 12. U.S. Highway 160 delineates the northern boundary of the management unit.

No big game, such as deer and elk, are hunted near the quarry pit. Small game, such as rabbits and prairie dogs, occur through out the grassland land. However, small game hunting is minimal. Upland game birds, such as quail and doves, also occur through out the area, however, upland game birds are also not extensively hunted. There are no permanent lakes, ponds, or streams near the quarry pit suitable for fishing or waterfowl hunting. Trapping of furbearers is permitted on the Navajo Nation, however, trapping does not occur near the quarry pit. Most trapping occur toward the San Juan River basin.

No gathering of herbs or medicinal plant occurs near the Carrizo Quarry Pit.

#### 2. Timber Harvesting

Neither pre-commercial or commercial size trees exist on or near the quarry pit.

#### 3. Agriculture

No cultivated fields or orchards were noted near the quarry pit during the survey.

#### 4. Mining

The only mining has been the extraction of raw gravel deposits from the existing pit.

#### 5. Outdoor Recreation

No outdoor recreation facilities exist in the immediate area.

#### 6. Transportation Use Networks

Arizona State Highway 160 is located approximately 0.6 of a mile north and east of the quarry pit and will be the primary route utilized for the hauling of the crushed gravel materials to the various road construction projects. No airports or rail lines are located near the project area.

#### 7. Land Use Plans

In that this pit was utilized prior for the same purpose proposed by Apache County/District 1 the land use plan remains as the original intent. Otherwise, there are no plans with goals and objectives for this area. The surrounding area will continue to be used for random homesite development and livestock grazing.

#### 8. Solid Waste Sites

No solid waste facilities exist in the general vicinity of the quarry pit. Solid waste materials are generally transported to dump facilities located in Cortez, Colorado.

#### 9. Hazardous Waste Sites

No hazardous waste facilities exist in the general vicinity of the quarry pit.

#### H. Other Values

#### 1. Wilderness

There are no designated wilderness areas on the Navajo Reservation.

#### 2. Sound & Noise

The only noise noticed during the field survey was produced by vehicle traffic along U.S. Highway 160, local graveled or dirt roads, and overhead aircrafts.

#### 3. Public Health & Safety

The nearest medical, emergency response, and police facilities are located approximately 5.5 miles east in the Teec Nos Pos, AZ community.

#### 4. Visual Setting

Natural monuments visible from the pit area are the Carrizo Mountains, San Juan River Valley, the Sleeping Ute Mountain, and the Abajo Mountains.

#### 5. Non-User Values

Presently, non-user values are not an issue in this area.

#### IV. Environmental Consequences of the Proposed Action

Only impacts as a result of the preferred alternative will be discussed under this section.

#### A. Land Resources

Since the quarry pit will be excavated, there will be impact to the soil and gravel source. The existing quarry pit is located on the edge of a northeast/southwest trending bench. Without adequate erosion control, there is a potential for accelerated erosion of this bench.

#### B. Wa ter Resources

Again, from the edge of the bench, the terrain slopes down 36 degrees for approximately 75 feet. Without best management practices for erosion and sedimentation control, rain water run-off has the potential of moving sedimentation, and possible pollutants from equipment, off the proposed project site and impacting drainages downstream.

#### C. Air Resource

There will be impacts to air resources as a result of reopening the Carrizo Quarry Pit. First of

all, as the soil is disturbed and moved around, and also from the crushing of rocks, dust particulates will be emitted into the atmosphere. Secondly, pollutants in the form of burned fossil fuel used by heavy equipment and crushing operation will also impact air resources.

#### D. Biological Resource

This action will impact small mammals, reptiles, and invertebrates currently occurring within the 36.29 acres proposed project site. However, this impact is unavoidable. No endangered, threatened, or species of concern to the Navajo Nation will be affected by this project within the immediate vicinity of the Carrizo Quarry Pit. No mitigation is required for biological resources occurring in the vicinity of the project area. Please refer to the biological evaluation attached as Appendix A.

#### E. Cultural Resource

On October 13, 1999, the NDOT Archaeology staff investigated the existing quarry pit and surrounding area. No cultural resources were identified during this inventory. A "Notice to Proceed" declaration has been issued by the Navajo Nation Historic Preservation Department. No m itigation is required for non-existing cultural resources. The Cultural Resources Compliance Form, HPD-99-927, is attached under Appendix C.

#### F. Socioeconomic Resource

Impacts on socioeconomic resources are primarily related to changes in land use, population, employment and community response to activities. The only foreseeable change as a result of this proposed action is increased improvements to roads in the northern section of Apache County. Population, employment, and land use will not affected by the operation. No mitigation is required.

#### G. Land Use

The Carrizo Quarry Pit was utilized for the same purpose in the pass by Apache County. Therefore, the land use of the surrounding area will remain as it currently exists. No mitigation is required.

#### H. Solid Waste:

Solid waste produced and indiscriminately disposed by those operating the quarry pit, crushing operation, and hauling operation can impact the project area. The wind can also transport indiscriminately disposed solid waste off the project site into the surrounding environment.

#### I. Hazardous Waste:

Construction equipment use of oils, fuels, lubricants, and hydraulic fluids for operation is essential. However, spillage of these potentially hazardous/toxic material may impact not only the project site, but also the surrounding environment.

#### J. Noise

Noise produced by heavy equipment excavating the site and rock crushing equipment will

#### increase noise through out this area.

#### V. Mitigation Measures of Impacts to the Proposed Action

#### A. Land Resources

The top soil within the area to be mined has already been removed by past mining activities. Since the existing vegetation will eventually have to be removed, the soil within the project area will be highly susceptible to wind and water erosion. Potential erosion can be mitigated by retaining as much of the existing vegetation as possible. Where it is necessary to remove vegetation, plants should be left as long as possible before clearing them out of the way. The area being disturbed should also be diligently watered to control blowing soil. Previous operators of the pit failed to reclaim the area before abandoning the site. As soon as an area of this project site has served its purpose, the area shall be reclaimed immediately using native vegetation.

Should the soil be contaminated by hazardous or toxic materials as a result of leaking equipment or spills, the soil shall be removed and disposed of in accordance to Navajo EPA guide lines.


#### B. Water Resources

In ord er to mitigate the possibility of rain water run-off transporting sediments and other possible contaminants off the northwestern edge of the site, the operator of the aggregate pit shall maintain a 30 foot buffer zone between the edge of the bench and the active part of the aggregate pit (Figure 4). No equipment, gravel, or by-products of the crushing operation shall be placed or stored within the buffer zone. Signs delineating the buffer zone shall be posted at 50 foot intervals 30 feet from the edge of the bench.

The drainage over which the access road to the Carrizo Quarry Pit is classified as "waters of the United States", and therefore require a Clean Water Act Section 401 certification from the U. S. E PA prior to a determination of Section 404 of the Clean Water Act by the U. S. Army Corps of Engineers. Applications have been submitted to the U. S. EPA, Region 9, and U. S. Army Corps of Engineers for a water quality certification and Nationwide Permit #14 determination, respectively. Section 402 of the Clean Water Act specifies that storm water discharge from a construction site of five or more acres to "waters of the United States" must be authorized by a National Pollutant Discharge Elimination System permit. Therefore, the operator of the quarry pit shall comply, if applicable, with all conditions of the general NPDES permit and shall develop a Storm Water Pollution Prevention Plan prior to initiating excavation and operation of the quarry pit.

#### C. Air Resource

Impacts to the air resources will occur from the disturbance of soil, crushing operation, and burned fossil fuel emissions from heavy equipment and rock crushing equipment. Disturbance to the soil can be mitigated by diligently watering and keeping the soil moist.



The rock crushing equipment should be regularly inspected to insure all parts are maintained and operating appropriately. This equipment should also be operated by qualified individuals familiar with proper operating procedures. The quarry pit operation will not be continuously operated. After a required amount of gravel has been produced, the operation will shut down until more gravel is needed. Therefore, emissions of burning fossil fuel into the atmosphere will only be temporary.

The pit and staging area will be kept clean and free of litter always, to prevent debris and litter from entering bodies of water. All trash will be disposed of according to EPA regulations and the equipment storage areas will be restored to their natural condition at project completion according to Navajo Nation permit requirement.

#### D. Solid Waste

The potential impact of solid waste can be mitigated by developing sound solid waste disposal policies and strict adherence to these policies. All solid waste shall be disposed of in accordance to EPA regulations, and all areas of the project site shall be maintained to natural conditions (litter free) as much as possible.

#### E. Hazardous Waste

To prevent the possibility of leakage of oils and other toxic and hazardous substances into the environment, all oils, fuels, lubricants, hydraulic fluids, etc., shall be kept in sealed storage containers or facilities that meet EPA regulations for preventing contamination of the environment. All construction equipment, containers, and facilities shall be inspected daily for leaks and spills. The operator of the quarry pit shall immediately address, contain, and repar all leaks and clean up all spills. All hazardous/toxic waste shall be disposed of in accordance to EPA regulations and guidelines.

#### F. Noise

)

The C arrizo Quarry Pitt is located approximately two miles from the nearest human inhabitants. Thus, the effects of noise pollution from this operation will be negligible. No mitigation is necessary for this impact.

#### Description of Action:

Apache County is interested in reopening an aggregate pit (sometimes referred to as the "Carrizo Pit") located approximately 5.5 miles west of Teec Nos Pos, AZ. Please refer to Figure 1 for the general location of this proposed project. The County would like to reopen this pit for the purpose of improving roads under their stewardship in the northern region of Apache County. Aggregate will be excavated, crushed, and stored on site within the 36.3 acre surveyed project plat. Please refer to Figure 2.

Improvements to a one-half (<sup>1</sup>/<sub>2</sub>) mile access road will also be part of this proposed action. The access road will be graded, widen, and graveled. One culvert will be installed along this road to insure unrestricted drainage of rain water run-off.

#### Description of the Environment:

This project is located north of Carrizo Mountain. This area consists of rolling hills covered with grass and shrubs. Dominant grass species in this area are blue grama grass (*Bouteloua gracillis*), downy brome (Bromus tectorum), galleta (*Hilaria jamesii*), and three-awn (*Aristida purpurea*). Dominant shrubs include gray rabbitbrush (*Chrysothamus nauseosus*), Broom snakeweed (*Gutierrizia sarothrae*), and Mormon tea (*Ephedra trifurca*) The aggregate pit is located on the edge of a northeast/southwest trending bench. The existing pit is highly disturbed from past usage. The site was never reclaimed prior to abandonment. Three excavated areas and four piles of sand grain size soil, a by-product of passed crushing operations, are located within the proposed pit area.

#### Species Biology and Status:

Source of information on "species of concern" were obtained from a list provided by the Natural Heritage Program, Navajo Fish & Wildlife Department (Attachment A). The Navajo Fish & Wildlife Department "has no record of species of concern occurring on the project site". Species known to occur within one mile of the project site is the Loggerhead Shrike (*Lanius ludovicianus*). Species known to occur within three miles of the project site is the Parish's alkali grass (*Puccinellia parishii*). Additional species of concern with the potential to occur on the 7.5 minute USGS quadrangle map on which the project is located include: Golden Eagle (*Aquila chrysaetos*), Ferruginous hawk (*Buteo regalis*), Mountain Plover (*Charadrius montanus*), Southwestern Willow Flycatcher (*Empidonax traillii extimus*), Peregrine Falcon (*Falco peregrinus*), Black-footed ferret (*Mustela nigripes*), Northern leopard frog (*Rana pipiens*), and Western seep fritillary (*Speyeria nokomis nokomis*).

Loggerhead Shrike; MBTA. Diving from a low look-out perch, then rising swiftly to the next perch, this bird hunts in open or brushy areas for insects, rodents, snakes, and small birds.

Parish's alkali grass; NESL group 2. This is a water dependent grass, preferring to grow near alkali seeps or springs, or on salt crusted soil along perennial streams. This plant's life cycle is limited to the month of May.

Golden Eagle; NESL group 3; MBTA; EPA. This raptor prefers high cliffs, such as buttes, mesas, and volcanic plugs surrounded by open grassland with minimal human disturbances.

Ferruginous Hawk; NESL group 3; MBTA. This bird prefers open plains, prairies, or badlands

where they feed on small mammals. This hawk has a preference for nesting on buttes and mesas where they have a view of the surrounding grassland.

Mountain Plover; NESL group 4; ESA candidate; MBTA. Prefers habitat on dry, semidesert prairies and grassland with scattered shrubs. Frequently associated with prairie dog towns, nesting in shallow depression on barren flat ground.

Southwestern Willow Flycatcher; NESL group 2; ESA endangered. Flycatcher territories and nests are typically near open water, cienegas, marshy seeps, or saturated soil having dense patches of vegetation interspersed with small openings and sparser vegetation that is not uniformly dense.

Peregrine Falcon; NESL group 3; ESA endangered; MBTA. Probably the most common characteristic of this bird's habitat is the presence of tall cliffs (typically over 50 meters). Cliffs serve as perching and nesting sites, and an unobstructed view of the surrounding area. Peregrines feed primarily on small to medium sized birds, such as songbirds, shore birds, and ducks.

Black-footed ferret; NESL group2; ESA endangered. These mammals are usually found in the vicinity of prairie dog towns where they use burrows for shelter and prairie dog for food. Ferrets are nocturnal and usually conduct most of their activities in the evenings and early morning hours.

Northern leopard frog; NESL group 3. This frog is associated with streams, rivers, ponds, lakes, marshes, and irrigation canals. Diet consists of a wide variety of invertebrate prey, such as, insects and spiders.

Western seep fritillary; NESL group 3. Prefers marshlands, boggy streams, wet meadows. The larvae of this butterfly can only feed and survive on violets, and the only violet occurring on the Navajo Nation is the Kidney-leaved violet (*Viola nephrophylla*).

#### Survey Method:

- Reviewed data provided by the Natural Heritage Program and other file reports and information
  pertinent to the species listed above.
- Determined the exact location of the project and completed an on-site field survey.
- Field survey consisted of driving on established roads within and around the existing aggregate pit and walking within the surveyed, staked boundary. Topography, vegetation, potential habitat, and other possible biological concerns were noted.
- A ½ mile radius around the project area was also generally surveyed for possible impacts to sensitive species.
- Reviewed information on "species of concern" again to be certain all possible concerns were adequately addressed.

#### Survey Result:

Prior to conducting a field survey, it was determined that no suitable habitat on or within the immediate (1/4 mile) area of the proposed aggregate pit existed for the following species:

Parish's alkali grass (Puccinellia parishii)

Golden Eagle (Aquila chrysaetos)

The abandoned aggregate pit and surrounding area was surveyed on May 25, 2000 to determine potential habitat for the Black-footed ferret, Loggerhead Shrike, and Mountain Plover.




FIGURE 3. Map Indicating the Presence of Active/Inactive Prairie Dog Burrows.

Determining potential habitat for the Black-footed ferret consisted of driving along existing roads within the aggregate pit and surrounding area and visually surveying the area. However, due to the height of the vegetation, I was unable to see burrows from the existing roads. Therefore, it was necessary to walk the entire project area within the staked boundary. All burrows were counted during this survey. Burrows with clean openings were counted as active; and burrows with debris (sticks, tumbleweed, grass parts, etc.) or extensive spider web constructed across the burrow were counted as inactive. Mounds having no burrow, but slight depression indicating past active burrows were not counted. Within the staked boundary, no prairie dog burrows were found along the west and northwestern boundaries, or on the disturbed area of the aggregate pit. Please refer to Figure 3. However, 36 inactive and 17 active burrows were identified between the existing pit area and the southern and eastern edge of the staked boundary. This area consists of approximately 11 acres. That's approximately 1.5 active burrows per acre. Less than the density required to be considered a prairie dog town. During this extensive four hour survey, no prairie dogs were seen or heard around the area.

During habitat assessment for the Black-footed ferret, I was also looking out for the Loggerhead Shrike. I was looking for a grey bird with a long dark tail, dark wings with white patches, and a dark mask. I did not see any birds resembling this description. Approximately 90 percent of the shrub, other than grasses, consist of snakeweed having an average height of eight inches. There are rabbitbrush with a height of 18 inches in the area, however, this vegetation is limited to, and scattered throughout the disturbed area of the pit. More suitable habitat for this bird exists to the south near the foothills of the Carrizo Mountains, or north toward the banks of the San Juan River.

During the field survey, no suitable habitat for the Mountain Plover was found. Again, most of the vegetation in this area consist of eight inch tall snakeweed, ephedra, and various grasses. Even though various grasses grow through out the area, the thick, eight inches tall growth of snakeweed dominate the area. Wind blown soil also accumulate around the growth of ephedra making the terrain uneven.

#### Impact Analysis:

- Due to lack of habitat, this action will not impact the Mountain Plover (Charadrius montanus) and Loggerhead Shrike (Lanius ludovicianus).
- There are prairie dog mounds on portions of the proposed site, however, the density of active burrows is not sufficient enough to support Black-footed ferret. Therefore, this project will not impact the Black-footed ferret (*Mustela nigripes*).
- The existing pit is located along the edge of a northeast/southwest trending bench. From the edge of the pit, the terrain slopes down 36 degrees for approximately 75 feet. Rain water run-off carrying suspended sedimentation, and possible pollutants from equipment, off the proposed project area may impact drainages downstream.
- Vegetation will be impacted within the excavation, crushing, and storage areas. Elimination of
  vegetation will increase wind and water erosion.

#### Avoid ance and Mitigation:

• No avoidance, or mitigation is required for the Mountain Plover (*Charadrius montanus*), Loggerhead Shrike (*Lanius ludovicianus*), Black-footed ferret (*Mustela nigripes*), and habitat.

. . .

- In order to mitigate the possibility of rain water run-off draining off the northwestern edge of the site, the operator of the aggregate pit shall maintain a 30 feet buffer zone between the edge of the beach and the active part of the aggregate pit. No equipment, gravel, or by-product of the crushing operation shall be stored within this buffer zone. Signs delineating the buffer zone shall be posted at 50 feet intervals 30 feet from the edge of the bench.
- Previous operators of the pit failed to reclaim the area before abandoning the site. After the aggregate pit has served its purpose, the site shall be reclaimed using native plant species.

#### Alternatives:

An alternative is to not reopen the Carrizo aggregate pit. Apache County could continue to purchase their gravel and haul it long distances to their respective projects. Another alternative is to open an aggregate pit at a different location. However, a new pit would impact an environment which has not been previously impacted by such action.

#### Conclusion:

The proposal to reopen the aggregate pit near US Highway 160 will not effect any of the "species of concern" provided by the Natural Heritage Program, Navajo Department of Fish & Wildlife. Based on habitat and field survey, a determination of a "No effect" is recommended.





) ) FIGURE 2. Specific Location of Proposed Aggregate Pit.

The following information on species of concern<sup>1</sup> is provided in response to your 29 October 1999 request concerning the subject project, which consists of Apache County reopening a gravel pit approximately 5 1/2 miles west of Teec Nos Pos, Arizona. The reopening of the gravel pit would be used for maintaining and regrave 1 roads throughout that area.

At this time, the Navajo Fish and Wildlife Department (NFWD) has no record of species of concern occurring on the project site.

Species of concern known to occur within one mile of the project site include:

1. Lanjus Iudovicianus (Loggerhead Shrike); MBTA.

2. Puc cinellia parishii (Parish's alkali grass); NESL group 2.

Additional species of concern with potential to occur on the 7.5-minute quadrangle (Cow Butte, AZ-UT) containing the project boundaries include the following. Potential is based primarily on quadrangle-wide coarse h abitat characteristics and species range information. Your project biologist should determine habitat s uitability at the project site.

- 3. Aquila chrvsaetos (Golden Eagle); NESL group 3; MBTA: EPA.
- 4. Buteo regalis (Ferruginous Hawk); NESL group 3; MBTA.
- 5. Charadrius montanus (Mountain Plover); NESL group 4: ESA candidate; MBTA.
- 6. Emeridonax traillii extimus (Southwestern Willow Flycatcher); NESL group 2; ESA endangered; MBTA.
- 7. Falco peregrinus (Peregrine Falcon): NESL group 3; MBTA.
- 8. Mustela nigripes (black-footed ferret); NESL group 2; ESA endangered. Potential for the black-

The U.S. Fish & Wildlife Service's National Wetlands Inventory (NWI) maps should be examined to determine whether areas classified as wetlands are located close enough to the project site(s) to be impacted. In cases where the maps are inconclusive (e.g., due to their small scale), field surveys must be completed. For field surveys, wetlands identification and delineation methodology contained in the "Corps of Engineers Wetlands Delineation Manual" (Technical Report  $\Upsilon$ -87-1) should be used. When wetlands are present, potential impacts must be addressed in an environmental assessment and the Army Corps of Engineers, Phoenix office, must be contacted. NWI maps are available for examination at the NFWD's Natural Heritage Program (NHP) office, or may be purchased through the U.S. Geological Survey (order forms are available through the NHP). The NHP has complete coverage of the Navajo Nation, excluding Utah, at 1:100,000 scale; and coverage at 1:24,000 scale in the southwestern portion of the Navajo Nation.

The information in this report was identified by the NFWD's biologists and computerized database, and is based on current data. It should not be regarded as the final statement on the occurrence of any species, nor shoul d it substitute for on-site surveys. Also, because the NFWD's information is continually updated, any given information response is only wholly appropriate for its respective request.



The Navajo Nation Environmental Protection Agency (NNEPA) reviewed <sup>1</sup> and recommends conditional approval for the proposed action pursuant the Title 4, NNC Chapter 9 Navajo Nation Environmental Policy Act, Subchapter 1, §904. The Apache County District 1, PO Box 1952, Chinle, Arizona, 86503, is proposing to reopen a former gravel pit, Carrizo Sand & Gravel quarry and mine 36.29 acres and improve an existing access road. A total 83.62 acres surface land will be disturbed. The proposed action is located 5.5 miles west of Teec Nos Pos, Arizona. The mining activities will include mechanically removing natural gravel deposits. The deposits will be excavated, crushed and stored onsite. Existing access road will be improved and a culvert will be placed in the drainage along the access road. The gravel will be used for county road and school route

improvements. The proposed action is located north ½ Section 35 and the south ½ Section 26, T41N, R29E, G&SRM, Teec Nos Pos, Arizona. No buildings, structures or utility lines will be constructed. No blasting will occur. Heavy machinery will be stored off site in designated locations.

#### 1. Navajo Nation Clean Water Act:

- a. §401 Certification: The EA states "The drainage near the access road to the Carrizo Quarry Pit is classified as "waters of the US" therefore a CWA 401 certification from USEPA [NNEPA] prior to a determination of Sectin 404 of the CWA by the US Army Corps of Engineers. Applications have been submitted to the USEPA Region 9 and US Army Corps of Engineers for a water quality certification and Nationwide Permit #14." Copies of the application should be submitted to Ms. Lee Anna Silversmith, 401 Certification Water Quality Specilalist, 928/871-7700, before commencing any construction activities for the proposed sand and gravel mining activities. A 401 certification application is on the NNEPA website - <u>http://www.navajonationepa.org</u>. A copy of this letter will be provided for Ms. Silversmith.
- b. §402 Navajo Pollutant Discharge Elimination System (NPDES): The proposed action is greater than 1 acre therefore Apache County is subject to complete the requirements under the Clean Water Act Section 402. Stormwater Pollution Prevention Plan (SWPPP), Best Management Practices (BMPs) and Notice of Intent (NOI) will be completed and submitted to USEPA Region 9 and a copy will be provided to Patrick Antonio, Principal Hydrologist with NNEPA Water Quality Program. His office phone is 928/871-7185. The SWPPP template can be found online at the following weblink:
  - http://cfpub.epa.gov/npdes/stormwater/swppp.cfm#template.
- c. §404 Dredge & Fill: Apache County maybe subject to complete a 404 permit.

#### 2. Navajo Nation Air Pollution Prevention and Control Act:

- a. Apache County District 1 will consult with NNEPA and Region IX USEPA regarding a new source performance standards review of the proposed sand and gravel site and acquisitions of permits as appropriate.
- b. The proposed action will be located within an area designated as Class II which is unclassified for the National Ambient Air Quality Standards (NAAQS)~ attainment of the NAAQA;
- c. Visibility is good to excellent. Dust suppression must be implemented in the Best Management Practice.
- d. NNEPA recommends for Apache County District 1 to complete and submit the Navajo Nation Air Quality Control Program Activity Application to NNEPA Air Quality Operating Permit Program.

#### 3. Navajo Nation Safe Drinking Water Act:

- a. Ensure there are no existing drinking waterlines and/or domestic waste waterlines located within the premises of the proposed site to avoid significant impacts to the Teec Nos Pos and surrounding communities' safe drinking water resources before trenching and/or digging.
- b. The NNEPA Public Water Systems Supervision Program (PWSSP) recommends all proposed drinking water projects (extensions, upgrades, new wells, new public water systems, etc.) must also comply with the design review and construction permit of

c. The owner/operator and water utility company are subject to submit the proposed domestic waste water and public drinking water lines to Ms. Yolanda Barney, Program Manager, NNEPA PWSSP, she can be contacted at 928/871-7715 or visit the website at <u>www.navajopublicwater.org</u>.

#### 3. Navajo Nation's Solid Waste Act:

- a. If illegal waste dumps are encountered at the proposed sand & gravel site, Apache County District 1 will be responsible to clean the dumpsite and properly dispose to an approved landfill.
- b. If a sub-contractor will be hired to transport waste, ensure the contractors are certified and licensed with the Navajo Nation Business Regulatory Office.
- c. The contractor must submit a copy of the landfill receipt/ticket to NNEPA Resource Conservation Recovery Program using the above mailing address as a guarantee the construction waste has been properly disposed of.
- d. Do not allow public to take construction waste, cumulatively NNEPA receives complaints and reports on illegal trash dumpings on rural areas and in the waters of the US and Navajo Nation.
- e. The Apache County District 1 is subject to control the solid waste bin to reduce injuries or fatalities of mining related waste to human, wildlife and domestic animals.

# 4. Navajo Nation Comprehensive, Environmental Response, Compensation and Liability Act (CERLA):

a. Pursuant the Navajo Nation Comprehensive Environmental Response, Compensation and Liability Act approved by the Navajo Nation Council, CF-07-08, February 26, 2008, the NN CERCLA includes petroleum (including crude oil or any fraction thereof, natural gas, natural gas liquids, liquefied natural gas or synthetic gas usable for fuel (or mixtures of natural gas and synthetic gas)) unlike the US CERCLA or the Superfund Law and mandates petroleum, operator and guarantor to report petroleum release ≥ 25 gallons at the site and/or during transport immediately to the Navajo Nation Department of Emergency Management within the Navajo Nation Division of Public Safety.

5. Navajo Nation Storage Tank Act (NNSTA) (formerly Underground Storage Tank (UST) Act; amended February 2012):

- a. If during the sand & gravel mining operating activities, a need arises for an aboveground storage tanks (AST) greater than 100 gallons, it must meet the design and installation specifications as described in the NNSTA.





#### WHEREAS:

- An Intergovernmental Agreement (IGA) was established between Apache County, Navajo Nation and B.I.A. Regional Office for the purpose of performing routine road maintenance on officially approved IGA school bus routes within District One of Apache County; AND
- 3. Teec Nos Pos Chapter and Apache County District One have identified the abandoned Carrizo Sand & Gravel Pit, situated in Section 6 & of Township 38 North and Range 24 East, PM, as a site for the extraction and production of road plating material for clayey roadways, stabilization of soft spots within the roadway and installation of pipes and erosion control devices; AND
- 4. Because of some legal terms and conditions surrounding the acquisition of an approved sand & gravel lease by Apache County, Apache County gave all approved feasibility studies for Carrizo Sand and Gravel Pit to the Navajo Division of Transportation on December 20, 2007; AND
- 5. Navajo Division of Transportation was not able to obtain an approved sand and gravel lease for Carrizo Sand and Gravel Pit from the Navajo Nation; AND

#### WHEREAS:

- 1. The Teec Nos Pos is a Certified Chapter of the Navajo Nation established and recognized by the Navajo Nation Council as a foundation of the Navajo Nation government vested with the authority to plan and implement projects in the best interest of he community. See generally, 2 N.N.C. §4021 et seq. and 26 N.N.C. §102, and
  - Pursuant to 2 N.N.C. §102(A), the Navajo Nation Council is governing body of the Navajo Nation; and
  - By resolution CAP-34-98, the Navajo Nation Council approved the "Local Governance Act" wherein the Navajo Nation Council delegated governmental authority to the Chapters of the Navajo Nation to address matters of local concerns with Navajo law, custom and tradition; and
  - An Intergovernmental Agreement (IGA) was established between Apache County, Navajo Nation and B.I.A. Navajo Regional Office for the purpose of performing routine maintenance of official IGA school bus routes; and
  - 5. Apache County District One office has identified county routes that are serving as school bus routes that need routine maintenance and improvements in Teec Nos Pos chapter; and
  - 6. Teec Nos Pos Chapter and Apache County District One Office have identified the abandoned Carrizo Sand & Gravel Pit, situated in Section 6 of Township 38 North and Range 24 East, PM, as a site for extraction of material for plating of clayey roadways, stabilizing soft sorts within roadways and installing rip rap for erosion control; and
  - 7. There are not sand and gravel pit available to easy access for quality materials within Navajo Nation and for this reason, Teec Nos Pos Chapter fully supports this initiative; and
  - The extraction material from Carrizo Sand & Gravel Pit will be used to address school bus routes and will not be used for commercials purposes.

#### THEREFORE IT BE RESOLVED:

1. Teec Nos Pos Chapter hereby approves Apache County, District One Office to work with the Navajo Nation Minerals Department, Resources Committee and B.I.A. Realty Office to obtain an approved Sand and Gravel Lease for the extraction of road material from Carrizo Sand and Gravel Pit (36.92 Acres)

2. Teec Nos Pos Chapter further requests of the Navajo Nation Mineral Department, Resources Committee and B.I.A. Realty Office to approve 0.7 miles of access route as an easement for the Carrizo Sand & Gravel Pit.

Page Two Resolution/Carizzo Sand and Gravel Pit

3. Teec Nos Pos Chapter further requests that Navajo Nation agrees to and approves the royalty waiver for this endeavor since the materials will be used for school bus routes.

4. Teec Nos Pos Chapter supports the issuance of Survey Permits to Apache County District One for the performance of engineering survey and all other surveys, studies and clearance of the gravel pit.



#### **RESOLUTION OF TEEC NOS POS CHAPTER**

TEEC NOS POS CHAPTER HEREBY RECINDS RESOLUTION TNPCH-091-06R; AND AUTHORIZES THE NAVAJO DEPARTMENT OF TRANSPORTATION (NDOT) TO RE-ESTABLISH AND TO OBTAIN AN APPROVED CARRISO SAND AND GRAVEL PIT LEASE ON 36.92 ACRES AND 0.45 MILE ACCESS EASEMENT TO THE GRAVEL PIT.

#### WHEREAS:

1

- Teec Nos Pos Chapter is a duly certified chapter of the Navajo Nation pursuant to 11 N.N.C., Part 1, Section 10, and pursuant to 26 N.N.C., Section 1 (B)(1), the Navajo Nation Council delegated to chapters governmental authority with respect to local matters consistent with Navajo Nation laws, including customs and tradition; and
- An intergovernmental Agreement (IGA) was established between Apache County, Navajo Nation and B. I. A. Regional Office for the purpose of performing routine road maintenance on officially approved IGA school bus routes within District One of Apache County; and
- Teec Nos Pos Chapter and Apache County District One have identified the abandoned Carrizo Sand & Gravel Pit situated in Section 6 & of Township 38 and Range 24 East, PM, as a site for the extraction and production of plating material of clayey roadways, stabilization of soft spots within the roadway and installation of erosion control devices; and
- 4. Because of some legal terms and conditions surrounding the acquisition of an approved sand & gravel lease, Apache County has given all paperwork for Carrizo Quarry Pit to the Navajo Department of Transportation (NDOT); and
- 5. Navajo Department of Transportation will acquire the approved sand & gravel lease for Carrizo Quarry Pit with the understanding that Apache County District One will still implement its plan to set up a rock crusher to produce aggregate for plating and rip rap material for erosion control devices on approved IGA school bus routes; and
- 6. Navajo Department of Transportation is getting more and more involved with road maintenance and other activities related to development of transportation system and this is the first gravel pit project to be undertaken by the program and
- Apache County will be allowed to used the gravel pit according to the conditions established by the Navajo Department of Transportation and the extracted material by Apache County will not be used for commercial purposes; and
- 8. The re-opening of Carrizo Sand & Gravel Pit will be a landmark for Navajo Nation Department of Transportation as it ventures more into different areas of transportation development within the boundaries of the Navajo Nation.

#### NOW, THEREFORE BE IT RESOLVED THAT:

- Teec Nos Pos Chapter hereby rescinds resolution TNPCH-091-06R and approves the Navajo Nation Department of Transportation to establish a Sand & Gravel Pit. Located 5.5 miles west of Teec Nos Pos Chapter, and to obtain an approved Sand & Gravel Lease to re-establish Carrizo Sand & Gravel Pit which is abandoned covering 36.92 acres of land; for the purpose of extracting roads materials.
- 2. 'Teec Nos Pos Chapter further requests the Navajo Nation Material Department Resources Committee and B. I. A. Realty Office to approve the initiative to obtain and Improve 0.45 miles access easement with a sixty (60) feet corridor between BIA Route N5043 and the proposed Carrizo Sand & Gravel Pit.
- Teec Nos Pos Chapter recommends that the material obtained from the approved pit by Apache County District One will only be use for the purpose of road maintenance on approved IGA school bus routes and not to be used for commercial purposes.






Figure 4: Survey Plat of Carrizo Quarry Pit
