SECTION TWO. FINDINGS

A. Willard Tsingine was previously enrolled with the Hopi Tribe on November 8, 1988. See Exhibit A, p. 1.

- B. The Hopi Tribe has since confirmed that Willard Tsingine formally relinquished his Hopi tribal membership on November 27, 2000. See Exhibit A, p. 1. The reason given is that Willard Tsingine was going to enroll with the Navajo Nation. See Exhibit A, p. 2.
- C. Willard Tsingine is ½ Navajo blood, as confirmed by the Hopi Tribe. See Exhibit A, p. 3. He is therefore eligible to enroll as a member of the Navajo Nation. 1 N.N.C. §701(B).
- D. Willard Tsingine has sent a letter to the Navajo Nation requesting reenrollment with the Navajo Nation. See Exhibit B.


SECTION THREE. REENROLLMENT


To Whom It May Concern:
