PURPOSE: This resolution, if approved, will amend the language requirements of the Navajo Nation Election Code.

This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each committee member to review the proposed resolution in detail.

- D. 1 N.N.C. § 203(B), Diyin Bits'éádéé' Beehaz'áaníí declares and teaches that all leaders chosen by the Diné are to carry out their duties and responsibilities in a moral and legal manner in representing the people and the government; people's trust and confidence in the leaders and the continued status as a leader are dependent upon adherence to the values and principles of Diné bi beenahazáanii.
- E. 1 N.N.C. § 203(C), Diyin Bits'áádéé' Beehaz'áaníí declares and teaches that the leaders of the Executive Branch (Alaají Hózhóójí Naat'áah) shall represent the Navajo Nation to other peoples and nations and implement the policies and laws enacted by the legislative branch.
- F. 1 N.N.C. § 204(A), Diyin Dine'é Bits'áádéé Beehaz'áanii declares and teaches that it is the right and freedom of the people that there always be holistic education of the values and principles underlying the purpose of living in balance with all creation, walking in beauty and making a living.
- G. 1 N.N.C. § 204(C), Diyin Dine'é Bits'áádéé Beehaz'áanii declares and teaches that it is the right and freedom of the people that the sacred Diné language (nihiinéí) be taught and preserved.
- H. 1 N.N.C. § 204(F), Diyin Dine'é Bits'áádéé Beehaz'áanii declares and teaches that it is the right and freedom of the people that our children are provided with education to absorb wisdom, self-knowledge, and knowledge to empower them to make a living and participate in the growth of the Navajo Nation.
- I. 1 N.N.C. § 206(A), Diyin Nohookáá Diné Bi Beehaz'áanii declares and teaches that the knowledge, wisdom, and practices of the people must be developed and exercised in harmony with the values and principles of the Diné Bi Beenahaz'áanii; and in turn, the written laws of the Navajo Nation must be developed and interpreted in harmony with Diné Common Law.
- J. 1 N.N.C. § 206(B), Diyin Nohookáá Diné Bi Beehaz'áanii declares and teaches that the values and principles of Diné Common Law must be recognized, respected, honored and trusted as the motivational guidance for

- the people and their leaders in order to cope with the complexities of the changing world, the need to compete in business to make a living and the establishment and maintenance of decent standards of living.
- K. 1 N.N.C. § 206(C), Diyin Nohookáá Diné Bi Beehaz'áanii declares and teaches that the values and principles of Diné Common Law must be used to harness and utilize the unlimited interwoven Diné knowledge, with our absorbed knowledge from other peoples. This knowledge is our tool in exercising and exhibiting self-assurance and self-reliance and in enjoying the beauty of happiness and harmony.
- L. 2 N.N.C. § 1004(A) states, no person shall serve as President or as Vice-President of the Navajo Nation unless he/she is an enrolled member of the Navajo Nation, 30 years old or older.
- M. 2 N.N.C. § 1004(B) states, no person shall serve as President or Vice-President of the Navajo Nation unless he/she has continually, during the last three years before the time of election been physically present within the Navajo Nation. The "Navajo Nation" is defined at 7 N.N.C. § 254.
- N. 11 N.N.C. § 8 provides qualifications for President and Vice-President to include an age requirement at 11 N.N.C. § 8(A)(3), similar to 2 N.N.C. § 1004(A), a membership requirement at 11 N.N.C. § 8(A)(2), similar to 2 N.N.C. § 1004(A) and a residency requirement at 11 N.N.C. § 8(A)(1), similar to 2 N.N.C. § 1004(B); along with other requirements such as being a registered voter, be on the agency census roll of the Bureau of Indian Affairs, fluently speak and understand Navajo and read and write English, not have been convicted of a felony with the last five years, must have unswerving loyalty to the Navajo Nation and must be competent and capable of upholding the oath of office, among other qualifications.
- O. The qualifications for President and Vice-President at 2 N.N.C. § 1004 and 11 N.N.C. § 8 are not in harmony.
- P. As recent events have developed it is obvious there is much confusion and misinformation among the Navajo people about the value of their participation

- in the primary election; about whether their voice through their vote has been heard.
- Q. The Navajo Nation has been at this precipice 25 years prior at which time the Navajo Nation was deeply divided, causing great disharmony to Navajo families and the government; currently there is the potential to completely destabilize the electoral process at various levels which will lead to instability in government, threatening the functions of the executive agencies, law enforcement, fire protection, emergency medical services and other vital services to public safety. There is a pressing public need for the Navajo Nation Council to address this matter.
- R. The issue of the ability to speak the Navajo language is an issue that is present not just in the presidential election but also the other elections for public office. It is time to address this issue.
- S. The Navajo Nation Election Code lists numerous qualifications for elective office. Included in these requirements are the ability to speak Navajo and English. The Election Code, however, is not consistent as to these requirements. For example, some positions merely require the ability to speak Navajo, while others require speaking Navajo "fluently." Some positions do not require any Navajo language requirements at all, such as for Chapter Officers and school board members. And, all positions, except for school boards and the Board of Education, require the ability to speak English.
- T. These inconsistencies in the Election Code may potentially violate due process rights of candidates, deny the right to the equal protection of the law and infringe upon the fundamental right voters to select their own leaders. It is necessary that all provisions on any language requirements, Navajo or English, whether speaking or writing it, be amended to permit voters to determine on their own who may be the best qualified candidate.
- U. We are all Navajo people. In abiding by Diné Bi Beenahaz'áanii and our Navajo Bill of Rights we do not want to provide impediments that prevent the Navajo people, both young and old, from exercising their political leadership

Should any provisions of this ordinance be determined invalid by the Navajo Nation Supreme Court, or the District Courts of the Navajo Nation, without appeal to the Navajo Nation Supreme Court, those portions of this ordinance which are not determined invalid shall remain the law of the Navajo Nation.

With respect to the Legislation, I believe it gives an appearance of segregation of our Dine' — if you speak the language, Navajo fluently vs if you cannot speak the language, Navajo, the lines form here. I must share that it is "bullying" to be singled out because of language disparities. I have seen and heard many times, and more times than any, even years before and to the present time, the Representation of The Navajo Nation not speaking the Navajo language to conduct the Official Business, including in the House of the People, the Council Chambers-I see Internet displays, reading of documents, all in English. Although I cannot relate to the BIA Boarding School syndrome, but I am told of the times students were severely disciplined, many other forms of actions taken against them for speaking the Navajo language or Native language. Comparably, as voted delegates to represent the many Dine' people, to cause atrocity to our own relatives by creating a biased code. How many can say in the local levels of the Government and in Offices serving the Navajo Nation that a majority of the communication is done in the Navajo language? In the mainstream society, outside the Reservation that is grounds for discrimination.

Therefore, in closing I request that your decisions be with broad minds, intelligence and just, in order for our Navajo Nation to flourish to support and recognize Bi-lingual-ness.

- 2. SO therefore, this LEGISLATION NO: _0014-15 needs to pass. I am urging the Council to think about this!! T'aashodi Yee Nabik'iyadaalti'.
- 3. If we choose not to vote for it, then we are getting no where. We need to think about the future; which are our children.
- 4. We need to make the future ready for our children -- WE Want to AMEND the language requirement so our children can be Leaders!!!

I voted this pass election in the Navajo Nation elections for people I thought would look out for the best interest of the Navajo Nation and represent our Nation with integrity and honesty. I listen to the debates and studied the different candidates and made my choice, only to have my vote disenfranchised and wiped away. My vote should count for something. Let the chips fall where they may by the number of votes that the different candidates received, and let the people choose who they want in the different offices of the Navajo Nation.

My first language was the Dine language. I went to school and received an education. I went on to a university and obtained my Bachelor of Science degree and later my Master's degree. In addition, I was privileged to get funding by the Navajo Nation Scholarship Office to get my education and am forever grateful for that. I currently work off the Nation and anticipate on returning to the Nation one day to serve my Nation in honor of my grandparent's and the Nation's investments.

I stay involved in local elections because I believe that without my vote, I am not able to voice my concerns. I do the same for state and federal elections. But with this last Navajo election, I get the impression that off reservation Navajos are not allowed to come back the Nation to do their civic duties for the Nation. I want to have the opportunity to fairly participate in my Navajo government. By approving this legislation, I will have the opportunity to vote for who I feel is best suited for the different elected offices, even if it means that I have to Write-In my candidate. In addition, approving this legislation will re-install my confidence in the Navajo Nation electoral process.

Do not change the language requirement leave the standard as is. Lowering the standard increases the chance of losing the language leaving the standard as is guarantees a president knows and understands Dine Bizaad. The amendment states that "we leave it up to the voters to decide". This does not need to be said or made into a law because the voters already decide this and have been deciding this ever since we started voting. This statement is an insult to the Navajo People because we do not need to be told this. Of course we can and will and always well decide on language fluency. Voters always had this right and always will. It does not need to be stated. If we do away with the current language requirement we are lowering the standard plain and simple. It shouldn't have to be said the importance of a leader understanding Dine Bizaad and the effect this will have on the youth to ensure they strive to learn. Lead by example. To lower the standard we are telling all of us we are not capable of learning Dine Bizaad. I heard and argument by Council Delegate Honorable Leanord Tsosie about the concern that three Navajo interns not fluent in Navajo would not be able to help the tribe. He said we need these students so we should lower the standard. In that one sentence he effectively said these students or any students are not capable of learning the language. This is an insult to everyone as I believe we can learn enough to pass any test. I am a 1st Lieutenant in the US Army and if I lower the standards in my platoon I am effectively weakening my platoon. Keep the language strong.

Language requirement has been there for awhile and I believe it is based on the honor system of each candidate. I don't believe anyone anticipated a candidate being dishonorable or lying on the application as most presidential candidates have a high degree of integrity. However, if a candidate is believed to not speak Dine Bizaad we have a system to challenge this in court. Currently we have a stronger system in place. If a candidate is honorable he will be able to pass all tests. This ensures candidates are fluent in Navajo.

If not, then fluency in Navajo is desirable but not a requirement for a presidential position or other elected offices.
