PURPOSE: The purpose of this proposed resolution is to provide a supplemental appropriation to several Navajo Nation Grantees.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

19	SECTION ONE. AUTHORITY
20	A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §102(A).
21	As such, the Council may approve supplemental appropriations whenever additional
22	sources of revenues above current revenue projections are anticipated and such revenues
23	exceed the required reserve amount. 12 N.N.C. §820(L).
24	B. The Navajo Nation Council may approve emergency legislation to address any matter
25	"constituting an emergency [that] shall be limited to the cessation of law enforcement
26	services, and disaster relief services, fire protection services or other direct services
27	required as an entitlement under Navajo Nation or Federal law, or which directly threaten
28	the sovereignty of the Navajo Nation. Such an emergency matter must arise due to the
29	pressing public need for such resolution(s) and must be a matter requiring final action by
30	the Council." 2 N.N.C. §164 (A)(16).

- C. This Resolution is offered as an emergency due to the need created from several Navajo Nation grant programs not having their grants encumbered by the close of Fiscal Year 2022. Specifically, this has impacted funding to Diné College, Navajo Technical University, Navajo Preparatory School, Inc. and Phoenix Indian Center, Inc. This creates an emergency because it will directly threaten the sovereignty of the Navajo Nation if the Grantees supplemental appropriation requests are not funded, as it will have a direct impact on the Grantees continued operations.
- D. The restrictions on supplemental appropriations, including all monies from the Navajo

 Nation's UUFB, include:
 - 1. Payment of recurring government operating expenses shall be from recurring revenues and payment of nonrecurring expenses shall be from nonrecurring revenues such as UUFB funds. 12 N.N.C. §820(E) and §820(F).
 - 2. Specifically, the UUFB shall not be used for recurring government expenditures or operations. 12 N.N.C. §820(J) and §820(L).
 - 3. Nonrecurring revenues funds may be used only after the Controller determines whether or not such revenues are subsidizing an imbalance between the Navajo Nation's recurring revenues and expenditures, and government expenditures shall only be authorized if a long-term (3-year to 5-year year) forecast shows that the operating deficit will not continue; otherwise, nonrecurring revenues will be added to the UUFB. 12 N.N.C. §820(F).
 - 4. The above provisions in Title 12 may be amended or waived by a two-thirds vote of the full Navajo Nation Council. 12 N.N.C. §820(F) and 12 N.N.C. §880.
 - 5. In compliance with 12 N.N.C. §820(F) all UUFB funding requests must be reviewed by the Controller. Such review is also required because the Controller determines which revenues and expenses are recurring and which are non-recurring. 12 N.N.C. §820(L).
 - 6. In compliance with 12 N.N.C. §820(M) all UUFB funding requests must be submitted to the Office of Management and Budget ("OMB") for a budget impact analysis.

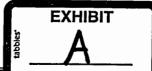

Diné College is the first tribally controlled institution in the United States. Established in 1968 as Navajo Community College, it was renamed Diné College in 1997. Located in Tsaile, AZ on the Navajo Nation. Diné College serves a predominantly Navajo student populationn (92%). Diné College is accredited by the Higer learning Commission as a four-yar instituation. The College offers 6 certificate, 16 associate degree, 20 bachelor degree and 1 master's degree programs

PROBLEMS/NEEDS STATEMENT

Describe the problems and needs identified to be addressed through this funding request. Include relevant data such as the number and location of the Navajo population to be served.

Diné College serves a predominantly Navajo student population across the 27,000 square miles of the Navajo Nation that spans across the states of Arizona, New Mexico, Utah and globally. The College offers General Education courses that provide students with a high-quality experience while earning various degree programs in the areas important to the economic, political, environmental and social development of the Navajo Nation. The need of the Diné College is make college affordable for the students to implement & expand technology, to boost student engagement & success, and improve ways to support students accademic success. (Diné College didn't receive the \$4.7M for FY21-22, \$3,525,000 was reverted back to NN General Fund, the \$1,175M was rolled forwarded to FY 22-23, but has not been reimbursed to Diné College, which is why we are applying for supplemental Funding.)

Describe the services to be provided with the requested funds and how the services will address the problems and needs identified above.

The Funding received from the Navajo Nation allows the College to provide quality education and other services in a consistent manner without having to curtail services to our students and the people of the Navajo Nation. Funding will provide technological & academic support by increasing information technology & facility infrastructure, to increase connectivity for accessibility for students, and to expand & increase educational programs to meet the economic & social needs of the Navajo Nation.

Describe the entity or organization requesting the grant.

Navajo Nation Council Legislation CJY-45-17, August 2017, increased the annual appropriation to \$4,200,000 which enables NTU to provide educational and vocational learning opportunities. The University prepares Navajos and other students with a quality technical and vocational education, associate degrees, bachelor degrees, master degrees, or other community education in a higher learning setting. Main campus is in Crownpoint, NM and satellite campuses in Chinle, Teecnospos, Arizona and Kirtland, Zuni, New Mexico.

PROBLEMS/NEEDS STATEMENT

Describe the problems and needs identified to be addressed through this funding request. Include relevant data such as the number and location of the Navajo population to be served.

The Navajo Nation lacks certified early childhood teachers as well as an educated workforce. The Navajo Nation has a small percentage of Navajo people with bachelor degrees and the median age is 24, which indicates a high number of our population are within school age population. About 38% of the population is under the age of 19 (US Census Bureau Survey, American Community Survey, 2019).

The Navajo Nation sorely lack certified teachers and law enforcement officers, as such the Nation has requested NTU to provide the necessary training for these professionals.

METHODOLOGY

Describe the services to be provided with the requested funds and how the services will address the problems and needs identified above.

Navajo Technical University offers programs in adult basic education, certificates, associate degrees, baccalaureate and Master degrees at five campuses in Arizona and New Mexico. Eight course offerings are provided fully on-line and other courses are provided face to face or in combination of face-to-face and virtual.

NTU is accredited by the Higher Learning Commission, ABET, American Veterinary Medical Association, Culinary Federation and other accreditation that is required. NTU has agreements with Navajo Head Start and the Division of Pubic Safety to educate early childhood teachers and police officers.

Navajo Preparatory School (Navajo Prep) is a tribally controlled BIE grant school authorized by the Navajo Nation. Navajo Prep School was established in 1991 by the Education Committee of the Navajo Nation Council to offer a college preparatory program and produce leaders for the Navajo Nation. Navajo Prep is located in Farmington New Mexico, on an 82.45-acre site, formerly the Navajo Methodist Mission School campus. The land and the property are now the permanent home of Navajo Prep through a 99-year lease with the Navajo Nation.

PROBLEMS/NEEDS STATEMENT

Describe the problems and needs identified to be addressed through this funding request. Include relevant data such as the number and location of the Navajo population to be served.

Navajo Preparatory School, Inc. sits below a mesa that houses the Farmington airport, and runoff drains directly into the Navajo Prep campus. The runoff has caused flooding in academic basements, the Auxiliary gym, and the main gym. This drainage project will help Navajo Prep build a permanent drainage ditch and holding pond at the base of the mesa. This project also can assist with drainage control near the canal that runs through the Navajo Prep campus.

METHODOLOGY

This project will require a civil engineer designs and a general contractor. Navajo Prep's civil engineer stated that this project will cost at the minimum 1.5 million. 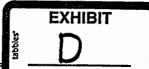

The Phoenix Indian Center (PIC), established in 1947, is the oldest agency in the United States dedicated to improving the health and well-being of American Indian people by providing quality, culturally based youth programming, prevention of substance abuse and suicide, language/culture, education and job preparedness services. The Navajo Language & Culture Program provides education, cultural enrichment, community engagement and support services for urban Navajos residing in Maricopa County.

PROBLEMS/NEEDS STATEMENT

Describe the problems and needs identified to be addressed through this funding request, include relevant data such as the number and location of the Navajo population to be served.

According to the US Census, the Arizona population is estimated at 6,731,484 of which 5.3% (356,768) are American Indian and 31% of that population is Navajo. The 2011-2013 Census American Community Survey estimated the urban-living American Indian population in Maricopa County (off reservation) was 127,364 with 30% (38,209) being Navajo. Phoenix is the 3rd largest city with American Indian people in the United States. The Census also estimated that 20.8% of the homes in Arizona spoke Spanish followed by the next significant language group, Navajo at 1.48%. The Phoenix Indian Center annually provides services to over 9,000 people and reaches many more through presentations and community outreach events. 4 of every 10 clients to the Phoenix Indian Center identify themselves as Navajo tribal members. It is evident that many Navajo people relocate to the Phoenix area for various reasons including employment and/or to pursue higher education. Currently, many Navajo members who are no longer surrounded by their language report being detached from their Navajo community, not being fluent or have little speaking ability in their ancestral language and have limited cultural knowledge. This funding will provide continued opportunities for the urban Navajo community members to engage and to learn their heritage language, culture, and traditions which can promote self identity and self sufficiency. Additionally this project will provide support for Navajo families in crisis by offering assistance with items such as rental, utility, emergency shelter or transportation needs **METHODOLOGY**

Describe the services to be provided with the requested funds and how the services will address the problems and needs Identified above.

The problems and objectives discussed will be addressed through the following approach: Navajo language and culture classes will be offered to address the need to grow more Dine speakers and gain knowledge and preservation of cultural practices. Navajo language and culture classes will be offered on a semester basis and varied throughout the week on different days, times and locations for both youth and adults. Class offerings to date have included Adult Beginning Navajo Language, Adult Intermediate Navajo Language, Navajo Literacy, Intergenerational Language and Culture, Children's Navajo Language, Dine Culture, Navajo Singing Language Class and Navajo Weaving. Additionally, special seasonal cultural story telling events using Navajo experts to share cultural teachings with the Navajo people residing in the Phoenix Metro will be offered thus preserving and growing the Dine knowledge. Finally, with approximately 38,000+ Dine families living in Phoenix, those who experience crisis mode can utilize the emergency assistance for key necessities such as rental, utility, emergency shelter or transportation to Navajo Nation.
