

**RESOLUTION OF THE
BUDGET AND FINANCE COMMITTEE
OF THE NAVAJO NATION COUNCIL**

25TH NAVAJO NATION COUNCIL - First Year, 2023

AN ACTION

RELATING TO THE BUDGET AND FINANCE COMMITTEE; APPROVING AND RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2024 BUDGET FOR THE OFFICE OF THE NAVAJO TAX COMMISSION AND RELATED MATTERS, TO BE INCLUDED IN THE NAVAJO NATION'S FY2024 COMPREHENSIVE BUDGET

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council with oversight authority over the Office of the Navajo Tax Commission ("ONTC"). 2 N.N.C. § 300(A); 2 N.N.C. § 301(B)(13).
- B. Each oversight committee, including the Budget and Finance Committee, shall review and make recommendations regarding the program under its oversight responsibility, regarding the Navajo Nation's Comprehensive Budget for the upcoming Fiscal Year. 12 N.N.C. § 840(A).

SECTION TWO. FINDINGS

- A. Pursuant to 12 N.N.C. § 840(A), each Oversight Committee, including the Budget and Finance Committee, "shall review and make recommendations to the Budget and Finance Committee concerning the budget[s]" for the Programs they oversee. 12 N.N.C. § 840(A) further provides that Oversight Committee recommendations shall not exceed the base planning amounts established in the FY2024 Budget Instructions Manual. The base planning amounts were established by the Budget and Finance Committee in the FY2024 Budget Instructions Manual (see Resolution No. BFJY-15-23).

- B. In accordance with 12 N.N.C. § 840(A), the Budget and Finance Committee held public meetings and heard reports from Program staff and the Office of Management and Budget regarding the proposed FY2024 Budget for the Office of the Navajo Tax Commission.
- C. During these budget meetings, the Budget and Finance Committee reviewed and considered the proposed FY2024 Budget for the Office of the Navajo Tax Commission, as compared to the base planning amounts established in the FY2024 Budget Instructions Manual and as recommended by the Office of Management and Budget.
- D. The Budget and Finance Committee finds that approval of the proposed FY2024 Budget for the Office of the Navajo Tax Commission and inclusion of such Budget in the Navajo Nation's FY2024 Comprehensive Budget is in the best interest of the Navajo Nation.

SECTION THREE. APPROVING AND RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2024 BUDGET FOR THE OFFICE OF THE NAVAJO TAX COMMISSION AND RELATED MATTERS

- A. The Budget and Finance Committee hereby approves the FY2024 Budget for the Office of the Navajo Tax Commission, as detailed in the "Fund Type Budget Summary" attached hereto as **Exhibit A**.
- B. The Budget and Finance Committee hereby approves certain revisions to the Branch Chiefs' proposed FY2024 Budget amount for the Office of the Navajo Tax Commission, as shown in Columns D and E in the "General Fund Comparative Summary" attached hereto as **Exhibit B**.
- C. The Budget and Finance Committee recommends the changes to the General Fund Budget described in **Exhibit C**.
- D. The Budget and Finance Committee hereby recommends certain Conditions of Appropriation and Legislative Concerns, as listed in **Exhibit D**.
- E. The Budget and Finance Committee hereby recommends that certain Unmet Needs for the Office of the Navajo Tax Commission be included in the FY2024 Comprehensive Budget, as explained in **Exhibit E**.

- F. The Budget and Finance Committee hereby recommends that the Budget and Finance Committee approve the Office of the Navajo Tax Commission FY2024 Budget and all Committee recommendations, as set forth in **Exhibits A-E**.
- G. As necessary and appropriate, the Budget and Finance Committee hereby authorizes the Chair and Vice-Chair to negotiate the Budget and Finance Committee recommendations herein with the Budget and Finance Committee.

SECTION FOUR. EFFECTIVE DATE

This Action shall become effective as provided in 2 N.N.C. § 189(A).


