# RESOLUTION OF THE NAVAJO NATION COUNCIL $24^{\rm th}$ NAVAJO NATION COUNCIL - SECOND YEAR, 2020

#### AN ACTION

RELATING TO HEALTH, EDUCATION AND HUMAN SERVICES, NAABIK'ÍYÁTI' AND NAVAJO NATION COUNCIL; APPROVING THE REINSTATEMENT OF HALEY JENNIFER MOSES AND HARRY MOSES IV AS MEMBERS OF THE NAVAJO NATION

#### BE IT ENACTED:

#### SECTION ONE. AUTHORITY

- A. Pursuant to the Navajo Nation law: Any enrolled member of the Navajo Nation may renounce [his/her] membership by written petition to the President of the Navajo Nation requesting that his name be stricken from the Navajo Nation roll. See 1 N.N.C. § 705 (Renunciation of membership).
- B. The Navajo Nation in addition states, "[n]o person, otherwise eligible for membership in the Navajo Nation, may enroll as a member of the Navajo Nation, who, at the same time, is on the roll of any other tribe of Indians." See 1 N.N.C. § 703 (Member of another tribe).
- C. Renounced members may be reinstated by the Navajo Nation only by the vote of majority of the Navajo Nation Council. See 1 N.N.C.  $\S$  705 (Renunciation of membership).

#### SECTION TWO. FINDINGS

- A. On June 19, 2018, the mother of Haley Jennifer Moses and Harry Moses IV, Ms. Marlene Jordan, requested that her two children be stricken from the Navajo Nation census roll. Her reason given is that she wanted to enroll her two children with the Colorado River Indian Tribe. See Exhibit A.
- B. On July 24, 2019, the Navajo Nation Office of Vital Records provided to Marlene Jordan a confirmation of "final relinquishment" of her two children of their Navajo Nation membership. See Exhibit B.
- C. On October 27, 2020, Marlene Jordan requested to have her two children's Navajo Nation membership reinstated. Her reason given is that the father of her two children, who is a member

of the Colorado River Indian Tribe, has refused to allow her children to be enrolled with his tribe. See Exhibit C.

D. Marlene Jordan's October 27, 2020 letter asks if her two children can have the same enrollment numbers that were originally issued to them. See Exhibit C.

#### SECTION THREE. REENROLLMENT

Haley Jennifer Moses and Harry Moses IV are and shall be reinstated, or otherwise reenrolled, as members of the Navajo Nation. By this action of the Navajo Nation Council and pursuant to the laws of the Navajo Nation, they shall be entitled to all rights, benefits and privileges associated with membership with the Navajo Nation.

#### CERTIFICATION

I hereby certify that the foregoing resolution was duly considered by the 24<sup>th</sup> Navajo Nation Council at a duly called meeting in Window Rock, Navajo Nation (Arizona), at which a quorum was present and that the same was passed by a vote of 21 in Favor, and 00 Opposed, on this 23<sup>rd</sup> day of December 2020.


