
This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee shall review and make recommendations concerning the budget and submit it to the Navajo Nation Council for deliberation and adoption. 12 N.N.C. §840(A) and (B).
- B. The Naabik'iyáti' Committee is assigned proposed resolutions that require final action by the Navajo Nation Council. 2 N.N.C. §164(A)(9).
- C. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §102(A).

SECTION TWO. FINDINGS

- 1 A. The Navajo Nation Council approved Council Resolution CN-88-20, the Navajo
2 Nation Fiscal Year 2021 Comprehensive Budget, on November 30, 2020 and the
3 Navajo Nation President signed CN-88-20 on December 10, 2020.
- 4 B. As a result of the Navajo Nation President's exercise of the line item veto authority in
5 Council Resolution CN-88-20, several legislative branch offices and programs have
6 been impacted to the point of not being able to continue its work through Fiscal Year
7 2021.
- 8 C. The Office of the Speaker and the Office of the President and Vice President, along
9 with the Budget and Finance Committee of the Navajo Nation Council, have had
10 discussions on the importance of restoring funding to the Legislative Branch to ensure
11 continuity in its operations.
- 12 D. If additional budgets are presented for the Executive, Legislative, and Judicial
13 Branches, future amendments to Council Resolution CN-88-20 may be required.
- 14 E. The Navajo Nation Council amends the Fiscal Year 2021 Comprehensive Budget as
15 indicated in the Section Three, below.

17 **SECTION THREE. AMENDING COUNCIL RESOLUTION CN-88-20, THE**
18 **NAVAJO NATION FISCAL YEAR 2021 BUDGET**

- 19 A. The Navajo Nation Council approves the appropriations for Fiscal Year 2021 as listed
20 here for the Legislative Branch for the following Business Units, totaling \$1,514,536,
21 from General Funds which were the subject of a line item veto. Each affected Office or
22 Program has submitted budget forms 1, 2, and 4. These forms are included in **Exhibit A**.
- 23 B. The Navajo Nation Council approves amending Council Resolution CN-88-20, to restore
24 funding for the Legislative Branch as follows:
- 25 a) Navajo Nation Council, BU # 101001, in the amount of \$521,153,
 - 26 b) Budget and Finance Committee, BU # 101003, in the amount of \$42,345,
 - 27 c) Office of the Speaker, BU # 101015, in the amount of \$551,038,
 - 28 d) Office of Legislative Counsel, BU # 101017, in the amount of \$220,000, and
 - 29 e) Elections Administration Office BU # 101021, in the amount of \$180,000.

1 **SECTION FOUR. DIRECTIVE TO THE OFFICE OF MANAGEMENT AND**
2 **BUDGET**

3 The Navajo Nation directs the Office of Management and Budget to immediately
4 recalculate the final monetary totals such that the figures conform to the amendments
5 passed by the Navajo Nation Council.
