RESOLUTION OF THE NAVAJO NATION COUNCIL 25th NAVAJO NATION COUNCIL - FIRST YEAR, 2023

AN ACTION

RELATING TO HEALTH, EDUCATION AND HUMAN SERVICES COMMITTEE, NAABIK'ÍYÁTI' COMMITTEE AND THE NAVAJO NATION COUNCIL; CONFIRMING THE APPOINTMENT OF DEBBIE NEZ-MANUEL AS THE EXECUTIVE DIRECTOR OF THE DIVISION OF HUMAN RESOURCES

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 400(A). The Health, Education and Human Services Committee exercises oversight authority over the Division of Human Resources. 2 N.N.C. § 401(C)(1).
- B. The Naabik'iyati' Committee is a standing committee of the Navajo Nation Council. The Committee reviews all legislation requiring final action by the Navajo Nation Council. 2 N.N.C. §§ 164(A)(9), 700(A).
- C. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102(A).

SECTION TWO. FINDINGS

- A. The establishment of the Division of Human Resources and the duties of the Executive Director are outlined at 2 N.N.C. § 1701 et seq.
- B. The Executive Director of the Division of Human Resources shall be appointed by and serve at the pleasure of the President of the Navajo Nation and confirmed by the Navajo Nation Council. 2 N.N.C. § 1703(A)(2).
- C. The Navajo Nation President appointed Mrs. Debbie Nez-Manuel as the Executive Director of the Navajo Division of Human Resources. Mrs. Nez-Manuel's letter of interest, appointment letter, and résumé are attached as **Exhibit A**.

SECTION THREE. CONFIRMING THE APPOINTMENT OF THE EXECUTIVE DIRECTOR OF THE DIVISION OF HUMAN RESOURCES

The Navajo Nation Council hereby confirms the appointment of Mrs. Debbie Nez-Manuel as the Executive Director of the Division of Human Resources.
