#### BE IT ENACTED:

### SECTION ONE. AUTHORITY

A. The Navajo Nation Council established the Resources and Development Committee as a Navajo Nation Standing Committee.

### SECTION TWO. FINDINGS

- A. The Resources and Development Committee shall consist of six members. 2 N.N.C.  $\S$  500 (A)-(B).
- B. The Resources and Development Committee's Chairperson and Vice-Chairperson shall be selected by a vote of the Resources and Development Committee. 2 N.N.C. § 184 (A).
