RESOLUTION OF THE RESOURCES AND DEVELOPMENT COMMITTEE 23rd Navajo Nation Council --- Fourth Year, 2018

AN ACTION

RELATING TO THE RESOURCES AND DEVELOPMENT COMMITTEE; APPROVING A BUDGET REALLOCATION IN THE TOTAL AMOUNT OF \$1,535,899.93 OF FUNDS FROM VARIOUS BUSINESS UNITS TO TEN (10) CAPITAL PROJECTS

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Resources and Development Committee ("RDC") is a standing committee of the Navajo Nation Council. 2 N.N.C. § 500 (A).
- B. The Resources and Development Committee is the oversight committee of the Division of Community Development which includes the Capital Project Management Department ("CPMD"). 2 N.N.C. 501(C)(1). See also RDC0-77-16.
- C. Pursuant to 2 N.N.C. §185(A), a standing committee may reallocate funds appropriated by the Navajo Nation Council to a division or program over which the committee has oversight. A reallocation of funds must be approved "by two-thirds (2/3) vote of the full membership of the committee, board or commission." 2 N.N.C. §185(A).

SECTION TWO. FINDINGS

- A. A budget reallocation is the reallocation of funds between business units which requires oversight approval. Navajo Nation Budget Instruction Manual Fiscal Year 2018, Section XIII, C, 1, b.
- B. The Navajo Nation Division of Community Development Capital Project Management Department requests a budget reallocation in the amount of \$1,535,899.93 in accordance with the amounts and business unit numbers listed on the Navajo Nation Division of Community Development Budget Revision Requests, attached as **Exhibit A**.
- C. This reallocation of funds will allow the Capital Project Management Department to address audit findings, close out completed projects and to continue funding 10 priority

projects. Updated Project Forms are attached hereto as **Exhibit B**.

D. The Executive Branch has completed its 164 review process. The Office of Management and Budget, Office of the Controller, and the Department of Justice have all indicated the documentation is sufficient. These approvals are provided attached hereto as **Exhibit C** and include but is not limited to: a memorandum dated August 8, 2017, from the Office of Management and Budget providing a review of the proposed reallocation; a memorandum dated August 28, 2017, from the Controller providing a review of the proposed reallocation; a memorandum dated October 16, 2017 from the CPMD responding to inquiries made by reviewers; and a memorandum dated October 30, 2017, from the Navajo Department of Justice providing a review of the proposed budget reallocation.

SECTION THREE. APPROVAL OF REALLOCATION

- A. The Navajo Nation Resources and Development Committee hereby approves a budget reallocation in the total amount of \$1,535,899.93 as set forth in the Budget Revisions Request Forms attached hereto as **Exhibit A**.
- B. The Navajo Nation Resources and Development Committee hereby directs the staff of the Office of Management and Budget to establish the necessary business units for the reallocated funds.

It was the former Design & Engineering Services (DES) who monitored the funding, perform all the procurement activity and all the approval processes.

2. Business CO1498 Cameron Multipurpose Facility has a balance of \$138.00. The amount list has \$139.00.

This is a typo-error. The correct amount is \$138.00.

3. Large balances. Business Unit CO1399 Shiprock Youth Development project has a balance of \$777,257.65.

In moving towards the recommendation of the Auditor General Report No.17-10 December 2016, "large carryover balance demonstrates ineffective use of Capital Improvement funds", therefore needs to be reallocated to another project. 4. Have these closed capital projects been notified that the remaining balances are being reallocated to another project?

These are completed close capital project funds. The closeout documents have been developed by the Project Managers. It is the responsibility of the CPMD/DCD to reallocate where it's needed.

5. Funds should not be co-mingled.

This will be addressed by OMB and OOC once the reallocation is completed.
