# RESOLUTION OF THE RESOURCES AND DEVELOPMENT COMMITTEE Of the 23rd Navajo Nation Council---Second Year 2016

## AN ACTION

RELATING TO RESOURCES AND DEVELOPMENT; RESCINDING RDCJY-46-16; AND APPROVING THE MUTUAL TERMINATION OF BUSINESS SITE LEASE NO. SR-99-159 BETWEEN THE NAVAJO NATION AND GIANT FOUR CORNERS, INC

BE IT ENACTED:

### Section One. Authority

A. The Resources and Development Committee is established as a standing committee of the Navajo Nation. 2 N.N.C. § 500 (A).

B. The Resources and Development Committee of the Navajo Nation Council is empowered to grant final approval for non-mineral leases. 2 N.N.C. §501(B)(2).

## Section Two. Findings

A. The Resources and Development Committee passed Resolution Number RDCJY-46-16, An Action Relating to Resources and Development; Approving the Mutual Termination of Business Site Sublease No. SR-99-159 between the Navajo Nation and Giant Four Corners, Inc. RDCJY-46-16 is attached as **Exhibit 4**.

B. Exhibits and the title of Resolution Number RDCJY-46-16 do not clearly delineate that the document to be mutually terminated is a Lease as opposed to a Sublease; therefore, in the interest of clarity, RDCJY-46-16 should be rescinded and a new resolution with exhibits clearly stating that the mutual termination is for a Lease.

C. In a letter, August 15, 2016, **Exhibit 2**, Roger C. Sprouse, of Giant Four Corners, Inc., requests a correction to a previous letter dated April 25, 2016 which referenced a Sub-lease. Mr. Sprouse's August 15, 2016 letter requests "for mutual termination of the . . . Base Lease [SR-99-159]."

D. The Executive Summary of the Regional Business Development Office (RBDO), **Exhibit 3**, requests an amendment to RDCJY-46-16 to mutually terminate the Bureau of Indian Affairs Lease No. SR-99-159 rather than mutually terminating a Sublease.

E. The Mutual Termination Lease No. SR-99-159 is attached as **Exhibit 1**.

# Section Two. Approval:

A. The Navajo Nation hereby approves the Mutual Termination of Business Site Lease SR-99-159, as set forth in **Exhibit 1** 

B. The Navajo Nation hereby authorizes the President of the Navajo Nation to execute this Mutual Termination of Business Site Lease SR-99-159 and all other documents necessary to effectuate the intent of this resolution.
