### RESOLUTION OF THE NAVAJO NATION COUNCIL

#### 23RD NAVAJO NATION COUNCIL -- Fourth Year, 2018

#### AN ACTION

RELATING TO THE NAVAJO NATION COUNCIL; CONFIRMING THE APPOINTMENT OF JOANN JAYNE AS PROBATIONARY CHIEF JUSTICE OF THE NAVAJO NATION SUPREME COURT

#### BE IT ENACTED:

#### Section One. Authority

- A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102 (A).
- B. The Navajo Nation Council confirms the appointment of the Chief Justice of the Navajo Nation Supreme Court. 7 N.N.C. § 355 (A).
- C. Pursuant to 7 N.N.C. § 355 (A) "The President of the Navajo Nation shall appoint the Chief Justice, Associate Justices, and District Court Judges with confirmation by the Navajo Nation Council from among those applicants recommended by the Judiciary Committee of the Navajo Nation Council."
- D. The duties of the Judiciary Committee of the Navajo Nation Council were placed within the authorities of the Law and Order Committee of the Navajo Nation Council after the number of Navajo Nation Council delegates were reduced in number from 88 to 24 and when the number of standing committees were reduced from twelve to five. CO-45-12; 2 N.N.C. §§ 600 et seq.
- E. Pursuant to 7 N.N.C. § 355 (B), The Chief Justice ... of the Supreme Court... shall be appointed for a probationary period of two years and upon permanent appointment shall serve thereafter during good behavior.

#### Section Two. Findings

- A. The Chief Justice position of the Navajo Nation Supreme Court is vacant.
- B. The Law and Order Committee of the Navajo Nation Council, pursuant to 7 N.N.C. § 355 (A), through Resolution Number LOCJN-08-17, provided JoAnn Jayne's name to the Navajo Nation President as an applicant recommended for the position of Chief Justice of the Navajo Nation.

C. The President of the Navajo Nation's letter appointing JoAnn Jayne as Chief Justice and related documents are attached hereto as **Exhibit "A."** 

### Section Three. Confirming JoAnn Jayne as Probationary Chief Justice

The Navajo Nation Council hereby confirms the Navajo Nation President's appointment of JoAnn Jayne as probationary Chief Justice of the Navajo Nation Supreme Court pursuant to 7 N.N.C. § 355 (A).





JoAnn Jayne, known as Joey Jayne, applied for the Chief Justice position with the Navajo Nation Supreme Court. Most notable for this position is Ms Jayne served as Judge Jayne for State Justice Court, Lake County, Polson, Montana during 2013and 2014. Her caseload encompassed the 8<sup>th</sup> highest number for State justice courts in Montana. During her tenure, I had the opportunity and privilege to see her demeanor, professionalism, and knowledge as a competent judge.

Joey, as I call her, was the first Navajo, and first Native American woman in the State of Montana to be elected for any state judge position.
