


SECTION ONE. AUTHORITY

- A. The Law and Order Committee is a standing committee of the Navajo Nation Council.
2 N.N.C. § 600(A).
- B. The Law and Order Committee is the oversight committee of the Navajo Nation Labor
Commission. 2 N.N.C. § 601(C)(1).
- C. The Naabik'iyati' Committee is a standing committee of the Navajo Nation Council
with the authority to confirm those appointments to the Navajo Nation Labor
Commission made by the President of the Navajo Nation. 2 N.N.C. § 700(A), 15
N.N.C. § 303(A).
- D. "Each member of the Commission shall serve for a term of four (4) years and until his
or her successor is appointed." 15 N.N.C. § 303(D)

1 **SECTION TWO. FINDINGS**

- 2 A. The Navajo Nation Labor Commission is established “to hear and adjudicate cases as
3 the quasi-judicial hearing body under the Navajo Preference in Employment Act.” 15
4 N.N.C. § 302 (A).
- 5 B. The membership of the Labor Commission consists of five members. 15 § 303 (A). All
6 five members must be licensed by the Navajo Nation Bar Association. 15 N.N.C. § 303
7 (B) (2). Of the five, two members must be state licensed attorneys, in Arizona and New
8 Mexico or Utah. 15 N.N.C. § 303 (B) (3).
- 9 C. Two of the members of the Labor Commission are appointed by the Health, Education
10 and Human Services Committee. 15 N.N.C. § 303 (A). Three are appointed by the
11 President of the Navajo Nation., with concurrence of the Naabik’íyáti Committee of
12 the Navajo Nation Council. 15 N.N.C. § 303 (A).
- 13 D. Navajo Nation President Jonathan Nez appoints Loretta J. Danzuka to serve on the
14 Navajo Nation Labor Commission. Letter of appointment attached as **Exhibit A**.
- 15 E. Loretta J. Danzuka’s letter of interest, resume, and Certificate of Good Standing are
16 attached as **Exhibit B**, **Exhibit C**, and **Exhibit D**, respectively.

18 **SECTION THREE. CONFIRMATION**

19 Pursuant to 15 N.N.C. § 303 (A), the Naabik’iyati’ Committee hereby confirms the



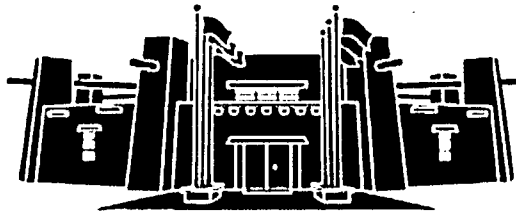
