PURPOSE: The purpose of this legislation is to approve funding of fifty million dollars (\$50,000,000) from the Síhasin Fund to establish the Navajo Nation Scholarship Endowment Expenditure Plan pursuant to 12 N.N.C §§ 2501 – 2508. In complying with 12 N.N.C. § 2502 (A)(2), the legislation enacts the Navajo Nation Scholarship Endowments.

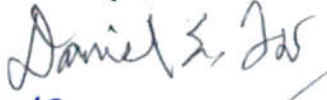
This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

NAVAJO NATION SCHOLARSHIP ENDOWMENT

BE IT ENACTED:

SECTION ONE. AUTHORITY

A. The Law and Order Committee of the Navajo Nation Council is empowered to review and make recommendations to the Navajo Nation Council on proposed amendments to and enactments in the Navajo Nation Code. 2 N.N.C. § 601 (B) (14).

B. The Health, Education and Human Services Committee of the Navajo Nation Council is empowered to exercise oversight authority to review and recommend resolutions relating to social services and education. 2 N.N.C. § 401(B)(6)(a).

C. The Budget and Finance Committee of the Navajo Nation Council is empowered to review and recommend to the Navajo Nation Council the budgeting, appropriation, investment, and management of all funds. 2 N.N.C. § 301 (B) (2).

1 D. The Naabik'iyati' Committee of the Navajo Nation Council is empowered to review
2 all proposed legislation which requires final action by the Navajo Nation Council and
3 shall recommend to [the] Navajo Nation Council financial support and/or financing
4 plan(s) for the purposes set out in 12 N.N.C. § 2502 (the Navajo Nation Síhasin Fund). 2
5 N.N.C. §164(A)(9) and NABIJY-38-19.

6 E. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §
7 102 (A).

8 9 **SECTION TWO. THE NAVAJO NATION SÍHASIN FUND**

10 A. The Navajo Nation Code at 12 N.N.C. § 2502, as amended by CJA-03-18, provides the
11 purpose of the Navajo Nation Síhasin Fund ("Síhasin Fund") as follows:

12 §2502. Purpose

13 A. The purposes of this Fund are to provide financial support and/or financing for:

- 14 1. The planning and development of economic development and regional
15 infrastructure supporting economic development and community
16 development, including such infrastructure as, but not limited to, housing,
17 commercial and government buildings, waterline, solid waste management
18 development, powerline projects, and transportation and communication
19 systems, within the Navajo Nation; and
20 2. Education opportunities for members of the Navajo Nation.

21 B. For the Purpose in § 2502(A)(1), Fund expenditures for infrastructure shall not be
22 limited by 12 N.N.C. § 1301(F) or TCDCJY-77-99.

23 C. Leveraging the Fund by way of guaranteeing loans, match funding, direct funding
24 in part, and other weighted uses of the Fund, including loan financing from the Fund,
25 for the purposes in § 2502(A)(1), shall be favored over direct funding in whole.
26

29 B. The Síhasin Fund provides that Fund Principal shall consist of all deposits made to the
30 Síhasin Fund and that Fund Income shall consist of all earnings (interest, dividends, *etc.*)

generated and realized by the Fund Principal, and that Fund Income shall be deposited in and added to Fund Principal until such time as a Fund Expenditure Plan is duly adopted. 12 N.N.C. §§ 2504 and 2505 (C).

- C. Amendments to the Síhasin Fund require “a ninety percent (90%) vote of the full membership of the Navajo Nation Council and signature of the President of the Navajo Nation.” 12 N.N.C. § 2508.

SECTION THREE. FINDINGS

- A. The purpose of the Scholarship Endowment is to provide full funding for Navajo students pursuing a college degree with the condition of returning to the Navajo Nation to complete a minimum of four years of government service to the Navajo Nation.
- B. The Office of Navajo Nation Scholarship and Financial Assistance 2017 Annual Report highlights that \$20,434,982 was disbursed in Calendar Year 2016 to 6,486 students and \$24,127,385 was disbursed in Calendar Year to 6,755 students. *See* Exhibit “A,” the 2017 Annual Report.
- C. The Office of Navajo Nation Scholarship and Financial Assistance 2017 Annual Report indicates only 51% of Navajo students were awarded financial aid in 2016 and only 53% of Navajo students were awarded financial aid in 2017.
- D. The Office of Navajo Nation Scholarship and Financial Assistance 2017 Annual Report shows that in 2017 a total of 1,594 award recipients earned a degree or certification from one of 20 educational institutions within or surrounding the Navajo Nation with the top five (5) areas of study being Nursing, General Studies, Business Administration, Psychology, and Biology and graduate degree areas of study include Social Work, Business Administration, Education, Educational Leadership, and Law.
- E. The Office of Navajo Nation Scholarship and Financial Assistance 2017 Annual Report explains the funding sources for student scholarships and financial assistance comes from Navajo Nation general funds, federal funds, corporate funds, and trust funds for a total of \$24,127,385.

1 F. Even with the funds available for scholarships and financial aid many Navajo students do
2 not have the opportunity to begin, or complete, a college degree program; as outlined in
3 the 2017 Annual Report, 51% in 2016 and 53% in 2017 were denied awards.

4 G. Diné Customary Law declares and teaches that it is the right and freedom of the people
5 that our children are provided with education to absorb wisdom, self-knowledge to
6 empower them to make a living and participate in the growth of the Navajo Nation. 1
7 N.N.C. § 204(F).

8
9 **SECTION FOUR. APPROVAL AND ADOPTION OF EXPENDITURE PLAN FROM**
10 **SÍHASIN FUNDS**

11 A. The Navajo Nation hereby approves and adopts the Navajo Nation Scholarship
12 Endowment.

13 B. The Navajo Nation hereby approves funding to establish a Navajo Nation Scholarship
14 Endowment in the amount of fifty million dollars (\$50,000,000).

15 C. The Síhasin Funds allocated to establish the Navajo Nation Scholarship Endowment
16 Expenditure Plan may be further leveraged by bond or loan financing pursuant to the
17 Navajo Nation Bond Financing Act, 12 N.N.C. § 1300 *et seq.*, as amended, using Síhasin
18 Fund Earnings for repayment and financing costs upon the recommendation of the
19 Budget and Finance Committee and approval by a two-thirds (2/3) vote of all members of
20 the Navajo Nation Council.

21
22 **SECTION FIVE. APPROVAL AND ADOPTION OF EXPENDITURE PLAN**
23 **ADMINISTRATION**

24 The Navajo Nation hereby approves administration of the Navajo Nation Scholarship
25 Endowment Expenditure Plan as follows:

26 A. The Navajo Nation Controller shall determine whether the source of the fifty million
27 dollars (\$50,000,000) will be Síhasin Fund Principal or Income or a combination of both;

28 B. The funds allocated for the Navajo Nation Scholarship Endowment shall be for the
29 purposes specified in the Navajo Nation Scholarship Endowment, at 12 N.N.C. § 1192, in
30 Section Six of this Resolution.

1 C. The Navajo Nation Controller shall establish the Navajo Nation Scholarship Endowment
2 during Navajo Nation Fiscal Year 2019 or Fiscal Year 2020, provided that the Navajo
3 Nation Scholarship Endowment is established within thirty (30) days of the formal
4 adoption of this legislation.

5
6 **SECTION SIX. ENACTING THE NAVAJO NATION SCHOLARSHIP**
7 **ENDOWMENT**

8 The Navajo Nation enacts the Navajo Nation Scholarship Endowment, as follows:

11 Title 12. Fiscal Matters
12 Chapter 10. Navajo Nation Trust Funds
13 Subchapter 10. Navajo Nation Scholarship Endowment
14

15 §1191. Establishment

16 The “Navajo Nation Scholarship Endowment” hereinafter “Scholarship
17 Endowment” is established with an initial allocation of fifty million dollars
18 (\$50,000,000) from the Navajo Nation Síhasin Fund. Any funds deposited into the
19 Scholarship Endowment, plus accrued interest, shall be used only as provided
20 hereinafter in this subchapter.

21
22 § 1192. Purpose

23 The purpose of the Scholarship Endowment is to provide full funding for
24 Navajo students pursuing a college degree with the condition of returning to the
25 Navajo Nation immediately upon graduation to complete a minimum of four (4) years
26 of government service to the Navajo Nation or reimbursed loan repayment for three
27 (3) of government service to the Navajo Nation immediately upon graduation, but not
28 both.

29
30 §1193. Definition of Principal and Income

1 A. Scholarship Endowment Principal shall consist of the initial funding that
2 established the fund, all Navajo Nation appropriations made pursuant to the
3 Navajo Nation appropriation processes and procedures; and any contributions
4 made by any parties or entities.

5 B. Scholarship Endowment income shall consist of all earnings, such as interest
6 and dividends generated by the principal and interests of the Scholarship
7 Endowment.

8
9 § 1194. Expenditure of Scholarship Endowment Income

10 The Scholarship Endowment income shall be expended as follows:

11 A. Ninety-five percent of the Scholarship Endowment income shall be used as
12 provided in § 1192 of this subchapter. Five percent (5%) of the Scholarship
13 Endowment shall be reinvested to cover the rate of inflation.

14 B. Any awards made from Scholarship Endowment income to Navajo Nation
15 college students, shall be awarded in accordance with rules and regulations
16 developed by the Office of Navajo Nation Scholarship and Financial Assistance,
17 as approved by the Health, Education and Human Services Committee of the
18 Navajo Nation Council.

19
20 § 1195. Expenditure of Fund Principal

21 Fund principal shall not be expended except pursuant to a referendum adopted
22 by a two-thirds majority of those voting in an election open to all registered Navajo
23 voters. The Navajo Nation Council may place a "Referendum to Expend Scholarship
24 Endowment Principal" on the ballot of any primary or general election by a two-
25 thirds (2/3) vote of the full Navajo Nation Council.

26
27 § 1196. Expenses

28 All expenses directly associated with the administration and management of the
29 Scholarship Endowment shall be paid from the Scholarship Endowment income as
30 approved by the Budget and Finance Committee of the Navajo Nation Council, prior

1 to any income distributions made in accordance with §§ 1194 and 1195 of this
2 subchapter. Such expenses shall include investment advisory and management fees,
3 audit costs, and other related expenses, pursuant to duly approved contracts for such
4 services.

5
6 §1197. Fund Investment

7 All monies deposited into the Navajo Nation Scholar Endowment shall be
8 invested in accordance with the Navajo Nation Master Investment Policies as adopted
9 by the Budget and Finance Committee of the Navajo Nation Council.

10
11 § 1198. Amendments

12 Any section or sections in this subchapter may be amended upon the
13 recommendation of the Health, Education and Human Service Committee and the
14 Budget and Finance Committee of the Navajo Nation Council and by a majority vote
15 of the full membership of the Navajo Nation Council and in accordance with 2
16 N.N.C. § 221(B).

17

21 **SECTION SEVEN. COMPLIANCE WITH 12 N.N.C. § 2502 (A)(1)**

22 The Navajo Nation Council approves the purpose of the Síhasin Fund appropriation
23 as enumerated in 12 N.N.C. § 2502 (A)(2) to provide the initial funds to establish the
24 Navajo Nation Scholarship Endowment.

25
26 **SECTION EIGHT. DIRECTIVE**

27 All Navajo Nation programs, specifically including, but not limited to, the Office of
28 Controller and the Office of Management and Budget, shall take all steps necessary to
29 expeditiously implement the Navajo Nation Scholarship Endowment Expenditure Plan
30 consistent with the provisions set forth above.

1
2
3 **SECTION NINE. SAVING CLAUSE**

4 The provisions of the Act which amend or adopt new sections of the Navajo Nation
5 Code shall be codified by the Office of Legislative Counsel. The Office of Legislative
6 Counsel shall incorporate such amended provisions in the next codification of the Navajo
7 Nation Code.
8

9 **SECTION TEN. CODIFICATION**

10 Should any provision of this Act be determined invalid by the Navajo Nation Supreme
11 Court or the District Courts of the Navajo Nation, without appeal to the Navajo Nation
12 Supreme Court, the remainder of the Act shall remain the law of the Navajo Nation.
13

14 **SECTION ELEVEN. EFFECTIVE DATE**

15 The provisions of this Act shall become effective in accordance with 2 N.N.C. § 221(B)
16 and 2 N.N.C. §§1005 (C) (10-12).

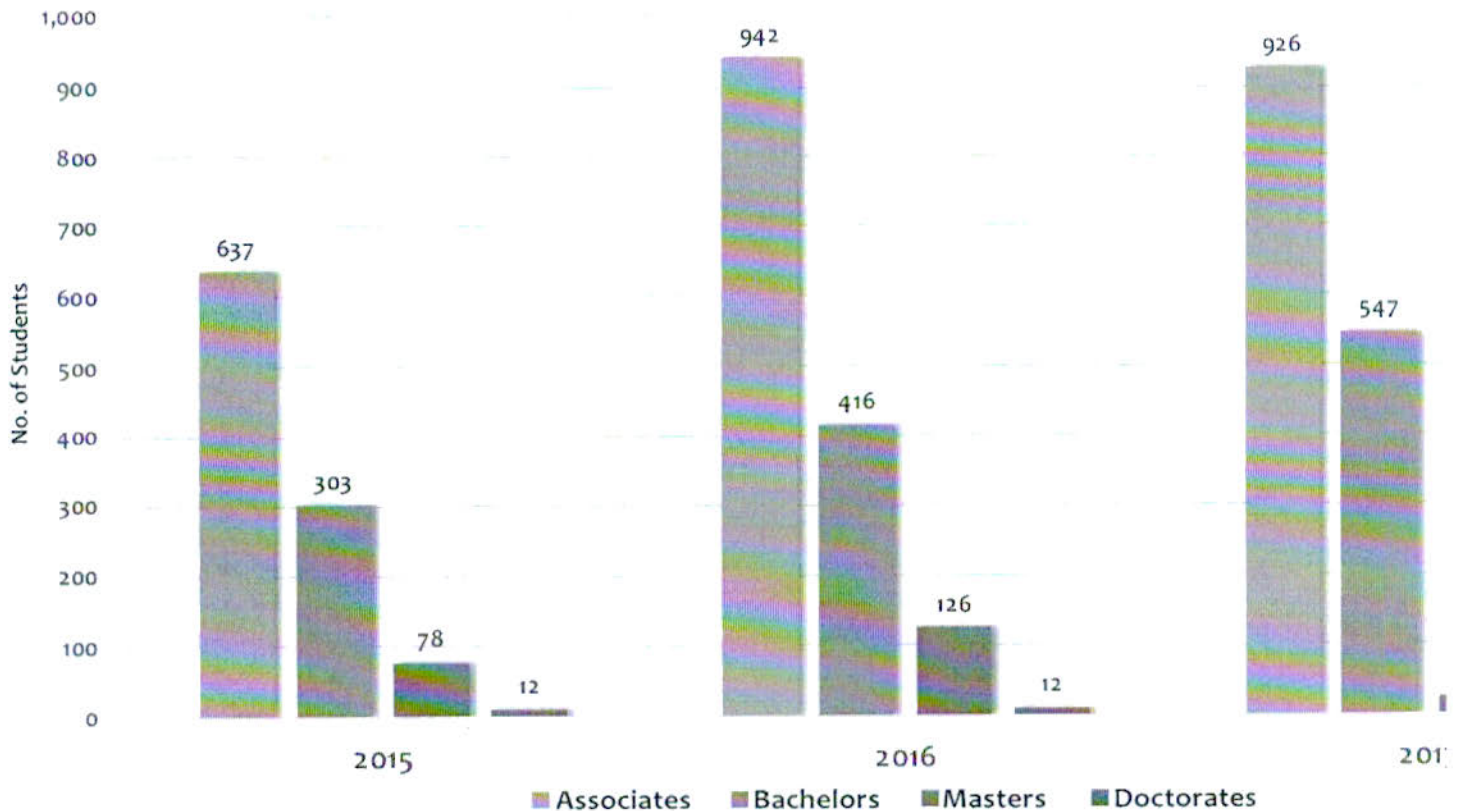

Types of Student Funding

Financial Need-Based Awards (up to \$2,000 per semester) Need-based funding is provided to students who demonstrate financial need according to the Financial Need Analysis (FNA) form submitted on their behalf by the school of attendance. Students in this category are deemed not to have sufficient personal or family resources to meet a college's or university's cost of attendance (e.g. tuition, books and housing). Awards of up to \$2,000 per semester or \$4,000 per academic year are provided to students	No-Need-Based Awards (\$500 per semester) No-need-based funding is provided to students, who are deemed to have enough resources to meet the cost of attendance at a college or university of their choice. 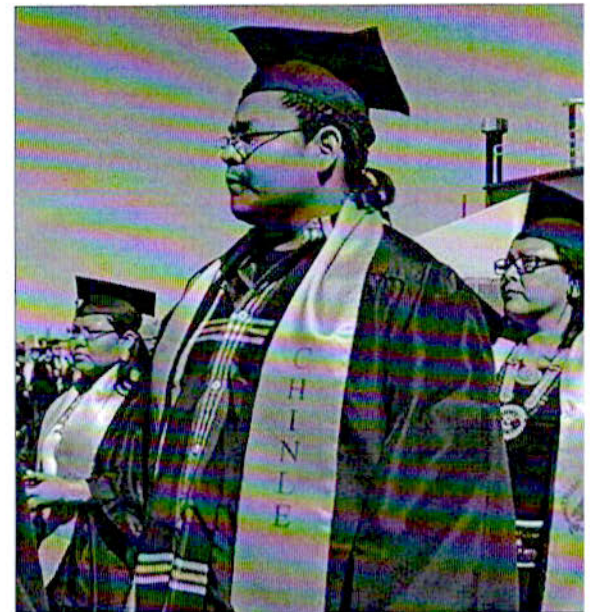
Education in 2017



1,594 Award Recipients Attain College Degrees

An increasing number of recipients attained college degrees/certifications in 2017. Data, compiled from 28 schools within the Four Corners region, revealed a total of 1,594 award recipients earned a degree or certificate. A total of 926 recipients attained an Associates/Certification, 547 attained a Bachelor degree, 27 earned a Master's degree and 94 earned a Doctorate degree in 2017.

Data was obtained from two- and four-year institutions including Arizona State University, Chandler-Gilbert Community College, Coconino Community College, Diné College, Estrella Mountain Community College, Fort Lewis College, Gateway Community College, Maricopa Community Colleges, Mesa Community College, Navajo Technical University, Northland Pioneer College, Paradise Valley Community College, Phoenix College, Rio Salado Community College, San Juan College, Scottsdale Community College, South Mountain Community College, Southern Utah University, University of New Mexico,

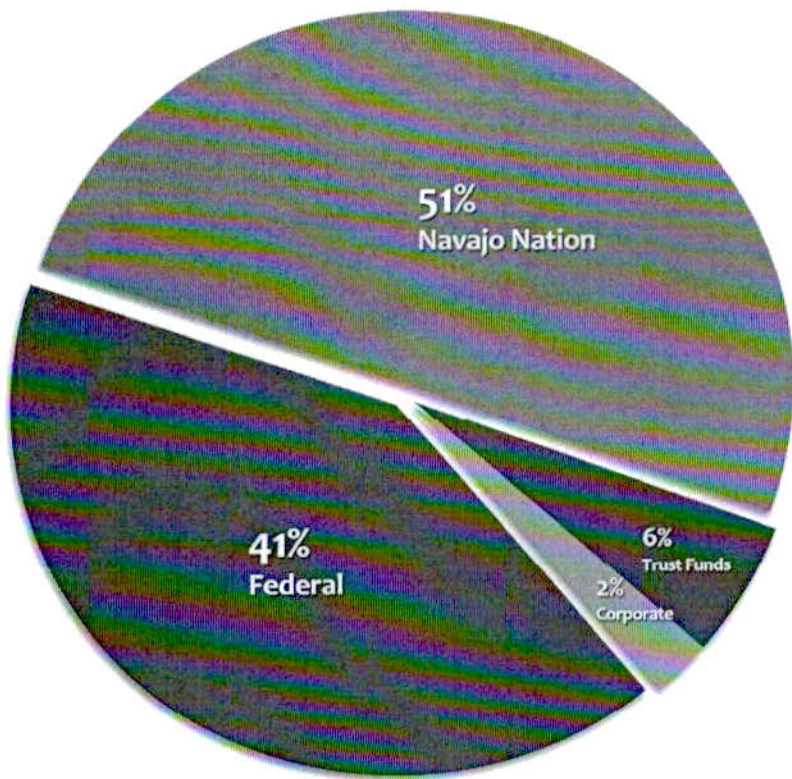

The total number of students who received awards from the four funding sources equated to 6,755. The total number of awards made from all funding sources amounted to 9,423. 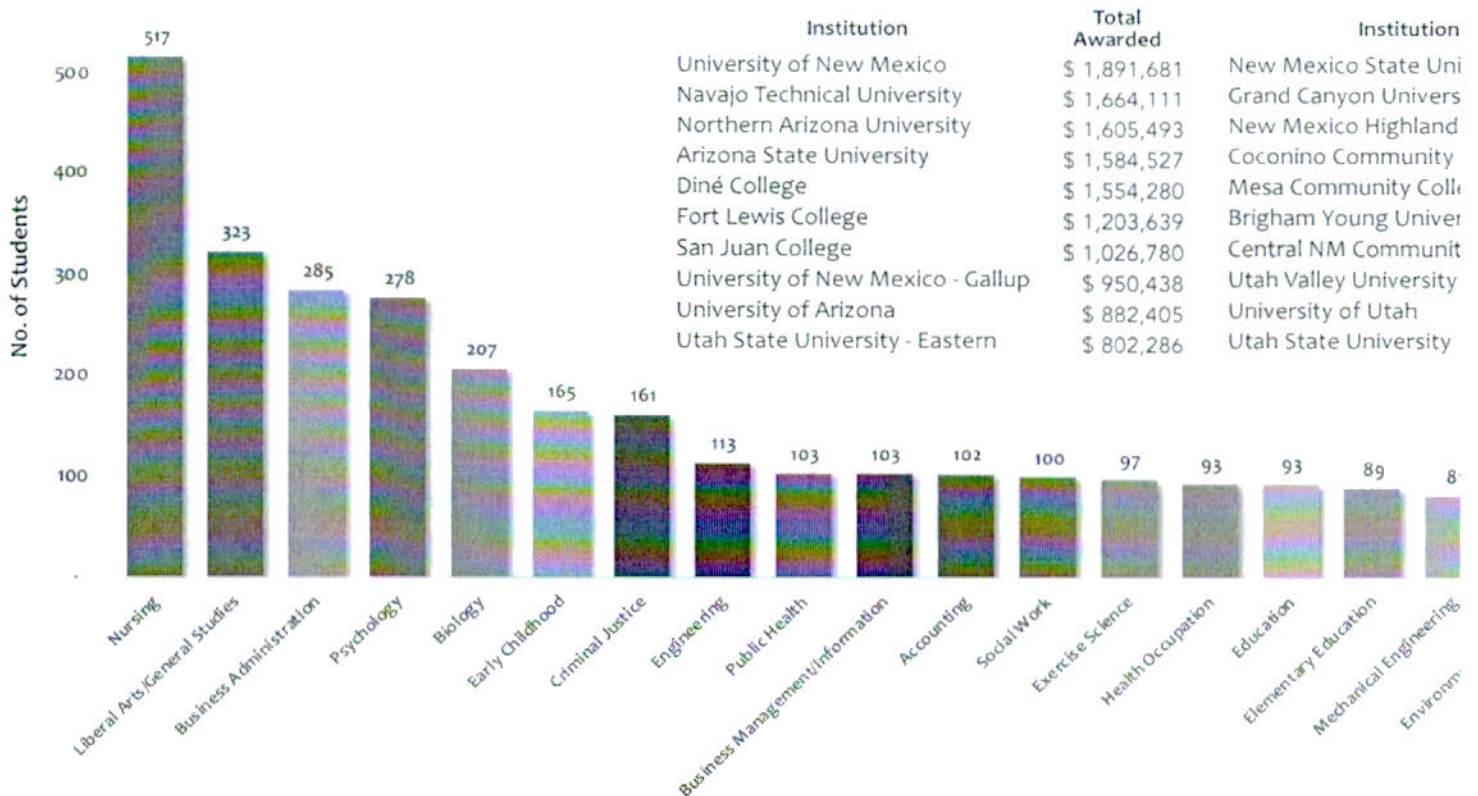

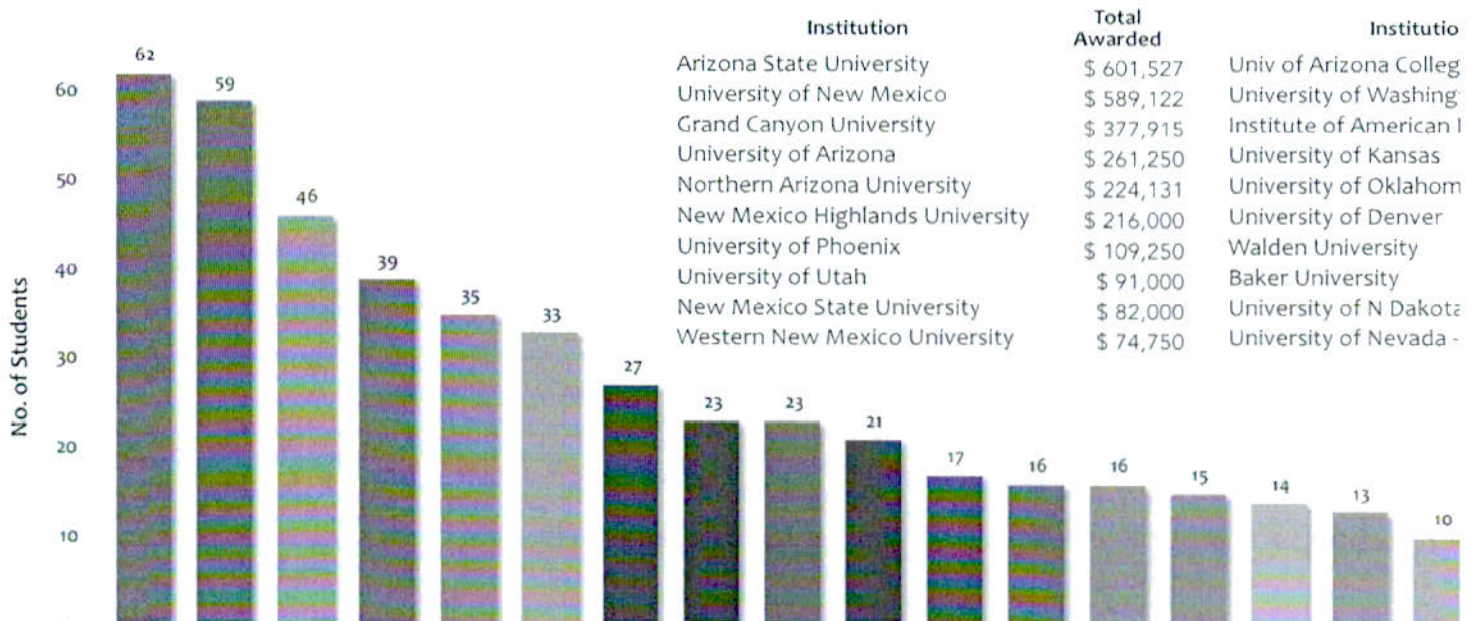

Chapter Affiliation

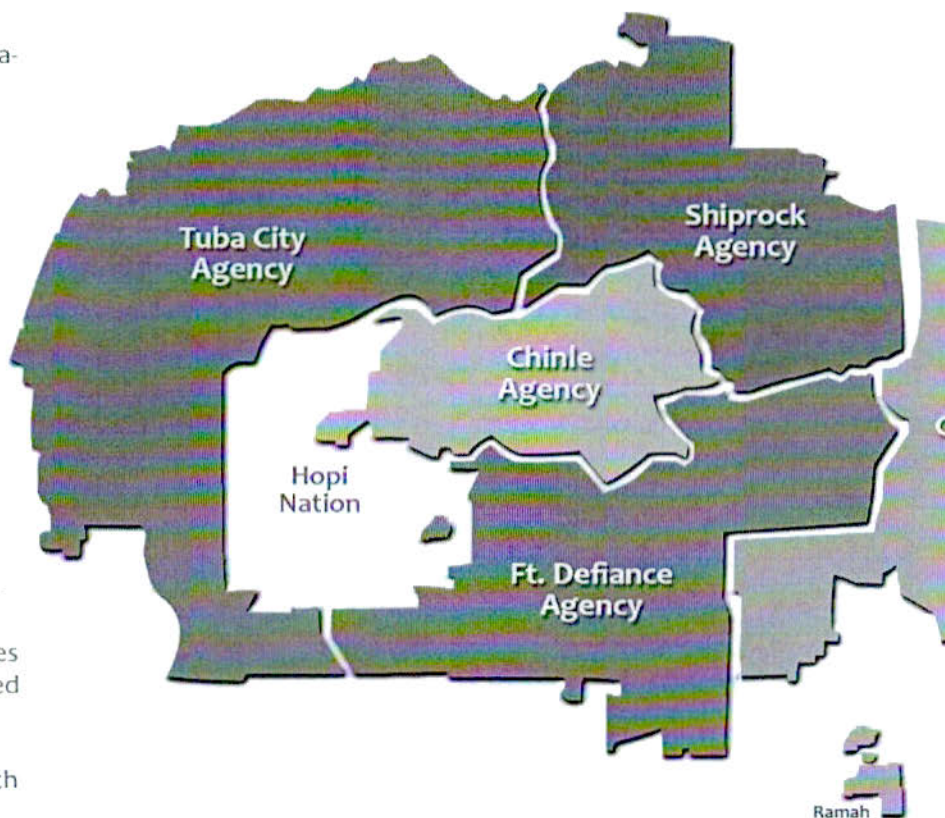
Students submitting an ONNSFA application are asked to state their chapter affiliation. This information is used to determine which agency office a student's file will be assigned to and for reporting purposes.

Choosing a Chapter

On occasion, students inquire about which of the Navajo Nation's 110 chapters they should state on the application. We encourage students to consider the chapter nearest to their residence or the chapter at which their parents are registered to vote.

Voter Registration

Students, who become registered voters on the Navajo Nation, have an opportunity to elect leadership at the chapter and national levels. Many Navajo Nation services and funds are divided among chapters based upon the number of registered voters and population. Financial Need-Based Awards

(up to \$2,500 per semester)

Need-based funding is provided to students who demonstrate financial need according to the Financial Need Analysis (FNA) form submitted on their behalf by the school of attendance. Students in this category are deemed not to have sufficient personal or family resources to meet a college's or university's cost of attendance (e.g. tuition, books and housing).

Awards of up to \$2,500 per semester or \$5,000 per academic year are provided to students based upon their individual need assessment. Primary funding sources of need-based awards are PL 93-638 funds and Navajo Nation Funds.

No-Need-Based Awards

(\$1,000 per semester)

No-need-based funding is provided to students, who are deemed to have enough resources to meet the cost of attendance at a college or university of their choice.

Chief Manuelito Scholarships

(\$3,500 per semester)

Merit-based scholarships are provided students, who achieve a high grade point average and a commensurate ACT or SAT college test score. Students are required to complete courses in Navajo Language (1 unit) and Navajo Government (½ unit) prior to the application deadline to be considered for this scholarship. Full-time undergraduate students may also qualify for the Chief Manuelito scholarship under the 24/3 rule by completing 24 credit hours of college-level courses with a 3.0 GPA.

Graduate Student Awards

(\$2,500 to \$5,000 per semester)

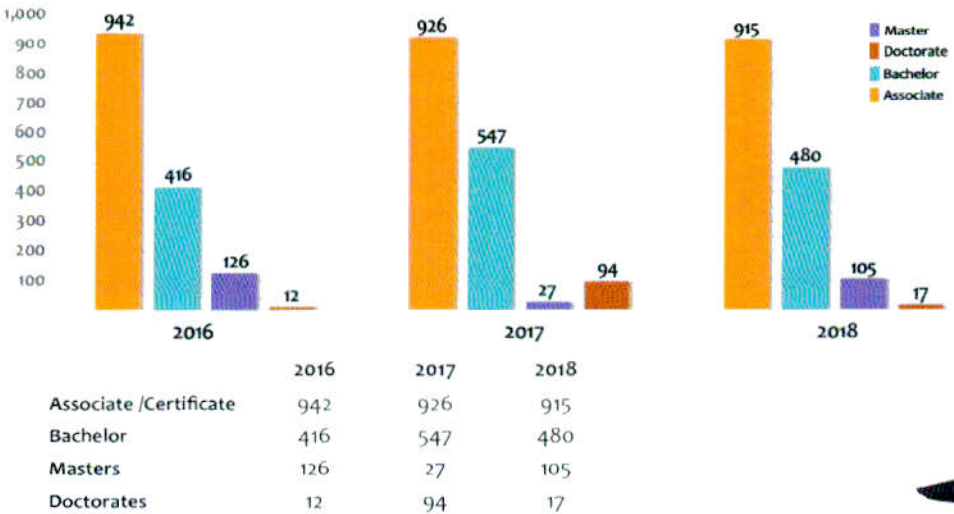
Grant awards are provided to Navajo students seeking graduate-level degrees.

Part-Time Undergraduate and Graduate Awards

Funding is available for eligible part-time undergraduate and graduate students. Part-time application requirements and award amounts vary.

awarded Navajo Nation financial assistance or scholarship from 2016 to 2018. A majority of the degrees were attained from institutions within the Four-Corners region.

Data was compiled from 28 schools within this area. Schools ranged from two-year to four-year institutions including: Arizona State University, Chandler Coconino Community College, Diné College, Fort Lewis College, Navajo Technical University, University of New Mexico, New Mexico State University, New Mexico Highlands University and Northern Arizona University.

Rising Numbers of Navajo College Students

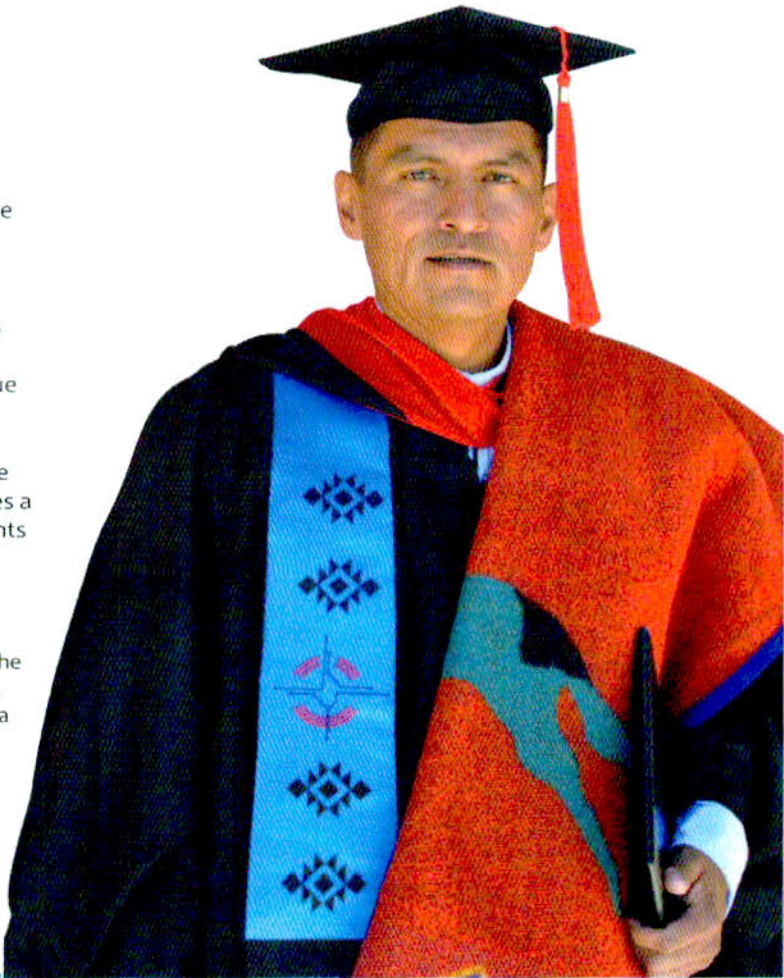
The number of Navajo students seeking a college degree continues to increase. From 2010 to 2018, a total of 125,175 students submitted applications for scholarships to the Office of Navajo Nation Scholarship & Financial Assistance.

Meanwhile an average of 56 percent of applicants were not funded. Funding for students is imperative as many students depend on financial assistance and scholarships from the Navajo Nation to help meet educational costs, which continue to rise significantly.

Thus, the ONNSFA continues to seek partnerships to increase resources to Navajo college student The table below provides a snapshot of the number of college degrees earned by students

LEFT Perry R. James of Continental Divide, NM received the first Master of Arts degree in Diné Culture, Language & Leadership at Navajo Technical University in 2016. NTU has since strengthened the program and several more have attained a Master of Arts Degree. The university has begun to take the initial steps in implementing a doctorate program.

The ONNSFA is proud to partner with NTU in providing up to \$2,500 per semester for full-time students pursuing a bachelor degree in any of NTU's ten bachelor degree program or up to \$5,000 per semester for students seeking a Masters degree. Funding under this agreement covers full-time enrollment for up to six continuous semesters. For information contact the NTU Admissions Office at 505.786.4100.

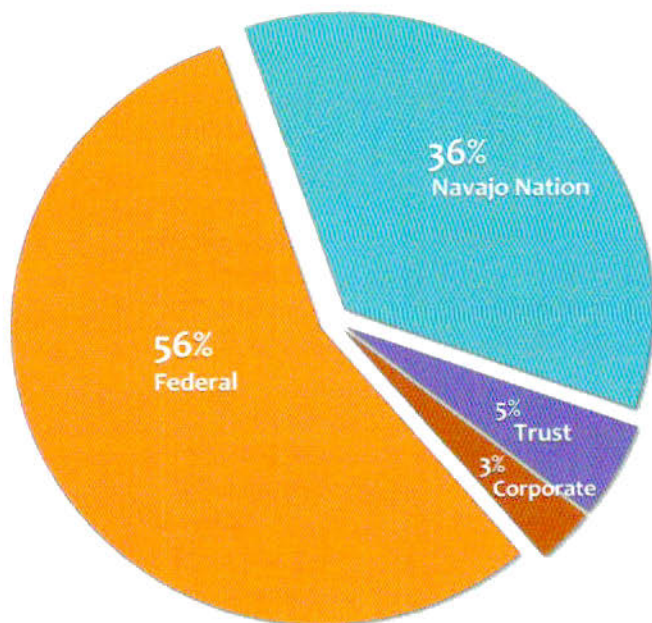

Federal funds, provided through a P.L. 93-638 contract with the Navajo Region Bureau of Indian Affairs, comprised about 56 percent of the funds awarded by the Navajo Scholarship Office. Federal funds are used to award undergraduate students with financial need

as determined by the student's Financial Need Analysis and also for merit-based awards to Chief Manuelito Scholars.

Navajo Nation General Funds comprised about 36 percent of scholarship funds. These funds are used to provide awards to graduate students, undergraduates and students enrolled in the Navajo Teacher Education program.

Interest revenue from trust funds comprised about 6 percent of funds awarded by ONNSFA in 2018. Policies for trust funds including the Graduate Trust Fund, the Navajo Engineering & Construction Authority Trust Fund, the

Vocational Education Trust Fund and Tucson Electric Funds stipulate that "10% of the fund [market value] shall be used as scholarship and financial assistance." Interest revenue from these sources fluctuate from year-to-year based upon market value.

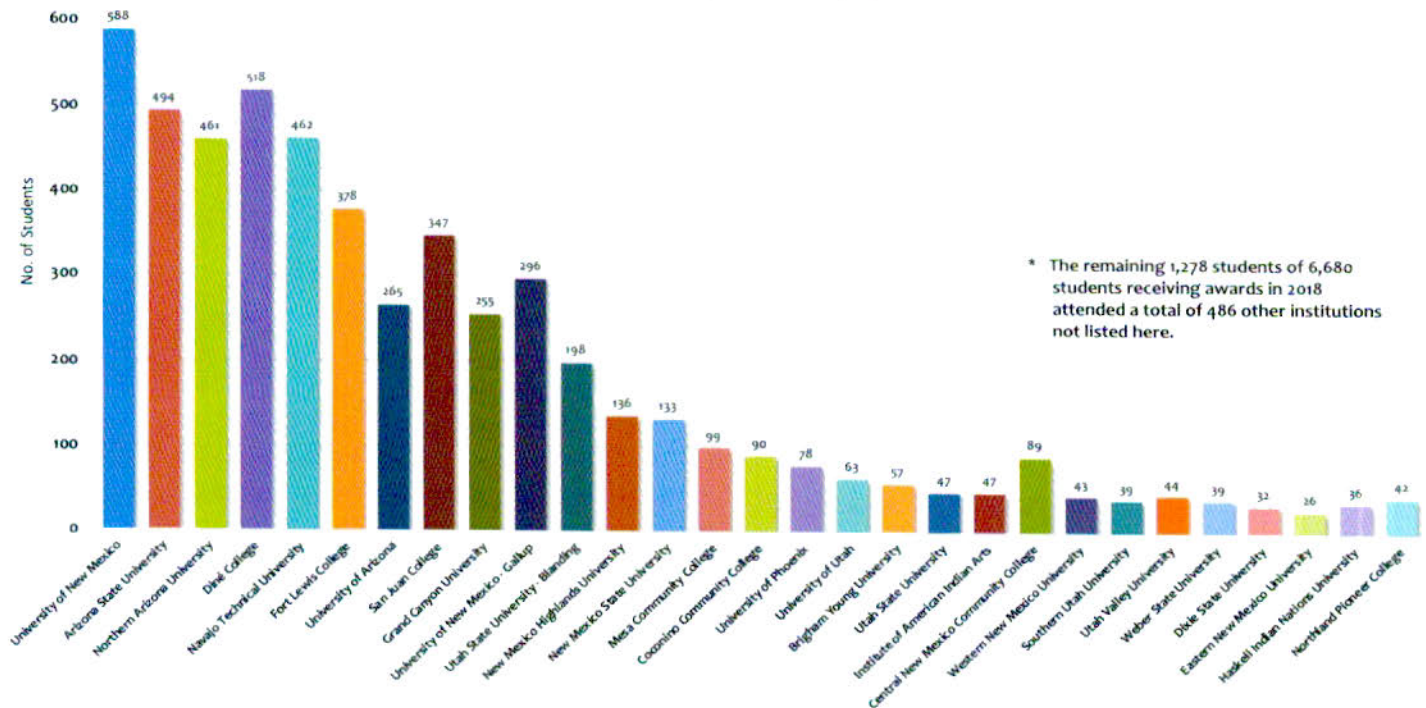

No. of Recipients at Top 29 Schools



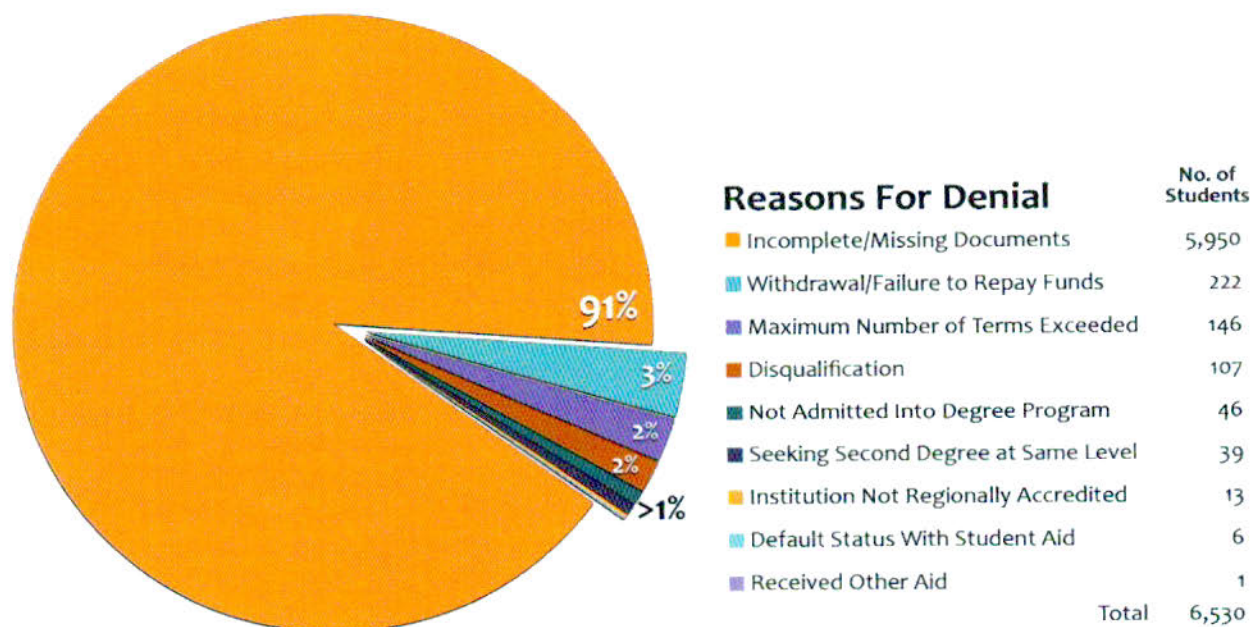
Awards to Students at 29 Schools Account for 81 Percent of Funds

2018 ONNSFA Denials



49 Percent of All Applicants Denied

In 2018, a total of 13,210 students applied to the Office of Navajo Nation Scholarship & Financial Assistance (ONNSFA).

Approximately 51 percent or 6,680 students who applied received an award. Another 49 percent or 6,530 applicants were denied. Applicants were denied for several reasons including:

Incomplete/Missing Documents

Ninety-one percent (5,950 students) either submitted incomplete applications or failed to provide all required documents.

Withdrawal/Failure to Repay Funds

Three percent or 222 applicants were denied due to outstanding debts to the ONNSFA arising from withdrawing from school without proper justification. All applicants with outstanding debts to the ONNSFA are disqualified.

Maximum Number of Terms Exceeded

Two percent or 146 applicants were denied due to exceeding the maximum number of terms which generally are:

- **Undergraduates:** Ten semesters or fifteen quarters;
- **Graduates:** Five semesters or seven quarters;
- **Two-Year Institutions:** Five academic terms or sixty-four semester credit hours, or equivalent amount of quarter or trimester credit hours.

Disqualification

Two percent or 107 applicants were denied due to violation of the ONNSFA's policies including not maintaining the required grade point average, repeating courses, or falsifying information.

Not Admitted Into Degree Program

A total of 46 applicants were denied due to not gaining admission to a degree program. Graduate applicants are required to submit a regular Letter of Acceptance to

the graduate program of study in addition to a Regular Letter of Admission from the graduate university.

Seeking Second Degree at Same Level

A total of 39 applicants were denied as they were requesting additional funds toward a second undergraduate, graduate or postgraduate degree at the same level.

Institute Not Regionally Accredited

A total of 13 applicants were denied as the institutions they sought to attend were not accredited by a regional accrediting association or the appropriate accrediting association for highly specialized majors.

Default Status With Student Aid

Six applicants were denied due to default status. Students who are in default on a federal student loan are ineligible for additional federal student aid.

Received Other Aid

One applicant was denied due to receiving aid for other sources.

Student Awards (by Chapter)

Chapter Affiliation

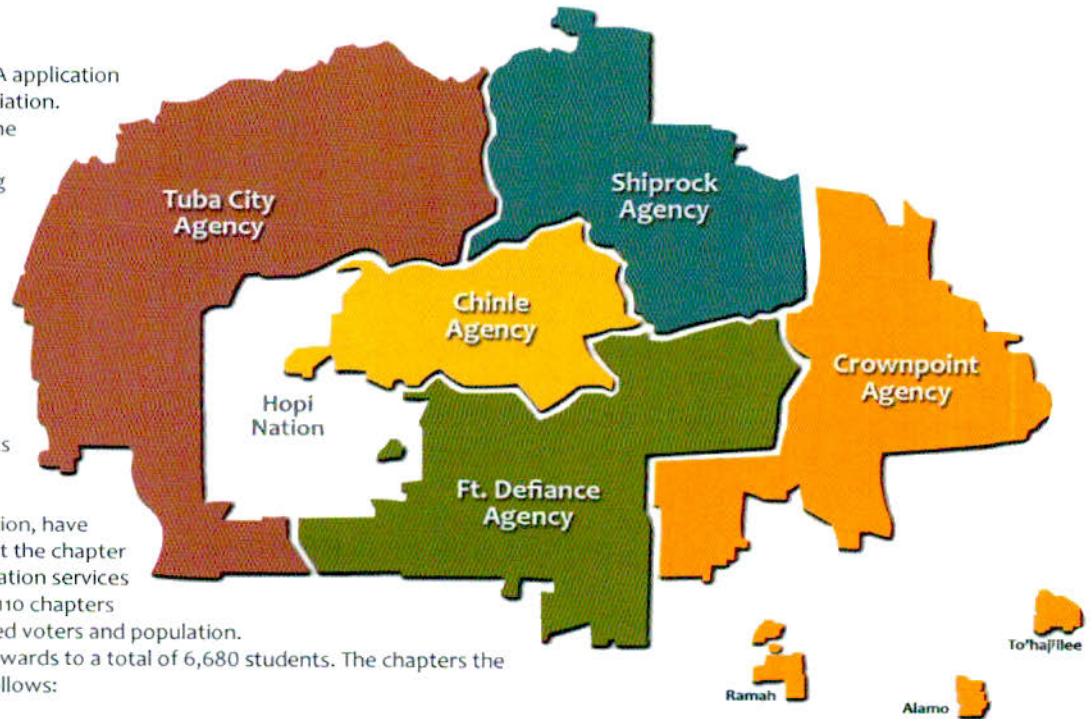
Students submitting an ONNSFA application are asked to state their chapter affiliation. This information is used to determine which agency office a student's file will be assigned to and for reporting purposes.

Choosing a Chapter

On occasion, students inquire about which of the Navajo Nation's 110 chapters they should state on the application. We encourage students to consider the chapter nearest to their residence or the chapter at which their parents are registered to vote.

Students, who become registered voters on the Navajo Nation, have an opportunity to elect leadership at the chapter and national levels. Many Navajo Nation services and funds are divided amongst the 110 chapters based upon the number of registered voters and population.

In 2018, the ONNSFA provided awards to a total of 6,680 students. The chapters the students are affiliated with are as follows:

This memo is in regards to Legislation 0238: ...Navajo Nation Scholarship Endowment... and 0263-19: ...Sihasin Higher Education initiative Fund.

First and foremost, Navajo Nation Scholarship Office receives Grants (used as scholarship funding) through annual Sales Tax appropriations and Interest income generated from its respective trusts. Dine College and Navajo Technical University receives regular annual appropriations (e.g. Higher Education). In FY 2019, the total funding for scholarships and colleges was approximately \$19 million. In recent years the funding amounts were:

Legislation 0238-19

Council will be acting on legislation 0238-19. This legislation is requesting \$50 million from the Sihasin Fund in order to increase additional Scholarships to Navajo Students. The Legislation aims to increase scholarship funding by utilizing interest income that is generated from the \$50 million contribution. Interest income will be the only source for scholarships. 95% of the interest income will be utilized for scholarships. Assuming 2% annual yield for income, 95% available for scholarship is \$950,000 and 5% to be reinvested is \$50,000. The fund will need to grow to have a substantial amount of interest to achieve 100% student funding.

Legislation 0263-19

This legislation is requesting \$60 million from the Sihasin fund. Dine College and Navajo Technical University would like to establish an Endowment Portfolio that will be administered by each of the School's respective Boards.

This legislation was referred back to the Health, Education, and Human Services Committee during a Budget and Finance Committee meeting that took place on October 18, 2019. Our office issued a memorandum on this legislation during the BFC meeting. The Legislation had inconsistencies with respect to the legislative intent and the administration of the endowments.

Administration of endowments.

In order to account for and administer the endowment return objectives, the requested amounts should they stay internally with the Nation's investment portfolio, will have to be separated from the Sihasin Fund. It would need to have its own fund management plan for the uses of the fund because the parameters of the fund are governed by the plan. In addition, it would be counter intuitive to have a plan within a plan.

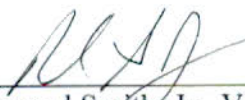

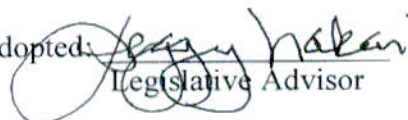

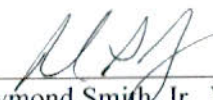
