## TITLE OF RESOLUTION: AN ACTION RELATING TO HEALTH EDUCATION AND HUMAN SERVICES, BUDGET AND FINANCE, LAW AND ORDER, AND NAABIK'ÍYÁTÍ COMMITTEES AND NAVAJO NATION COUNCIL; EXTENDING THE FUND LAPSE EXCEPTION TO THE ANNUAL APPROPRIATION TO THE VETERANS TRUST FUND, AS SET FORTH IN 12 N.N.C. § 1171 (B), THROUGH NAVAJO NATION FISCAL YEAR 2024

**PURPOSE:** If this resolution is approved, Veteran Trust Fund Housing Program funds will not lapse until the end of FY 2024.

This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each committee member to review the proposed resolution in detail.

9	SECTION TWO. FINDINGS
10	A. The Navajo Nation Veterans Trust Fund is set forth in the Navajo Nation Code
11	at 12 N.N.C. § 1171 et seq
12	B. The establishment section of the Navajo Nation Veterans Trust Fund states as
13	follows:
14	§ 1171. Establishment
15	A. The "Navajo Nation Veterans Trust Fund" hereinafter the "Trust Fund" is
16	established with an initial appropriation of six million dollars
17	(\$6,000,000.00) from revenues from Undesignated Tribal Reserves. Each
18	year, during the appropriation of the Navajo Nation Comprehensive
19	Budget, the Navajo Nation Council shall budget a sum equal to at least
20	four percent (4%) of any and all projected revenues of the Navajo Nation,
21	including, but not limited to revenues received from taxes, oil and gas,
22	mining and minerals, timber, land rentals, interest and dividends, gain on
23	sale of securities and other revenue producing activities. One-half (1/2) of
24	that four percent (4%) shall be transferred to the Navajo Veteran's Trust
25	Fund to be used as set forth herein. The remaining one-half (1/2) of that
26	four percent (4%) shall be administered by the Department of Navajo
27	Veteran's Affairs (DNVA). Each of the five (5) DNVA Agency offices
28	shall be allocated an equal share of that amount to provide construction of
29	up to fifteen (15) homes equitably in each of their respective Agencies
30	using all possible assistance program funds that such veterans may qualify

1	for to construct as many homes as possible and provide minor home
2	renovations and repairs for Navajo veterans.
3	B. The annual appropriation authorized above shall continue and for purposes
4	of this resolution, all unexpended funds shall not lapse back into the
5	Veterans Trust Fund through Fiscal Year 2017, and shall expire thereafter,
6	unless specifically re-authorized.
7	C. Navajo Nation Council Resolution No. CS-56-17, attached as Exhibit 1,
8	extended 12 N.N.C. § 1171 (B)'s exception to the fund lapse provision for
9	Veterans Housing Programs funds through Fiscal Year 2020.
10	D. Through NNVAC-10-20, attached as Exhibit 2, the Navajo Nation Veterans
11	Advisory Council has recommended that the exception to the fund lapse
12	provision for Veterans Housing Program funds be extended.
13	E. It is in the best interest of the Navajo Nation veterans and others effected that
14	the Navajo Nation specifically re-authorize the continued availability of
15	unexpended funds in the Navajo Nation Veterans Housing Program at the end
16	of Fiscal Year 2020 by extending their exemption from lapsing until the end of
17	Fiscal Year 2024.
18	
19	SECTION THREE. APPROVAL
20	The Navajo Nation hereby specifically re-authorizes, as required by 12 N.NC.
21	§ 1171 (B), the continued availability of unexpended funds in the Navajo
22	Nation Veterans Housing Program at the end of Fiscal Year 2020 by extending
23	such funds exemption from lapsing until the end of Fiscal Year 2024.

25	SECTION FOUR. EFFECTIVE DATE

#### 23<sup>RD</sup> NAVAJO NATION COUNCIL - THIRD YEAR, 2017

#### AN ACTION

RELATING TO HEALTH, EDUCATION AND HUMAN SERVICES, BUDGET AND FINANCE COMMITTEE, LAW AND ORDER, AND NAABIK'ÍYÁTI'COMMITTEE; REAUTHORIZING THE EXCEPTION TO FUND LAPSE REQUIREMENTS WITH RESPECT TO THE ANNUAL APPROPRIATION TO THE VETERANS TRUST FUND AS AMENDED AND PROVIDED FOR IN NAVAJO NATION COUNCIL RESOLUTION CS-48-13 AND AUTHORIZING EXTENDING THAT EXCEPTION FROM FUND LAPSE THROUGH FISCAL YEAR 2020

BE IT ENACTED:

#### Section One. Authority

- A. The Navajo Nation established the Health, Education and Human Services Committee (HEHSC) as a Navajo Nation Council standing committee and as such empowered HEHSC to review and recommend resolutions regarding veterans' services. 2 N.N.C. \$400(C)(3).
- B. The Budget and Finance Committee of the Navajo Nation Council is empowered to review and recommend to the Navajo Nation Council the budgeting, appropriation, investment, and management of all funds. 2 N.N.C. §300(8)(2).
- C. The Law and Order Committee of the Navajo Nation Council, pursuant to 2 N.N.C. §601 (B)(14), reviews and makes recommendations to the Navajo Nation Council proposed amendments to the Navajo Nation Code.
- D. The Naabik'íyáti' Committee of the Navajo Nation Council, pursuant to 2 N.N.C. \$164 (A)(9), reviews proposed legislation which requires final action by the Navajo Nation Council.

#### Section Two. Findings

- A. The Navajo Nation Council adopted Council Resolution CS-48-13, September 9, 2013 and such was signed by the President September 13, 2013. See Exhibit "A".
- B. Council Resolution CS-48-13 amended the Navajo Nation Veterans Trust Fund to provide for equal distribution of the annual comprehensive budgeted amount between the Navajo Nation Trust Fund and the Department of Navajo Veterans Affairs to construct up to 15 homes and to provide minor



renovation and repairs for Navajo veterans in each of the Five (5) Navajo Agencies. See Exhibit "A".

- C. In addition, Council Resolution CS-48-13 provided that the annual appropriation authorized by the Resolution continue for the purposes of the resolution and that all expended funds shall not lapse back into the Veterans Trust Fund through Fiscal Year 2017.
- D. The Navajo Nation Auditor General completed and presented an audit report of the Navajo Nation Veterans Administration-Veterans Housing Program in January 2017. Report 17-15
- E. The Auditor General's Report No. 17-15, called for numerous corrective actions and determined a substantial balance of unexpended funds remaining as the deadline of the end of Fiscal Year 2017 approaches.
- F. In order that the necessary funds remain available for proper use for the Veterans Housing Program and not lapse on September 30, 2017, the end of Fiscal Year 2017, it is necessary to specifically re-authorize, as required by CS-48-13, the continued availability of those funds by extending their exemption from the lapsing requirement until the end of Fiscal Year 2020.
- G. This proposed action is supported by the Northern Agency Veterans Organization and Fort Defiance Agency Veterans Organization. See Exhibit "B".
- H. It is in the best interest of the Navajo Nation that the Navajo Nation specifically re-authorize, as required by CS-48-13, the continued availability of such unexpended funds in the Navajo Nation Veterans Housing Program at the end of Fiscal Year 2017 by extending their exemption from the lapsing requirement until the end of Fiscal Year 2020.

#### Section Three. Approval

The Navajo Nation hereby specifically re-authorizes, as required by CS-48-13, the continued availability of such unexpended funds in the Navajo Nation Veterans Housing Program at the end of Fiscal Year 2017 by extending their exemption from the lapsing requirement until the end of Fiscal Year 2020. Prior to any additional distribution or expenditure of funds for its Veterans Housing Program, the Veterans Administration must complete the following items:

 The Veterans Administration is required to have the following documents approved by the Health, Education and Human Services Committee: (a) a Housing Action Plan,

(b) an amended Plan of Operation, and (c) amended Policies and Procedures that incorporate procedures about how the money will be expended for the Veterans Administration Housing Program. The Housing Action Plan contain practices designed to remediate the must Veterans Administration audit findings in order to implement the corrective action plan. The Housing Action Plan and the Veterans Administration's amended Policies and Procedures must include specific language allowing the Housing Program to contract with manufactured home builders and other vendors to fulfill program obligations.

- 2. The Housing Action Plan must contain the following sections: (a) purpose and objectives specific to housing for eligibility criteria, veterans, (b) (C) documentation required to satisfy the eligibility criteria, (d) the standard to which the homes will be built, such applicable building codes as and accessibility under the Americans with Disabilities Act, (e) contracting procedures that conform to the Navajo Nation Procurement Act (12 N.N.C § 301 et seq.), and (f) accounting, expenditure, and cash control procedures.
- As part of the corrective action plan approved through 3. Resolution BFAU-24-17, the Veterans Administration must submit a written status report to the Office of the Auditor General and the Chief of Staff, Office of the President and Vice-President six months after the approval of the corrective action plan. If the plan is not submitted or if the Veterans Administration has not implemented a majority of the corrective action plan, the Office of the Auditor General shall immediately report this to both the Budget and Finance Committee and the Health, Education and Human Services Committee. Failure to report to the Office of the Auditor General will result in the termination of any future fund disbursements to the Veterans Administration to fund the Veterans Housing Program.
- 4. The Office of the Controller is directed to ensure the Veterans Administration has satisfied the conditions set forth in subsections 1-3 above prior to any disbursements to the Veterans Administration for the Veterans Housing Program.

#### Section Four. Effective Date

This legislation shall become effective in accordance with 2 N.N.C. § 221(B).



RELATING TO HEALTH, EDUCATION AND HUMAN SERVICES, BUDGET AND FINANCE, LAW AND ORDER, AND NAABIK'ÍYÁTI' COMMITTEE; AMENDING THE NAVAJO NATION VETERANS TRUST FUND, 12 N.N.C. §1171 TO PROVIDE FOR EQUAL DISTRIBUTION OF THE ANNUAL COMPREHENSIVE BUDGETED AMOUNT BETWEEN THE NAVAJO NATION VETERANS TRUST FUND AND THE DEPARTMENT OF NAVAJO VETERANS AFFAIRS TO CONSTRUCT UP TO 15 HOMES AND TO PROVIDE MINOR RENOVATION AND REPAIRS FOR NAVAJO VETERANS IN EACH OF THE FIVE (5) NAVAJO AGENCIES

BE IT ENACTED:

#### Section 1. Findings and Purpose

The Navajo Nation finds it to be in the best interest of the Navajo Nation and the Navajo people to hereby amend the Navajo Nation Veterans Trust Fund, 12 N.N.C. §1171, in order to provide equal distribution of the annual comprehensive budgeted amount between the Navajo Nation Veterans Trust Fund and the Department of Veterans Affairs to provide for veterans' housing for each of the five Agencies. 2% Navajo Veterans Trust Funds, Allocation for Home Construction Proposal August 2013, attached hereto as Exhibit A.

## Section 2. Navajo Nation Veterans Trust Fund Amendment

The Navajo Nation amends the Navajo Nation Veterans Trust Fund, 12 N.N.C. §1171, as follows:

## Chapter 10, Navajo Nation Trust Fund Subchapter 8. Navajo Nation Veterans Trust Fund

#### § 1171. Establishment.

A. The "Navajo Nation Veterans Trust Fund" hereinafter the "Trust Fund" is established with an initial appropriation of six

million dollars (\$6,000,000) from revenues from the Undesignated Tribal Reserves. Each year, during the appropriation of the Navajo Nation Comprehensive Budget, the Navajo Nation Council shall budget a sum equal to at least 4% of any and all projected revenues of the Navajo Nation, including, but not limited to revenues received from taxes, oil and gas mining and minerals, timber, land rentals interest and dividends, gain on sale of securities and other revenue producing activities. One-half of that 4% shall be transferred to the Navajo Veteran's Trust Fund to be used as set forth herein. The remaining one-half of that 4% shall be administered by the Department of Navajo Veteran's Affairs (DNVA). Each of the five (5) DNVA Agency Offices shall be allocated an equal share of that amount to provide construction of up to 15 homes equitably in each of their respective agencies using all possible assistance program funds that such veterans may qualify for to construct as many homes as possible and provide minor home renovations and repairs for Navajo Veterans.

B. The annual appropriation authorized above shall continue and for purposes of this resolution, all unexpended funds shall not lapse back into the Veterans Trust Fund through Fiscal Year 2017, and shall expire thereafter, unless specifically re-authorized.

#### Section 3. Effective Date

The amendments enacted herein shall be effective pursuant to 2 N.N.C. § 221(B).

#### Section 4. Codification

The provisions of this Act which amend or adopt new sections of the Navajo Nation Code shall be codified by the Office of Legislative Council. The Office of Legislative Counsel shall incorporate such amended provisions in the next codification of the Navajo Nation Code.

#### Section 5. Savings Clause

Should any portion of the amendment enacted herein be determined invalid by the Navajo Nation Supreme Court, or the District Court of the Navajo Nation, without appeal to the Navajo Nation Supreme Court, those portions not determined invalid shall remain the law of the Navajo Nation.

- 2. Pursuant to Navajo Nation Council Resolution CMA-25-71; The Navajo Veterans were recognized and an Navajo Nation Veterans Administration was established under the Executive Branch of the Navajo Nation Government- Office of the President and Vice President of the Navajo Nation; and
- 3. The Ft. Defiance Agency Veterans Organization is duly recognized by the Navajo Nation with a Plan of Operation to address the issues, concerns and advocate for all Navajo Veterans; and



## SECTION THREE, AMENDMENT TO TITLE 12

The Navajo Nation amends the Navajo Nation Code 12 N.N.C. § 1171, as follows:

## <u>NAVAJO NATION CODE ANNOTATED</u> <u>TITLE 12. FISCAL MATTERS</u> <u>CHAPTER 10. NAVAJO NATION TRUST FUNDS</u> <u>SUBCHAPTER 8. NAVAJO NATION VETERANS TRUST FUND</u>

#### \*\*\*

§ 1171. Establishment

A. The "Navajo Nation Veterans Trust Fund" hereinafter the "Trust Fund" is established with an initial appropriation of six million dollars (\$6,000,000.00) from revenues from Undesignated Tribal Reserves. Each year, during the appropriation of the Navajo Nation Comprehensive Budget, the Navajo Nation Council shall budget a sum equal to at least four percent (4%) of any and all projected revenues of the Navajo Nation, including, but not limited to revenues received from taxes, oil and gas, mining and minerals, timber, land rentals, interest and dividends, gain on sale of securities and other revenue producing activities. One-half (1/2) of that four percent (4%) shall be transferred to the Navajo Veteran's Trust Fund to be used as set forth herein. The remaining one-half (1/2) of that four percent (4%) shall be transferred to the Navajo Veteran's Trust Fund to be used as set forth herein. The remaining one-half (1/2) of that four percent (4%) shall be administered by the Department of Navajo Veteran's Affairs (DNVA). Each of the five (5) DNVA Agency offices shall be allocated an equal share of that amount to provide construction of up to fifteen (15) homes equitably in each of their respective Agencies using all possible assistance program funds that such veterans may qualify for to construct as many homes as possible and provide minor home renovations and repairs for Navajo veterans. Navajo Veterans shall be eligible to use veterans housing funds as a down payment on a mortgage.

B. The annual appropriation authorized above shall continue and for purposes of this resolution, all unexpended funds shall not lapse back into the Veterans Trust Fund through Fiscal Year 2017, and shall expire thereafter, unless specifically re-authorized.

## SECTION FOUR. CODIFICATION

The provisions of the Act which amend or adopt new sections of the Navajo Nation Code shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel shall incorporate such amended provisions in the next codification of the Navajo Nation Code.

## SECTION FIVE. SAVING CLAUSE

Should any provision of this Act be determined invalid by the Navajo Nation Supreme Court or the District Courts of the Navajo Nation, without appeal to the Navajo Nation Supreme Court, the remainder of the Act shall remain the law of the Navajo Nation.

Renumber or re-letter succeeding paragraphs or sections accordingly, if necessary; and this amendment shall supersede inconsistent language contained in any other committee amendment, which shall be conformed to the intent or language of this amendment.
