TITLE OF RESOLUTION: AN ACTION RELATING TO HEALTH EDUCATION AND HUMAN SERVICES, BUDGET AND FINANCE AND NAABIK'ÍYÁTI' COMMITTEES AND NAVAJO NATION COUNCIL; ADOPTING THE SÍHASIN FUND INDIVIDUALS WITH DISABILITIES EXPENDITURE PLAN PURSUANT TO CD-68-14 AND 12 N.N.C §§ 2501 – 2508

PURPOSE: This resolution, if approved, will approve the Individuals with Disabilities expenditure plan for funding to the Navajo Nation Trust Fund for Handicapped Services for grants to supplement Navajo Nation government and non-Navajo government projects for opportunities for Navajo members with disabilities.

This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each committee member to review the proposed resolution in detail.

18	A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C.	
19	§ 102 (A).	
20	B. The Naabik'iyati' Committee of the Navajo Nation Council is empowered to review	
21	all proposed legislation which requires final action by the Navajo Nation Council. 2

Section Two. Findings

- A. On May 30, 2014, the 22nd Navajo Nation Council adopted Resolution No. CMY-28-14 accepting a settlement of the Navajo Nation's lawsuit, *Navajo Nation v. United States*, No. 06-945L (United States Court of Federal Claims) against the United States for its historical mismanagement of the tribe's trust assets and its failure to ensure that the Navajo Nation received all funds due and owed under the United States' trust obligations and fiduciary duties. Resolution No. CMY-28-14 was signed into law by the President of the Navajo Nation on June 4, 2014.
- B. The 22nd Navajo Nation Council recognized that during the many decades that the United States was in breach of its trust obligations and fiduciary duties to the Nation, the tribal government was without funds to develop the comprehensive nation-wide infrastructures necessary to support and promote community growth and sustainability through the expansion of economic development, as well as to provide the educational opportunities, critical for the prosperity of current and future generations of Diné. See Resolution No. CMY-28-14.
- C. Between October 6, 2014 and November 8, 2014 the Office of the Speaker held seven (7) Public Hearings, as directed by the Navajo Nation Council's Naabik'iyati' Committee on July 10, 2014, to receive input from Navajo Nation members on how the net proceeds from *Navajo Nation v. United States*' should be used. During that same time period, the Office of the President & Vice-President also held five (5) town hall meetings for a similar purpose.
 - D. On December 13, 2014, the 22nd Navajo Nation Council adopted Resolution No.
 CD-68-14 enacting the Navajo Nation Breach of Trust Settlement Act of 2014 (hereinafter "2014 Act") and establishing the Navajo Nation Síhasin Fund at 12 N.N.C. § 2501 et seq. The President of the Navajo Nation signed Resolution No.
 CD-68-14 into law on December 31, 2014.
- E. The 2014 Act mandated that the net proceeds and earnings thereon received by the Navajo Nation from the settlement of *Navajo Nation v. United States*, No. 06-945L, and that, when duly designated, the net proceeds of settlements or judgement

awards of other litigation(s) brought against the United States concerning its failure to ensure that the Navajo Nation received all funds due and owing under the United States' trust obligations and fiduciary duties, be deposited into the Síhasin Fund and managed and invested to provide financial support and/or financing for (1) the planning and development of regional infrastructure supporting economic and community development, including housing, within the Navajo Nation; and/or (2) education opportunities for members of the Navajo Nation. See 12 N.N.C § 2501 and § 2502 (A).

- F. The 2014 Act also established that "leveraging of the [Síhasin] Fund by way of guaranteeing loans, match funding, direct funding in part and other weighted uses of the Fund shall be favored over direct funding in whole". 12 N.N.C § 2502 (B).
- G. The 2014 Act further established that with the exception of outstanding and accrued litigation costs, Síhasin Fund Principal and Income shall only be expended pursuant to a Fund Expenditure Plan consistent with the purposes set forth in the 2014 Act at 12 N.N.C. §2502 and adopted by a two-thirds (2/3) vote of all members of the Navajo Nation Council. See 12 N.N.C. § 2505 (A).
- H. The 2014 Act states that "Fund Principal" shall consist of all deposits made to the Síhasin Fund and that "Fund Income" shall consist of all earnings (interest, dividends, etc.) generated and realized by the Fund Principal and that Fund Income shall be deposited in and added to Fund Principal until such time as a Fund Expenditure Plan is duly adopted. See 12 N.N.C. §§ 2504 and 2505 (c).
- I. The Office of the Controller reported that as of January 1, 2016, the amount of the Síhasin Fund Principal is Four Hundred Eighty Seven million Nine Hundred Ninety Thousand Eight Hundred Forty One Dollars and Ninety One Cents (\$487,990,841.91) with interest earnings of Four Hundred Fifty Eight Thousand Four Hundred Thirty One Dollars and Seventy Five Cents (\$458,431.75).
- J. On April 9, 2015, the Naabik'íyáti' Committee adopted NABIAP-20-15 establishing the Naabik'íyáti' Síhasin Fund Subcommittee to "review and evaluate the Public Hearing comments and recommendations from the Navajo People" and "recommend to the Naabik'íyáti' Committee and Navajo Nation Council financial

support and/or financing plan(s) for the purposes designated in CD-68-14 [Navajo Nation Breach of Trust Settlement Act of 2014, establishing the Síhasin Fund]".

K. Between April 2015 and December 2016, the Síhasin Fund Subcommittee, assisted by the Office of Legislative Services, Office of the Speaker, and Office of Legislative Counsel, met on at least twenty-five (25) occasions in either work sessions or official meetings to review and evaluate the Public Hearing comments and recommendations from the Navajo People; hear proposals from Navajo Nation entities, chapters, programs and officials; and develop an expenditure plan(s) for the Síhasin Fund Principal and Income consistent with the purposes set forth in the 2014 Act.

- L. The Síhasin Fund Subcommittee determined that for an expenditure plan to fully meet the leveraging criteria of the 2014 Act, the expenditure plan shall not rely on Síhasin Funds for full direct project funding, unless such funds are to be repaid under a loan agreement, and instead must utilize the Síhasin Funds for (1) match funding, joint funding, contribution funding, cost-share funding or similar weighted uses of the funds; (2) reimbursement funding; and/or (3) loan or bond financing or guarantee.
- M. The Síhasin Fund Subcommittee also determined that the 2014 Act allowed for the adoption of multiple expenditure plans and that it would be prudent for the Navajo Nation to adopt integrated, yet distinct, expenditure plans for regional-level infrastructure planning and development in four broad infrastructure areas or categories consistent with the purposes of the 2014 Act: Water and Natural Resource Infrastructure Development; Economic Development; Community Development; and Housing Development.
- N. After reviewing the comments submitted during the Public Hearings and town hall meetings, as well as the reports and comments made during the Síhasin Fund Subcommittee meetings, the Subcommittee determined that the Navajo people were supportive of community development allocations for human services, including but not limited to support for individuals with disabilities.

O. In addition, the Toadlena/Two Grey Hills and Pine Dale Chapters adopted resolutions, attached as Exhibit A, supporting the allocation of Síhasin Funds for services for individuals with disabilities.

- P. In 1986, the Navajo Nation established the Navajo Nation Trust Fund for Handicapped Services, 12 N.N.C. §§ 1101-1108, wherein "95% of the Fund income shall be used as Navajo Nation grants to supplement Navajo Nation government and non-Navajo Nation government programs and projects that provide services to Navajo handicapped citizens." 12 N.N.C. § 1105(A).
- Q. The Síhasin Fund Subcommittee has determined that Síhasin Funds could lawfully be added to the Navajo Nation Trust Fund for Handicapped Services if the interest earnings (Fund income) derived from the added Síhasin Funds were segregated and only expended for (a) projects that meet the requirements of the Síhasin Fund purposes, i.e., (1) the planning and development of regional infrastructure supporting economic and community development, including housing, within the Navajo Nation; and/or (2) education opportunities for members of the Navajo Nation; and (b) projects that leverage Síhasin Funds with other funds, such as federal and state funding for individuals with disabilities, Medicaid and Medicare, private insurance, Navajo Nation Trust Fund for Handicapped Services non-Síhasin Fund-derived income, etc.
- R. The Síhasin Fund Subcommittee determined that the Navajo Nation Office of Special Education and Rehabilitation Services, within the Navajo Nation Department of Díne Education, and the Navajo Nation Council on the Handicapped, 13 N.N.C. §§ 4801-4809, have the expertise to recommend and administer the expenditure of Síhasin Funds for the benefit of individuals with disabilities consistent with the purposes and leveraging requirements set forth in 12 N.N.C. § 2502 pursuant to an annual plan adopted by the Health Education and Human Services Committee.
- S. The Síhasin Fund Subcommittee has also determined that allocating and adding ten million dollars (\$10,000,000.00) of Síhasin Funds to the Navajo Nation Trust Fund for Handicapped Services for the purposes of the planning and development of

regional infrastructure *specifically for individuals with disabilities* supporting economic and community development, including housing, within the Navajo Nation; and/or (2) education opportunities for members of the Navajo Nation *with disabilities* is within the purposes of the 2014 Act.

- T. The Síhasin Fund Subcommittee additionally determined that it was in the best long-term interest of the Navajo Nation and the Navajo people to provide financial support to individuals with disabilities and recommends to the Navajo Nation Standing Committees and the Navajo Nation Council that ten million dollars (\$10,000,000.00) of Síhasin Funds be allocated for and added to the Navajo Nation Trust Fund for Handicapped Services as the Síhasin Fund Individuals With Disabilities Expenditure Plan, as set forth in sections Three and Four below, under section 2505 of the 2014 Act.
 - U. After considering the recommendations of the Síhasin Fund Subcommittee, the Navajo Nation Council hereby determines that the Síhasin Fund Individuals With Disabilities Expenditure Plan fits within the priorities established under the July 20, 2015 <u>One Nation, One Voice</u> Navajo Nation Three Branch Agreement and that it is in the best interests of Navajo individuals and their families, as well as in the best interests of economic and community development, including housing, within the Navajo Nation, as well as education opportunities for Navajo members, to fund the Síhasin Fund Individuals With Disabilities Expenditure Plan, as set forth in sections Three and Four below.

Section Three. Approval and Adoption of Expenditure Plan

- A. The Navajo Nation hereby approves and adopts the Síhasin Fund Individuals With Disabilities Expenditure Plan wherein ten million dollars (\$10,000,000.00) of Síhasin Funds will be transferred to and deposited in the Navajo Nation Trust Fund for Handicapped Services during Navajo Nation Fiscal Year 2017.
- B. The Navajo Nation hereby approves and adopts that each year 95% of the Fund income attributable to the Síhasin Funds deposited in the Nation Trust Fund for Handicapped Services shall be used as Navajo Nation grants to supplement Navajo

Nation government and non-Navajo Nation government projects that provide services to Navajo individuals with disabilities specifically for the purposes of (1) the planning and development of regional infrastructure supporting economic and community development, including housing, within the Navajo Nation; and/or (2) education opportunities for Navajo members with disabilities.

- C. The Navajo Nation hereby approves and adopts that interest earnings or income attributable to the Síhasin Funds deposited in the Nation Trust Fund for Handicapped Services shall be leveraged by way of match funding, direct funding in part and/or other weighted or supplemental uses and shall be not used as direct funding in whole for any project.
- D. The Síhasin Funds allocated for the Síhasin Fund Individuals With Disabilities Expenditure Plan may be further leveraged by bond or loan financing pursuant to the Navajo Nation Bond Financing Act, 12 N.N.C. § 1300 et seq., as amended, using other Síhasin Fund Earnings for repayment and financing costs upon the recommendation of the Budget & Finance Committee and approval by a two-thirds (2/3) vote of all members of the Navajo Nation Council.

Section Four. Approval and Adoption of Expenditure Plan Administration

- A. The Navajo Nation hereby approves administration of the Síhasin Fund Individuals
 With Disabilities Expenditure Plan as follows:
 - The Navajo Nation Controller shall determine whether the source of the allocated ten million dollars (\$10,000,000.00) will be Síhasin Fund Principal or Income or a combination of both;
 - 2. The Síhasin Fund transferred to the Navajo Nation Trust Fund for Handicapped Services shall be invested and managed consistent with the Navajo Nation Trust Fund for Handicapped Services statute, 12 N.N.C. §§ 1101-1108, but the interest earnings or income from such Síhasin Funds shall be segregated and may only be expended for projects that meet *all* the requirements of 12 N.N.C. § 2502.

- 3. The interest earnings or income from Síhasin Funds in the Navajo Nation Trust Fund for Handicapped Services shall only be expended pursuant to an annual plan developed and recommended by the Navajo Nation Office of Special Education and Rehabilitation Services, within the Navajo Nation Department of Díne Education, concurred to by the Navajo Nation Council on the Handicapped and adopted by the Health Education and Human Services Committee of the Navajo Nation Council.
- 4. The Navajo Nation Office of Special Education and Rehabilitation Services shall account for and be held accountable for the expenditure of interest earnings and income attributable to the Síhasin Funds with such expenditures audited on an annual basis by either an independent auditor or the Office of the Auditor General with such audit report submitted to the Health Education and Human Services Committee, Naabik'íyáti' Committee, Office of the Controller, and Office of the President and Vice-President.
- B. The Navajo Nation Office of Special Education and Rehabilitation Services shall report the status of all projects funded by interest earnings and income attributable to the Síhasin Funds to the Naabik'íyáti' Committee and Office of the President and Vice-President on a quarterly basis.
- Section Five. Effective Date

The Síhasin Fund Individuals With Disabilities Expenditure Plan, as set forth above, shall become effective pursuant to 12 N.N.C. § 2505.

Section Six. Directives

A. All Navajo Nation programs, specifically including, but not limited to, the Office of Special Education and Rehabilitation Services, Navajo Nation Department of Dine Education, Navajo Nation Council on the Handicapped, Office of Controller, and Office of Management & Budget, shall take all steps necessary to expeditiously implement the Sihasin Fund Individuals with Disabilities Expenditure Plan consistent with the provisions set forth above. B. Navajo Nation programs named in this legislation shall be held accountable for the progress of tasks under their responsibility and control and shall report on a semiannual basis to the Naabik'íyáti' Committee on the progress of their respective tasks.

SUPPORTING AND RECOMMENDING THE NAVAJO NATION REQUEST THE NAVAJO NATION COUNCIL TO ALLOCATE TEN MILLION DOLLARS (\$10,000,000.00) FROM THE SIHASIN FUND TO THE NAVAJO HANDICAP TRUST FUND

WHEREAS:

- Toadlena/Two Grey Hills Chapter is a certified Chapter that is recognized by the Navajo Nation Council pursuant to 26 N.N.C. Section 3 and pursuant to 11 N.N.C. Part 1 Section 10, the Navajo Nation Council adopted the Navajo Nation Local Government Act which directs local Chapters to promote all matters that affect he local community members and to make appropriate decisions, recommendations, and advocate on their behalf; AND
- 2. The **Toadlena/Two Grey Hills Chapter** finds on December 29, 2006 the Navajo Nation filed suit against the United States in the U.S. Court of Federal Claims seeking monetary damages from the federal government for its mismanagement of tribal trust fund assets and resources dating back as early as 1946; AND
- The Toadlena/Two Grey Hills Chapter finds on May 30, 2014 the 22nd Navajo Nation Council formally accepts the settlement offer of \$554 Million by adopting Resolution No. CMY-28-14, which was signed into law by the President on June 4, 2014; AND
- 4. The Toadlena/Two Grey Hills Chapter finds the Office of the Speaker conducted a total of seven public hearings in 2014 to gain input and recommendations as to how the settlement award should be used and/or invest to best serve the needs of the Navajo Nation. The Navajo Nation people overwhelming requested allocations in the area of Capital Improvement, Infrastructure/Roads, Education and Human Services; AND
- 5. The Toadlena/Two Grey Hills Chapter finds The Office of the Controller reported that as of January 1, 2016, the amount of the Sihasin Fund Principal is Four Hundred Eighty Seven Million Nine Hundred Ninety Thousand Eight Hundred Forty One Dollars and Ninety One Cents (\$487,990,841.91) with interest earnings of Four Hundred Fifty Eight Thousand Four Hundred Thirty One Dollars and Seventy Five Cents (\$458,431.75); AND

- 7. The Toadlena/Two Grey Hills Chapter respectful request the Navajo Nation Council to allocate Ten Million Dollars (\$10,000,000.00) to the Navajo Handicap Trust Fund. The Navajo Nation Handicap Trust Fund assist with the purchase of accessibility ramps, specialized equipment.

SUPPORTING AND RECOMMENDING THE NAVAJO NATION REQUEST THE NAVAJO NATION COUNCIL TO ALLOCATE TWENTY MILLION DOLLARS (\$20,000,000.00) FROM THE SIHASIN FUND TO THE NAVAJO HANDICAP TRUST FUND

WHEREAS:

- 1. The Northern Navajo Agency Council is a recognized political subdivision of the Navajo Nation and has the authority to advocate and make appropriate recommendations on behalf of the 20 Northern Navajo Agency Chapters to the Navajo Nation Government, Federal, State, and local entities for appropriate action: and
- 2. The Northern Agency Council finds on December 29, 2006 the Navajo Nation filed suit against the United States in the U.S. Court of Federal Claims seeking monetary damages from the federal government for its mismanagement of tribal trust fund assets and resources dating back as early as 1946.
- 3. The Northern Agency Council finds on May 30, 2014 the 22nd Navajo Nation Council formally accepts the settlement offer of \$554 Million by adopting Resolution No. CMY-28-14, which was signed into law by the President on June 4, 2014.
- 4. The Northern Agency Council finds the Office of the Speaker conducted a total of seven public hearings in 2014 to gain input and recommendations as to how the settlement award should be used and/or invest to best serve the needs of the Navajo Nation. The Navajo Nation people overwhelming requested allocations in the area of Capital Improvement, Infrastructure/Roads, Education and Human Services.
- 5. The Northern Agency Council finds The Office of the Controller reported that as of January 1, 2016, the amount of the Sihasin Fund Principal is Four Hundred Eighty Seven Million Nine Hundred Ninety Thousand Eight Hundred Forty One Dollars and Ninety One Cents (\$487,990,841.91) with interest earnings of Four Hundred Fifty Eight Thousand Four Hundred Thirty One Dollars and Seventy Five Cents (\$458,431.75).
- 6. The Northern Agency Council recognizes any use or allocation of the funds requires legislative action and approval by the Navajo Nation Council.
- The Northern Agency Council respectful request the Navajo Nation Council to allocate Twenty Million Dollars (\$20,000,000.00) to the Navajo Handicap Trust Fund. The Navajo Nation Handicap Trust Fund assist with the purchase of accessibility ramps, specialized equipment.

NOW, THEREFORE, BE IT RESOLVED THAT:

The Northern Agency Council, hereby supports the allocation to the Navajo Nation Handicap Trust Fund assist with the purchase of accessibility ramps, specialized equipment.
