The Navajo Nation Council adopted Council Resolution CAP-35-18, "Adopting the Síhasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-68-14, as Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended; Waiving 12 N.N.C. §§ 810 (F), 820 (I) and (M) and 860 (C) Relating to the Capital Budget and Capital Improvement Process" on April 17, 2018. See, CAP-35-18.
- B. A Capital Projects Management Department, Sihasin Project Amendment Certification, CAP-35-18, document is attached as Exhibit 1.
- C. The Capital Projects Management Department, Sihasin Project Amendment Certification, CAP-35-18, document, Exhibit 1, indicates three Steamboat Chapter projects described as D-132, Old Chapter Renovation, D-133, Chapter Building Renovation, and D-134, Chapter Warehouse totaling \$833,333.33 are to be deleted.
