TITLE OF RESOLUTION: AN ACT RELATING TO LAW AND ORDER, RESOURCES AND DEVELOPMENT, NAABIK'ÍYÁTI' COMMITTEES AND NAVAJO NATION COUNCIL; WAIVING THE SOVEREIGN IMMUNITY OF THE NAVAJO NATION WITH RESPECT TO THE NAVAJO NATION SURFACE COAL MINING AND RECLAMATION ACT; ENACTING THE NAVAJO NATION SURFACE COAL MINING AND RECLAMATION ACT, ESTABLISHING NEW SECTIONS IN TITLE 18 AT 18 N.N.C. §§ 1701 ET SEQ.

PURPOSE: The purpose of the resolution is to enact the Navajo Nation Surface Coal Mining and Reclamation Act, establishing new Navajo Nation Code sections 18 N.N.C. §§ 1701 *et seq.* This enactment will provide for the regulation and enforcement of surface coal mining and reclamation operations and coal exploration. This legislation will also waive the sovereign immunity of the Navajo Nation with regard to the Navajo Nation Surface Coal Mining and Reclamation Act allowing suits against the Navajo Nation. If this legislation is passed, the Navajo Nation could be on track to be the first American Indian Nation to obtain primacy over surface coal mining reclamation.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

20	Section One. Findings
21	A. The Law and Order Committee of the Navajo Nation Council, pursuant to 2
22	N.N.C. § 601(B)(14), reviews and makes recommendations to the Navajo Nation
23	Council proposed amendments to the Navajo Nation Code.
24	B. The Resources and Development Committee is a standing committee of the
25	Navajo Nation Council and exercises oversight over the land and environmental
26	protection. 2 N.N.C. § 500(C).
27	C. The Naabik'íyáti' Committee of the Navajo Nation Council, pursuant to 2 N.N.C.
28	§ 164(A)(9), reviews proposed legislation which requires final action by the
29	Navajo Nation Council.
30	

D. Enactments of positive law must be reviewed and approved by resolution by the Navajo Nation Council. 2 N.N.C. § 164(A).

- E. Pursuant to the Surface Mining Control and Reclamation Act (SMCRA), when an Indian Nation seeks to obtain SMCRA's primary regulatory authority, "an Indian tribe shall waive sovereign immunity for purposes of section 520 and paragraph (4)." SMCRA, PL 95-87 Section 710(j)(3), or 30 USC 1300(j)(3). Section 520 is the Citizen Suits section of SMCRA which would authorize "Any person having an interest which is or may be adversely affected may commence a civil action in Navajo Nation District Court for the District of Window Rock on his or her own behalf to compel compliance with this Act ... against the Navajo Nation or any other governmental instrumentality or agency of the Navajo Nation[.]"
- F. In addition, Section 520 (G) of this legislation, the Navajo Nation Surface Coal Mining and Reclamation Act, states that: "After exhausting all Navajo Nation remedies with respect to a civil action arising under the Navajo regulatory program, an interested party may, pursuant to section 710(j)(4)(A) of SMCRA, file a petition for judicial review of the civil action in the United States Court of Appeals for the circuit in which the surface coal mining operation named in the petition is located, or, for civil actions in which no surface coal mining operation is named in the petition, in the United States Court of Appeals for the petition, in the United States Court of Appeals for the named in the petition."
 - G. The Navajo Nation Minerals Department has worked decades to obtain the Navajo Nation primacy over surface coal mining reclamation. If this legislation is passed, the Navajo Nation could be on track to be the first American Indian Nation to obtain primacy over surface coal mining reclamation.
 - H. It is in the best interest of the Navajo Nation to obtain primary regulatory authority over surface coal mining reclamation.

Section Two. Waiver of Navajo Nation sovereign immunity with regard to the Navajo Nation Surface Coal Mining and Reclamation Act The Navajo Nation hereby waives its sovereign immunity with regard to the Navajo Nation Surface Coal Mining and Reclamation Act.

Section Three. Enacting the Navajo Nation Surface Coal Mining and Reclamation Act, 18 N.N.C. § 1701 et seq.

The Navajo Nation hereby enacts the Navajo Nation Surface Coal Mining and Reclamation Act, to provide for the regulation and enforcement of surface coal mining and reclamation operations and coal exploration, Navajo Nation Code, Title 18, §§ 1701 *et seq.* as follows:

1	1. "Act" means the Navajo Nation Surface Coal Mining and Reclamation Act;
2	2. "Attorney General" means the Attorney General of the Navajo Nation:
3	3. "BIA" means the Bureau of Indian Affairs of the U.S. Department of the
4	Interior;
5	4. "BLM" means the Bureau of Land Management of the U.S. Department of the
6	Interior;
7	5. "Federal Lands" means any land, including mineral interests, owned by the
8	United States without regard to how the United States acquired ownership of the
9	land and without regard to the agency having responsibility for management
10	thereof, except Indian lands;
11	6. "Federal Program for Indian Lands" means the program at 30 CFR Part 750
12	established by the Secretary pursuant to SMCRA section 710(d) to regulate
13	surface coal mining and reclamation operations on Indian Lands in accordance
14	with the requirements of SMCRA;
15	7. "Indian Lands" means all lands, including mineral interests, within the exterior
16	boundaries of any federal Indian reservation, notwithstanding the issuance of any
17	patent, and including rights-of-way, and all lands including mineral interests held
18	in trust for or supervised by an Indian tribe;
19	8. "Indian tribe" means any Indian tribe, band, group, or community having a
20	governing body recognized by the Secretary;
21	9. "Local government," "local agency," "local governmental agency," and "local
22	governmental body" mean a Navajo Nation Chapter, a local governmental unit of
23	a state, or a non-Navajo tribal government or agency or local governmental unit
24	thereof, which may be affected by the Navajo regulatory program;
25	10. "Navajo Nation" means the federally recognized Navajo Tribe of Indians, an
26	Indian nation governed by the Navajo Nation government:
27	11. "Navajo Nation Chapter" means a unit of local government that is a political
28	subdivision of the Navajo Nation and identified as a Chapter under Navajo Nation
29	<u>law;</u>

1	12. "Navajo Nation law" means the entire body of law of the Navajo Tribe of
2	Indians, including the Navajo Nation Code, all lawfully promulgated rules and
3	regulations of agencies of the Navajo Tribe of Indians, and all lawfully enacted
4	resolutions and ordinances of the Navajo Nation Chapters, Provided, that this Act
5	preempts any authority of any political subdivision of the Navajo Nation over
6	surface coal mining and reclamation operations;
7	13. "Navajo regulatory program" means the program established by the Navajo
8	Nation and approved by the Secretary pursuant to sections 503, 504(e), and 710(j)
9	of SMCRA to regulate surface coal mining and reclamation operations on Navajo

11	CFR Chapter VII;
12	14. "Navajo regulatory program lands" means those lands upon which surface
13	coal mining and reclamation operations and coal exploration are regulated by the
14	NSCMP under the Navajo regulatory program, which consist of all lands within
15	the formal Navajo Indian Reservation as established by the Treaty of June 1, 1868
16	and subsequent acts of Congress and executive orders;
17	15. "Navajo Surface Coal Mining Program" is the tribal regulatory authority for
18	administering this Act and SMCRA under the Navajo regulatory program
19	approved by the Secretary;
20	16. "NNOHA" means the Navajo Nation Office of Hearings and Appeals which is
21	the government unit responsible for conducting administrative hearings and
22	deciding appeals of decisions of the Navajo Surface Coal Mining Program that are
23	required or authorized by this Act;
24	17. "NSCMP" means the Navajo Surface Coal Mining Program;
25	18. "operator" means any person, partnership, or corporation engaged in coal
26	mining who removes or intends to remove coal from the earth by coal mining;
27	19. "OSMRE" means the Office of Surface Mining Reclamation and Enforcement
28	of the U.S. Department of the Interior;
29	20. "other minerals" means clay, stone, sand, gravel, metalliferous and
30	nonmetalliferous ores, and any other solid material or substances of commercial

3	21. "permit" means a permit to conduct surface coal mining and reclamation

7	23. "permit area" means the area of land indicated on the approved map submitted

11	24. "permittee" means a person holding a permit;
12	25. "person" means an individual, partnership, association, society, joint stock

22	State or Tribe is administering SMCRA under an approved state or tribal program
23	or OSMRE where OSMRE is administering SMCRA under a federal program for
24	a State, the Federal Program for Indian Lands, or the Federal Lands Program, or
25	the Initial Program at 30 CFR Chapter VII, Subchapter B;
26	29. "Resources Committee" means the Resource and Development Committee of
27	the Navajo Nation Council or any successor Navajo governmental entity,
28	including any Navajo Executive Branch Division or Department to which
29	authorities of the Resources and Development Committee may be delegated;
30	30. "Secretary" means the Secretary of the U.S. Department of the Interior;

1	31. "SMCRA" means the Surface Mining Control and Reclamation Act of 1977
2	(P.L. 95-87), and all subsequent revisions and amendments to it;
3	32. "State" means a State of the United States;
4	33. "surface coal mining and reclamation operations" means surface coal mining
5	operations and all activities necessary and incident to the reclamation of such
6	operations after August 3, 1977;
7	<u>34. "surface coal mining operations" means —</u>
8	a. activities conducted on the surface of lands in connection with a surface coal
9	mine or subject to the requirements of Section 516 of this Act surface operations
10	and surface impacts incident to an underground coal mine, the products of which
11	enter commerce or the operations of which directly or indirectly affect interstate
12	commerce. Such activities include excavation for the purpose of obtaining coal
13	including such common methods as contour, strip, auger, mountaintop removal,
14	box cut, open pit, and area mining, the uses of explosives and blasting, and in-situ
15	distillation or retorting, leaching or other chemical or physical processing, and the
16	cleaning, concentrating, or other processing or preparation, loading of coal for
17	interstate commerce at or near the mine site: Provided, however, that such
18	activities do not include the extraction of coal incidental to the extraction of other
19	minerals where coal does not exceed 16 2/3 percent of the tonnage of minerals
20	removed for purposes of commercial use or sale or coal explorations subject to
21	section 512 of this Act; and

23	natural land surface. Such areas shall also include any adjacent land the use of
24	which is incidental to any such activities, all lands affected by the construction of
25	new roads or the improvement or use of existing roads to gain access to the site of
26	such activities and for haulage, and excavations, workings, impoundments, dams,
27	ventilation shafts, entryways, refuse banks, dumps, stockpiles, overburden piles,
28	spoil banks, culm banks, tailings, holes or depressions, repair areas, storage areas,
29	processing areas, shipping areas and other areas upon which are sited structures,

facilities, or other property or materials on the surface, resulting from or incident to such activities; and

35. "Uniform Rules" means the Uniform Regulations for Permit Review, Administrative Enforcement Orders, Hearings, and Rulemakings under Navajo Nation Environmental Acts; Provided, that, as referred to in the Uniform Rules, "Director" shall mean "Program Manager," "NNEPA" shall mean "NSCMP," "USEPA" shall mean "OSMRE," "tape recording" and "tape" shall include "other types of electronic recording," "a brief description of the proposed regulation" also shall include "a statement of the basis and purpose of the proposed regulation," in section 407(b) of the Uniform Rules, "adoption of the final regulation" shall include "approval of the final regulations by the Resources Committee," and in section 407(c) of the Uniform Rules, "approval of the final regulations by the Resources Committee" shall mean "approval of the final regulations by the Resources Committee and by the Secretary or the OSMRE Director." In the case of any conflict between a provision of this Act or regulations implementing this Act and a provision of the Uniform Rules, the provision of this Act or implementing regulations shall govern.

"alluvial valley floors" means the unconsolidated stream-laid deposits holding streams where water availability is sufficient for subirrigation or flood irrigation agricultural activities but does not include upland areas which are generally overlain by a thin veneer of colluvial deposits composed chiefly of debris from sheet erosion, deposits by unconcentrated runoff or slope wash, together with talus, other mass movement accumulation and windblown deposits;

2. "approximate original contour" means that surface configuration achieved by backfilling and grading of the mined area so that the reclaimed area, including any terracing or access roads, closely resembles the general surface configuration of the land prior to mining and blends into and complements the drainage pattern of the surrounding terrain, with all highwalls and spoil piles eliminated; water

1	impoundments may be permitted where the NSCMP determines that they are in
2	compliance with section 515(B)(8) of this Act;
3	3. "authorized land user" means a landowner, a person with valid homesite lease
4	issued by the Navajo Land Department, a person with a valid grazing permit
5	issued by the BIA, or a person with a valid permit, lease, right-of-way, or other
6	type of authorization for surface or subsurface use of Navajo regulatory program
7	lands or structures;
8	4. "cemetery" means any area of land where human bodies are interred, including
9	family burial grounds and any site or area where a body is interred in the
10	traditional Navajo way;
11	5. "commerce" means trade, traffic, commerce, transportation, transmission, or
12	communication among the several States/Tribes or between a State/Tribe and any
13	other place outside thereof, or between points in the same State/Tribe which
14	directly or indirectly affect interstate commerce;
15	6. "head-of-hollow fill" means a fill structure consisting of any material, other
16	than organic material, placed in the uppermost reaches of a hollow where side
17	slopes of the existing hollow, measured at the steepest point, are greater than 20
18	degrees or the average slope of the profile of the hollow from the toe of the fill to
19	the top of the fill is greater than 10 degrees. In head-of-hollow fills the top surface
20	of the fill, when completed, is at approximately the same elevation as the adjacent
21	ridge line, and no significant area of natural drainage occurs above the fill
22	draining into the fill area;
23	7. "imminent danger to the health and safety of the public" means the existence of
24	any condition or practice, or any violation of a permit or other requirement of this
25	Act in a surface coal mining and reclamation operation, which condition, practice,
26	or violation could reasonably be expected to cause substantial physical harm to
27	persons outside the permit area before such condition, practice, or violation can be
28	abated. A reasonable expectation of death or serious injury before abatement
29	exists if a rational person, subjected to the same conditions or practices giving rise
30	

1	to the peril, would not expose himself or herself to the danger during the time
2	necessary for abatement;
3	8. "landowner" means both the legal owner of record and the equitable owner of
4	record of the land;
5	9. "prime farmland" means land that is defined as prime farmland by the
6	Secretary of the U.S. Department of Agriculture on the basis of such factors as
7	moisture availability, temperature regime, chemical balance, permeability, surface
8	layer composition, susceptibility to flooding, and erosion characteristics, and
9	which historically has been used for intensive agricultural purposes, and as
10	published in the Federal Register;
11	10. "steep slope" means any slope above twenty degrees;
12	11. "unwarranted failure to comply" means the failure of a permittee to prevent
13	the occurrence of any violation of his or her permit or any requirement of this Act
14	due to indifference, lack of diligence, or lack of reasonable care, or the failure to
15	abate any violation of such permit or this Act due to indifference, lack of
16	diligence, or lack of reasonable care;
17	12. "valley fill" means a fill structure consisting of any material, other than
18	organic material, that is placed in a valley where side slopes of the existing valley,
19	measured at the steepest point, are greater than 20 degrees, or where the average
20	slope of the profile of the valley from the toe of the fill to the top of the fill is
21	greater than 10 degrees; and
22	13. "water user" means a person with an ownership interest in the water resource,
23	a person with a valid right to the surface water or groundwater, a person with a
24	valid water use permit issued by the Navajo Nation Department of Water
25	Resources Water Code Administration, or a person with a valid permit, lease, or
26	other type of authorization for use of the waters of the Navajo Nation.
27	SEC. 102. Findings
28	The Navajo Nation Council finds and declares that —
29	A. The extraction of coal from the earth can be accomplished by various methods
30	of mining, including surface mining;

B. The Navajo Nation owns and leases substantial and valuable deposits of coal, which may be recovered through both surface and underground mining methods. Commercial exploitation of coal resources yields significant benefits to the Navajo Nation and its members, including royalty and tax income and employment opportunities. Moreover, the commercial exploitation of coal resources contributes greatly to the well-being of surrounding States, and enhances the energy self-sufficiency and national security of the United States;

C. Many surface coal mining operations on the Navajo Nation have resulted and may result in disturbances of surface areas that burden and adversely affect the public welfare by destroying or diminishing the utility of land for commercial, industrial, residential, recreational, agricultural, cultural, and forestry purposes, by causing erosion and landslides, by contributing to floods, by polluting the water, by destroying vegetation, fish, and wildlife habitats, by impairing natural beauty, by damaging the property of the Navajo Nation and its residents, by creating hazards dangerous to life and property, by degrading quality of life in local communities, and by counteracting governmental programs and efforts to conserve soil, water, and other natural resources;

D. The Navajo Nation recognizes the need to establish appropriate standards to minimize damage to the environment and to restore the productivity of the soil and to protect the health and safety of the public:

E. Surface coal mining and reclamation technologies are now developed so that
 the effective and reasonable regulation of surface coal mining operations on the
 Navajo Nation in accordance with the requirements of this Act is an appropriate
 and necessary means to minimize so far as practicable the adverse social,
 economic, and environmental effects of such mining operations;

F. The Navajo Nation shall set surface coal mining and reclamation standards consistent with, and no less stringent than, the standards set forth in SMCRA and regulations promulgated thereunder, in order to ensure that competitive pressures among coal suppliers will not undermine the ability of the Navajo Nation to

1	improve and maintain adequate environmental standards for coal mining
2	operations within the Navajo Nation;
3	G. Surface coal mining and reclamation operations contribute to the economic
4	well-being and general welfare of the Navajo Nation and should be conducted in
5	an environmentally sound manner, with proper respect for the characteristics,
6	culture, and traditions of the Navajo Nation and its people;
7	H. The comprehensive and cooperative effort established by this Act is necessary
8	to prevent or mitigate adverse environmental effects of present and future surface
9	coal mining operations;
10	I. The health, welfare, cultural integrity, and economic viability of the Navajo
11	Nation depend on its natural and human resources. The lands of the Navajo
12	Nation have enormous economic and social significance for the Navajo People, as
13	rangeland for the grazing of livestock, as homeland for the many thousands of
14	Navajos who prefer to live in the traditional Navajo way on the land, as farmland
15	for the raising of crops, as forests for timber development, as habitat for diverse
16	species of wildlife, as the source of plants and herbs vital to numerous traditional
17	religious rites and ceremonies, and as an embodiment of much of the spirit of
18	traditional Navajo beliefs. The increase in the Navajo population has caused the
19	Navajo Nation land base to become crowded in many areas. Thus, care must be
20	taken to ensure that the positive values of a one-time, temporary land use such as
21	surface coal mining do not damage the long-term interests of the Navajo Nation
22	and its people; and
23	J. The regulation of land use within the territorial jurisdiction of the Navajo
24	Nation for all its residents is an essential component of the sovereignty of the
25	Navajo Nation. The Navajo Nation seeks self-sufficiency and should undertake
26	full responsibility for effectuating this component of Navajo Nation sovereignty.
27	
28	SEC. 103. Purposes
29	It is the purpose of this Act to —
30	

1	A. Establish a program for the Navajo Nation to protect people and the
2	environment from the adverse effects of surface coal mining operations;
3	B. Assure that the rights of surface landowners, residents, water users, and
4	authorized land users are fully protected from such operations;
5	C. Assure that surface coal mining operations are not conducted where
6	reclamation as required by this Act is not feasible;
7	D. Assure that surface coal mining operations are conducted so as to protect the
8	environment;
9	E. Assure that adequate procedures are undertaken to reclaim surface areas as
10	contemporaneously as possible with the surface coal mining operations;
11	F. Assure that the coal supply essential to the Navajo Nation's economic and
12	social well-being is provided and strike a proper balance, consistent with this Act
13	and SMCRA, between protection of the environment and agricultural productivity
14	and the Navajo Nation's need for coal as an essential source of revenue:
15	G. Assure that appropriate procedures are provided for public participation in the
16	development, revision, and enforcement of regulations, standards, reclamation
17	plans, or programs established by the Navajo Nation under this Act;
18	H. Wherever necessary, exercise the full reach of the sovereign and delegated
19	powers of the Navajo Nation to the extent allowed by applicable laws to ensure
20	the protection of the public interest through effective control of surface coal
21	mining operations; and
22	I. Carry out the provisions and purposes of SMCRA and implementing federal
23	regulations, as amended.
24	
25	SUBCHAPTER 2 – NAVAJO SURFACE COAL MINING PROGRAM
26	
27	SEC. 201. Establishment, Employees, and Duties of the Navajo Surface Coal
28	Mining Program
29	A. There is established in the Navajo Nation Division of Natural Resources,
30	Minerals Department, the Navajo Surface Coal Mining Program to regulate

surface coal mining and reclamation operations and coal exploration on Navajo regulatory program lands pursuant to this Act.

B. The NSCMP shall have a Program Manager who shall be hired in accordance with Navajo Nation personnel practices, and who shall report to the Director of the Navajo Nation Minerals Department. The Program Manager shall have the responsibilities provided under subsection (C) of this section. Employees of the NSCMP shall be recruited consistent with Navajo Nation laws and personnel practices on the basis of their professional competence and capacity to administer the provisions of this Act. The NSCMP may use employees of federal agencies on a reimbursable basis when appropriate and where authorized by applicable federal law; Provided that, such federal employees shall be subject to SMCRA section 201(f) and the federal agencies and employees shall comply with the requirements of 30 CFR Part 706. The NSCMP may use, on a reimbursable basis when appropriate, employees of other Navajo Nation agencies to administer the provisions of this Act, providing that no legal authority, program, or function in any Navajo Nation agency which has in its purpose promoting the development or use of coal or other mineral resources or regulating the health and safety of miners under the provisions of the Federal Coal Mine Health and Safety Act of 1969 (83 Stat. 742) shall be transferred to the NSCMP.

C. The Program Manager shall —

1. administer the NSCMP and the Navajo regulatory program for controlling surface coal mining and reclamation operations and coal exploration; make those investigations and inspections necessary to ensure compliance with this Act; conduct hearings, administer oaths, issue subpoenas, and compel the attendance of witnesses and production of written or printed material as provided for in this Act; issue cease-and-desist orders; review and vacate or modify or approve orders and decisions; review and approve, disapprove, or conditionally approve permit applications for surface coal mining operations and coal exploration; issue or deny permits for surface coal mining operations and coal exploration; and order the suspension, revocation, or withholding of any permit for surface coal mining

1	operations and coal exploration for failure to comply with any of the provisions of
2	this Act or any rules and regulations adopted pursuant thereto;
3	2. publish and promulgate, pursuant to the rulemaking procedures of Subpart 4 of
4	the Uniform Rules, such rules and regulations as may be necessary to carry out
5	the purposes and provisions of this Act, including procedures and requirements
6	for administrative adjudicatory hearings to be conducted by the NNOHA under
7	this Act;
8	3. consult with federal agencies, other Navajo Nation agencies, and, where
9	appropriate, state and non-Navajo tribal agencies having expertise in the control
10	and reclamation of surface coal mining operations, to provide for effective
11	administration of this Act and to minimize unnecessary duplication of effort;
12	4. conduct a continuing study of surface coal mining and reclamation operations
13	within the Navajo Nation by collecting data, conducting experiments, and
14	conducting appropriate research in order to improve reclamation technology;
15	5. develop objective criteria and appropriate procedures and institutions for
16	determining those areas of Navajo regulatory program lands to be designated
17	unsuitable for all or certain types of surface coal mining pursuant to section 522
18	of this Act;
19	6. cooperate with other Navajo Nation and federal agencies and state and tribal
20	regulatory authorities to minimize duplication of inspections, enforcement, and
21	administration of this Act and SMCRA;
22	7. administer cooperative agreements with OSMRE, other federal agencies, and,
23	where appropriate, state and tribal agencies;
24	8. develop and implement the Navajo regulatory program for regulation of surface
25	coal mining and reclamation operations that reflects the requirements and
26	environmental, cultural, and agricultural conditions of the Navajo Nation as
27	provided in this Act;
28	9. assure that the decisions, goals, regulations, and non-confidential information
29	of the NSCMP are made available to the public at reasonable times and
30	interpreted when requested;

1	10. notify OSMRE of potential criminal actions associated with surface coal
2	mining and reclamation operations on Navajo regulatory program lands and
3	recommend that OSMRE pursue criminal penalties under SMCRA; and
4	11. perform such other duties as may be provided by law and relate to the
5	purposes of this Act.
6	D. The Program Manager shall not use, either permanently or temporarily, any
7	person charged with responsibility of inspecting coal mines under the Federal
8	Coal Mine Health and Safety Act of 1969, unless he or she finds and publishes
9	such finding in a daily or weekly newspaper of general circulation in the Navajo
10	Nation that such activities would not interfere with such inspections under the
11	<u>1969 Act.</u>
12	E. No employee of the NSCMP or any other Navajo Nation employee performing
13	any function or duty under this Act shall have a direct or indirect financial interest
14	in underground or surface coal mining operations. A person shall not be deemed
15	to have a direct or indirect financial interest in underground or surface coal
16	mining operations by virtue of such person's membership in the Navajo Nation.
17	No employee of the NSCMP or any other Navajo Nation employee performing
18	any function or duty under this Act shall be eligible for a per capita distribution of
19	any proceeds from coal mining operations conducted on Indian reservation lands
20	under SMCRA. Whoever knowingly violates the provisions of this subsection
21	shall, upon conviction, be punished by a fine of not more than\$2,500, or by
22	imprisonment for not more than one year, or both, to the extent authorized by
23	applicable law. The Program Manager shall publish and promulgate regulations,
24	in accordance with the Uniform Rules, Subpart 4, that meet the minimum policies
25	and procedures of 30 CFR Part 705 to monitor and enforce the provisions of this
26	subsection, including appropriate rules for the filing by such employees of
27	statements concerning their financial interests which may be affected by this
28	subsection and the review of such statements and supplements thereto.
29	F. Petitions for issuance, amendment, or repeal of rule; filing; hearing or
30	investigation; notice of denial

1	1. After the NSCMP has adopted regulations as required by section 501 of this
2	Act, any person may petition the Program Manager to initiate a proceeding for the
3	issuance, amendment, or repeal of a rule under this Act.
4	2. Such petitions shall be filed in the principal office of the Program Manager and
5	shall set forth only the facts which it is claimed established that it is necessary to
6	issue, amend, or repeal a rule under this Act.
7	3. The Program Manager may hold a public hearing or may conduct such
8	investigation or proceeding as he or she deems appropriate in order to determine
9	whether or not such petition should be granted.
10	4. Within 90 days after filing of a petition described in paragraph (1) of this
11	subsection, the Program Manager shall either grant or deny the petition. If the
12	Program Manager grants such petition, the Program Manager shall promptly
13	commence an appropriate proceeding in accordance with the provisions of
14	Subpart 4 of the Uniform Rules. If the Program Manager denies such petition, the
15	Program Manager shall so notify the petitioner in writing setting forth the reasons
16	for such denial. The Program Manager's decision denying in whole or in part
17	such petition shall be subject to appeal pursuant to section 526 of this Act.
18	G. The NSCMP shall not participate in any way in negotiations for and leasing of
19	Navajo Nation coal or other mineral resources.
20	H. The NSCMP is authorized to submit grant applications and receive and
21	administer grants under 30 CFR Chapter VII, Subchapter C. Funds received by
22	the NSCMP for any purpose whatsoever shall be disbursed and accounted for in
23	accordance with this Act and applicable Navajo Nation and federal laws.
24	I. The Navajo Nation hereby waives sovereign immunity for the limited purposes
25	of citizen suits arising under section 520 of this Act or under section 520 of
26	SMCRA, judicial review under section 526 of this Act, and judicial review under
27	SMCRA section 710(j)(4). The NSCMP shall be and hereby is clothed with the
28	sovereign immunity from suit enjoyed by the Navajo Nation, to the extent not
29	waived in this Act. Permittees and operators of surface coal mining and
30	reclamation operations in which the Navajo Nation has an ownership or

1	controlling interest are not clothed in sovereign immunity for the purposes of this
2	Act and are fully subject to the provisions of this Act.
3	J. The Program Manager shall closely monitor all pertinent legislation, both
4	Navajo Nation and federal, concerning coal mining, Indian lands, regulatory
5	powers, reclamation, and related issues to protect the interests of the Navajo
6	Nation. The Program Manager may represent the Navajo Nation at hearings and
7	provide comments, both written and oral, with respect to mining reclamation and
8	regulatory issues in the name of the Navajo Nation: Provided, that participation
9	in such hearings and such comments are reviewed and approved in accordance
10	with applicable Navajo Nation law.
11

16	SUBCHAPTER 5 – CONTROL OF THE ENVIRONMENTAL IMPACTS OF
17	SURFACE COAL MINING
18	
19	SEC. 501. Promulgation of Implementing Regulations
20	A. After the enactment of this Act, the Program Manager shall publish and
21	promulgate regulations covering the standards and procedures for surface coal
22	mining and reclamation operations based on and incorporating the provisions set
23	out in this Act. The Program Manager shall follow the rulemaking procedures in
24	Subpart 4 of the Uniform Rules, including providing public notice of these
25	proposed regulations and affording interested persons and Navajo Nation, federal,
26	state, and local governments a period of not less than 30 days following
27	publication to review and comment on the proposed regulations. The Program
28	Manager also shall provide at least one public hearing, in Window Rock, on the
29	proposed regulations.
30	

1	B. The Program Manager shall consult with OSMRE, BIA, BLM, and the Navajo
2	Nation Environmental Protection Agency, and solicit their comments prior to the
3	promulgation of such rules. Comments submitted by all agencies and the public
4	shall be considered by the Program Manager.
5

14	SEC. 506. Permits
15	A. Persons engaged in surface coal mining within Navajo Nation; time limit;
16	exception
17	1. On the effective date of approval of the Navajo regulatory program by the
18	Secretary, pursuant to SMCRA sections 503 and 710(j), no person shall engage in
19	or carry out on Navajo regulatory program lands any surface coal mining
20	operations unless such person has first obtained a permit issued by the NSCMP
21	pursuant to the Navajo regulatory program or holds a valid permit from OSMRE
22	under the Federal Program for Indian Lands. A person conducting surface coal
23	mining operations under a permit issued by OSMRE under the Federal Program
24	for Indian Lands may continue to conduct such operations as authorized in the
25	permit, subject to the provisions of paragraph (A)(2) of this section.
26	2. Upon the effective date of approval of the Navajo regulatory program by the
27	Secretary, the NSCMP shall become the regulatory authority administering the
28	federal permits issued by OSMRE under the Federal Program for Indian Lands for
29	those surface coal mining operations on Navajo regulatory program lands that are
30	authorized under the federal permit. The NSCMP shall review such permits to

determine that the permit meets the requirements of this Act and the regulations promulgated thereunder. The federal permittee shall also have the right to apply for a tribal permit to supersede his or her federal permit. Should the Navajo regulatory program contain additional requirements not contained in the Federal Program for Indian Lands, the permittee will be provided the opportunity for an administrative hearing and up to 180 days after notification by the NSCMP of such additional requirements or the conclusion of the administrative hearing, if requested, to conform his or her ongoing surface coal mining and reclamation operations to such additional requirements. Upon the effective date of approval of the Navajo regulatory program by the Secretary, the NSCMP shall also be responsible for the regulation of surface coal mining and reclamation operations on Navajo regulatory program lands under the initial regulatory program at 30 <u>CFR Chapter VII Subchapter B.</u>

B. All permits issued pursuant to this Act shall be issued for a term not to exceed five years: Provided, that if the applicant demonstrates that a specified longer term is reasonably needed to allow the applicant to obtain necessary financing for equipment and the opening of the operation, and if the application is full and complete for such specified longer term, the NSCMP may grant a permit for such longer term. A successor-in-interest to a permittee who applies for a new permit within 30 days of succeeding to such interest, and who is able to obtain the bond coverage of the original permittee, may continue surface coal mining and reclamation operations according to the approved mining and reclamation plan of the original permittee until such successor's application is granted or denied.

C. A permit shall terminate if the permittee has not commenced the surface coal mining operations covered by such permit within three years of the permit issuance: Provided, that the NSCMP may grant reasonable extensions of time upon a showing that such extensions are necessary by reason of litigation precluding such commencement or threatening substantial economic loss to the permittee, or by reason of conditions beyond the control and without the fault or negligence of the permittee: Provided further, that in the case of a coal lease

1	issued by the Navajo Nation for coal owned in whole or in part in fee by the
2	Navajo Nation or held by the United States in trust for the Navajo Tribe of
3	Indians, no extension of time may extend beyond the period allowed for
4	development in accordance with such lease or other applicable law and in the case
5	of a coal lease issued under the federal Mineral Leasing Act, as amended,
6	extensions of time may not extend beyond the period allowed for diligent
7	development in accordance with section 7 of that Act: Provided further, That with
8	respect to coal to be mined for use in a synthetic fuel facility or specific major
9	electric generating facility, the permittee shall be deemed to have commenced
10	surface coal mining operations at such time as the construction of the synthetic
11	fuel or generating facility is initiated.
12	D. Renewal
13	1. Any valid permit issued pursuant to this Act shall carry with it the right of
14	successive renewal upon expiration with respect to areas within the boundaries of
15	the existing permit. The holders of the permit may apply for renewal and such
16	renewal shall be issued (provided, that on application for renewal the burden shall
17	be on the opponents of renewal), subsequent to fulfillment of the public notice
18	requirements of sections 513 and 514 of this Act unless it is established that and
19	written findings by the NSCMP are made that:
20	(a) the terms and conditions of the existing permit are not being satisfactorily met;
21	(b) the present surface coal mining and reclamation operations are not in
22	compliance with the environmental protection standards of this Act and the
23	Navajo regulatory program;
24	(c) the renewal requested substantially jeopardizes the operator's continuing
25	responsibility on existing permit areas;
26	(d) the operator has not provided evidence that the performance bond in effect for
27	said operation will continue in full force and effect for any renewal requested in
28	such application as well as any additional bond the NSCMP might require
29	pursuant to section 509 of this Act; or
30	

1	(e) any additional revised or updated information required by the NSCMP has not
2	been provided.
3	2. Prior to the approval of any permit renewal, the NSCMP shall provide notice to
4	the appropriate Navajo Nation Chapters, Departments, Commissions, and
5	Divisions, and other public authorities.
6	3. If an application for renewal of a valid permit includes a proposal to extend the
7	mining operation beyond the boundaries authorized in the existing permit, the
8	portion of the application for renewal of a valid permit which addresses any new
9	land areas shall be subject to the full standards applicable to new applications
10	under this Act.
11	4. Any permit renewal shall be for a term not to exceed the period of the original
12	permit established by this Act. An application for permit renewal shall be made
13	at least 120 days prior to the expiration of the valid permit.
14	
15	SEC. 507. Application Requirements
16	A. Each application for a surface coal mining and reclamation permit pursuant to
17	this Act shall be accompanied by a fee as determined by the NSCMP. Such fee
18	may be less than but shall not exceed the actual or anticipated cost of reviewing,
19	administering, and enforcing such permit issued pursuant to the Navajo regulatory
20	program. The NSCMP may develop procedures so as to enable the cost of the fee
21	to be paid over the term of the permit.
22	B. The permit application shall be submitted in a manner satisfactory to the
23	NSCMP and shall contain, among other items —
24	1. the names and addresses of (A) the permit applicant; (B) every landowner of
25	the property (surface and mineral) to be mined; (C) the holders of record of any
26	leasehold interest in the property; (D) any purchaser of record of the property
27	under a real estate contract; (E) any authorized land user; (F) the operator if s/he
28	is a person different from the applicant; and (G) if any of the above is a business
29	entity other than a single proprietor, the names and addresses of its principals,
30	

1	officers, and registered agent for service of process pursuant to the Navajo Nation
2	Corporation Code;
3	2. the names and addresses of the landowners of all surface and subsurface areas
4	adjacent to any part of the permit area;
5	3. a statement of any current or previous surface coal mining permits in the
6	United States held by the applicant and the permit identification, and each
7	pending application;
8	4. if the applicant is a partnership, corporation, association, or other business
9	entity, the following where applicable: the names and addresses of every officer,
10	partner, director, or person performing for the applicant a function similar to a
11	director, together with the name and address of any person owning of record 10
12	percent or more of any class of voting stock of the applicant, and a list of all
13	names under which the applicant, partner, or principal shareholder previously
14	operated a surface mining operation within the United States within the five-year
15	period preceding the date of submission of the application;
16	5. a statement of whether the applicant or any subsidiary, affiliate, or persons
17	controlled by or under common control with the applicant, has ever held a federal,
18	state, or tribal mining permit, that in the five-year period prior to the date of
19	submission of the application has been suspended or revoked or has had a mining
20	bond or similar security deposited in lieu of bond forfeited and, if so, a brief
21	explanation of the facts involved;
22	6. a copy of the applicant's advertisement to be published in a newspaper of
23	general circulation in the locality of the proposed site at least once a week for four
24	successive weeks, and which includes the ownership, a description of the exact
25	location and boundaries of the proposed site sufficient so that the proposed
26	operation is readily locatable by local residents, and the location of where the
27	application is available for public inspection;
28	7. a description of the type and method of coal mining operation that exists or is
29	proposed, the engineering techniques used or proposed to be used, and the
30	equipment used or proposed to be used;

8. the anticipated or actual starting and termination dates of each phase of the mining operation and the number of acres of land to be affected;

9. an accurate map or plan, to an appropriate scale, that clearly shows the land to be affected as of the date of the application, the area of land within the permit area upon which the applicant has the legal right to enter and commence surface mining operations, and a statement of those documents upon which the applicant bases his or her legal right to enter and commence surface mining operations on the area affected and whether that right is the subject of pending court litigation: Provided, that nothing in this Act shall be construed as vesting in the NSCMP the jurisdiction to adjudicate property title disputes;

11 10. the name of the watershed and location of the surface stream or tributary into
 12 which surface and pit drainage will be discharged;

11. a determination of the probable hydrologic consequences of the mining and 13 14 reclamation operations, both on and off the mine site, with respect to the hydrologic regime, quantity and quality of water in surface water and 15 groundwater systems, including the dissolved and suspended solids under 16 seasonal flow conditions, and the collection of sufficient data for the mine site and 17 surrounding areas so that an assessment can be made by the NSCMP of the 18 19 probable cumulative impacts of all anticipated mining in the area upon the hydrology of the area and particularly upon water availability: Provided, 20 however, that the determination shall not be required until such time as 21 hydrologic information on the general area prior to mining is made available from 22 an appropriate Navajo Nation, federal, state, or tribal agency, and Provided 23 further, that the permit shall not be approved until such information is available 24 by the applicant and is incorporated into the application; 25

After a surface coal mining and reclamation permit application has been approved but before such a permit is issued, the applicant shall file with the NSCMP, on a form prescribed and furnished by the NSCMP, a bond for performance payable to the Navajo Nation and conditional upon faithful performance of all the requirements of this Act and the permit. The bond shall cover that area of land within the permit area upon which the operator will initiate and conduct surface coal mining and reclamation operations within the initial term of the permit. As succeeding increments of surface coal mining and reclamation operations are to be initiated and conducted within the permit area, the permittee shall file with the NSCMP an additional bond or bonds to cover such increments in accordance with this section. The amount of the bond required for each bonded area shall depend upon the reclamation requirements of the approved permit; reflect the probable difficulty of reclamation considering such factors as the site's topography, geology, hydrology, and revegetation potential; and be determined by the NSCMP. The amount of the bond shall be sufficient to ensure the completion of the reclamation plan if the work had to be performed by the NSCMP in the event of forfeiture, and in no case shall the bond for the entire area under one permit be less than \$10,000.

B. Liability under the bond shall be for the duration of the surface coal mining and reclamation operation and for a period coincident with the operator's responsibility under the revegetation requirements in section 515 of this Act. The

1	bond shall be executed by the operator and a corporate surety licensed to do
2	business in the state where such operation is located, except that the operator may
3	elect to deposit cash, negotiable bonds of the United States Government or such
4	state, or negotiable certificates of deposit of any bank organized or transacting

At the time of submission of an application for a surface coal mining and reclamation permit, or revision of an existing permit, pursuant to the provisions of this Act, the applicant shall submit to the NSCMP a copy of his or her advertisement of the ownership, precise location, and boundaries of the land to be affected. The advertisement shall provide for a public comment period on the application of at least 30 days following the publication of the last advertisement, and shall include notice of an informal conference if the NSCMP determines there is sufficient interest in the application. As soon as the NSCMP approves the form and content of the advertisement, the applicant shall place such advertisement in a local newspaper of general circulation in the locality of the proposed surface mine at least once a week for four consecutive weeks, as required by section 507(B)(6)of this Act. The NSCMP shall notify appropriate agencies of the Navajo Nation, various local governmental bodies, planning agencies, sewage and water treatment authorities, and water companies in the locality in which the proposed surface mining will take place, notifying them of the operator's intention to surface mine a particularly described tract of land and indicating the application's permit number and where a copy of the proposed mining and reclamation plan may be inspected. These local bodies, agencies, authorities, or companies may submit written comments on the mining application, within the public comment period, with respect to the effects of the proposed operation on the environment which are within their area of responsibility. Such comments shall immediately be transmitted to the applicant by the NSCMP and be made available to the public at the same location(s) as the mining application.

B. Any person having an interest which is or may be adversely affected or the officer or head of any Navajo Nation, federal, or local governmental agency or authority shall have the right to file written objections to the proposed initial or revised application for a permit for surface coal mining and reclamation operation with the NSCMP within 30 days after the last publication of the above notice and request an informal conference on the application if one has not already been scheduled pursuant to subsection (A) of this section. Such objections shall immediately be transmitted to the applicant by the NSCMP and shall be made available to the public. If written objections are filed and an informal conference is requested, the NSCMP shall hold the conference in the locality of the proposed mining and reclamation operation if requested within a reasonable time of the receipt of such objections or request. If not already advertised under subsection (A) of this section, the date, time and location of the conference shall be advertised by the NSCMP in a newspaper of general circulation in the locality at least two weeks prior to the scheduled conference date. The NSCMP may arrange with the applicant, upon request by any party, access to the proposed mining area for the purpose of gathering information relevant to the conference. An electronic or stenographic record shall be made of the informal conference. Such record shall be maintained and be accessible to the parties until final release of the applicant's performance bond. In the event all parties requesting the informal conference withdraw their request prior to the informal conference, such informal conference need not be held.

SEC. 514. Decisions of the Navajo Surface Coal Mining Program and Appeals
 A. If an informal conference has been held pursuant to section 513(B) of this Act,
 the NSCMP shall issue and furnish the applicant for a permit and persons who are
 parties to the administrative proceedings with the written finding of the NSCMP,

granting or denying the permit in whole or in part and stating the reasons therefor, within the 60 days of said hearings.

B. If there has been no informal conference held pursuant to section 513(B) of this Act, the NSCMP shall notify the applicant for a permit within a reasonable time as determined by the NSCMP and set forth in regulations, taking into account the time needed for proper investigation of the site, the complexity of the permit application, and whether or not written objection to the application has been filed, whether the application has been approved or disapproved in whole or part.

C. If the application is approved, the permit shall be issued. If the application is disapproved, specific reasons therefor must be set forth in the notification. Within 30 days after the applicant is notified of the final decision of the NSCMP on the permit application, the applicant or any person with an interest which is or may be adversely affected may request a hearing on the reasons for the final determination. The NNOHA shall hold a hearing within 30 days of such request and provide notification to all interested parties at the time that the applicant is so notified. Such hearing shall be of record, adjudicatory in nature and no person who presided at a conference under section 513(B) of this Act shall either preside at the hearing or participate in this decision thereon or in any administrative appeal therefrom. Within 30 days after the hearing the NNOHA shall issue and furnish the applicant, and all persons who participated in the hearing, with the written decision of the NNOHA granting or denying the permit in whole or in part and stating the reasons therefor.

D. Where a hearing is requested pursuant to subsection (C) of this section, the NNOHA may, under such conditions as it may prescribe, grant such temporary relief as it deems appropriate pending final determination of the proceedings if – 1. all parties to the proceedings have been notified and given an opportunity to be heard on a request for temporary relief;

2. the person requesting such relief shows that there is a substantial likelihood that he or she will prevail on the merits of the final determination of the proceeding; and

3. such relief will not adversely affect the public health or safety or cause significant imminent environmental harm to land, air, or water resources.

E. For the purpose of such hearing, the NNOHA may administer oaths, subpoena witnesses, or written or printed materials, compel attendance of witnesses, or production of the materials, and take evidence including but not limited to site inspections of the land to be affected and other surface coal mining operations carried on by the applicant in the general vicinity of the proposed operation. A verbatim record of each public hearing required by this Act shall be made, and a transcript made available on the motion of any party or by order of the NNOHA.

F. Any applicant or any person with an interest which is or may be adversely affected, who has participated in the administrative proceedings as an objector, and who is aggrieved by the final permit decision of the NNOHA, or if the NSCMP or the NNOHA fails to act within the time limits specified in this Act, shall have the right to appeal the final permit decision in accordance with section 526 of this Act.

SEC. 515. Performance Standards

A. Any permit issued under the Navajo regulatory program to conduct surface coal mining operations shall require that such surface coal mining operations will meet all applicable performance standards of this Act, and such other requirements as the NSCMP shall promulgate in the Navajo regulatory program.
B. General performance standards shall be applicable to all surface coal mining and reclamation operations and shall require an operation as a minimum to —
1. conduct surface coal mining operations so as to maximize the utilization and conservation of the solid fuel resource being recovered so that reaffecting the land in the future through surface coal mining can be minimized or eliminated;

2. restore the land affected to a condition capable of supporting the uses which it was capable of supporting prior to any mining, or higher or better uses of which there is reasonable likelihood, so long as such use or uses do not present any actual or probable hazard to public health or safety or pose any actual or probable threat of water diminution or pollution, and the permit applicant's declared proposed land use following reclamation is not deemed to be impractical or unreasonable, inconsistent with applicable land-use policies and plans, involves unreasonable delay in implementation, or violates federal or Navajo Nation law or applicable laws of states or local governments;

3. with respect to all surface coal mining operations, backfill, compact (where advisable to ensure stability or to prevent leaching of toxic materials), and grade in order to restore the approximate original contour of the land with all highwalls, spoil piles, and depressions eliminated (unless small depressions are needed in order to retain moisture to assist revegetation or as otherwise authorized pursuant to this Act): Provided, however, that in surface coal mining which is carried out at the same location over a substantial period of time where the operation transects the coal deposit and the thickness of the coal deposits relative to the volume of the overburden is large, and where the operator demonstrates that the overburden and other spoil and waste materials at a particular point in the permit area or otherwise available from the entire permit area is insufficient, giving due consideration to volumetric expansion, to restore the approximate original contour, the operator, at a minimum, shall backfill, grade, and compact (where advisable) using all available overburden and other spoil and waste materials to attain the lowest practicable grade but not more than the angle of repose, to provide adequate drainage and to cover all acid-forming and other toxic materials, in order to achieve an ecologically sound land use compatible with the surrounding region: And provided further, that in surface coal mining where the volume of overburden is large relative to the thickness of the coal deposit and where the operator demonstrates that due to volumetric expansion the amount of overburden and other spoil and waste materials removed in the course of the

mining operation is more than sufficient to restore the approximate original contour, the operator shall after restoring the approximate contour, backfill, grade and compact (where advisable) the excess overburden and other spoil and waste materials to attain the lowest grade but not more than the angle of repose, and to cover all acid-forming and other toxic materials, in order to achieve an ecologically sound land use compatible with the surrounding region and that such overburden or spoil shall be shaped and graded in such a way as to prevent slides, erosion, and water pollution and shall be revegetated in accordance with the requirements of this Act;

4. stabilize and protect all surface areas, including spoil piles affected by the surface coal mining and reclamation operation, to effectively control erosion and attendant air and water pollution;

5. remove the topsoil from the land in a separate layer, replace it on the backfill area, or if not utilized immediately, segregate it in a separate pile from other spoil, and when the topsoil is not replaced on a backfill area within a time short enough to avoid deterioration of the topsoil, maintain a successful cover thereafter by quick-growing plants or other means so that the topsoil is preserved from wind and water erosion, remains free of any contamination by other acid or toxic materials, and is in a usable condition for sustaining vegetation when restored during reclamation, except if the topsoil is of insufficient quantity or of poor quality for sustaining vegetation, or if other strata can be shown to be more suitable for vegetation requirements, then the operator shall remove, segregate, and preserve in a like manner such other strata which are best able to support vegetation;

6. restore the topsoil or the best available subsoil which is best able to support vegetation;

7. for all prime farmlands, as identified in section 507(B)(16) of this Act, to be mined and reclaimed, soil removal, storage, replacement, and reconstruction shall be conducted according to specifications established by the Natural Resources Conservation Service, and the operator shall, as a minimum, be required to —

1	a. segregate the A horizon of the natural soil, except where it can be shown that
2	other available soil materials will create a final soil having a greater productive
3	capacity; and if not utilized immediately, stockpile this material separately from
4	other spoil, and provide needed protection from wind and water erosion or
5	contamination by other acid or toxic material;
6	b. segregate the B horizon of the natural soil, or underlying C horizons or other
7	strata, or a combination of such horizons or other strata that are shown to be both

24	necessary stability with an adequate margin of safety compatible with that of
25	structures constructed under Public Law 83-566 (16 U.S.C. 1006);
26	c. the quality of impounded water will be suitable on a permanent basis for its
27	intended use and that discharges from the impoundment will not degrade the
28	water quality in the receiving stream below water quality standards established
29	pursuant to applicable federal, Navajo Nation, state, and non-Navajo tribal laws;

e. final grading will provide adequate safety and access for proposed water users; and

f. such water impoundments will not result in the diminution of the quality or quantity of water utilized by adjacent or surrounding landowners, water users, and authorized land users for agricultural, industrial, recreational, or domestic uses;
9. conduct any augering or highwall mining operation associated with surface mining in a manner to maximize the recoverability of mineral reserves remaining after the operation and reclamation are complete and seal all auger or highwall mining holes with an impervious and noncombustible material in order to prevent drainage except where the NSCMP determines that the resulting impoundment of water in such auger or highwall mining holes may create a hazard to the environment or to public health or safety: Provided, that the NSCMP may prohibit augering or highwall mining if necessary to maximize the utilization, recoverability, or conservation of the solid fuel resources or to protect against adverse water quality impacts:
10. minimize the disturbances to the prevailing hydrologic balance at the mine

site and in associated offsite areas, and to the quality and quantity of water in surface water and groundwater systems both during and after surface coal mining operations and during reclamation by —

a. avoiding acid or other toxic mine drainage by such measures as, but not limited to —

22 <u>i. preventing or removing water from contact with toxic-producing deposits;</u>

23 <u>ii. treating drainage to reduce toxic content which adversely affects downstream</u>
 24 <u>water upon being released to watercourses;</u>

25 iii. casing, sealing, or otherwise managing boreholes, shafts, and wells and
 26 keeping acid or other toxic drainage from entering surface water and
 27 groundwater;

b. conducting surface coal mining operations so as to prevent, to the extent
 possible using the best technology currently available, additional contributions of
 suspended solids to streamflow, or runoff outside the permit area, but in no event

shall contributions be in excess of requirements set by applicable federal, Navajo 1 2 Nation, state, and non-Navajo tribal law; and constructing any siltation structures 3 pursuant to this subsection prior to commencement of surface coal mining operations, such structures to be certified by a qualified registered engineer or a 4 5 qualified professional land surveyor registered by any State that authorizes land surveyors to prepare and certify such maps or plans that they are constructed as 6 designed and as approved in the reclamation plan; 7 c. cleaning out and removing temporary or large settling ponds or other siltation 8 structures from drainways after disturbed areas are revegetated and stabilized, and 9 depositing the silt and debris at a site and in a manner approved by the NSCMP; 10 d. restoring recharge capacity of the mined area to approximate premining 11 12 conditions; e. avoiding channel deepening or enlargement in operations requiring the 13 discharge of water from mines; 14 15 f. preserving, throughout the mining and reclamation process, the essential hydrologic functions of alluvial valley floors; and 16 17 g. such other actions as the NSCMP may prescribe; 11. with respect to the surface disposal of mine wastes, tailings, coal processing 18 wastes, and other wastes in areas other than the mine workings or excavations, 19 20 stabilize all waste piles in designated areas through construction in compacted layers, including the use of incombustible and impervious materials if necessary, 21 and ensure that the final contour of the waste pile will be compatible with natural 22 surroundings and that the site can and will be stabilized and revegetated according 23 to the provisions of this Act; 24 12. refrain from surface coal mining within 500 feet of active and abandoned 25 underground mines in order to prevent breakthroughs and to protect the health or 26 27 safety of miners: Provided, that the NSCMP shall permit an operator to mine near, through, or partially through an abandoned underground mine or closer to an 28 29 active underground mine if (A) the nature, timing, and sequencing of the 30 approximate coincidence of specific surface mine activities with specific

1	underground mine activities are jointly approved by the NSCMP and the
2	appropriate regulatory authority concerned with the health and safety of
3	underground miners, and (B) such operations will result in improved resource
4	recovery, the abatement of water pollution, or the elimination of hazards to public

23	resident living within 1/2 mile of the proposed blasting site, and by providing daily
24	notice to resident/occupiers in such areas prior to any blasting:
25	b. maintain for a period of at least three years, and make available for public
26	inspection upon request, a log detailing the location of the blasts, the pattern and
27	depth of the drill holes, the amount of explosive used per hole, and the order and
28	length of delay in the blasts;
29	c. limit the type of explosives and detonating equipment and the size, the timing
30	and the frequency of blasts based upon the physical conditions of the site so as to

1	prevent (i) injury to persons, (ii) damage to public and private property outside the

4	d. require that all blasting operations be conducted by trained and competent

8	permittee shall conduct a pre-blasting survey of such structures and submit the
9	survey to the NSCMP and a copy to the resident or owner making the request.

5	g. the final configuration is compatible with the natural drainage pattern and
6	surroundings and is suitable for intended uses;
7	h. design of the spoil disposal area is certified by a qualified registered
8	professional engineer in conformance with professional standards; and
9	i. all other provisions of this Act are met;
10	23. meet such other criteria as are necessary to achieve reclamation in accordance
11	with the purposes of this Act, taking into consideration the physical,

Surface Effects of Underground Coal Mining Operations A. The NSCMP shall promulgate rules and regulations directed toward the 13 14 surface effects of underground mining operations, embodying the following requirements and in accordance with the procedures established under section 501 15 of this Act: Provided, however, that in adopting any rules and regulations, the 16 17 NSCMP shall consider the distinct difference between surface coal mining and underground coal mining. Such rules and regulations shall not conflict with nor 18 supersede any provision of the Federal Coal Mine Health and Safety Act of 1969 19 nor any regulation issued pursuant thereto, and shall be consistent with the 20 applicable requirements of 30 CFR Chapter VII. 21 B. Each permit issued under the Navajo regulatory program pursuant to this Act 22 and relating to underground coal mining shall require the operator to -23 1. adopt measures consistent with known technology in order to prevent 24 subsidence causing material damage to the extent technologically and 25 economically feasible, maximize mine stability, and maintain the value and 26 27 reasonably foreseeable use of such surface lands, except in those instances where the mining technology used requires planned subsidence in a predictable and 28 29 controlled manner: Provided, That nothing in this subsection shall be construed 30 to prohibit the standard method of room and pillar mining;

1	2. seal all portals, entryways, drifts, shafts, or other openings between the surface
2	and underground mine working when no longer needed for the conduct of the
3	mining operations:
4	3. fill or seal exploratory holes no longer necessary for mining, maximizing to the
5	extent technologically and economically feasible return of mine and processing
6	waste, tailings, and any other waste incident to the mining operation, to the mine
7	workings or excavations;
8	4. with respect to surface disposal of mine wastes, tailings, coal processing
9	wastes, and other wastes in areas other than the mine workings or excavations,
10	stabilize all waste piles created by the permittee from current operations through
11	construction in compacted layers including the use of incombustible and
12	impervious materials if necessary and ensure that the leachate will not degrade
13	below water quality standards established pursuant to applicable federal, Navajo
14	Nation, state, and non-Navajo tribal law surface waters or groundwaters, that the
15	final contour of the waste accumulation will be compatible with natural
16	surroundings, and that the site is stabilized and revegetated according to the
17	provisions of this section;
18	5. design, locate, construct, operate, maintain, enlarge, modify, and remove, or

20	817.87, all existing and new coal mine waste piles consisting of mine wastes,
21	tailings, coal processing wastes, or other liquid and solid wastes and used either
22	temporarily or permanently as dams or embankments;
23	6. establish on regraded areas and all other lands affected, a diverse and
24	permanent vegetative cover capable of self-regeneration and plant succession and
25	at least equal in extent of cover to the natural vegetation of the area;
26	7. protect offsite areas from damages which may result from such mining
27	operations;
28	8. eliminate fire hazards and otherwise eliminate conditions which constitute a
29	hazard to health and safety of the public;
30	

1	9. minimize the disturbances of the prevailing hydrologic balance at the minesite
2	and in associated offsite areas and to the quantity of water in surface water and
3	groundwater systems both during and after coal mining operations and during
4	reclamation by-
5	a. avoiding acid or other toxic mine drainage by such measures as, but not limited
6	<u>to –</u>
7	i. preventing or removing water from contact with toxic producing deposits;
8	ii. treating drainage to reduce toxic content which adversely affects downstream
9	water upon being released to water courses;
10	iii. casing, sealing, or otherwise managing boreholes, shafts, and wells to keep
11	acid or other toxic drainage from entering ground and surface waters; and
12	b. conducting surface coal mining operations so as to prevent, to the extent
13	possible using the best technology currently available, additional contributions of
14	suspended solids to streamflow or runoff outside the permit area (but in no event
15	shall such contributions be in excess of requirements set by applicable federal,
16	Navajo Nation, state, or non-Navajo tribal law), and avoiding channel deepening
17	or enlargement in operations requiring the discharge of water from mines;
18	10. with respect to other surface impacts not specified in this subsection including
19	the construction of new roads or the improvement or use of existing roads to gain
20	access to the site of such activities and for haulage, repair areas, storage areas,
21	processing areas, shipping areas, and other areas upon which are sited structures,
22	facilities, or other property or materials on the surface, resulting from or incident
23	to such activities, operate in accordance with the standards established under
24	section 515 of this Act for such effects which result from surface coal mining
25	operations: Provided, That the Program Manager shall make such modifications
26	in the requirements imposed by this subparagraph as are necessary to
27	accommodate the distinct difference between surface and underground coal
28	mining;
29	11. to the extent possible using the best technology currently available, minimize
30	disturbances and adverse impacts of the operation on fish, wildlife, and related

1	environmental values, and achieve enhancement of such resources where
2	practicable;
3	12. locate openings for all new drift mines working acid-producing or iron-
4	producing coal seams in such a manner as to prevent a gravity discharge of water
5	from the mine.
6	C. In order to protect the stability of the land, the NSCMP shall suspend
7	underground coal mining under urbanized areas, cities, towns, and communities
8	and adjacent to industrial or commercial buildings, major impoundments, or
9	permanent streams if he or she finds imminent danger to inhabitants of the
10	urbanized areas, cities, towns, and communities.
11	D. The provisions of this Act relating to permits, bonds, inspections and
12	enforcement, public review, and administrative and judicial review shall be
13	applicable to surface operations and surface impacts incident to an underground
14	coal mine with such modifications to the permit application requirements, permit
15	approval or denial procedures, and bond requirements as are necessary to
16	accommodate the distinct difference between surface and underground coal
17	mining. The Program Manager shall promulgate such modifications in
18	accordance with the rulemaking procedure established in section 501 of this Act
19	and shall ensure that such modifications are consistent with the applicable
20	provisions of 30 CFR Chapter VII.
21	
22	SEC. 517. Inspections and Monitoring
23	A. For the purpose of developing, enforcing, and administering the Navajo
24	regulatory program under this Act, or in the administration and enforcement of
25	any permit under this Act, or of determining whether any person is in violation of
26	any requirement of the Navajo regulatory program or any other requirements of
27	this Act—
28	1. the NSCMP shall require any permittee to (A) establish and maintain
29	appropriate records, (B) make monthly reports to the NSCMP, (C) install, use,
30	and maintain any necessary monitoring equipment or methods, (D) evaluate

1	results in accordance with such methods, at such locations and intervals, and in
2	such manner as the NSCMP shall prescribe, and (E) provide such other
3	information relative to surface coal mining and reclamation operations as the
4	NSCMP deems reasonable and necessary;
5	2. for those surface coal mining and reclamation operations which remove or
6	disturb strata that serve as aquifers which significantly ensure the hydrologic
7	balance of water use either on or off the mining site, the NSCMP shall specify
8	those
9	a. monitoring sites to record the quantity and quality of surface drainage above
10	and below the mine site as well as in the potential zone of influence;
11	b. monitoring sites to record level, amount, and samples of groundwater and
12	aquifers potentially affected by the mining and also directly below the lowermost
13	(deepest) coal seam to be mined;
14	c. records of well logs and borehole data to be maintained; and
15	d. monitoring sites to record precipitation. The monitoring data collection and
16	analysis required by this section shall be conducted according to standards and
17	procedures set forth by the NSCMP in order to ensure their reliability and
18	validity; and
19	3. the authorized representatives of the Program Manager, without advance notice
20	and upon presentation of appropriate credentials: (A) shall have the right of entry
21	to, upon, or through any surface coal mining and reclamation operations or any
22	premises in which any records required to be maintained under paragraph (1) of
23	this subsection are located; and (B) may at reasonable times, and without delay,
24	have access to and copy any record or inspect any monitoring equipment or
25	method of operation required under this Act.
26	B. The inspections by the NSCMP shall (1) occur on an irregular basis averaging
27	not less than one partial inspection per month and one complete inspection per
28	calendar quarter for the surface coal mining and reclamation operation covered by
29	each permit; (2) occur without prior notice to the permittee or his or her agents or
30	employees except for necessary onsite meetings with the permittee; and (3)

1	include the filing of inspection reports adequate to enforce the requirements of
2	and to carry out the terms and purposes of this Act.
3	C. Each permittee shall conspicuously maintain at the entrances to the surface
4	coal mining and reclamation operations a clearly visible sign which sets forth the
5	name, business address, and phone number of the permittee and the permit
6	number of the surface coal mining and reclamation operations. Such sign shall
7	include the following — "Mining and Reclamation Operations are regulated by
8	the NAVAJO SURFACE COAL MINING PROGRAM."
9	D. Each inspector, upon detection of each violation of any requirement of the
10	Navajo regulatory program or this Act, shall forthwith notify the operator in
11	writing, and shall report in writing any such violation to the NSCMP.
12	E. Copies of any records, reports, inspection materials, or information obtained
13	under this Act by the NSCMP shall be made immediately available to the public
14	at central and sufficient locations in the Navajo Nation and in the Chapter offices
15	of the Navajo Nation Chapters within which the surface coal mining operation is
16	located so that they are conveniently available to residents in the areas of mining.
17	F. Review; procedures for inspection
18	1. Any person who is or may be adversely affected by a surface mining operation
19	may notify the Program Manager or his or her authorized representative, in
20	writing, of any violation of this Act which he or she has reason to believe exists at
21	the surface mining site. The Program Manager shall, by regulation, establish
22	procedures for the informal review of any refusal by a representative of the
23	Program Manager to issue a citation with respect to any such alleged violation.
24	The Program Manager shall furnish such persons requesting the review a written
25	statement of the reasons for the Program Manager's final disposition of the case.
26	2. The Program Manager shall also, by regulation, establish procedures to ensure
27	that adequate and complete inspections are made. Any person may notify the
28	Program Manager of any failure to make such inspections, after which the
29	Program Manager shall determine whether adequate and complete inspections
30	have been made. The Program Manager shall furnish such persons a written

statement of the reasons for the Program Manager's determination that adequate and complete inspections have or have not been conducted.

SEC. 518. Penalties

A. In the enforcement of the Navajo regulatory program and this Act, any permittee who violates any permit condition, or who violates any other provision of this Act, may be assessed a civil penalty by the NSCMP, provided that if such violation leads to the issuance of a cessation order under section 521 of this Act, the civil penalty shall be assessed. Such penalty shall not exceed \$12,000 for each violation. Each day of continuing violation may be deemed a separate violation for purposes of penalty assessments. In determining the amount of the penalty, consideration shall be given to the permittee's history of previous violations at the particular surface coal mining operation; the seriousness of the violation, including any irreparable harm to the environment and any hazard to public health or safety; whether the permittee was negligent; and the demonstrated good faith of the permittee so charged in attempting to achieve rapid compliance after notification of the violation.

B. A civil penalty shall be assessed by the NSCMP only after the person charged with a violation described under subsection (A) of this section has been given an opportunity for an administrative hearing. Where such an administrative hearing has been held, the NNOHA shall make findings of fact, and it shall issue a written decision as to the occurrence of the violation and the amount of the penalty which is warranted, incorporating, when appropriate, an order therein requiring that the penalty be paid. When appropriate, the NNOHA shall consolidate such hearings with other proceedings under section 521 of this Act. Any administrative hearing under this section shall be on the record and conducted in accordance with the regulations for administrative hearings promulgated pursuant to section 201(C)(2) of this Act. Where the person charged with such a violation fails to avail himself of the opportunity for an administrative hearing, a civil penalty shall be assessed by the NSCMP after the NSCMP has determined that a violation did occur and the amount of the penalty which is warranted and has issued an order requiring that the penalty be paid.

C. Upon the issuance of a notice or order charging that a violation of this Act has occurred, the NSCMP shall inform the operator within 30 days of the proposed amount of said penalty. The person charged with the penalty shall then have 30 days to pay the proposed penalty in full or, if the person wishes to contest either the amount of the penalty or the fact of the violation, forward the proposed amount to the NSCMP for placement in an escrow account. Failure to forward the money to the NSCMP within 30 days shall result in a waiver of all legal rights to contest the violation or the amount of the penalty. If through administrative or judicial review of the proposed penalty, it is determined that no violation occurred, or that the amount of the penalty should be reduced, the NSCMP shall within 30 days remit the appropriate amount to the person, with interest at the rate of six percent, or at the prevailing U.S. Department of the Treasury rate, whichever is greater.

D. Civil penalties owed under this Act may be recovered in a civil action brought by the Attorney General, at the request of the Program Manager, in the Navajo Nation District Court for the District of Window Rock.

E. Any person who willfully and knowingly violates a condition of a permit issued pursuant to the Navajo regulatory program or fails or refuses to comply with any order issued under section 521 or section 526 of this Act, or any order incorporated in a final decision issued by the Program Manager or NNOHA under this Act, except an order incorporated in a decision issued under subsection (B) of this section, shall, upon conviction, be subject to the sanctions and penalties of SMCRA section 518(e). Any criminal actions associated with surface coal mining and reclamation operations on Navajo regulatory program lands are enforced by OSMRE under SMCRA section 518. The NSCMP will notify OSMRE of such potential criminal actions and recommend that OSMRE pursue criminal penalties under SMCRA. F. Whenever a corporate permittee violates a condition of a permit issued pursuant to the Navajo regulatory program or fails or refuses to comply with any order issued under section 521 of this Act, or any order incorporated in a final decision issued by the Program Manager or NNOHA under this Act except an order incorporated in a decision issued under subsection (B) of this section, any director, officer, or agent of such corporation who willfully and knowingly authorized, ordered, or carried out such violation, failure, or refusal shall be subject to the same civil penalties, fines, and imprisonment that may be imposed upon a person under subsections (A) and (E) of this section.

G. Whoever knowingly makes any false statement, representation, or certification, or knowingly fails to make any statement, representation, or certification in any application, record, report, plan, or other document filed or required to be maintained pursuant to the Navajo regulatory program or any order of decision issued by the Program Manager or NNOHA under this Act, shall, upon conviction, be subject to the sanctions and penalties of SMCRA section 518(g). Any criminal actions associated with surface coal mining and reclamation operations on Navajo regulatory program lands are enforced by OSMRE under SMCRA section 518. The NSCMP will notify OSMRE of such potential criminal actions and recommend that OSMRE pursue criminal penalties under SMCRA.

H. Any operator who fails to correct a violation for which a citation has been issued under section 521(A) of this Act within the period permitted for its correction shall be assessed a civil penalty of not less than \$925 for each day during which such failure or violation continues. The period permitted for such corrections shall not end until (1) the entry of a final order by the NNOHA, in the case of any review proceedings under section 525 of this Act initiated by the operator wherein the NNOHA orders, after an expedited hearing, the suspension of the abatement requirements of the citation after determining that the operator will suffer irreparable loss or damage from the application of those requirements, or (2) the entry of an order of the court, in the case of any review proceedings under section 526 of this Act initiated by the operator wherein the court orders the suspension of the abatement requirements of the citation.

I. Nothing herein shall be construed to eliminate any additional enforcement rights or procedures which are or may become available to the NSCMP under Navajo Nation law or applicable federal law, but which are not specifically enumerated herein.

SEC. 519. Release of Performance Bonds or Deposits

A. The permittee may file a request with the NSCMP for the release of all or part of a performance bond or deposit. Within 30 days after any application for bond or deposit release has been filed with the NSCMP, the operator shall submit a copy of an advertisement placed at least once a week for four successive weeks in a newspaper of general circulation in the locality of the surface coal mining operation. Such advertisement shall be considered part of any bond release application and shall contain a notification of the precise location of the land affected, the number of acres, the permit and the date approved, the amount of the bond filed and the portion sought to be released, the type and dates of reclamation work performed, and a description of the results achieved as they relate to the operator's approved reclamation plan. In addition, as part of any bond release application, the applicant shall submit copies of letters which he or she has sent to adjoining landowners; planning agencies and other appropriate agencies of the Navajo Nation, federal, state, and local governments; and sewage and water treatment authorities or water companies in the locality in which the surface coal mining and reclamation activities took place, notifying them of his or her intention to seek release from the bond or deposit.

B. Upon receipt of the notification and request, the NSCMP shall within 30 days conduct an inspection and evaluation of the reclamation work involved. Such evaluation shall consider, among other things, the degree of difficulty to complete any remaining reclamation, whether pollution of surface water and groundwater is occurring, the probability of such pollution continuing, and the estimated cost of

1	abatement. The NSCMP shall notify the permittee in writing of its decision to
2	release or not to release all or part of the performance bond or deposit within 30
3	days from the inspection and evaluation if no public hearing is held pursuant to
4	section 519(F) of this Act, and if a public hearing is held pursuant to section
5	519(F), such notification shall occur within 30 days thereafter. Any person
6	having an interest which is or may be adversely affected by such decision shall
7	have to right to file an appeal with the NNOHA in accordance with section 525 of
8	this Act.
9	C. The NSCMP may release in whole or in part said bond or deposit if the
10	NSCMP is satisfied the reclamation covered by the bond or deposit or portion
11	thereof has been accomplished as required by this Act according to the following
12	schedule:
13	1. When the operator completes the backfilling, regrading, and drainage control of
14	a bonded area in accordance with his or her approved reclamation plan, the
15	release of up to 60 percent of the bond or collateral for the applicable permit area.
16	2. After revegetation has been established on the regraded, mined lands in
17	accordance with the approved reclamation plan, the release of an amount of bond
18	to be determined by the NSCMP. When determining the amount of bond to be
19	released after successful revegetation has been established, the NSCMP shall
20	retain that amount of bond for the revegetated area which would be sufficient for
21	a third party to cover the cost of reestablishing revegetation and for the period
22	specified for operator responsibility in section 515(B)(20) of this Act. No part of
23	the bond or deposit shall be released under this paragraph so long as the lands to
24	which the release would be applicable are contributing suspended solids to
25	streamflow or runoff outside the permit area in excess of the requirements set by
26	section 515(B)(10) of this Act or until soil productivity for prime farmlands has
27	returned to equivalent levels of yield as nonmined land of the same soil type in
28	the surrounding area under equivalent management practices as determined from
29	the soil survey performed pursuant to section 507(B)(16) of this Act. Where a silt
30	dam is to be retained as a permanent impoundment pursuant to section 515(B)(8)

1	of this Act, a portion of the bond may be released under this paragraph so long as
2	adequate and enforceable written provisions for sound future maintenance by the
3	operator or the landowner have been made with the NSCMP.
4	3. When the operator has completed successfully all surface coal mining and
5	reclamation activities, but not before the expiration of the period specified for
6	operator responsibility in section 515(B)(20) of this Act, the release of the
7	remaining portion of the bond: Provided, however, that no bond shall be fully
8	released until all reclamation requirements of this Act are fully met.
9	D. If the NSCMP disapproves the application for release of the bond or deposit, or
10	portion thereof, the NSCMP shall notify the permittee, in writing, stating the
11	reasons for disapproval and recommending corrective actions necessary to secure
12	said release and allowing opportunity for a public hearing.
13	E. When any application for total or partial release of a bond or deposit is filed
14	with the NSCMP, the NSCMP shall notify the Navajo Nation Chapters in which a
15	surface coal mining operation is located and all appropriate Navajo Nation,
16	federal, state, and local agencies, as determined by the NSCMP. Notification
17	shall occur by certified mail at least 30 days prior to the release of all or a portion
18	of the bond or deposit.
19	F. Any person with a valid legal interest that might be adversely affected by
20	release of the bond or deposit, or the responsible officer or head of any federal,
21	Navajo Nation, state, or local agency that has jurisdiction or special expertise with
22	respect to any environmental, social, or economic impact involved in the
23	operations, or is authorized to develop and enforce environmental standards with
24	respect to such operations, shall have the right to file written objections to the
25	proposed release from bond or deposit to the NSCMP within 30 days after the last
26	publication of the above notice. If written objections are filed, and a hearing
27	requested, the NSCMP shall inform all the interested parties of the time and place
28	of the hearing, and hold a public hearing in the locality of the surface coal mining
29	operation proposed for release of the bond or deposit within 30 days of the request
30	for such hearing. The date, time, and location of such public hearings shall be

1	advertised by the NSCMP in a newspaper of general circulation in the locality for
2	two consecutive weeks. At the option of the objector(s), the NSCMP shall hold a
3	public hearing in the locality of the surface coal mining operation proposed for
4	release of the bond or deposit or at the NSCMP's offices within 30 days of the
5	request for such hearing.
6	G. Without prejudice to the rights of the objector(s), the applicant, or the
7	responsibilities of the NSCMP pursuant to this section, the NSCMP may establish
8	an informal conference as provided in section 513 of this Act to resolve such
9	written objections.
10	H. For the purpose of conducting a hearing under subsection (F) of this section,
11	the NSCMP is hereby authorized and empowered to administer oaths, subpoena
12	witnesses or written or printed materials, compel the attendance of witnesses or
13	production of the materials, and take evidence, including but not limited to
14	inspections of the land affected and other surface coal mining operations carried
15	on by the applicant in the general vicinity. A verbatim record of each public
16	hearing required by this Act shall be made, and a transcript made available on the
17	motion of any party or by order of the NSCMP.
18	
19	SEC. 520. Citizen Suits
20	A. Any person having an interest which is or may be adversely affected may
21	commence a civil action in Navajo Nation District Court for the District of
22	Window Rock on his or her own behalf to compel compliance with this Act
23	1. against the Navajo Nation or any other governmental instrumentality or agency
24	of the Navajo Nation to the extent permitted by section 201(I) of this Act and in
25	accordance with the procedural requirements of paragraph (B)(1) of this section,
26	which is alleged to be in violation of the provisions of SMCRA or this Act or of
27	any rule, regulation, order or permit issued pursuant thereto, or against any person
28	who is alleged to be in violation of any rule, regulation, order, or permit issued
29	pursuant to SMCRA or this Act; or
30	

1	2. against the NSCMP to the extent permitted by section 201(I) of this Act and in
2	accordance the procedural requirements of paragraph (B)(2) of this section where
3	there is alleged a failure of the NSCMP to perform any act or duty under SMCRA
4	or this Act which is not discretionary with the NSCMP.
5	B. No action may be commenced —
6	1. under paragraph (A)(1) of this section —
7	a. until the plaintiff fulfills the jurisdictional condition precedent procedures of the
8	Navajo Sovereign Immunity Act codified at 1 N.N.C. § 555 and any successors
9	thereto and has given notice in writing of the violation to any alleged violator; or
10	b. if the Navajo Nation has commenced and is diligently prosecuting a civil action
11	in the Navajo Nation District Court for the District of Window Rock to require
12	compliance with the provisions of this Act, or any rule, regulation, order, or
13	permit issued pursuant to this Act, but in any such action, such person may
14	intervene as a matter of right; or
15	2. under paragraph (A)(2) of this section until the plaintiff fulfills the
16	jurisdictional condition precedent procedures of the Navajo Sovereign Immunity
17	Act codified at 1 N.N.C. § 555 and any successors thereto except that such action
18	may be brought immediately after the notice is served upon the appropriate
19	Navajo Nation officials as required at 1 N.N.C. § 555 (a)(1) and (2) and any
20	amendments or successors thereto in the case where the violation or order
21	complained of constitutes an imminent threat to plaintiff's health or safety or
22	would immediately affect a legal interest of the plaintiff.
23	C. In any action under this section, the NSCMP, if not a party, may intervene as a
24	matter of right.
25	D. The Navajo Nation District Court, in issuing any final order in any action
26	brought pursuant to subsection (A) of this section, may award costs of litigation
27	(including attorney and expert witness fees) to any party, whenever the court
28	determines such award is appropriate. The Navajo Nation District Court may, if a
29	temporary restraining order or preliminary injunction is sought, require the filing
30	

1	of a bond or equivalent security in accordance with the Navajo Rules of Civil
2	Procedure.
3	E. Nothing in this section shall restrict any right which any person (or class of
4	persons) may have under other applicable law to seek enforcement of any of the
5	provisions of this Act and the regulations thereunder or to seek any other relief
6	(including relief against the NSCMP).
7	F. Any person who is injured in his or her person or property through the violation
8	by any operator of any rule, regulation, order, or permit issued pursuant to this
9	Act may bring an action for damages (including reasonable attorney and expert
10	witness fees) in the Navajo Nation District Court for the District of Window
11	Rock. Nothing in this subsection shall affect rights established by or limits
12	imposed under any applicable workers' compensation laws.
13	G. After exhausting all Navajo Nation remedies with respect to a civil action
14	arising under the Navajo regulatory program, an interested party may, pursuant to
15	section 710(j)(4)(A) of SMCRA, file a petition for judicial review of the civil
16	action in the United States Court of Appeals for the circuit in which the surface
17	coal mining operation named in the petition is located, or, for civil actions in
18	which no surface coal mining operation is named in the petition, in the United
19	States Court of Appeals for the Ninth Circuit.
20	
21	SEC. 521. Enforcement
22	A. Inspections and enforcement
23	1. Whenever, on the basis of any information available to him or her, including
24	receipt of information from any person, the Program Manager has reason to
25	believe that any person is in violation of any requirement of this Act or any permit
26	condition required by this Act, the Program Manager shall immediately order
27	inspection of the surface coal mining operation at which the alleged violation is
28	occurring unless the information available to the Program Manager was found in a
29	previous inspection of such surface coal mining operation, and the alleged
30	violation was already addressed by the NSCMP. When the inspection results

from information provided to the Program Manager by any person, the Program Manager shall notify such person when the inspection is proposed to be carried out and such person shall be allowed to accompany the inspector during the inspection. If the person informing the Program Manager of an alleged violation has provided adequate proof that an imminent danger of significant environmental harm exists, the Program Manager or his or her authorized representative shall immediately inspect the operation. If no inspection is to be conducted, such person shall be notified of the reason(s) for not inspecting.

2. When, on the basis of any inspection, the Program Manager or his or her authorized representative determines that any condition or practices exist, or that any permittee is in violation of any requirement of this Act or any permit condition required by this Act, which condition, practice, or violation also creates an imminent danger to public health or safety, or is causing, or can reasonably be expected to cause significant, imminent environmental harm to land, air, or water resources, the Program Manager or his or her authorized representative shall immediately order a cessation of surface coal mining and reclamation operations or the portion thereof relevant to the condition, practice, or violation. Such cessation order shall remain in effect until the Program Manager or his or her authorized representative determines that the condition, practice, or violation has been abated, or until the order is modified, vacated, or terminated by the Program Manager or his or her authorized representative pursuant to paragraph (A)(5) of this section. Where the Program Manager finds that the cessation of surface coal mining and reclamation operations, or any portion thereof, will not completely abate the imminent danger to public health or safety or the significant imminent environmental harm to land, air, or water resources, the Program Manager shall, in addition to the cessation order, impose affirmative obligations on the operator requiring him or her to take whatever steps the Program Manager deems necessary to abate the imminent danger or the significant environmental harm. 3. When, on the basis of any inspection, the Program Manager or his or her

authorized representative determines that any permittee is in violation of any

requirement of this Act or any permit condition required by this Act, but such violation does not create an imminent danger to public health or safety, or cannot be reasonably expected to cause significant, imminent environmental harm to land, air, or water resources, the Program Manager or his or her authorized representative shall issue a notice to the permittee or his or her agent fixing a reasonable time but not more than 90 days for abating the violation. Such notice shall also provide opportunity for an administrative hearing. If, upon expiration of the period of time as originally fixed or subsequently extended, for good cause shown and upon the written finding of the Program Manager or his or her authorized representative, the Program Manager or his or her authorized representative finds that the violation has not been abated, he or she shall immediately order a cessation of surface coal mining and reclamation operations or the portion thereof relevant to the violation. Such cessation order shall remain in effect until the Program Manager or his or her authorized representative determines that the violation has been abated, or until the order is modified, vacated, or terminated by the Program Manager or his or her authorized representative pursuant to paragraph (A)(5) of this section. In the order of cessation issued by the Program Manager or his or her authorized representative under this subsection, the Program Manager or his or her authorized representative shall determine the steps necessary to abate the violation in the most expeditious manner possible, and shall include the necessary measures in the order.

4. When, on the basis of any inspection, the Program Manager or his or her authorized representative determines that a pattern of violations of any requirements of this Act or any permit conditions required by this Act exists or has existed, and if the Program Manager or his or her authorized representative also finds that such violations are caused by the unwarranted failure of the permittee to comply with any requirements of this Act or any permit conditions, or that such violations are willfully caused by the permittee, the Program Manager or his or her authorized representative shall forthwith issue an order to the permittee to show cause as to why the permit should not be suspended or revoked, and shall provide the opportunity for an administrative hearing. If a hearing is requested the NNOHA shall inform all interested parties of the time and place of the hearing. Upon the permittee's failure to show cause as to why the permit should not be suspended or revoked, the NNOHA shall forthwith suspend or revoke the permit.

5. Notices and orders issued pursuant to this section shall set forth with reasonable specificity the nature of the violation and the remedial action required, the period of time established for abatement, and a reasonable description of the portion of the surface coal mining and reclamation operation to which the notice or order applies. Each notice or order issued under this section shall be given promptly to the permittee or his or her agent by the Program Manager or his or her authorized representative who issues such notice or order, and all such notices and orders shall be in writing and shall be signed by such authorized representatives or the Program Manager. Any notice or order issued pursuant to this section may be modified, vacated, or terminated by the Program Manager or his or her authorized representative: Provided, that any notice or order issued pursuant to this section which requires cessation of mining by the operator shall expire within 30 days of actual notice to the operator unless an administrative hearing is held at the site or within such reasonable proximity to the site that any viewings of the site can be conducted during the course of the administrative hearing.

B. The Program Manager may request the Attorney General to institute a civil
 action for relief, including a permanent or temporary injunction, restraining order,
 or any other appropriate order in the Navajo Nation District Court for the District
 of Window Rock, whenever such permittee or his or her agent —

- 26 <u>1. violates or fails or refuses to comply with any order or decision issued by the</u>
 27 Program Manager or his or her authorized representative under this Act;
- 28 <u>2. interferes with, hinders, or delays the Program Manager or his or her authorized</u>
 29 representatives in carrying out the provisions of this Act;
- 30 3. refuses to admit such authorized representative to the operation;

4. refuses to permit inspection of the operation by such authorized representative;
5. refuses to furnish any information or report requested by the Program Manager or his or her authorized representative in furtherance of the provisions of this Act; or

6. refuses to permit access to, and copying of, such records as the Program Manager or his or her authorized representative determines necessary in carrying out the provisions of this Act. The Navajo Nation District Court shall have jurisdiction to provide such relief as may be appropriate. Temporary restraining orders shall be issued in accordance with Rule 65 and Rule 65.1 of the Navajo Rules of Civil Procedure. Any relief granted by the Navajo Nation District Court to enforce an order under clause (a) of this section shall continue in effect until the completion or final termination of all proceedings for review of such order under this Act, unless, prior thereto, the Navajo Nation District Court granting such relief sets it aside or modifies it. After exhausting all Navajo Nation remedies with respect to a civil action arising under the Navajo regulatory program, an interested party may, pursuant to section 710(j)(4)(A) of SMCRA, file a petition for judicial review of the civil action in the United States Court of Appeals for the circuit in which the surface coal mining operation named in the petition is located.

C. Nothing within this Act shall be construed so as to eliminate any additional enforcement rights or procedures which are available to the NSCMP under Navajo Nation law, but which are not specifically enumerated herein.

24 SEC. 522. Land Unsuitable for Surface Coal Mining

A. The NSCMP shall establish a planning process.

1. This process shall enable objective decisions based upon competent and scientifically sound data and information as to which, if any, areas of Navajo regulatory program lands are unsuitable for all or certain types of surface coal mining operations pursuant to the standards set forth in paragraphs (2) and (3) of

1	this subsection, but such designation shall not prevent the mineral exploration
2	pursuant to this Act of any area so designated.
3	2. Upon petition pursuant to subsection (B) of this section, the NSCMP shall

16	substantial loss or reduction of the long-range productivity of the water supply or
17	of food or fiber products, and such lands to include aquifers and aquifer recharge
18	areas; or
19	d. affect natural hazard lands in which such operations could substantially
20	endanger life and property, such lands to include areas subject to frequent
21	flooding and areas of unstable geology.
22	4. The NSCMP is responsible for surface coal mining lands review. The NSCMP
23	shall develop a process which includes —
24	a. a database and an inventory system which will facilitate the proper evaluation
25	of the capacity of different areas of the Navajo Nation to support and permit
26	reclamation of surface coal mining operations;
27	b. a method or methods for implementing land-use planning decisions concerning
28	surface coal mining operations; and
29	c. proper notice and opportunities for public participation, including a public
30	hearing prior to making any designation or redesignation, pursuant to this section;

5. Determinations of the unsuitability of land for surface coal mining, as provided for in this section, shall be integrated as closely as possible with present and future land-use planning and regulation processes of federal, Navajo Nation, and local agencies.

6. The requirements of this section shall not apply to lands on which surface coal mining operations are being conducted under a permit issued by the NSCMP pursuant to this Act or by OSMRE under the Federal Program for Indian Lands, or where substantial legal and financial commitments in such operation were in existence prior to January 4, 1977.

10 B. Any person having an interest which is or may be adversely affected shall have the right to petition the NSCMP to have an area designated as unsuitable for surface coal mining operations, or to have such a designation terminated. Such 12 petition shall contain allegations of facts with supporting evidence which would 13 tend to establish the allegations. Within ten months after receipt of a petition, the 14 15 NSCMP shall hold a public hearing in the locality of the affected area, after appropriate notice and publication of the date, time, and location of such hearing. 16 After a person having an interest which is or may be adversely affected has filed a 17 petition and before the hearing, as required by this subsection, any person may 18 intervene by filing allegations of facts with supporting evidence which would tend 19 20 to establish the allegations. Within 60 days after such hearing, the NSCMP shall 21 issue and furnish to the petitioner and any other party to the hearing, a written decision regarding the petition, and the reasons therefor. Any person having an 22 interest which is or may be adversely affected by such decision shall have the right to file an appeal with the Navajo Nation Supreme Court in accordance with 24 section 126(A)(2) of this Act. In the event that all the petitioners stipulate 25 agreement prior to the requested hearing, and withdraw their requests, such 26 hearing need not be held. 27

C. Prior to designating any land areas as unsuitable for surface coal mining operations, the NSCMP shall prepare a detailed statement on (i) the potential coal

1	resources of the area, (ii) the demand for coal resources, and (iii) the impact of
2	such designation on the environment, the economy, and the supply of coal.
3	D. Subject to valid existing rights, no surface coal mining operations except those
4	which existed on August 3, 1977 shall be permitted —

21	3. which will adversely affect any publicly owned park or place included in, or

24	place is located, and the federal, Navajo Nation, state, or local agency with
25	jurisdiction over the park or the historic place;
26	4. within 100 feet of the outside right-of-way line of any public road, except
27	where mine access roads or haulage roads join such right-of-way line and except
28	that the NSCMP may permit such roads to be relocated or the area affected to lie
29	within 100 feet of such road, if after public notice and opportunity for public
30	hearing in the locality a written finding is made that the interests of the public, the

landowners, and authorized land users who may be affected thereby will be
protected;
5. within 300 feet from any occupied dwelling, unless knowingly and voluntarily
waived in writing by the owner thereof, nor within 300 feet of any public

cultural, park, wilderness, or wildlife refuge.

Any agency, unit, or instrumentality of federal, Navajo Nation, state, or local
government, including any publicly-owned utility or publicly-owned corporation

surface coal mining operations on Navajo regulatory program lands shall comply
with the provisions of this Act.
SEC. 525. Administrative Review
A. Procedures for review.
1. A permittee issued a notice or order by the Program Manager or his or her
authorized representative pursuant to the provisions of paragraph (A)(2) or (3) of
section 521 of this Act or any person having an interest which is or may be
adversely affected by such notice or order or by any modification, vacation, or
termination of such notice or order, may apply to the NSCMP for review of the
notice or order within 30 days of receipt thereof, or within 30 days of its
modification, vacation, or termination. Upon receipt of such application, the
NSCMP shall cause such investigation to be made as he or she deems appropriate.
Such investigation shall provide an opportunity for an administrative hearing by
the NNOHA, at the request of the applicant or the person having an interest which

17	of the application for review unless temporary relief has been granted by the

21	the applicant may file with the NNOHA a written request that the NNOHA grant

Following the issuance of an order to show cause as to why a permit should 7 not be suspended or revoked pursuant to section 521 of this Act, the NNOHA 8 shall hold an administrative hearing after giving written notice of the time, place, 9 and date thereof. Any such hearing shall be of record and conducted in 10 conformity with the regulations for administrative hearings promulgated pursuant 11 to section 201(C)(2) of this Act. Within 60 days following the administrative 12 hearing, the NNOHA shall issue and furnish to the permittee and all other parties 13 to the hearing a written decision, and the reasons therefor, concerning suspension 14 or revocation of the permit. If the NNOHA revokes the permit, the permittee 15 shall immediately cease surface coal mining operations on the permit area and 16 shall complete reclamation within a period specified by the NNOHA, or the 17 NSCMP shall declare as forfeited the performance bond(s) for the operation. 18 E. Whenever an order is issued under this section, or as a result of any 19 20 administrative proceeding under this Act, at the request of any person, a sum equal to the aggregate amount of all costs and expenses (including attorney fees) 21 as determined by the NNOHA to have been reasonably incurred by such person 22 for or in connection with his or her participation in such proceedings, including 23 any judicial review of agency actions, may be assessed against either party as the 24 court, resulting from judicial review, or the NNOHA, resulting from 25 administrative proceedings, deems proper. 26 27 SEC. 526. Judicial Review 28 29 A. Procedures.

1. After exhausting available administrative remedies, any action constituting rulemaking under this Act shall be subject to judicial review by the Navajo Nation District Court for the District of Window Rock, with a right of appeal to the Navajo Nation Supreme Court. Any action subject to judicial review under this subsection shall be affirmed unless the court concludes that such action is arbitrary, capricious, or otherwise inconsistent with law. A petition for review of any action subject to judicial review under this subsection shall be filed in the Navajo Nation District Court for the District of Window Rock within 60 days from the date of such action, or after such date if the petition is based solely on grounds arising after the sixtieth day. Any such petition may be made by any person who participated in the administrative proceedings and who is aggrieved by the action of the Program Manager or the NSCMP.

2. Any order or decision issued by the NNOHA in a civil penalty proceeding or any other adjudicatory administrative proceeding conducted by the NNOHA or the NSCMP pursuant to this Act shall be subject to judicial review on or before 30 days from the date of such order or decision in accordance with paragraph (B) of this section in the Navajo Nation Supreme Court. In the case of a proceeding to review an order or decision issued by the NNOHA under the penalty section of this Act, the Court shall have jurisdiction to enter an order requiring payment of any civil penalty assessment enforced by its judgment.

B. The Court shall hear such petition or complaint solely on the record made before the Program Manager, the NSCMP, or the NNOHA. Except as provided in subsection (A)(1), the findings of the Program Manager, the NSCMP, or the NNOHA, if supported by substantial evidence on the record considered as a whole, shall be conclusive. The Court may affirm, vacate, or modify any order or decision or may remand the proceedings to the Program Manager, the NSCMP, or the NNOHA for such further action as it may direct. Pursuant to SMCRA section 710(j)(4)(i), after exhausting all remedies with respect to a civil action arising under the Navajo regulatory program, an interested party may file a petition for judicial review of the civil action in the United States Court of Appeals for the

SEC. 611. Experimental Practices

In order to encourage advances in coal mining and reclamation practices or to allow postmining land use for industrial, commercial, residential, or public use (including recreational facilities), the NSCMP, with approval by the OSMRE Director, may authorize departures in individual cases, on an experimental basis, from the environmental protection performance standards promulgated under sections 515 and 516 of this Act. Such departures may be authorized if (i) the experimental practices are potentially more or at least as environmentally protective, during and after coal mining operations, as those required by promulgated standards; (ii) the coal mining operations approved for particular land use or other purposes are not larger or more numerous than necessary to determine the effectiveness and economic feasibility of the experimental practices; and (iii) the experimental practices do not reduce the protection afforded public health and safety below that provided by promulgated standards.

D. All reclamation activities proposed to be conducted during the current calendar year and subsequent calendar year must conform to the schedule and specifications of the reclamation plan in the permit application approved by the NSCMP pursuant to section 510 of this Act.

SUBCHAPTER 7 - RESERVED

Section Four. Effective Date


The Act enacted herein shall be effective upon its approval pursuant to 2 N.N.C. §221.

Section Five. Codification

The provisions of the Act which amend or adopt new sections of the Navajo Nation Code shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel shall renumber sections of this legislation such that the legislation conforms to the standard form of the Navajo Nation Code. The Office of Legislative Counsel shall incorporate such amended provisions in the next codification of the Navajo Nation Code.

Section Six. Savings Clause

Should any provision of this Act be determined invalid by the Navajo Nation Supreme Court, or the District Court of the Navajo Nation, without appeal to the Navajo Nation Supreme Court, or any other court of competent jurisdiction, those portions of this Act which are not determined invalid shall remain the law of the Navajo Nation. *Office of Legislative Counsel Telephone: (928) 871-7166 Fax # (928) 871-7576*

As requested, I have prepared the above-referenced proposed resolution and associated legislative summary sheet pursuant to your request for legislative drafting.

There is a two-thirds vote requirement for this legislation which will waive the sovereign immunity of the Navajo Nation with respect to "citizen suits."

Based on existing law and review of documents submitted, the resolution as drafted is legally sufficient. As with any action of government however, it can be subject to review by the courts in the event of proper challenge. Please ensure that his particular resolution request is precisely what you want. You are encouraged to review the proposed resolution to ensure that it is drafted to your satisfaction.

The Office of Legislative Counsel confirms the appropriate standing committee(s) based on the standing committees powers outlined in 2 N.N.C. §§301, 401, 501, 601 and 701. Nevertheless,

"the Speaker of the Navajo Nation Council shall introduce [the proposed resolution] into the legislative process by assigning it to the respective oversight committee(s) of the Navajo Nation Council having authority over the matters for proper consideration." 2 N.N.C. §164(A)(5).
