**PURPOSE:** The purpose of this resolution is to approve a supplemental appropriation for enterprises of the Navajo Nation.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

B. The Navajo Nation Code provides, "[m]atters constituting an emergency shall be limited to the cessation of law enforcement services, and disaster relief services, fire protection services or other direct services required as an entitlement under Navajo Nation or

Federal law, or which directly threaten the sovereignty of the Navajo Nation. Such an emergency matter must arise due to the pressing public need for such resolution(s) and must be a matter requiring final action by the Council. 2 N.N.C.§ 164(16).

## SECTION TWO. TITLE 12 FINANCE ACT SUPPLEMENTAL APPROPRIATION REQUIREMENTS

- A. The Navajo Nation Council has the authority to approve supplemental appropriations. 12 N.N.C. § 820(L). Pursuant to 12 N.N.C. § 820(L), "[t]he Navajo Nation Council may adopt and approve supplemental appropriations to the Annual Comprehensive Budget during the fiscal year. Supplemental appropriations of General Funds within the current fiscal year are permitted, if and when additional sources of revenues above and beyond the initial or current revenue projections are projected and which are also in excess of the reserve amount set forth at § 820(J)."
- B. All requests for annual operating funds and supplemental funds shall be submitted to the Office of Management and Budget for budget impact analysis. 12 N.N.C. § 820(M).
- C. When the Controller identifies additional sources of revenues above and beyond the initial or current revenue projections, supplemental appropriations may be approved by the Navajo Nation Council. 12 N.N.C. § 820(L).
- D. Supplemental Appropriations made from non-recurring revenues shall only be made for non-recurring operations or purposes, as set forth at § 820(F). The Controller of the Navajo Nation shall be responsible for the designation of recurring and non-recurring revenues. 12 N.N.C. § 820(L).
- E. The Nation shall budget all recurring operating expenses, including capital maintenance, from recurring revenues. Long term debt shall not be used to finance recurring operating expenses. 12 N.N.C. §820(E).
- F. The Navajo Nation Code provides, "[t]he Nation shall restrict non-recurring revenues to budget non-recurring expenditures. In addition, non-recurring revenues will be budgeted only after an examination by the Controller to determine whether or not the revenues are subsidizing an imbalance between recurring revenues and expenditures, and expenditures may be authorized only if a long-term (three-five year) forecast shows that the operating

29 30 deficit will not continue. Otherwise, non-recurring revenues will be added to the Unreserved, Undesignated Fund Balance. This provision may be amended or waived by a two-thirds vote of the full Navajo Nation Council." 12 N.N.C. § 820(F).

## SECTION THREE. FINDINGS

- A. The novel coronavirus (or "COVID-19"), is a highly contagious and potentially fatal respiratory virus, that has severely impacted the Navajo Nation's and the Navajo Nation Enterprises' ability to generate revenue for the Navajo Nation and to maintain employment for Navajo People.
- B. This Resolution is offered as an emergency due to the damaging economic impact COVID-19 has had within the Navajo Nation. The Navajo Nation Enterprises provide employment throughout the Navajo Nation, and should the enterprises be forced to close, or be unable to end layoffs, it will directly threaten the Navajo Nation's sovereignty.
- C. The U.S. Department of Health and Human Services declared a Public Health Emergency related to the COVID-19 outbreak on January 31, 2020; and the World Health Organization declared a global pandemic due to COVID-19 on March 11, 2020.
- D. The Navajo Nation Commission on Emergency Management, with the concurrence of Navajo Nation President Jonathan Nez, declared a Public Health State of Emergency on the Navajo Nation on March 11, 2020 due to COVID-19 in Resolution No. CEM 20-03-11. The Navajo Nation Department of Health subsequently issued numerous Public Health Emergency Orders. Public Health Emergency Orders 2020-001 through 2021-02 ("Public Health Emergency Orders") are incorporated by reference into this resolution.
- E. Navajo Nation Enterprises have worked with Navajo leaders to reduce the spread of COVID-19 by closing their operations or restricting their operations to essential employees. As a result of closures caused by the COVID-19 pandemic, the Navajo Nation Enterprises are struggling to meet financial business obligations and keep employees in the work force.
- F. The Navajo Nation Gaming Enterprise has implemented a layoff twice within approximately a 10-month period of nearly 1,000 members of the Navajo Nation

- currently on layoff status until further notice, or until immediate relief funding can be received by the NNGE.
- G. If the Enterprises do not receive COVID-19 relief funding, the Nation will risk the health, safety, and well-being of many Navajo People vulnerable to job loss and loss of health insurance, including the many dependent children, elders and other relatives who are also covered by the Enterprises' health benefits.
- H. The Navajo Nation Enterprises listed below have submitted requests for supplemental funding from the Unreserved, Undesignated Fund Balance, along with budget forms, supplemental funding proposal summaries, and grant applications, for a total of \$32,193,514:
  - 1. Navajo Nation Gaming Enterprise has requested funding of \$15,000,000 as indicated in **Exhibit A**;
  - 2. Navajo Tribal Utility Authority has requested funding of \$7,830,191 as indicated in **Exhibit B**;
  - 3. Navajo Nation Shopping Centers, Inc. has requested funding of \$903,541 as indicated in **Exhibit C**;
  - 4. Navajo Engineering and Construction Authority has requested funding of \$6,996,576 as indicated in **Exhibit D**; and
  - 5. Navajo Nation Hospitality Enterprise has requested funding of \$1,463,206, as indicated in **Exhibit E**.
- I. Support for the Navajo Nation Enterprises is a priority in order for the Navajo Nation to remain competitive within their respective industries and to help recover from the devasting impacts of the COVID-19 pandemic.
- J. The Controller has updated the balance of the UUFB and indicated that as of January 21, 2021, \$63,795,352 is available for supplemental appropriations in Fiscal Year 2021.
- K. In its approval of the Navajo Nation Budget Instruction Manual ("BIM") for Fiscal Year 2021, the Budget and Finance Committee recognized the difficulties involved in obtaining signatures on budget forms related to requests for appropriation. The Fiscal Year 2021 BIM, therefore, reflects that divisions and departments are encouraged, rather than

## **DESCRIPTION OF ENTITY OR ORGANIZATION**

The Navajo Nation Gaming Enterprise was created by NNC CS-34-06 as the tribal gaming enterprise to conduct gaming operations within the Navajo Nation under the auspice of the Indian Gaming Regulatory Act of 1988 (P.L. 100-47), the NN Gaming Ordinance (5 N.N.C. Sec. 2001 et seq), the gaming compacts with Arizona and New Mexico, and to generate gaming revenues.

### PROBLEMS/NEEDS STATEMENT

Describe the problems and needs identified to be addressed through this funding request. Include relevant data such as the number and location of the Navajo population to be served.

NNGE was forced to close its 4 casinos on March 17, 2020 due to Navajo Nation public health orders related to COVID-19. As of January 17, 2021, a full 10-months later, NNGE's casinos still remain closed.

NNGE has fully exhausted its capital set asides, PPP Funds, and CARES Allocation to maintain operations and employees during closure. During the closure period, the Enterprise has NOT generated any revenue which translates into lost cash flow of approximately \$47.8M. During normal operations of the Enterprise, this cash flow is used to pay debt service to the Navajo Nation, fund development projects that create new jobs and reinvest in vital infrastructure to support present and future operations of the Enterprise.

NNGE has temporarily laid off nearly 1,000 employees until funding is made available to replenish its cage and working capital requirements, and the Navajo Nation authorizes the reopening.

## **METHODOLOGY**

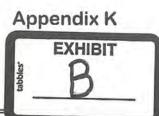

The Navajo Tribal Utility Authority (NTUA) was established on January 22, 1959, to address the absence of utilities on the 27,000 square-mile Navajo Nation. NTUA is organized for the operation, maintenance and expansion of electric, communications, natural gas, water, wastewater and generation, including photovoltaic (solar) services for the Navajo people at a low and reasonable cost.

### PROBLEMS/NEEDS STATEMENT

NTUA is an essential business for the Navajo people. NTUA provides utility services in regards to electricity, water, wastewater, gas, photovoltaic, telecommunications, and solar generation.

NTUA employees (808) worked more than 1,173,961 hours during the period 3/13/2020 to 12/31/2020. This amounted to a calculated hazard pay cost of \$7.830.191.

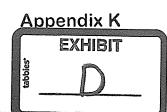

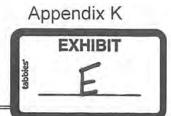
