This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. Under the laws of the Navajo Nation, any enrolled member of the Navajo Nation may renounce [her] membership by written petition to the President of the Navajo Nation requesting that his name be stricken from the Navajo Nation roll. *See* 1 N.N.C. § 705 (Renunciation of membership).
- B. The Navajo Nation in addition states, “[n]o person, otherwise eligible for membership in the Navajo Nation, may enroll as a member of the Navajo Nation, who, at the same time, is on the roll of any other tribe of Indians.” *See* 1 N.N.C. § 703 (Member of another tribe).
- C. Renounced members may be reinstated by the Navajo Nation only by the vote of majority of the Navajo Nation Council. *See* 1 N.N.C. § 705 (Renunciation of membership).

1 **SECTION TWO. FINDINGS**

- 2 A. The Navajo Nation Office of Vital Records has issued a memorandum dated August
3 19, 2021, attached as **Exhibit A**, confirming Nizhoni Harker (“Ms. Harker”) was
4 enrolled with the Navajo Nation on January 18, 1994. Ms. Harker is one-half (1/2)
5 Navajo blood and eligible for re-enrollment with the Navajo Nation so long as she is
6 not enrolled with another Indian tribe.
- 7 B. On September 2, 1998, Ms. Harker’s parents petitioned for relinquishment of Ms.
8 Harker from the Navajo Nation through the Section 164 Review Process #11313,
9 attached as **Exhibit B**, with the intent to enroll her with the Zuni tribe.
- 10 C. Ms. Harker has formally requested reinstatement into the Navajo Nation. *See* letter
11 dated July 31, 2021, as **Exhibit C**.
- 12 D. The Zuni Tribe has confirmed, as provided in **Exhibit D**, Ms. Harker formally
13 relinquished her Zuni tribal membership on June 19, 2019.

15 **SECTION THREE. REENROLLMENT**

16 Nizhoni Harker is and shall be reinstated, or otherwise re-enrolled, as a member of the
17 Navajo Nation. By this action of the Navajo Nation Council and pursuant to the laws of
18 the Navajo Nation, she shall be entitled to all rights, benefits and privileges associated with
19 membership with the Navajo Nation.

This memorandum is to verify the enrollment and subsequent relinquishment of Nizhoni Harker, date of birth

Ms. Harker enrolled with the Navajo Nation on January 18, 1994 with enrollment number . Her blood quantum is one-half Navajo and one-half Zuni according to our records. Ms. Harker's parents petitioned for relinquishment from the Navajo Nation through the Section 164 Review Process, #11313 with the intent to enroll her with the Zuni tribe.

Relinquishment occurred on October 19, 1999 upon the signature of President Kelsey A. Begaye when Nizhoni was six (6) years of age. Relevant documents are attached for reference in her current request for reinstatement to the Navajo Nation.

Pursuant to Title 1 § 703, no person may enroll as a member of the Navajo Nation who is on the roll of another Indian tribe. In this instance, Ms. Harker would need to demonstrate that she has relinquished from the Zuni Tribe. If this has been completed, then Ms. Harker would be eligible for reinstatement and should her request be granted, her original enrollment number would be restored to her.

Our reason is that We want our daughter to become an enrolled member of the Zuni Indian Tribe.

Subject to the acknowledgment of the Navajo Nation President, We do hereby withdraw and renounce our daughter membership in the Navajo Tribe.

We understand and agree that by executing this Relinquishment, We are forfeiting any and all rights and benefits that our daughter may have, including, but not limited to, any personal or other property of any kind or character, which is based on Navajo membership. We further understand that this Relinquishment will become effective upon receipt of the Navajo Nation Office of Vital Records.





My name is Nizhoni Harker and I am from Yatahey, New Mexico. I moved back in 2019 and withdrew from the Zuni Tribe on June 19th, 2019. A Relinquishment of Membership was finalized. My father was deceased and i simply did not have no intent of going back to Zuni. I had started the application process to enroll back with the Navajo Nation tribe and retain my census number. All documents were filled out and returned to Vital Records there in Window Rock, Arizona. I was then informed I had to attain a repre ntative in order for my application to be approved for my census. The Vice President of Rock Springs Chapter did acknowledge you, Eugenia for representation. I am not sure how the whole process works and I am willing to do what I can to move forward with this. Being a member of the Navajo Tribe will give me more opportunities to employment and move further with my career as some places do enforce the Navajo Preference Act. I have attached the relinquishment from the Zuni Tribe.

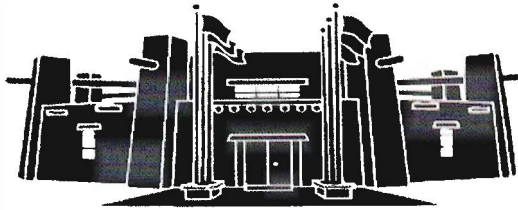


