RESOLUTION OF THE NAABIK'IYATI' COMMITTEE OF THE NAVAJO NATION COUNCIL

23RD Navajo Nation Council - Third Year, 2017

AN ACTION

RELATING TO NAABIK'ÍYÁTI' COMMITTEE; APPROVING A BUDGET REALLOCATION OF \$26,200 FROM THE OFFICE OF LEGISLATIVE SERVICES, BUSINESS UNIT NO. 101019, TO HEALTH, EDUCATION AND HUMAN SERVICES COMMITTEE, BUSINESS UNIT NO. 101030, TO RESTORE FUNDS PROVIDED FOR CONSULTING SERVICES

BE IT ENACTED:

SECTION ONE. AUTHORITY.

- A. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. §700 (A).
- B. The Naabik'íyáti' Committee is the oversight committee of the Office of Legislative Services and other offices, programs, commission, boards or task forces under the Legislative Branch of the Navajo Nation government. 2 N.N.C. § 701(A)(5).
- C. A standing committee may reallocate funds appropriated by the Navajo Nation Council to a division or program over which the committee has oversight. 2 N.N.C. §185(A).
- D. A reallocation of funds must be approved "by two-thirds (2/3) vote of the full membership of the committee, board or commission." 2 N.N.C. §185(A).

SECTION TWO. FINDINGS.

- A. The Office of Legislative Services set up the Diné Bibeehaz'aanii Binaaltsoos (DiBB) website to provide a location for legislation tracking, committee meeting information, reference material, Standing and Subcommittee membership, and action items addressed by the Navajo Nation Council.
- B. The DiBB system is a website being constantly updated with new information helpful to the Navajo Nation government and the general public.

- C. The Office of Legislative Services contracted for the website maintenance to ensure the website is accessible at all times.
- D. The Health, Education and Human Services provided funds to the Office of Legislative Services to continue the contract for the DiBB system and provided \$26,200 from the consultant account.
- E. The requested budget reallocation from the Office of Legislative Services of \$26,200 is sufficient to restore funds to the Health, Education and Human Services Committee for allocating funds for continued operation of the DiBB system.

SECTION THREE. APPROVAL OF REALLOCATION

The Navajo Nation hereby approves the budget reallocation in the total amount of \$26,200, distributed from Business Unit No. 101019 to Business Unit No. 101030; to restore the funds to the Health, Education and Human Services Committee. The budget reallocation document is attached as **Exhibit A**.
