**PURPOSE:** This resolution will amend 2 N.N.C. § 164 on emergency legislation.

15	Section One. Findings	
16	A. Navajo Nation Council often considers matters of emergency nature under the	
17	emergency clause of 2 N.N.C. § 164 (A)(16) which states as follows:	
18	Matters constituting an emergency shall be limited to the cessation of law	
19	enforcement services, disaster relief services, fire protection services or other direct	
20	services required as an entitlement under Navajo Nation or Federal law, or which	
21	directly threaten the sovereignty of the Navajo Nation. Such an emergency matter	
22	must arise due to the pressing public need for such resolution(s) and must be a matter	
23	requiring final action by the Council.	
24	B. When other urgent or emergency matters arise not fitting the definition of the	
25	emergency clause, it results in endless debate or passage of a legislation that may be	
26	challenged as not fitting the emergency clause. Not all emergency or urgent matters	
27 28	can be fitted under the emergency clause; and the current emergency clause is too limiting and does not consider other emergency matters.	
29	C. It is important to have the Navajo Nation Council consider other emergency or	
30	urgent matter facing the Navajo Nation.

Section Two. Amending Title 2, Chapter 3, Subchapter 1, § 164(A)(16)

The Navajo Nation Council hereby amend 2 N.N.C. §164 as follows:

#### § 164. Navajo Nation Council and Committee Legislative Process

A. Statements of policy, enactment of positive law, intergovernmental agreements, budget resolutions and reallocations, must be reviewed and approved by resolution by the appropriate standing committee(s) and the Navajo Nation Council except as otherwise provided herein.

\*\*\*\*

16. Notwithstanding other provisions provided in this section, including provisions on comment periods and committee review, proposed legislation addressing emergencies shall be processed for immediate consideration by the Navajo Nation Council. Matters constituting an emergency shall be limited to the cessation of law enforcement services, disaster relief services, fire protection services or other direct services required as an entitlement under Navajo Nation or Federal law, or which directly threaten the sovereignty of the Navajo Nation, or other matters which the Navajo Nation Council considers to be of an emergency or urgent nature, including proposed legislation that is in the legislative process, upon a 4/5 vote of the Delegates present before consideration. Such an emergency matter must arise due to the pressing public need for such a resolution(s) and must be a matter-requiring final action by the Council.

#### Section Three. Codification

The provisions of this Act which amend or adopt new sections of the Navajo Nation Code shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel shall incorporate such amended provisions into the next codification or supplement of the Navajo Nation Code.

#### Section Four. Savings Clause

Should any provision of this Act be determined invalid by the Navajo Nation Supreme Court or the District Courts of the Navajo Nation, without appeal to the Navajo Nation Supreme Court, the remainder of the Act shall remain the law of the Navajo Nation.

Section Five. Effective Date

The provisions of this Act shall become effective in accord with 2 N.N.C. § 221(B).
