**PURPOSE:** The purpose of this resolution is to approve \$2,644,380.00 in Sihasin funding for the purchase of emergency vehicles for the Ganado Fire District.

21	SECTION ONE. AUTHORITY
22	A. The Resources and Development Committee of the Navajo Nation Council is
23	empowered to provide oversight over chapter activities, as well as oversight over
24	community and economic development on the Navajo Nation. 2 N.N.C. §501 (C)(1).
25	B. The Budget and Finance Committee of the Navajo Nation Council is empowered to
26	review and recommend to the Navajo Nation Council the budgeting, appropriation,
	investment, and management of all funds. 2 N.N.C. § 301 (B)(2).
27	C. The Naabik'iyati' Committee of the Navajo Nation Council is empowered to review all

29	proposed legislation which requires final action by the Navajo Nation Council. 2

N.N.C. §164(A)(9).

- D. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102 (A).
- E. The Navajo Nation Code provides that the purpose of the Navajo Nation Síhasin Fund ("Síhasin Fund") is as follows:

§ 2502 Purpose

- A. The purposes of this Fund are to provide financial support and/or financing for:
  - 1. The planning and development of economic development and regional infrastructure supporting economic development, and community development, including such infrastructure as, but not limited to, housing, commercial and government buildings, waterline, solid waste management development, powerline projects, and transportation and communication systems, within the Navajo Nation; and
  - 2. Education opportunities for members of the Navajo Nation.
- B. For the Purpose in § 2502(A)(1), Fund expenditures for infrastructure shall not be limited by 12 NNC § 1310(F) or TCDCJY-77-99.
- C. Leveraging the Fund by way of guaranteeing loans, match funding, direct funding in part, and other weighted uses of the Fund, including loan financing from the Fund, for the purposes in § 2502(A)(1), shall be favored over direct funding in whole.
- 12 N.N.C. § 2502, as amended by CJA-03-18.
- F. The Síhasin Fund provides that "Fund Principal" shall consist of all deposits made to the Síhasin Fund and that "Fund Income" shall consist of all earnings (interest, dividends, etc.) generated and realized by the Fund Principal, and that Fund Income shall be deposited in and added to Fund Principal until such time as a Fund Expenditure Plan is duly adopted. 12 N.N.C. §§ 2504 and 2505 (C).

SECTION TWO. FINDINGS

A. Ganado Fire District is a political subdivision of the State of Arizona that provides emergency services to the Navajo Nation communities of Ganado, Steamboat,

Kindahlichii, Klagetoh,	Cornfields,	Woodsprings,	Cross Canyon,	Bashbito,	and '	Гоуеі
and others						

- B. The Ganado Fire District has need for \$2,644,380.00 worth of fire apparatus and rescue/medical transport units, to meet the fire and other emergency needs of the Ganado Chapter and surrounding Navajo Nation communities. Exhibit A.
- C. Ganado Fire District has provided a listing of its month activity statistics, as compared to those of the Navajo Nation Police Department, for the first seven months of 2020 and all of 2019. Exhibit B. These statistics show an urgent need for the requested emergency vehicles.
- D. Ganado Fire District has provided its 2019-2020 and its 2020-2021 budgets. **Exhibit C**. These budgets show a shortfall, such that the \$2,644,380.00 in funding is needed to purchase the requested emergency vehicles.
- E. Ganado Fire District has provided detailed descriptions of the fire apparatus and rescue/medical transport units that it is requesting. **Exhibit D**.
- F. The Navajo Nation Chapters of Ganado, Steamboat, Kindahlichii, Klagetoh, Cornfields, Jeddito, Nazlini, Greasewood Springs, and the District 17 Council, have all adopted resolutions supporting the request for funding for the purchase of the fire apparatus and rescue/medical transport units for Ganado Fire District. Exhibit E.
- G. The Navajo Nation finds that using the Síhasin Fund for the purchase of emergency vehicles, as set forth on Page 3 of **Exhibit A**, is within the purposes of 12 N.N.C. § 2502 (A) (1) and is in the best interests of Navajo communities and the Navajo People.

# SECTION THREE. ALLOCATION OF \$2,644,380.00 TO THE DIVISION OF COMMUNITY DEVELOPMENT AND APPROVAL AND ADOPTION OF THE SÍHASIN GANADO FIRE DISTRICT EMERGENCY VEHICLE EXPENDITURE PLAN

- A. The Navajo Nation hereby allocates \$2,644,380.00 from the Síhasin Fund to the Division of Community Development to implement the Síhasin Ganado Fire District Emergency Vehicle Expenditure Plan as detailed in **Exhibit A**.
- B. The Navajo Nation hereby approves and adopts the Síhasin Ganado Fire District Emergency Vehicle Expenditure Plan as set forth in **Exhibit A**.

C. The Síhasin Funds allocated for the Síhasin Ganado Fire District Emergency Vehicle Expenditure Plan may be further leveraged by bond or loan financing pursuant to the Navajo Nation Bond Financing Act, 12 N.N.C. § 1300 et seq., as amended, using Síhasin Fund earnings for repayment and financing costs upon the recommendation of the Budget and Finance Committee and approval by a two-thirds (2/3) vote of all members of the Navajo Nation Council.

# SECTION FOUR. APPROVAL OF SÍHASIN GANADO FIRE DISTRICT EMERGENCY VEHICLE EXPENDITURE PLAN ADMINISTRATION

The Navajo Nation hereby approves the administration of the Síhasin Ganado Fire District Emergency Vehicle Expenditure Plan as follows:

- A. The Navajo Nation Controller shall determine whether the source of the \$2,644,380 allocation from the Síhasin Fund will be from Fund Principal or Fund Income or a combination of both.
- B. The funds allocated for the Ganado Fire District Emergency Vehicle Expenditure Plan shall be distributed to the Division of Community Development within twenty (20) days following enactment of this legislation.
- C. Upon receipt of the \$2,644,380 in Sihasin funds, the Division of Community Development shall promptly purchase the emergency vehicles listed in **Exhibit C** and arrange for delivery of the vehicles, and transfer of vehicle titles, to the Ganado Fire District.
- D. Ganado Fire District shall be responsible for operation, maintenance, and repairs of the emergency vehicles, and shall obtain appropriate liability and other insurance covering use of the emergency vehicles. The Navajo Nation shall not be liable for any condition or event pertaining to the emergency vehicles.
- E. The funds allocated for the Ganado Fire District Emergency Vehicle Expenditure Plan shall be used solely to purchase the emergency vehicles described in **Exhibit C** and any and all cost-savings shall be returned to the Síhasin Fund once the Ganado Fire District Emergency Vehicle Expenditure Plan is completed.

F. The funds allocated for the Ganado Fire District Emergency Vehicle Expenditure Plan shall revert to the Síhasin Fund principal if not spent or encumbered within ninety (90) days of distribution to the Division of Community Development, unless recommended otherwise by the Resources and Development Committee and approved by the Naabik'íyáti' Committee.

#### SECTION FIVE. EFFECTIVE DATE

This legislation and the Síhasin Ganado Fire District Emergency Vehicle Expenditure Plan shall become effective pursuant to 12 N.N.C. § 2505.


#### SECTION SIX. SAVING CLAUSE

Should any provision(s) of this Action be determined invalid by the Navajo Nation Supreme Court or the District Courts of the Navajo Nation, without appeal to the Navajo Nation Supreme Court, the remainder of the Action shall remain the law of the Navajo Nation.

#### SECTION SEVEN. DIRECTIVES

The Division of Community Development shall provide a written report on the status of expenditures and project progress under the Síhasin Ganado Fire District Emergency Vehicle Expenditure Plan to the Naabik'iyati' Committee and Office of the President and Vice-President by the fifth day of each month following the enactment of this legislation.

#### **DULY PASSED ON DECEMBER 10, 2020**

Ganado Fire District Requesting Appropriation of \$2,644,380.00 from the Navajo Nation Shihasin Funds from the 24<sup>th</sup> Navajo Nation Council, the Navajo Nation Office of the Speaker and the Navajo Nation Office of the President and Vice President for the purpose of combating the Pandemic COVID-19 Coronavirus.

#### WHEREAS,

- 1. GANADO FIRE DISTRICT is seeking \$2,644,380.00 from the Shihasin Funds to assistance Navajo Nation combat COVID-19 Coronavirus;
- 2. GANADO FIRE DISTRICT provided fire, rescue, medical, and emergency dispatching services to five chapters, which include Ganado, Steamboat, Klagetoh, Kinlichee, Cornfields and the communities of Woodsprings, Cross Canyon, Bashbito, and Toyei; but not limited to the 1,000 square miles covered through Mutual Aid agreements and our firm mission to achieve life safety for all residence.
- 3. GANADO FIRE DISTRICT provided emergency and essential response to the Navajo people, our customers and visiting guest since 1982.
- 4. GANADO FIRE DISTRICT is seeking assistance to purchase six fire apparatus and four rescue/medical transport units (a.k.a. ambulance) to combat the Pandemic COVID-19 Coronavirus.
- 5. GANADO FIRE DISTRICT is seeking the support from Navajo Nation for the purpose of obtaining adequate and reliable apparatus, supporting Ganado Fire District essential emergency staff to provide emergency services to the Navajo Nation citizens.

NOW, THEREFORE BE IT RESLOVED THAT,

- 1. The Ganado Fire District Governing Board is seeking approval of \$2,644,380.00 from the Navajo Nation Shihasin funds from the 24<sup>th</sup> Navajo Nation Council, the Navajo Nation Office of the Speaker and Navajo Nation President and Vice President Office from to combat the Pandemic COVID-19 Coronavirus.
- 2. Ganado Fire District Governing Board further request that the 24<sup>th</sup> Navajo Nation Council, the Navajo Nation Office of the Speaker and the Navajo Nation President and Vice President Office for the purpose of obtaining adequate and reliable apparatus for the next twenty years, to continuing to provide adequate fire, rescue, medical, and emergency dispatching services to five chapters, which include Ganado, Steamboat, Klagetoh, Kinlichee, Cornfields and the communities of Woodsprings, Cross Canyon, Beshbatoh, and Toyei; but not limited to the 1,000 square miles covered through Mutual Aid agreements for Navajo Nation citizens.



Council to Appropriate \$3 Million from the CARES Act Fund for First Responders
Operations, Maintenance & Management During the COVID-19 Times

#### WHEREAS:

- 1. The Ganado Chapter is a duly certified local governing entity recognized by the Navajo Nation Council through 11 N.N.C. § 10(A), to advocate and address the needs and development of the local people to interact with other departments of the Navajo Nation, federal and local agencies which serve and affect the Navajo Nation; and
- 2. The Ganado Chapter is a Governance Certified Chapter of the Navajo Nation vested authority under 26 N.N.C. § 101 et. seq; and
- 3. Ganado Chapter pursuant to Navajo Nation central governing policies and procedures, has direct responsibility and authority to promote, protect and preserve the interest and general welfare of its community, memberships, programs and property; and
- 4. Ganado community is a secondary growth center comprising of 1200 registered voters, 3600 community members, multiple employers, Hubbell's Trading Post is a global attraction for tourists, Ganado Lake serves as a recreational place, recently the Loka'niteel Shopping Center was built and Ganado High School Pavilion at times serves as large meeting event place to accommodate 6,000 people; and
- 5. Ganado Chapter is aware that the Navajo Nation Commission on Emergency Management with the concurrence of the Navajo Nation President declared a Public Health State of Emergency on March 11, 2020 (CEM-20-03-11 attached); and
- 6. Ganado Chapter is aware that this COVID-19 pandemic certainly has brought much concerns with a heavy heart and mind amongst our community membership unexpectantly, many of our family members, relatives, and neighbors have parish which causes a financial burden; and
- 7. Ganado Chapter numerous times has observed sincere empathy and compassion by the Ganado Fire District personnel in always being first responders during emergency times of

### RESOLUTION OF THE FORT DEFIANCE AGENCY COUNCIL

Respectfully Supporting Navajo Nation Council Legislation Tracking No. 0023-21 Sponsored by Hon. Vince R. James: An Action Relating to Budget and Finance Committee, Resources and Development Committee, Naabi'iyati' Committee and the Navajo Nation Council; Allocating \$2,644,380.00 from the Sihasin Fund to the Division of Community Development for the Purchase of Fire Trucks and Ambulances for the Ganado Fire District; Adopting the Sihasin Ganado Fire District Emergency Vehicle Expenditure Plan Pursuant to 12 N.N.C §§ 2501 – 2508

### WHEREAS;

- 1. The Fort Defiance Agency Council is a consortium of duly elected Chapter Officials of twenty-eight (28) certified/non-certified Navajo Nation Chapters that advocate, promote, and support common goals and interests of the respective Chapters; and,
- 2. The Fort Defiance Agency Council is comprised of elected officials from twenty-eight (28) Navajo Nation Chapters within the Fort Defiance Agency and has the responsibility and authority to address matters and projects that will benefit the 28 chapters of the Fort Defiance Agency of the Navajo Nation; and,
- 3. Pursuant to 26 N.N.C., the Fort Defiance Agency Council is duly recognized as an Agency Council of the Navajo Nation Government, listed in 11 N.N.C. Part 1, Section 10; and,
- 4. Pursuant to 26 N.N.C., the Fort Defiance Agency Council is vested with the authority to review and adhere to all matters relating to and affecting the Twenty-eight (28) Navajo Communities and Chapters at which this council is made of, and take appropriate action when need be; and,
- 5. The Fort Defiance Agency Council is vested with the authority to review all matters affecting the community while making appropriate delicate decisions as deem necessary and to make recommendation to the Navajo Nation and other local agencies for appropriate actions; and
- 6. The Fort Defiance Agency Council is aware that this COVID-19 pandemic certainly has brought much concerns with a heavy heart and mind amongst our community membership unexpectantly, many of our family members, relatives, and neighbors have parish which causes a financial burden; and
- 7. The Fort Defiance Agency Council numerous times has observed sincere empathy and compassion by the Ganado Fire District personnel in always being first responders during emergency times of uncertainty, they are the first on site to address local urgencies whether it's an elderly that has slip off a porch, an unforeseen vehicle accident, a home that caught on fire unexpectantly; and
- 8. The Fort Defiance Agency Council has witness the local small unit of Fire Fighters who were the first on site to combat the Wood Springs Fire, and continued to assist as deem necessary; and
- 9. The Fort Defiance Agency Council has witness Ganado Fire District personnel have been overwhelm while constantly helping those that have been exposed to this COVID-19 pandemic virus, they

- 9. In the course of assisting those that were tested positive warranting quarantine status over a period of time, the Fort Defiance Agency Chapters spent it's "Emergency Fund" account to provide water, food, fire wood, face mask, rubber gloves, sanitizers, Clorox wipes, many types of cleaning essentials, ... to assist people during quarantine status, implementation in helping it's membership on account of escalating numbers certainly has vacuum avail funds; and
- 10. The Fort Defiance Agency Council was identified by the Navajo Nation Health Command Operations Center, Division of Community Development, Administrative Service Center to become a Ganado Staging Post; an unfunded establishment of an operations to accommodate eighteen (18) Navajo Nation Chapters, Ganado Staging Post recruited volunteers, in many instances had no choice but to hire temporary laborers/workers for receiving, sanitizing, inventory and disbursement of water, food, face mask, gloves, hand sanitizers, Clorox wipes, Lysol sprays ... inventory was equally disburse amongst eighteen Chapters to mitigate spreading of the virus; and
- 11. The Fort Defiance Agency Council is aware that an unfunded "Staging Post" at Ganado Chapter led to "taking from Paul to pay Peter" method with appropriate paper trail, with great hopes of reimbursement from Chapter's CARES Act Fund allocation for projects ... which was DENIED by the Navajo Nation Office of the Controller.

### NOW, THEREFORE BE IT RESOLVED THAT:

1. The Fort Defiance Agency Council is hereby respectfully requesting the Navajo Nation Council to appropriate ten million (\$10,000,000) dollars from the Undesignated Unreserved Fund Balance for one hundred and ten (110) Chapters to expend towards COVID-19 emergency financial needs for mitigation.
