TITLE OF RESOLUTION: PROPOSED STANDING COMMITTEE RESOLUTION; AN ACTION RELATING TO NAABIK'ÍYÁTI' COMMITTEE; CONFIRMING THE APPOINTMENT OF MR. DAVID N. SLOAN TO SERVE ON THE NAVAJO HOUSING AUTHORITY BOARD OF COMMISSIONERS AS THE REGISTERED ARCHITECT

PURPOSE: If approved by the Naabik'íyáti' Committee, this legislation would confirm the appointment of Mr. David N. Sloan to serve on the Navajo Housing Authority Board of Commissioners.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

SECTION ONE. AUTHORITY

- A. Pursuant to 6 N.N.C. §606 (A), [t]he Board Members shall be appointed, and may be reappointed, by the Nominations Committee composed of the Navajo Nation President, Speaker of the Navajo Nation Council, Resources and Development Committee designee, and confirmed by the Naabik'iyati' Committee of the Navajo Nation Council.
- B. Pursuant to 6 N.N.C. §606 (A), a resolution of the Naabik'iyati' Committee of the Navajo Nation Council as to the appointment or reappointment of any Commissioner shall be conclusive evidence of the due and proper appointment of the Commissioner.

SECTION TWO. FINDINGS

- A. Pursuant to 6 N.N.C. § 602 (A), The Navajo Nation established a public body of the Navajo Nation known as the Navajo Housing Authority (Authority) to: remedy unsafe and unsanitary housing conditions that are injurious to the public health, safety and morals; alleviate the acute shortage of decent, safe, and sanitary dwellings for

1 persons of low income; provide employment opportunities through the construction,
2 reconstruction, improvement, extension, alteration or repair operation of low income
3 dwellings; and promote economic growth and development activities within and near
4 the Navajo Nation. *See* 6 N.N.C. § 604 (A)-(D).

5 B. The affairs of the Authority shall be managed by a Board of Commissioners
6 composed of five persons. 6 N.N.C. § 605; CJA-13-17.

7 C. Pursuant to 6 N.N.C. § 606, the Nominations Committee has appointed Mr. David N.
8 Sloan. The appointment letter is attached as **Exhibit A**.

9 D. All Commissioners at a minimum, shall have post-high school education and
10 employment experience in at least one of the areas of business operations,
11 architecture, construction management, finance, accounting, investing, or in other
12 specialized areas of construction or business that correspond to the activities or
13 anticipated activities of the Authority, and at least three years of management or
14 leadership experience in business or a local unit of government. 6 N.N.C. § 606 (B);
15 CJA-13-17.

16 E. Mr. Sloan's letter of interest and resume are attached as **Exhibit B**. Mr. Sloan's
17 resume states that he has a Bachelor of Fine Arts degree in Architecture from the
18 University of New Mexico.

19 F. One Commissioner of the five, shall be a Registered Architect or licensed
20 Professional Engineer. 6 N.N.C. § 606 (B); CJA-13-17. Mr. Sloan's Architect
21 licenses from the State of New Mexico and State of Arizona are attached as **Exhibit**
22 **C**.

23 G. A majority of the Commissioners shall be members of the Navajo Nation. 6 N.N.C. §
24 606 (B); CJA-13-17. Mr. David N. Sloan's Navajo Nation Certificate of Indian
25 Blood is attached as **Exhibit D**.

26 H. The term of office shall be four years and staggered. When a Board is first
27 established, one member's term shall be designated to expire in one year, another to
28 expire in two years, a third to expire in three years, and the last two in four years.
29 Thereafter, all appointments shall be for four years. 6 N.N.C. § 607.

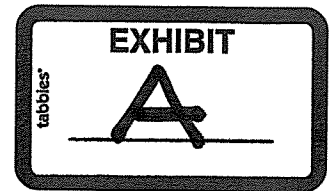
1 I. The term of years for the appointment of Mr. Sloan shall be in accordance with 6

7 Authority Board of Commissioners.



Title Six of the Navajo Nation Code, Section 606 (A) has authorized creation of the Navajo Housing Authority Board of Commissioners Nominations Committee (Nominations Committee) which is composed of three members: the Navajo Nation President, the Navajo Nation Council Speaker, and a member designated by the Resources and Development Committee. The Nomination Committee appoints members of the Navajo Housing Authority (NHA) Board of Commissioners. These appointments are confirmed by the Naabik'ikáti' Committee.

The NHA Board of Commissioners is made up of five individuals the majority of the Commissioners are to be Navajo Nation members. One of the Commissioners is to be a registered architect or licensed professional engineer.

Pursuant to its authority, the Nominations Committee appoints Mr. David N. Sloan to the NHA Board of Commissioners. Mr. Sloan is an enrolled member of the Navajo Nation with architectural licenses in the states of Arizona and New Mexico. The Nominations Committee respectfully submits Mr. David N. Sloan appointment to the Naabik'ikáti' Committee to be confirmed as a member of the Navajo Housing Authority Board of Commissioners.

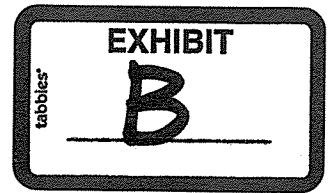
