BE IT ENACTED:

Section 1. Authority

- A. Pursuant to 2 N.N.C. § 601 (C) (1), the Law and Order Committee serves as the oversight committee for the Division of Public Safety.
- B. Pursuant to 2 N.N.C. § 401 (C) (1), the Law and Order Committee serves as the oversight committee for the Division of Human Resources.
- C. Navajo Nation established the Budget and Finance Committee as a Navajo Nation Council standing committee. 2 N.N.C. § 300 (A).
- D. Navajo Nation empowered the Budget and Finance Committee "[t]o promulgate rules and regulations relative to contracting, investments and financial matters." 2 N.N.C. § 301 (B) (1).
- E. The Navajo Nation Council instructs the Budget and Finance Committee to approve the budget instructions for each fiscal year. 12 N.N.C. § 830 (H).

- F. The Budget and Finance Committee adopted the Navajo Nation Fiscal Year 2017 Budget Instructions Manual. BFJN-18-16, June 21, 2016.
- G. The Budget and Finance Committee ". . . directs and authorizes the Office of Management and Budget to . . . recommend any amendments that it deems necessary to the Navajo Nation Fiscal Year 2017 Budget Instructions Manual for consideration by the Budget and Finance Committee." BFJN-18-16, Paragraph O.
- H. Council Delegates may also introduce proposed legislation to the Budget and Finance Committee. 2 N.N.C. § 164 (A)(1).

Section Two. Findings

- A. There is a need for the Navajo Division of Public Safety to utilize a specific Salary Schedule.
- B. The Department of Personnel Management has formulated Salary Schedule "AF" attached hereto and incorporated as Exhibit "A", in response to this need.
- C. The Law and Order Committee provided a proposed salary increase summary attached hereto and incorporated as Exhibit "B", in response to this need.

Section Three. Amendment

- A. The Budget and Finance Committee hereby amends the 2017 Budget Instructions Manual to Section VIII. B. (1) as follows:
 - 1. Salary Schedule. The detailed salary schedule for FY2017, in Appendix D, provides the pay grade and steps for all position classifications. Schedule AB is for use by class titles not eligible for a premium rate and Schedule AC is for use by class titles that have been determined eligible for the premium rate and Schedule AD is for use by the Navajo Head Start only for class titles not eligible for a

premium rate and Schedule AE is for use by the Navajo Head. Start for class titles that have been determined eligible for the premium rate. Schedule AF is for use by the Navajo Division of Public Safety for Commissioned Law Enforcement Officers only. The appropriate schedules are also available from the respective Personnel Office, if not shown in this manual.

- B. Appendix D is amended to include and insert Salary Schedule "AF" attached as Exhibit "A" after Salary Schedule "AE", page 63 of the 2017 Budget Instructions Manual.
- C. This amendment shall be effective October 1, 2016.


