Purpose of this Legislation:

to allocate \$4,000,000 from the UUFB for the 110 Chapters' Summer 2022 Youth Employment Programs; waiving 12 N.N.C. §820(E), §820(F), §820(J), and §820(L) to allow use of UUFB funds for recurring Chapter expenses.

The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §102(A). As such, the Council "... may adopt and approve supplemental appropriations to the Annual 8 9 Comprehensive Budget during the fiscal year. Supplemental appropriations of General Funds within the current fiscal year are permitted, if and when additional sources of revenues above 10 and beyond the initial or current revenue projections are projected and which are also in 11 excess of the reserve amount set forth at §820(J)." 12 N.N.C. §820(L). 12 13 F. The Title 12 restrictions on supplemental appropriations, including all amounts from the 14 UUFB, include: 15 1. Payment of recurring government operating expenses shall be from recurring revenues, and payment of nonrecurring expenses shall be from nonrecurring revenues such as UUFB 16 17 funds. 12 N.N.C. §820(E); 12 N.N.C. §820(F). 2. Specifically, the UUFB shall not be used for recurring government expenditures or 18 operations. 12 N.N.C. §820(J); 12 N.N.C. §820(L). 19 20 3. Nonrecurring revenues such as UUFB funds may be used only after the Controller determines whether or not such revenues are subsidizing an imbalance between the 22 Navajo Nation's recurring revenues and expenditures, and government expenditures shall only be authorized if a long-term (3-year to 5-year year) forecast shows that the operating deficit will not continue; otherwise, nonrecurring revenues will be added to the 24 Unreserved, Undesignated Fund Balance. 12 N.N.C. §820(F). 4. The above provisions in Title 12 may be amended or waived by a two-thirds vote of the 26 full membership of the Navajo Nation Council. 12 N.N.C. §820(F); 12 N.N.C. §880. 5. Pursuant to 12 N.N.C. §820(F) all UUFB funding requests must be reviewed by the 28 Controller. Such review is also required because the Controller determines which revenues and expenses are recurring and which are non-recurring. 12 N.N.C. §820(L).

6. Pursuant to 12 N.N.C. §820(M) all UUFB funding requests must be submitted to the Office of Management and Budget ("OMB") for a budget impact analysis.

SECTION TWO. FINDINGS

A. All 110 Navajo Nation Chapters have indicated a need for supplemental funds to pay for their summer youth employment programs for the Summer of 2022. On behalf of the 110 Chapters, the Division of Community Development ("DCD") is requesting \$4,000,000 in UUFB funds to distribute among all 110 Chapters.

B. The required Budget Forms, including Appendix K "Supplemental Funding Proposal Summary" for the Chapters' proposed expenditures, are attached as **EXHIBIT A**.

C. DCD has prepared a comprehensive list of each Chapter's needed amount to fund its Summer 2022 Youth Employment Program, showing the total amount needed of \$4,000,000 for all 110 Chapters. EXHIBIT B.

D. Diné Customary Law declares and teaches that: "[i]t is the right and freedom of the people that our children are provided with education to absorb wisdom, self-knowledge, and knowledge to empower them to make a living and participate in the growth of the Navajo Nation." 1 N.N.C. §204(F).

E. The Navajo Nation honors Diné Customary Law by assisting high school and college students with temporary employment during their summer breaks. Chapter summer youth employment programs offer these students the opportunity to gain work experience during their summer breaks, and to earn funds to pay for their school expenses.

F. Due to the COVID-19 pandemic, many Navajo Nation youth were largely unable to secure summer employment during the Summers of 2020 and 2021; therefore, this \$4,000,000 in funding is badly needed to assist them with jobs and income this Summer.

G. The Office of the Controller was asked to provide a memorandum as required by 12 N.N.C.
§820(L). This memorandum shall be provided to the assigned Committees and the Navajo
Nation Council when this legislation is up for consideration.

H. The Office of Management and Budget was asked to provide a budget impact analysis as
required by 12 N.N.C. § 20(M). This analysis shall be provided to the assigned Committees
and the Navajo Nation council when this legislation is up for consideration.

A. The Navajo Nation hereby allocates \$4,000,000 out of the UUFB to the Division of Community Development to be used for the 110 Chapters' summer youth employment programs for 2022, as shown in the attached EXHIBIT A and EXHIBIT B.

B. This supplemental appropriation shall be from those funds that exceed the minimum fund reserve balance in the UUFB required by 12 N.N.C. §820(J), as determined by the Controller.
C. Pursuant to 12 N.N.C. §820(O) the \$4,000,000 shall be deposited with each of the 110 Chapters as follows: "fifty percent (50%) of the appropriation shall be divided equally among all chapters and the remaining fifty percent (50%) shall be divided proportionately among the chapters using a percentage equal to that figure which the number of registered voters in each chapter bears to the whole of registered Navajo Nation votes as determined by the most current voter registration figures available as of the date of the appropriation."

D. Pursuant to 12 N.N.C. §820(N) the amount received by each of the 110 Chapters under the overall \$4,000,000 allocation approved herein shall not lapse at the end of the fiscal year, so long as each Chapter accounts for any funds that remain after the conclusion of its Summer 2022 Youth Employment Program and then budgets such funds in the next fiscal year for its Summer 2023 Youth Employment Program.

SECTION FOUR. WAIVING 12 N.N.C. §820(E), §820(F), §820(J), and §820(L) TO ALLOW USE OF UUFB FUNDS FOR RECURRING CHAPTER EXPENSES

The Navajo Nation hereby waives 12 N.N.C. §820(E), §820(F), §820(J), and §820(L) to allow use of the UUFB for the 110 Chapters' summer youth employment programs for Summer 2022, as shown in EXHIBIT A and EXHIBIT B. These waivers are necessary because the proposed Chapter UUFB expenditures are considered recurring government expenses.

29 SECTION FIVE. EFFECTIVE DATE

This Act shall become effective as provided in 2 N.N.C. §221(B) and 2 N.N.C. §164(A)(17).

WHEREAS:

- Pursuant to N.N.C., Title 26, Section 101, and the Navajo Nation Council Resources and Development Committee Legislation #RDCF-0052-15 dated February 17, 2015, Nazlini Chapter Government was recognized as an LGA Certified Chapter and delegated with the responsibility and authority to make decisions over local chapter matters; AND
- 2) The Chapter Summer Youth Employment Program provides valuable work experience and job readiness, career exploration and post-secondary options, guidance, knowledge of local governance, community engagement, public speaking, problem solving, financial literacy, teamwork, attendance and punctuality, accepting direction, workplace behavior, physical fitness, first aid and CPR training and mentoring; AND
- 3) All school districts, colleges and universities abruptly ceased in-person learning, forcing students to participate in virtual classrooms despite lack of/poor quality internet connectivity resulting in additional expenses to students and their families for purchase of costly internet access; AND
- 4) Thousands of Navajo Nation Youth were not allowed to work during summer and winter breaks, thus depriving them from earning income to assist with academic expenses, school clothing purchase and other expenses directly correlated to successful pursuit of higher education; AND
- 5) The Navajo Nation Unreserved, Undesignated Fund Balance (UUFB) is a contingency fund to consider any unmet needs of the Navajo Nation including chapter governments.

NOW THEREFORE BE IT RESOLVED THAT:

 The Nazlini Chapter hereby supports Navajo Nation Council Legislation #0060-22; approving supplemental funding from the Unreserved, Undesignated Fund Balance (UUFB) in the amount of \$4,000,000 for the 110 Navajo Nation Chapters Summer Youth Employment Programs and waiving 12 N.N.C., §§ 820, (E), (F), (J) and (L) to allow use of UUFB funds for recurring chapter expenses.
