

WHEREAS:

- A. The Navajo Nation established the Health, Education, and Human Services Committee as a standing committee of the Navajo Nation Council. 2. N.N.C. § 400(A).
- B. The purpose of the Health, Education and Human Services Committee is to oversee the education initiatives of the Navajo Nation by promoting academic excellence and culturally relevant education. 2 N.N.C. § 400 (2).
- C. The Health, Education, and Human Services Committee is empowered to represent the Navajo Nation at local, state and federal levels in coordination with the President of the Navajo Nation and the Naabik'íyáti' Committee on proposed legislation, funding and other actions affecting education. 2 N.N.C. § 401 (7)(a).

- 1 D. The Health, Education and Human Services Committee is also authorized to
2 assist, support and coordinate with local communities, parent organizations
3 and school boards and school board organizations. 2 N.N.C. § 401 (C)(4).
- 4 E. The Navajo Nation established the Naabik'íyáti' Committee as a Navajo
5 Nation Council standing committee and as such empowered Naabik'íyáti'
6 Committee to "coordinate all federal, county, and state programs with other
7 standing committees and branches of the Navajo Nation government to
8 provide the most efficient delivery of services to the Navajo Nation". 2 N.N.C.
9 § 701 (A)(4); 2 N.N.C. § 700 (A).
- 10 F. Of concern to the Navajo Nation are the Navajo children who receive their
11 education at Bluff Elementary School located in Bluff, Utah; a majority of
12 Navajo children reside on the Navajo Reservation and are bussed off the
13 reservation to attend school.
- 14 G. Currently, it has been reported that one hundred and thirteen children attend
15 Bluff Elementary School, making up ninety-four percent of the school's
16 population. *See* Exhibit A, (Letter from Melinda Blackhorse, Indian Education
17 Leader, Utah Indian Education Commission, to Navajo Utah Commission,
18 (Dec. 16, 2015).
- 19 H. On December 1, 2014 and January 20, 2015, the Board of Education and San
20 Juan County School District collectively bought two tracts of land with the
21 intention of constructing a new school in Bluff, Utah. *See* Exhibit B (Real
22 Property Sales Agreement, Dec. 1, 2014); *See also* Exhibit C (Real Property
23 Sales Agreement, Jan. 20, 2015); *See also* Exhibit D (Proposed Land Purchase
24 for Bluff Elementary School and Archaeological Site Locations Map).
- 25 I. The School Board Meeting minutes on August 18, 2015, stated the
26 Archeological survey for the Bluff Property has been completed and as
27 anticipated there are some archaeological sites that must be addressed before
28 construction begins; one of the sites on the property has been partially
29 excavated and burial sites were discovered; the placement of the building
30

1 would avoid that site altogether. *See* Exhibit E (Board Meeting Minutes, Aug.
2 18, 2015).

3 J. The School Board Meeting on October 13, 2015, Superintendent Wright noted
4 there were concerns regarding the preliminary archeological findings on the
5 recently purchased Bluff property. *See* Exhibit F (Board Meeting Minutes,
6 Oct. 13, 2015).

7 K. The School Board during the meetings has been made aware of the cultural
8 sensitivities of the Navajo people regarding burial sites. *See* Exhibit E (Board
9 Meeting Minutes, Aug. 18, 2015); *See also* Exhibit F (Board Meeting Minutes,
10 Oct. 13, 2015).

11 L. Furthermore, several surrounding chapters and the Dine' Medicine Man
12 Association, Inc. has passed resolution opposing the construction of the new
13 school the archeological site. *See* Exhibit G (Resolution of Mexican Water
14 Chapter, Dec. 6, 2015); *See also* Exhibit H (Resolution of Oljato Chapter, Dec.
15 6, 2015); *See also* Exhibit I (Resolution of Teec Nos Pos Chapter, Dec. 6,
16 2015); *See also* Exhibit J (Resolution of Navajo Mountain Chapter, Dec. 18,
17 2015); *See also* Exhibit K (Resolution of Dine' Medicinemen Association, Inc.
18 (Dec. 6, 2015); *See also* Exhibit L (Resolution of Red Mesa Chapter, Nov. 11,
19 2015); *See also* Exhibit M (Resolution of the Navajo Utah Commission of the

22 **NOW, THEREFORE BE IT RESOLVED:**

23
24 A. The Navajo Nation is in opposition to the Board of Education and San Juan
25 County School District intention of building the new Bluff Elementary School
26 on the property containing burial sites and remains due to cultural sensitivities
27 held by the Navajo people.

28 B. The Navajo Nation on behalf of the Navajo students, parents and surrounding
29 communities request the Board of Education and San Juan County School
30

District to understand the cultural beliefs relating to the Navajo children they are charged with educating.

- C. In addition, the Navajo Nation would encourage the Board of Education and San Juan County to continue working with the community to find an alternative resolution to the placement of the new school.

RE: San Juan School District Decision to Replace the Bluff Elementary School on lands containing Archaeological sites and maybe some remains.

I was appointed by Navajo Utah Commission to serve on the Utah Indian Education Commission to represent the Navajo Nation concentrating on San Juan School District which is within the seven Utah Chapter; Navajo Mountain Chapter, Oljato Chapter, Dennehotso Chapter, Mexican Water Chapter, Red Mesa Chapter, and Aneth Chapter. The most vital position I hold is being a mother of a San Juan school district student. I am also a future grandparent to grandkids who will attend the Bluff Elem School in the near future.

The appointed Indian Education Commission position was established by the House Bill 33 addressing the achievement gap of Native students in the state by bringing state and tribal leaders together in a Commission to plan for the future. In compiling data and doing my research in the local San Juan School District and community for this appointed position many issues aroused. One of the biggest issues that we are being faced with right now is the Purchase of Land with Archeological sites for a new school to be built in Bluff Utah a border town which schools mostly Native American Students (Navajo) that are bussed in from the Navajo Reservation to be more specific Mexican Water Chapter community as well as the Red Mesa Chapter community. This situation addresses Concurrent Resolution Supporting American Indian and Alaskan Native Education State Plan 51-5 Building statewide collaborations to address, and statewide awareness of, the needs of American Indian and Alaskan Native Children, including understanding of social cultural, educations needs and the role of tribal sovereignty.

Bluff Elementary School is a public elementary school in Bluff, Utah off the Navajo Nation. 113 children attend Bluff School and 94% are Native American (Navajo). I have enclosed with this report supporting documents regarding my concern. The reason a new school is direly needed is failure of a septic system of the current school. In 2001 a new septic system was installed by Engineer Firm Jones and DeMille who told the district the new septic system will last a minimum of five years, the five years is up since then. A history of School Board Meeting minutes addressing this subject is also enclosed. In the January 20th San Juan School District meeting minutes it was motioned to proceed with the purchase of property in Bluff for the future site of the Elementary school for the total amount of \$501,500.00 for 12.53 acres utilizing capital funds. School board meeting minutes Tuesday August 18, 2015 stated Archeological survey was completed with some archaeological sites. In the September 22nd 2015 meeting minutes It was also brought up that sites were found and that local cultural experts were to be contacted to advise the school district's planning of future construction of the property.

I was informed a report was to be presented by Dr. Tommy Lewis on November 4, 2015 before the HEHSC Committee in regards to HB33. Dr. Lewis also serves on the American Indian Commission representing the Navajo Nation. At the time of this meeting I addressed to the committee that a working relationship needs to be established between Dr. Tommy Lewis Superintendent of Schools, Department of Education and I. We serve on the same commission, but we do not communicate. I have on numerous times tried to establish communication to no avail. I addressed this concern to the HEHSC Committee and a directive was made that Dr. Tommy Lewis work with me. Since that date no working relationship has happened. Also at that time I was referred to the Sacred Sites Committee meeting in Chinle Az, on November 10, 2015 to present the Bluff School Issue as well before that committee.

Sacred Sites Committee meeting on November 10,2015 a presentation by me didn't happen due to time constraints for members of the Sacred Sites Committee, but a directive from Johnathan Hall was made. The directive stated that

Historical Sites and I will share information and compile data that will be presented at the next Sacred Sites meeting (no date yet). I have than contacted Melinda Cicco with Historical Sites as well as Ora Marek Martinez, SHIPO and had a meeting regarding the issue at hand. It came to our attention more research has to happen between Ora Marek Martinez and State of Utah SHIPO Office. Ora is researching to see if proper protocol and procedures were completed by San Juan School District when purchasing the land. Once she has compiled the data we will present before Sacred Sites Committee. Once the next Sacred Sites Committee meeting transpires more information will be presented before Navajo Utah Commission regarding the research and finding. I met with the Sacred Sites Committee after the Sacred Sites Meeting and they invited me to present before their organization on December 6, 2015. On December 6, 2015 a Resolution was approved to oppose the building of the proposed Bluff Elementary School on lands with Arc Sites. The Resolution is forthcoming and once obtained a copy will be given to NUC members.

I have requested that all seven chapters compose resolutions opposing the new school to be built on land that was bought with Arc Sites but not against a new school as well as Navajo Utah Commission. I am here before this committee to have your input since you as an established organization appointed me to the position of Education Leader for Utah Navajos to help make decisions as to what needs to transpire next. At the NUC meeting that transpired at Aneth Chapter Honorable Council Delegate Davis Filfred recommended to the San Juan School District Superintendent that maybe excavation could be a possibility. Mexican water chapter community members recommended as well having the new school built on Mexican Water Chapter lands which is already purchased and cleared for Arch sites. Another recommendation coming from the school board is maybe resell and rebuy land.

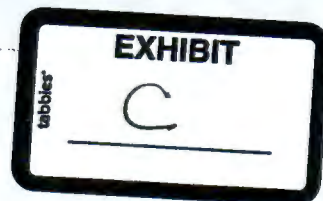

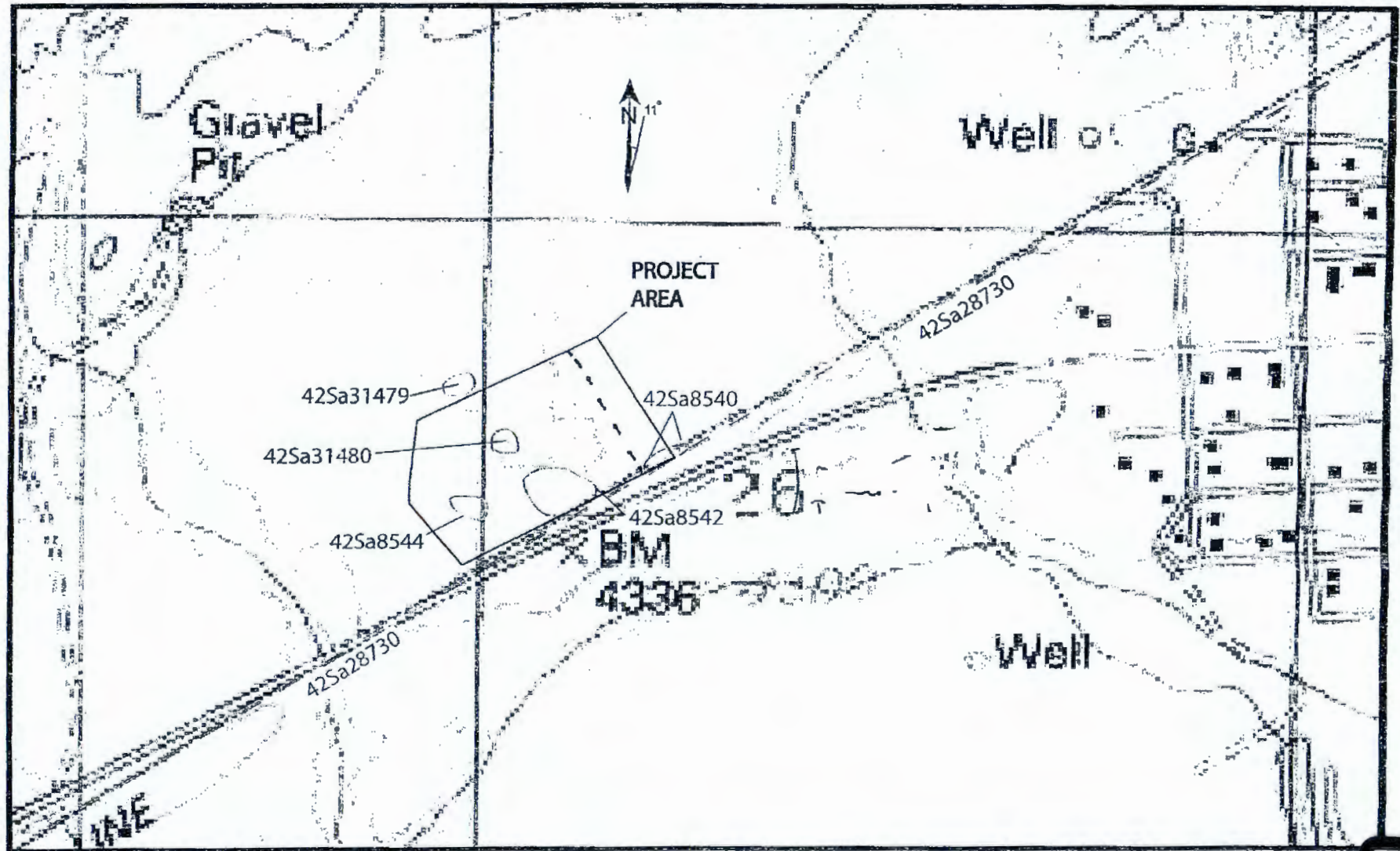

B. Board Work Session

1. Capital Outlay Updates:

The previously adopted Capital Projects calendar was reviewed. It has been adjusted for delays and changes in the schedule. The spreadsheet with the original plan was reviewed and an addendum to the plan was suggested. The plan includes a range of dates for actual completion dates and highlights completed projects.

Business Administrator Kyle Hosler updated the Board on the following projects:

Blanding Elementary school Carbon Monoxide detector project has been completed.

Outdoor bleacher upgrades for Monument Valley High School, Monticello High School and Whitehorse High School have been completed.

Auditorium seating replacement has been completed at Monument Valley High School, Monticello High School, Whitehorse High School and San Juan High School.

Housing Roof Replacement has been completed at Navajo Mountain.

Outdoor Safety Lighting has been completed at Whitehorse High School. Exterior fascia and paneling is near completion. Parking lot lighting is scheduled.

San Juan High School Auditorium remodel project has also been completed. New HVAC units will be added soon.

Monument Valley High School Administrative Office Complex, along with classroom and restroom modifications, have been completed.

Montezuma Creek front office repairs are still in planning stages.

* The Archeological survey for Bluff Property has been completed. As anticipated, there are some archaeological sites which must be properly addressed before any construction can be done. Further study as to how we can mitigate the sites must be done, but our intent is to look at the most effective and efficient way to preserve the archeological sites, with the first option to try to avoid them. Part of the reason for the large parcel of land was so that we could increase our options of properly siting the building while avoiding sites. One of the sites on the property, next to the highway right-of-way, has been partially excavated and burial sites were discovered there. The placement of the building would avoid that site all together. Digital excavation is an option to explore the unknown areas which would be impossible to avoid. Depending on what is discovered through the digital means, physical excavation may be required. Superintendent Wright explained that the current timeline is aggressive, due to the archeological precautions we would need to take. The Board will be updated as the progresses and adjust the timeline as needed. Board Member Nelson Yellowman noted the cultural sensitivities and the Board agreed to observe cultural needs prior to excavating the property and possibly ask community members what they would consider appropriate.

Big projects that are on the original list for this year that have yet to be addressed include: Whitehorse High School and San Juan High School locker room renovations, as well as school marquees locations and access to power. The need for additional housing in Monument Valley needs to be prioritized and added to the schedule.

Superintendent Wright commented that work continues on the acquisition on the Montezuma Creek property. It has been surveyed and work on an application to the Navajo Nation Land Office for the lease is under way.

Board Member Merri Shumway commented that projects need to be reviewed for efficiency and usage, as she has had some experiences in the past that have not gotten good use. Two projects of concern include the reception area in the District Office and the concrete work from the Zenos L. Black Building to the State Office Building. While this is a City of Blanding concrete project, Shumway's concern is that the district contributed to the labor costs and she has heard reports that some community members feel the location for the concrete upgrades are a waste of funds.

The Blanding Elementary rental home is now vacant and a decision needs to be made as to whether the property should be prepared for future renters or whether we want to use the land for other purposes. Mr. Hosler confirmed that it will take some financial commitment to renovate parts of the house to a livable standard. Minimal upkeep has been done on the home since it was purchased as was agreed upon with the current renters. Mr. Hosler will discuss costs it may take to bring the home up to a suitable condition with Colby Davis. The Board would like to see the cost estimate regarding renovations and is inclined to continue renting the home as a revenue option until the remodel of the school is closer.

Superintendent Wright recommended that the upcoming year be considered a "catch up" year for projects that have been delayed by political or budget reasons, moving the entire remaining schedule back a year. This would allow the District to logically complete pending projects. Other minor projects could also be moved into the current year and some basic maintenance requests that have been delayed could be addressed.

Board Member Bill Boyle requested that the bus parking area at Monticello Elementary School be completed for performance and safety issues.

Board Member Nelson Yellowman commended the Colby and Kyle in their Capital Projects progress, he also mentioned that Whitehorse and Monument Valley football field uprights may be out of compliance and should be padded.

Sound and lighting system at Monticello High School needs training. Superintendent Wright noted that the San Juan High School Auditorium is to be done by Taylor Lyman thru Northern Electric, and as they are under contract with the school district, we will refer the issues to them and ask them to add this to their to-do list.

2. Water Concerns due to EPA Incident

Superintendent Wright noted that the district is a consumer of water in the Montezuma Creek area and relies on NTUA to provide water and assure its safety. The EPA caused accident that affected the water supply in the Montezuma Creek and Halchita areas was discussed. Once it was determined that the water was safe and that the necessary precautions had taken to keep water in the well tanks safe for consumption, registration and school schedules continued as scheduled. There has been some expressed from a few parents and there has some discoloration in the water at Montezuma Creek Elementary School. When that occurred tap water use was immediately restricted for drinking and bottled water brought in. It was discovered later that because a new line had been tapped for use, some debris has caused discoloration. The water still remained safe.

3. School Turnaround and Leadership Development Act

Superintendent Wright reported legislation regarding School Turnaround that was recently presented is very similar to the program that the district is currently essentially already participating in from UVA.

One area of great concern from the board is that faculty turnover has had negative impact in some of the district's most volatile schools. The Board requested that Superintendent Wright compose a letter of support to USU-Eastern regarding local investment in the Education Program offerings. The desire is to support the development of local teaching resources and produce local teachers that understand the communities and that are committed to long term residence there.

4. Navajo Utah Commission presentation on District Finances

Superintendent Wright reported on a presentation he made concerning San Juan School District budget and financial information to the Navajo Utah Commission. The Commission requested some additional reports regarding curriculum, specifically Navajo Language curriculum, as well as agreements regarding the Red Mesa High School and the state laws regulating student enrollment and boundary compliance. Superintendent Wright will be attending the commission meeting again in the near future to present further.

5. Governor's Native American Summit

Nelson Yellowman and Elsie Dee attended this summit and reported that there was great representation from students in our district with performance and attendance. Nelson Yellowman commented that the leadership at the conference emphasized their concern and focus on education, however there were no details or plans regarding solutions or guidance to help. Nelson noted there were a couple of notable speakers and performances, but overall the meeting seemed redundant to the other meetings from prior years and there was no new plans of action presented addressing the needs of students.

6. Utah School Board's Association Delegate Assembly

Merri Shumway attended the Delegate Assembly and reported on a presentation from Utah Valley University and their remediation program to assure incoming students are ready for college level work. Superintendent Wright commented on a recent discussion in the Superintendent's Association about the need to be flexible with the decisions made in the Delegate Assembly as the timing of the group meetings seemed premature. At times, it is difficult to fully commit in August to the decisions made and positions taken at the Delegate Assembly when the Legislative sessions convene months later and situations or conditions have changes.. Merri Shumway stated that it seems the best course of action would be to attend these delegate meetings for informational purposes, but still remain proactive as a separate entity and take action with representatives and legislators when needed if there are concerns that arise later.

7. Navajo Nation v. San Juan County Voting Rights

Superintendent Wright commented that the Navajo Nation's attorneys have asked a representative from the district to respond with data involving and concerning school boundaries. The plaintiffs are now questioning the mail-in ballot process, but it is not clear how this issue will affect the current lawsuit. There is some movement by the Navajo Nation Human Rights Commission to identify individuals who feel there were disenfranchised by the mail-in ballots and would be willing to put their name in or if their intentions are to find potential plaintiffs to assist a possible second lawsuit.

Elsie Dee commented on the portion of the discussion that was presented in Navajo. She stated that it focused mainly on the voting rights and the concerns surrounding the fairness and understanding of that process.

Debbie Christiansen stated that the State of Utah has to approve all the census blocks and precincts and that ultimately, it seems more logical that the Navajo Nation should include the State of Utah in discussions as a responsible party.

Superintendent Wright summarized by stating that at this point it remains unclear as to the direction the case is going. He will continue to supply documentation as requested and as recommended by the district's Legal Counsel.

1. Technology, Mr. Decker Decker

Josh Decker, Director of Technology reported on the status of technology in the District. Currently the network's stability relies on the expertise of Jared Brown. Mr. Decker commended Jarred and his department for the positive status of our technology, and looks forward to completing the hiring process to fill the position of an assistant network administrator to be Jared's backup. He also noted David Brown's expertise in programming and his ability work with the school districts data systems to gain vital information and coordination between programs.

Mr. Decker commented that since the setup of the Web Help Desk, the technology department has received 7864 ticket requests for help. There have been over 17,000 calls to the Help Desk. The department is very busy.

A classroom technology pilot project using iPads, Chrome Books, and other devices has been an important undertaking for the Instructional Technology Team, and we are seeing positive impact in the classrooms where they are being used.

Mr. Decker thanked the Superintendent as the supervisor over the department and expressed his gratitude for the support he gives to the Technology Department and Instructional Technology program. A vision that Mr. Decker feels would be an ideal concept for the technology department to add would be an Educational Technology Coach in both Elementary and Secondary levels that could help faculty implement and use more technology in their instruction.

2. District Policy 4330 - Evaluations - 2nd Reading

He commented that the last written agreement expired in 2014. There have been needs arise that drew attention for the need to clarify responsibilities for field upkeep and conditions, as well as scheduling and liability. San Juan High School's report from Principal Bob Peterson for was rescheduled to a later Board Meeting.

The parent group interested in offering soccer at district schools asked to be able to comment at 5:00 p.m. as there is a middle school band concert scheduled for 6:00 p.m. that many of them wish to attend. The Board agreed to their request.

B. Board Work Session

✱ 1. Capital Projects

Superintendent Wright reminded the Board of the Capital Projects timeline adopted last year and expressed concerns with two major delays: Securing a lease agreement with the Navajo nation Lands Office for the property in Montezuma Creek surrounding the elementary school and the preliminary archeological findings on the recently purchased Bluff property. He noted that there is a revised timeline for Capital Projects in the Action Items of the agenda which incorporates these delays. An update on the progress with ongoing projects was reviewed.

In discussing the concerns which have arisen with the Bluff property, Nelson Yellowman urged the board to exercise awareness and cultural sensitivity. He stressed that personal visits with families in the attendance area, cultural representatives and the community would be necessary to gain a greater understanding of their position. Superintendent Wright noted that the ultimate goal is to provide a new school for the students in Bluff and expressed his frustration that this well-intentioned goal has been politicized and even villainized by some individuals and groups who have made many assumptions without considering the facts.

Melinda Blackhorse, Navajo Nation representative to Utah's Native American Education Commission explained that presented information and conducted discussion regarding this land purchase in the Mexican Water and Oljato Chapters and that they will be drafting resolutions outlining their position on the new building. She also indicated that the Navajo Utah Commission plans to draft a resolution along the same lines.

Board Member Bill Boyle defended the board's actions stating that it was premature for a resolution from any organization, especially considering that not even the archeologists have all the information necessary to make a recommendation. Mr. Boyle's concern is that there seems to be a practice of taking a stance or jumping to conclusions before there is conclusive data. He also noted that it brings a negative air to a very positive intention and that can be very damaging for the outcome and the community if this behavior continued. He summarized that the school board itself did not currently have all the information needed and that there is great effort from the board to make a decision that is in the best interest of the students, while still being culturally sensitive.

Board Vice President Merri Shumway recommended to Melinda Blackhorse that it would be more helpful for the students if the chapters worked together to offer solutions, instead of taking a stand against something before all the data is collected. She urged Ms. Blackhorse to work towards cooperation and not opposition so that a school can be supplied to the students in the area that all groups can see the positive results.

Board President Debbie Christiansen commented that the board's efforts to build a school in the Bluff area solidifies its commitment to have schools available as close to where the students live as is possible. She noted that this practice has resulted in small schools that are some of the most costly to operate in the state. The goal is to once again provide a school in Bluff that is culturally sensitive, accessible to students, and affordable.

The discussion was closed with the Superintendent's repeated invitation to Ms. Blackhorse to meet with him to discuss information that she lacked. She has been invited multiple times in the past, yet has not been able to schedule a visit.

2. October 1 Enrollment Report

October 1 count has been submitted to the State Office of Education. The district wide enrollment is 2975, which is down a total of 44 students from last year's enrollment of 3019.

Of the 12 schools, 5 increased slightly, and 7 decreased. The majority of the student enrollment loss was felt in Blanding schools, with a slight increase ARL (+20), offset by a substantial decrease between SJH (-34) and BES (-35) schools.

3. School PACE Reports / School Grades

School PACE reports were presented to the board members. PACE reports were developed by the Utah State Office of Education from the Governor's office, intending to provide a more comprehensive view of the school progress and standards.

4. Focus / Priority / Turnaround Schools

In the 2015 session, the State legislature passed SB235, The School Turnaround and Educational Leadership Developmental Act. The law is similar to the US Department of Education's mandate to address the needs of the lowest performing schools which has led to some of our school being involved with the Partnership for Leadership in Education at the University of Virginia and working under School Improvement Grants offered under Title 1. Four schools- Bluff Elementary, Tse bii nidzizgai Elementary, Monument Valley High, and Whitehorse High- have been named to participate in the State Turnaround program. All but Bluff Elementary are currently involved in the Title 1 turnaround which will result in overlapping and conflicting expectations and mandates. Some deadlines have been noted, but information from the State has not been released for choosing Turnaround models.

Superintendent Wright and Board Members discussed concerns regarding the layered legislation, mandated procedures and reporting, along with the great amount of work already being expected.

5. State of Utah SHARP Survey Results

2015 SHARP Survey results were provided to the board members for review.

C. Closed Session (if necessary)

No closed session was held.

D. Department Report - 4:00 p.m.

1. Food Service Department, Anna Fredericks

Ms. Fredericks took over the Food Service Department after the District decided to terminate its contract with ARAMark. The new department was tasked with making several major changes and improvements in the previous system. Meals that were unappetizing to students, inadequate portions, costly and not homemade were some of the biggest concerns starting out.

A recent administrative review from the State Office of Education praised the program as one of the best in the state. The foodservice department has seen an increase in both breakfast and lunch attendance. Ms. Fredericks also noted that they encourage schools to take lunches on busses

when students travel for school trips, including field trips and extracurricular activities in secondary schools.

It was reported that the UDSA has estimated that upcoming mandates may increase food service budgetary expenses as much as \$1.2 million dollars in the upcoming year. Offerings including offering water as a beverage, increased requirements in fresh fruits and vegetables and whole grains as ingredients.

Bill Boyle commented that since the School District took over the food service there has been opportunity for local vendors to collaborate with the District which has seen positive results.

Also, there has been very positive reviews regarding the "free lunch" changes which has eased the financial burden on families, and has simplified the financial secretaries' burden, and has eased the minds of many who see kids not getting adequate nutrition sent from homes who may not have resources to do so.

2. Blanding Elementary School, Mark Burge

Principal Mark Burge presented SAGE scores and compared previous year's increases in the number of students who showed proficiency. While there was slight drop in Language Arts, the shifted focus to Math showed positive results resulting in an overall school grade of a "B" compared to last year's "C."

School wide goals include improving Tier 1 instruction, student engagement, increased student collaboration vs. teacher lecture time, best use of intervention time, differentiate instruction for all students, improvements in testing scores, and focus on PLC effectiveness.

Mr. Burge also noted efforts in shifting to a Growth Mindset so that students gauge themselves and their success by what they've learned or could learn and the understanding that they may not know something, but that they have the ability to learn it.

E. Scheduled discussion with public, Citizens Comments regarding request for High School Soccer Team Program at San Juan High

1. Citizens' Comments

Keri Jensen and Nichole Black acted as spokespeople for the group. Approximately 12 adults came along with one high school student to request the board's action on a soccer program at San Juan High School. Nichole Black commented that last year over 100 kids (elementary age) played soccer in city league and that they have had a lot of response via social media regarding the prospect of a program at a secondary school age level.

The board has requested information in the past regarding coaches, number of players (boys and girls teams), fields for games and practice, certified officials, financial investment, Club options, insurance, travel, and regional play logistics.

The parent group proposed Jay Jones as a head coach, and Cory Raisor who is not certified but is willing to certify as an official via online programs. They commented that there is space at the district owned baseball fields for practice and play, but it would take some maintenance preparation and upkeep. There was no information brought regarding a potential game schedule, uniform and equipment costs or information on number of students at the High School level who have expressed interest. The parent group also expressed their feeling that Club teams would not fill the need and noted that school based funding is needed rather than running a team privately.

Business Administrator Kyle Holser was tasked to assist with gathering information regarding expense and academic impact to the students. Reports will be shared at the next local meeting in December 2015. Board President Debbie Christiansen specifically requested that at the next meeting the parents provide a list of High School age students who would play if given the opportunity.

F. Break - 5:50 p.m.

G. Public Session-Welcome and Recognition of Guests - 6:10 p.m.

1. Citizens Comments

Alfred Myerson stated he is present for observation at this time, as he has concerns regarding Capital Projects and some things he has heard. Board President Debbie Christiansen expressed to him that there was some work session discussion, but nothing has been decided upon and that the district and board are currently at an information gathering stage regarding the school building in Bluff, but would not likely re-open the topic again in this meeting.

Helen Meyerson expressed concerns regarding student privacy, policy, information release and policies at the elementary school. She stated that she is not on her grandchild's list at Tsebi'indzizgai Elementary School, but the principal has allowed other people, including non custodial parents, access to the student's information. Superintendent Wright took Ms. Myerson's phone number and will contact her following conversations with the school and principal regarding the situation.

Ms. Myerson also had concerns about specific volunteers who have access to her grandchildren that she does not agree with. Board Vice President Merri Shumway recommended to Ms. Myerson that in the future, please contact the Superintendent immediately when the concerns arise as student privacy and classroom situations can best be handled by him in a timely manner, rather than waiting to present at Board Meeting.

Francine Sam addressed the board regarding the alternative bus that Montezuma Creek secondary students catch in the Bluff area. Her concerns addressed overcrowding, kids sitting in

aisles, and the request to add a route for the kids that opt into bussing to Blanding instead of attending at Whitehorse. Her personal decision to send her daughter on a bus to Blanding was determined by behavioral issues at Whitehorse High School and the academic gains and more controlled environment in Blanding.

Superintendent Wright noted that state law allows for open enrollment and so the District allows students to attend a schools outside attendance area. The legal mandate states that the parent is required to get the student to their school of choice and the district accommodates their registration in that school, however, the district only provides required transportation to the appropriate school according to district school locations.

Kayla Atcitty, former Whitehorse High School student and currently attending at Dartmouth University, also spoke in support of providing assistance to parents and students who would like to bus to alternative schools in the district.

Sharon Cly-Stryker commented on school test scores and supported the desire for families to have that option. She also mentioned concerns with a GRAMA request she has made and also requested testing scores for a Heritage Language Competency test she took.

WHEREAS:


1. Pursuant to 26 N.N.C., Section 102 (B); which permits Mexican Water Chapter to exercise local governance authorities contained within 26 N.N.C. Section 103, with the exception of land administration authority pursuant to 26 N.N.C. Section (D) (1); and
 2. Pursuant to 26 N.N.C., Section 3 (A) the Mexican Water Chapter is a recognized certified Chapter of the Navajo Nation government, as listed at 11 N.N.C. part 1, section 10; and
 3. Pursuant to CAP-34-98, the Navajo Nation Council adopted the Navajo Nation Local Governance Act (LGA); and
 4. Pursuant to Mexican Water Chapter resolution MWCJUL11-105, the Mexican Water Chapter has approved its Five Management System Policies and Procedures Manuals; and
 5. Pursuant to the Resources and Development Committee certifying Mexican Water Chapter having met requirement under 26 N.N.C. & 102 (A) on February 07, 2012; and
 6. The Mexican Water Chapter consider their Navajo children as the tribe's greatest resource and agree that education is important and necessary in their growth and development; and
 7. The Bluff Elementary School is one of the site school under the San Juan Unified School District in the State of Utah and the facility located in Bluff, Utah identified as Bluff Elementary is an aging and deteriorating facility that serves as a predominately Navajo student population; and
 8. The San Juan Unified School District recently made a decision to replace the Bluff Elementary School and purchased 12.53 acres of land located in Bluff, Utah to serve as a new location for the Bluff Elementary School; and
 9. The preliminary findings of an archaeological assessment sanctioned by the San Juan School District found a significant evidence of archaeological remains and possibly burial site within location of the selected new site for the new school; and
 10. The cultural beliefs and practices of the Navajo people are strong, enduring and meaningful, particularly in regard to disturbance and disrespect of archaeological sites; and
 11. The San Juan School District is well aware of long standing antiquities issues in San Juan County, Utah and is continually reminded by high-profile issues such as the federal artifacts investigation, Recapture Protest Ride and Public Lands Initiative; and
 12. The Navajo people are not politicizing their beliefs and values and certainly not villianizing the San Juan School District in standing up for cultural beliefs and well-being of Navajo students; and

NOW THEREFORE IT BE RESOLVED THAT:



IN SUPPORTING THE MEMBERS OF ANETH CHAPTER OF THE SAN JUAN SDHOOOL DISTRICT DECISION TO REPLACE THE BLUFF ELEMENTARY SCHOOL BUT VEHEMENTLY OPPOSING SAN JUAN SCHOOL DISTRICT INFRASTRUCTURE PLAN FOR THE NEW SCHOOL ON LANDS CONTAINING ARCHAEOLOGICAL SITES AND REMAINS.

WHEREAS:

- 1. Dine' Medcinemen Association, Inc.,/s Authority**
- 2. The Dine' Medcinemen Association oversees the well-being of the Navajo children as the tribe's greatest resource through their educational endeavors and ensure Navajo children develop healthy lifestyle in their environment of their dwellings; and**
- 3. The Dine' Medcinemen Association understands the need for new infrastructure of Bluff Elementary School as an aging and deteriorating facility that serves predominately Navajo students; and**
- 4. The San Juan School District recently purchased 12.53 acres of land in Bluff, Utah, as a new location for the proposed new Bluff Elementary School; and**
- 5. The preliminary findings of an archaeological assessment sanctioned by the San Juan School District found significant evidence of archaeological remains and possibly burial site within the location of the new plan for the new school: and**
- 6. The Navajo cultural belief(s) and practices of the Navajo people are strong, enduring, and meaningful, and a way of life, particularly in regard to un-**

wellness affects and harm to individuals by disturbing and disrespect of archaeological sites; and

7. The Dine' Medicine Medicinemen Association has become aware of long standing antiquities issues in San Juan County and need not look far to recognize the seriousness of this matter (i.e., Federal artifacts investigation, Recapture ATV protest ride); and
8. The Dine' Medicinemen Association are not politicizing their beliefs and certainly not villainizing the San Juan School District in effort to stand up for cultural beliefs, practices and well-being of Navajo students.

NOW THEREFORE BE IT RESOLVED THAT:


