PURPOSE: This resolution if approved will approve supplemental funding from the Unreserved, Undesignated Fund Balance in the amount of \$395,425.00 for the Navajo Nation Elections Administration Office, to fund the referendum regarding chapter reorganization.

This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each committee member to review the proposed legislation in detail.

SECTION 2. FINDINGS

- A. Pursuant to 12 N.N.C. § 820 (L), "[t]he Navajo Nation Council may adopt and approve supplemental appropriations to the Annual Comprehensive Budget during the fiscal year. Supplemental appropriations of General Funds within the current fiscal year are permitted, if and when additional sources of revenues above and beyond the initial or current revenue projections are projected and which are also in excess of the reserve amount set forth at § 820(J)."
- B. The Title 12 Finance Act Supplemental Appropriation requirements include:
 - 1. Pursuant to 12 N.N.C. § 820(L), all requests for annual operating funds and supplemental funds shall be submitted to the Office of Management and Budget ("OMB") for budget impact analysis. A preview of the appropriation legislation is available to the OMB for their budget impact analysis response. The OMB review for this legislation has not yet been completed and must be provided prior to the approval of this legislation.
 - 2. Pursuant to 12 N.N.C. § 820(L), when the Controller identifies additional sources of revenues above and beyond the initial or current revenue projections, supplemental appropriations may be allocated by the Navajo Nation Council. *See* Exhibit B.
- C. The Navajo Nation currently has 110 local governing chapters. A number of chapters have elected officials, such as a President, a Vice President and a Secretary Treasurer. Some chapters operate under alternative forms of government, such as commission-type governments.
- D. On May 20, 2015, the Resources and Development Committee of the Navajo Nation Council established the "Title 26 Codification Task Force Committee." Stated purposes for creating this committee included reviewing accountability at the chapter level, exploring ways to empower chapters, streamlining the Five Management Plan System and transparency.
- E. The Title 26 Codification Task Force Committee completed its review of tasks assigned.

 The committee is recommending a referendum on regionalizing the 110 chapters into 24

- regions. These regions will be governed by commissioners elected by chapters in each region.
- F. The Supplemental Funding will be deposited with the Navajo Nation Office of the Speaker; the Program Budget Summary is attached as Exhibit "A."
- G. The Navajo Nation hereby finds it is in the best interest of the Navajo People to approve this supplemental funding request.

SECTION 3. APPROVING SUPPLEMENTAL FUNDING FROM THE UNRESERVED, UNDESIGNATED FUND BALANCE IN THE AMOUNT OF \$395,425.00 TO THE NAVAJO NATION ELECTION ADMINISTRATION OFFICE

- A. The Navajo Nation, upon receiving certification by the Office of the Controller hereby approves supplemental funding from the Unreserved, Undesignated Fund Balance in the amount of \$395,425.00 for the Navajo Nation Elections Administration Office, to fund the referendum regarding chapter reorganization. *See* Exhibit B.
- B. This supplemental appropriation of \$395,425.00 shall be to the Navajo Nation Election Administration Office, Business Unit #101021 and from that amount of funds that exceeds the minimum fund balance of the Unreserved, Undesignated Fund Balance as determined by the Office of the Controller, pursuant to 12 N.N.C. § 820(L).
