BE IT ENACTED:

Section 1. Authorities

A. Pursuant to 2 N.N.C. § 164 (A)(9), a proposed resolution that requires final action by the Navajo Nation Council must be assigned to the Naabik'íyáti' Committee before it is considered by the Navajo Nation Council.

B. The Navajo Nation Council, pursuant to 2 N.N.C. §972(A), confirms appointments to the Commission on Navajo Government Development.

Section 2. Findings

A. The Commission on Navajo Government Development consists of 12 Navajo members. Regarding appointments to this commission, Navajo Nation law mandates - "Commission members shall be chosen from among individuals who have demonstrated scholarship, a strong sense of public interest, knowledge of Navajo history and cultural

1 heritage, spiritual leadership, leadership in the Navajo government and abilities likely to
2 contribute to the fulfillment of the duties of the Commission." 2 N.N.C. § 972(D).

3 B. Once appointed, members of the Commission on Navajo Government Development are
4 confirmed by and serve at the pleasure of the Navajo Nation Council pursuant to 2 N.N.C. §
5 972(A).

6 C. For five positions on the Commission on Navajo Government Development, the law
7 provides - "Five members shall be nominated from the five agencies of the Navajo Nation.
8 Each agency council shall nominate one member from recommendations to be submitted by
9 Chapters in each agency, said nominees shall be either Chapter officers or Grazing
10 Committee/Land Board members. These members shall serve a term of four years from the
11 date of confirmation by the Navajo Nation Council so long as they continue as Chapter
12 officer or Grazing Committee/Land Board member." 2 NNC § 972(A)(5). In respect to this
13 section, Mr. Shawnevan Dale has been nominated by the Ft. Defiance Agency Council to
14 serve on the Commission on Navajo Government Development Commission. See attached
15 resolution of the Agency Council (FDAC-19-002), marked as Exhibit "A," the letter of the
16 Director of the Office of Navajo Government Development (dated May 9, 2019), marked
17 as Exhibit "B," and the letter of interest (with resume) of the nominee marked as Exhibit
18 "C."

19 D. Mr. Shawnevan Dale meets the qualifications set forth at 2 N.N.C. § 972(A)(5) to
20 serve as a commissioner on the Commission on Navajo Government Development.

22 **Section Three. Confirmation**

23 The Navajo Nation, pursuant to 2 N.N.C. § 972(A)(5), hereby confirms the
24 nomination of Mr. Shawnevan Dale to serve as a commissioner on the Commission of
25 Navajo Government Development for the Ft. Defiance Agency Council. Mr. Dale shall
26 serve a term consistent with the requirements of Navajo Nation law in respect to this action

WHEREAS:


1. The Fort Defiance Agency Council is a consortium of duly elected Chapter Officials of twenty-eight (28) certified/non-certified Navajo Nation Chapter that advocate, promote, and support common goals and interest of the respective Chapters; and
2. The Fort Defiance Agency Council is comprised of elected officials from twenty-eight (28) Navajo Nation Chapters within the Fort Defiance Agency and has the responsibility and authority to address matters and projects that will benefit the 28 chapters of the Fort Defiance Agency of the Navajo Nation; and
3. The Ft. Defiance Agency Council recognizes that pursuant to 2N.N.C. §§ 970 and 971(1)(2), the Commission on Navajo Government Development ("Commission") was established as a special entity with quasi-independent authority to accomplish the Council's project of instituting reforms necessary to ensure an accountable and responsible government; and,
4. The Ft. Defiance Agency Council recognizes that five members shall be nominated from the five agencies of the Navajo Nation. Pursuant to 2 N.N.C. § 972(A)(5), each agency council shall nominate one member whom is qualified to serve on the Commission on Navajo Government Development; [*"Each Agency Council shall nominate one member from recommendations to be submitted by chapters in each agency; nominees shall be either Chapter Officers or Grazing Committee / Land Board Members. These members shall serve a term of four (4) years, from the date of confirmation by the Navajo Nation Council so long as they continue as a chapter officer or as a Grazing Committee / Land Board member "*. (Emphasis added.)]; and,
5. The Ft. Defiance Agency Council passes a resolution supporting and recommending the appointment of Mr/Ms. Shawneen Dale, Wide Ruins Chapter/Commission Government to serve on the Commission on Navajo Government Development.

NOW THEREFORE BE IT RESOLVED THAT;





Yá'át'tééh! I hope this letter finds you in good spirit and health. On January 9, 2019, the Fort Defiance Agency representative to the Commission on Navajo Government Development (Commission) became vacant and thus an immediate effort was undertaken to get the vacancy filled.

On January 12, 2019, the Fort Defiance Agency Council (FDAC) passed Resolution No: FDAC-19-01-002, a resolution supporting and recommending the appointment of Mr. Darryl Tso, Nahata Dził Chapter/Commission Government to serve on the Commission on Navajo Government Development. Unfortunately, Mr. Tso never submitted his required and requested documents—a letter of interest and resume or CV—to the Office of Navajo Government Development for legislative packet preparation. Thus, FDAC swiftly to put this matter back on their agency council agenda on April 6, 2019 for a nominee.

On April 6, 2019, the Fort Defiance Agency Council (FDAC) passed Resolution No: FDAC-19-04-002, a resolution supporting and recommending the appointment of Mr. Shawnevan Dale, Wide Ruins Chapter, to serve on the Commission on Navajo Government Development. Mr. Dale has since submitted his letter of interest and resume in a timely matter.

The Office of Navajo Government Development respectfully request that you be the primary sponsor for this legislation and to submit this packet to the Office of Legislative Services, so the legal staff can prepare the necessary legislative documents. The Commission respectfully request this be introduced right away in hope that it makes the 24th Navajo Nation Council Summer Session.
