BE IT ENACTED:

SECTION 1. AUTHORITIES

- A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102(A). The Council, among other duties and responsibilities, "confirm[s] the appointments of division directors upon recommendation from the appropriate oversight committee." 2 NNC. 102(F). This authority to confirm appointments includes the Superintendent of Schools, Navajo Department of Diné Education. 2 N.N.C. § 1802(A).
- B. The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 400(A). The committee has oversight authority over the Navajo Department of Diné Education. 2 N.N.C. § 401(C)(1).
- C. The Naabik'iyáti Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 700(A). Pursuant to 2 N.N.C. §164(A)(9), "a proposed resolution that requires final action by the Navajo Nation Council [must] be assigned to standing

1 committee(s) having authority over the subject matter at issue and the Naabik'iyáti
2 Committee."

- 3 D. The Navajo Nation Board of Education oversees the operation of all schools serving
4 the Navajo Nation. 10 N.N.C. §106(A).

6 **SECTION TWO. FINDINGS**

- 7 A. The Superintendent of Schools position, Navajo Nation Department of Diné
8 Education, is currently vacant.

- 9 B. Pursuant to 2 N.N.C. § 1802 (A), the Department of Diné Education is "under the
10 immediate direction of the Navajo Nation Superintendent of Schools, subject to the
11 overall direction of the Navajo Nation Board of Education. The Navajo Nation
12 Superintendent of Schools is appointed by the Navajo Nation Board of Education,
13 subject to confirmation by the Navajo Nation Council."

- 14 C. Pursuant to 2 N.N.C. § 1802(B), "[t]he Navajo Nation Superintendent of Schools
15 shall serve at the pleasure of the Navajo Nation Board of Education." As "chief
16 administrative officer of the Board," the Superintendent is "empowered to do all
17 things necessary and proper to carry out the responsibilities of the Board." 10 N.N.C.
18 § 106(G) (2)(a).

- 19 D. The Navajo Nation Board of Education on April 2, 2020, by resolution NNBEAP-
20 613-2020, appointed and recommended the confirmation of Mr. Ronald Milton
21 Thompson as the Superintendent of Schools, Navajo Department of Diné Education.
22 See Exhibit A, Board resolution.

- 23 E. Mr. Ronald Milton Thompson is qualified for the position of Superintendent, Navajo
24 Nation Department of Diné Education. See letter of interest and resume, Exhibit B.

- 25 F. The Health, Education and Human Services Committee of the Navajo Nation Council
26 supports the appointment and confirmation of Mr. Ronald Milton Thompson as
27 Superintendent of Schools, Navajo Department of Diné Education.

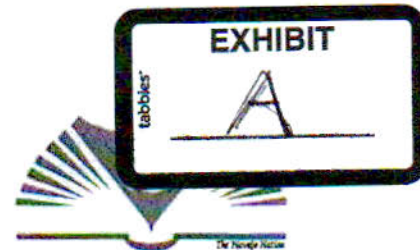

RESOLUTION OF THE NAVAJO NATION BOARD OF EDUCATION

Relating to Education; Recommending to the Navajo Nation Council to Confirm Ronald Milton Thompson as the Superintendent of Schools of the Department of Diné Education to the Navajo Nation Council Pursuant to 2 N.N.C. § 1802(A).

WHEREAS:

1. The Department of Diné Education (hereinafter the "Department") is the administrative agency within the Navajo Nation with responsibility and authority for implementing and enforcing the educational laws of the Navajo Nation. 2 N.N.C. § 1801 (B); 10 N.N.C. § 107 (A). The Department is under the immediate direction of the Board. 10 N.N.C. § 107 (B).
2. The Navajo Nation Board of Education (hereinafter the "Board") is the education agent in the Executive Branch for the purposes of overseeing the operation of all schools serving the Navajo Nation. 10 N.N.C. § 106 (A). The Board carries out its duties and responsibilities through the Department of Diné Education. 10 N.N.C. § 106 (G)(3). In addition, "the Board [has the] general power to monitor the activities of all Bureau of Indian Affairs funded schools and local community school boards serving the Navajo Nation..." 10 N.N.C. § 106 (G)(1).
3. "The Navajo Nation Superintendent of Schools is appointed by the Navajo Nation Board of Education, subject to confirmation by the Navajo Nation Council." 2 N.N.C. § 1802(A). The Board interviewed five (5) out of five (5) candidates for the Superintendent of Schools of the Department of Diné Education position and determined that Ronald Milton Thompson is the most qualified candidate. Documentation supporting the Board's recommendation is attached hereto as "EXHIBIT A."
4. The Board recommends Ronald Milton Thompson for confirmation and approval by the Navajo Nation Council as being in the best interests of the Department of Diné Education and the Navajo Nation.

NOW THEREFORE BE IT RESOLVED THAT:

1. The Navajo Nation Board of Education recommends that the Navajo Nation Council to confirm Ronald Milton Thompson as the Superintendent of Schools of the Department of Diné Education pursuant to 2 N.N.C. § 1802(A).
