# AN ACTION

RELATING TO RESOURCES AND DEVELOPMENT AND BUDGET AND FINANCE COMMITTEES; APPROVING A CHANGE IN RESOLUTION CAP-35-18 EXHIBIT D NO. 21 COYOTE CANYON CHAPTER PROJECT BY CHANGING THE PROJECT DESCRIPTION FROM "N96 CHIP SEAL" TO "N96 ROAD IMPROVEMENT"

BE IT ENACTED:

### SECTION ONE. AUTHORITY

- A. The Resources and Development Committee exercises authority over chapters of the Navajo Nation. 2 N.N.C. § 501(C)(1).
- B. The Budget and Finance Committee of the Navajo Nation Council exercises authority over budgeting, appropriation, investment and management of all funds. 2 N.N.C. § 301(B)(2).
- C. Council Resolution CAP-35-18, "[a] chapter project, powerline, or waterline project may be changed, including the year funded, or added to Exhibits A through E with the concurrence of the Delegate representing the chapter's Council District and the approvals of the Resources and Development Committee and Budget and Finance Committee, as long as such project has been certified as constructionready by CPMD or NTUA and the total Síhasin Funding for the District does not exceed \$4,166,666.67."

### SECTION TWO. FINDINGS

A. The Navajo Nation Council adopted Council Resolution CAP-35-18, "Adopting the Sihasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-68-14, as Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended; Waiving 12 N.N.C. § 810(F), 820(I), and (M) and 860(C) Relating to the Capital Budget and Capital Improvement Process" on April 17, 2018.

- B. Coyote Canyon Chapter Project is listed in CAP-35-18 at Exhibit D, Project Number 21, Exhibit D of CAP-35-18 is attached as Exhibit 2.
- C. Coyote Canyon submitted a CAP-35-18 Sihasin Project Amendment Certification form which is attached as Exhibit 1.
- D. The CAP-35-18 Sihasin Project Amendment Certification form, Exhibit 1, indicates changes to be made to Exhibit D, Project Number 21 the Coyote Canyon Chapter to change the Project Description from "N96 Chip Seal" to "N96 Road Improvement."
