BE IT ENACTED:

**Section One. Authority**

- A. The Law and Order Committee (LOC) and the Budget and Finance Committee (BFC) are standing committees of the Navajo Nation Council. 2 N.N.C. § 600(A) and 300(A).
- B. The LOC has oversight of the Department of the Division of Public Safety. 2 N.N.C. § 601(C)(1).
- C. The BFC is empowered to approve fund management plans upon the recommendation of the appropriate oversight committee and the affected division or branch. 2 N.N.C. § 301(B)(14).

**Section Two. Findings**

- A. The Navajo Nation entered into a Memorandum of Agreement with the Navajo Gaming Enterprise in January 2013 to provide a law enforcement presence at the Navajo Nation gaming facilities.

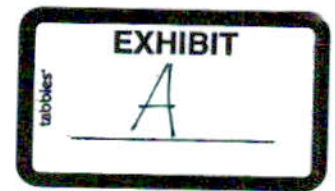
- 1 B. The Navajo Nation initially approved a fund management plan for the Navajo  
2 Division of Public Safety through Resolution BFMY-15-13. The fund management  
3 plan was subsequently amended through Resolution BFSC-22-14.
- 4 C. The proposed amendments to the fund management will allow the Division of  
5 Public Safety to fully support and pay for the operation and maintenance expenses  
6 of the Twin Arrows Public Safety Building not otherwise funded through the  
7 Navajo Nation's fixed cost budget.
- 8 D. The proposed amendments to the fund management plan for the Division of Public  
9 Safety are attached as **Exhibit A**.
- 10 E. For reference, a clean copy incorporating amendments to the current fund  
11 management plan is attached as **Exhibit B**.
- 12 F. The Navajo Division of Public Safety recommends the approval of the proposed  
13 amendments. A memorandum recommending the approval of the proposed  
14 amendments is attached as **Exhibit C**.

Amendment No. 2

**I. ESTABLISHMENT**

There is hereby established the Navajo Division of Public Safety Fund Management Plan for use by the Navajo Division of Public Safety.

**II. CRITERIA**

1. The Navajo Nation, through the Navajo Division of Public Safety ("NDPS"), has entered into a Memorandum of Agreement ("MOA") with the Navajo Nation Gaming Enterprise ("NNGE") to provide police services to Navajo Gaming Facilities.
2. The MOA requires that on-site police services be provided to the "Fire Rock Navajo Casino" located in Church Rock, Chapter, McKinley County; "Flowing Water Navajo Casino" located within Tsé Daak'aan Chapter, San Juan County; and "Northern Edge Navajo Casino" located within Upper Fruitland Chapter, San Juan County and "Twin Arrows Navajo Casino Resort" located in Leupp Chapter, Coconino County.
3. The ~~total~~ negotiated fee for this service is \$36,000 per month or \$432,000 per year for "Fire Rock Navajo Casino", "Flowing Water Navajo Casino", and "Northern Edge Navajo Casino". The ~~total~~ negotiated fee for this service is 25,000 per month or \$300,000 per year for "Twin Arrows Navajo Casino Resort". The total negotiated fee for this service is \$732,000 per year. The term of the MOA is perpetual, unless otherwise terminated pursuant to the requirements set forth in the MOA.
4. NDPS will use the funds generated to support the operation needs of NDPS police officers and the Department of Corrections.
5. This includes using the fund for personnel related expenses for overtime, training, lodging, meals, travel equipment, supplies and awards.
6. NDPS will also use the funds to purchase new patrol vehicles. The funds will also be used to pay associated expenses, including fees, insurance and repair work.
7. On an annual basis, beginning in FY 2019, NDPS will use the funds to fully support and pay for the operation and maintenance expenses of the Twin Arrows Public Safety Building, not otherwise paid for from the Navajo Nation's fixed cost budget.

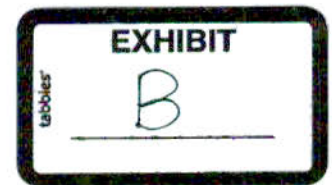
All funds paid under this Police Service MOA shall be deposited with the Office of the Controller and the NN Controller's Office shall establish a new fund, separate from the general fund.
