RESOLUTION OF THE BUDGET AND FINANCE COMMITTEE OF THE NAVAJO NATION COUNCIL

24TH NAVAJO NATION COUNCIL - Fourth Year, 2022

AN ACT

RELATING TO THE RESOURCES AND DEVELOPMENT, AND BUDGET AND FINANCE COMMITTEES; APPROVING A CHANGE TO CAP-35-18, EXHIBIT E, FOR THE CRYSTAL CHAPTER BY REALLOCATING \$165,666.66 IN SÍHASIN FUNDS TO THE CHAPTER'S FIRE SUPPRESSION PROJECT AND MOVING FUNDS TO THE YEAR 3 FUNDING PERIOD

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Resources and Development Committee of the Navajo Nation is empowered to exercise oversight authority over chapter activities. 2 N.N.C. § 500(C).
- B. The Budget and Finance Committee of the Navajo Nation Council is empowered to review and recommend to the Navajo Nation Council the budgeting, appropriation, investment and management of all funds and to coordinate and review all fiscal, financial and investment activities of the Navajo Nation. 2 N.N.C. § 301(B)(2) and § 301(B)(5).

SECTION TWO. FINDINGS

- A. The Navajo Nation Council approved Resolution No. CAP-35-18, entitled, "Adopting the Sihasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-68-14, as Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended; Waiving 12 N.N.C. §§ 810(F), 820(I), and (M) And 860(C) Relating to the Capital Improvement Budget and the Capital Improvement Process." CAP-35-18 is incorporated herein by this reference.
- B. Section 4(C) of CAP-35-18 allows an approved Chapter project to be changed, by changing the year funded, by adding to the project, or by changing the project entirely, with the concurrence of the Council Delegate representing the Council

District and the approvals of the Resources and Development Committee and Budget and Finance Committee, as long as such project has been certified as construction-ready and the total Síhasin Funding for the District does not exceed \$4,166,666.67.

- C. The amount of \$165,666.66 for the Crystal Chapter's "Green Knoll/Split Mesa Waterline and Storage" project was approved in Exhibit E of CAP-35-18. The CAP-35-18 Exhibit E showing the Crystal Project No. E-4 is attached hereto as **EXHIBIT 1**.
- D. The Crystal Chapter desires to delete Project No. E-4 in the Year 1 and Year 2 Funding Periods and reallocate the approved funds to the Year 3 Funding Period, and to change the approved project to the "Fire Suppression System" project. The Division of Community Development Capital Projects Management Department ("CPMD") has submitted, on behalf of the Chapter, a Sihasin Project Amendment Certification Form. EXHIBIT 2. The CPMD Amendment Certification Form shows the signature of the Navajo Nation Council Delegate for the Crystal Chapter, as required by CAP-35-18 Section 4(C).
- E. The Crystal Chapter has passed Resolution No. CRY-01-2022-002, dated January 23, 2022, to request this project change. **EXHIBIT 3**.
- F. As required by CAP-35-18 Section 4(C), the new project has been certified by CPMD as construction-ready and the total Sihasin funding for the Council District will not exceed \$4,166,666.67. In fact, the original Sihasin funding amount of \$165,666.66 for the Crystal Chapter, as approved in CAP-35-18, will remain unchanged.
- G. The Sihasin Fund shall be reimbursed the \$165,666.66 reallocated herein, from funds available to the Navajo Nation from any and all state and federal sources, including Congressional appropriations under the American Rescue Plan Act of 2021 or other COVID-19 related relief, so long as the expenditures described herein are deemed eligible under such COVID-19 related or other funding sources.

SECTION THREE. APPROVAL

The Navajo Nation Council hereby approves a change to Resolution No. CAP-35-18, Exhibit E, Project No. E-4, for the Crystal Chapter by deleting the "Green Knoll/Split Mesa Waterline

and Storage Project" in Funding Year 1 and Year 2, and adding the "Fire Suppression System" Project to the Year 3 Funding Period, as shown in the attached **EXHIBIT 2**.

SECTION FOUR. EFFECTIVE DATE

This Legislation shall become effective pursuant to 12 N.N.C. § 2505.

SECTION FIVE. SAVINGS CLAUSE

If any provision of this Legislation is determined invalid by the Supreme Court of the Navajo Nation, or by a Navajo Nation District Court without appeal to the Navajo Nation Supreme Court, the provision(s) not determined invalid shall remain as Navajo Nation law.

CERTIFICATION

RESOLUTION OF THE CRYSTAL CHAPTER

RESPECTFULLY REQUESTING RESOURCES & DEVELOPMENT COMMITTEE (RDC) AND THE BUDGET & FINANCE COMMITTEE (BFC) TO APPROVE A CHANGE IN FUNDING IN RESOLUTION CAP-35-18 TO TRANSFER THE REMAINING BALANCE OF \$165,666.67 FROM THE WATER LINE EXTENSION / WATER STORAGE PROJECT TO THE FIRE SUPPRESSION SYSTEM PROJECT.

WHEREAS:

- 1. Pursuant to 26 N.N.C, Section 3 (A) The Crystal Chapter is a duly recognized Certified Chapter of the Navajo Nation Government as listed at 11 N.N.C., Part 1 of Section 10; and
- 2. Pursuant to 26 N.N.C, Section 1 (B), the Crystal Chapter is delegated with the government authority to make decisions over local matters consistent with Navajo law, customs, and traditions; and
- 3. Pursuant to 2 N.N.C. #500(A) and (C)(7) and #501(C)(1), the Resources and Development Committee (RDC) was established as a Standing Committee of the Navajo Nation Council with the responsibility to establish rules, regulations and policies to streamline procedures for approval, management, and enforcement to enhance the development of the economy and increase development on the Navajo Nation and is the Oversight Committee of the Division of Community Development, Administrative Services Centers, and the 110 chapter; and
- 4. On May 07, 2018, the 23rd Navajo Nation Council passed resolution CAP-35-18, the Sihasin Fund Powerline and Chapter Projects Expenditure Plan, which combined the Undesignated Unreserved Fund Balance and Shiasin Fund totaling \$100,000,000.00 that was divided equally amongst the twenty-four (24) Council Delegate District equaling \$4,166,666.67 per district; and
- 5. The resolution CAP-35-18, the Sihasin funding and Chapter Project expenditure plan of \$165,666.67 was approved and allocated for the Crystal Chapter Water line extension / Water Storage Project; and
- 6. All required documents to request a "change in the funding and transfer" are hereby attached to the following resolution.

NOW THEREFORE, BE IT RESOLVED THAT:

1. The Crystal Chapter respectfully requests Resources & Development Committee (RDC) and the Budget & Finance Committee (BFC) to approve a change in funding year in

Resolution CAP-35-18 to transfer the remaining balance of \$165,666.67 from the Water line extension / Water storage Project to Fire suppression system project.
