AN ACTION RELATING TO NAABIK'ÍYÁTI' COMMITTEE; ACCEPTING THE RECOMMENDATION OF THE HEALTH, EDUCATION AND HUMAN SERVICES COMMITTEE AND GRANTING THE DESIGNATION OF "TRIBAL ORGANIZATION" TO THE FORT DEFIANCE INDIAN HOSPITAL BOARD, INC. FOR A PERIOD OF FIFTEEN (15) YEARS, FOR THE PURPOSES OF CONTRACTING WITH THE UNITED STATES INDIAN HEALTH SERVICE AND AUTHORIZING THE FORT DEFIANCE INDIAN HOSPITAL BOARD, INC. TO NEGOTIATE AND ENTER INTO TITLE I, INDIAN SELF-DETERMINATION ACT (P.L. 93-638, AS AMENDED) CONTRACTS AND TITLE V SELF GOVERNANCE COMPACTS PURSUANT TO THE INDIAN SELF-DETERMINATION ACT (P.L. 93-638, AS AMENDED), SUCH DESIGNATION OF "TRIBAL ORGANIZATION" BEING REVOCABLE AND CONTINGENT ON CONTINUING COMPLIANCE WITH ALL TERMS AND CONDITIONS AS APPROVED BY THE HEALTH, EDUCATION AND HUMAN SERVICES COMMITTEE OF THE NAVAJO NATION COUNCIL

BE IT ENACTED:

SECTION ONE. AUTHORITY

A. Pursuant to Navajo Nation Council Resolution CJY-33-10 and the Navajo Nation Code at 2 N.N.C. Section Five (5) "References to previous Standing Committees" which states in part "References Navajo Nation Code...to Government Services Intergovernmental Relations Committees shall Naabik'íyáti' Committee..." the Naabik'íyáti' Committee of the Navajo Nation Council exercises the authority to authorize and approve additional tribal organizations that have received the recommendation and approval of the Health, Education and Human Services Committee of the Navajo Nation Council.

SECTION TWO. FINDINGS

- A. The Fort Defiance Indian Hospital Board, Inc. has requested to be designated a "tribal organization" for a period of fifteen (15) years, beginning December 29, 2021, and ending December 28, 2036, for the purposes of contracting with the United States Indian Health Service and to negotiate and enter into Title I, Indian Self Determination Act (P.L. 93-638, as amended) Contracts and Title V Self Governance Compacts pursuant to the Indian Self-Determination Act (P.L. 93-638, as amended). See Exhibit 1-A
- B. The Health, Education and Human Services Committee of the Navajo Nation Council through Resolution HEHSCAU-08-21,

attached as Exhibit 1, has found it to be in the best interest of the Navajo Nation to approve and recommend to the Naabik'íyáti' Committee of the Navajo Nation Council that the Fort Defiance Indian Hospital Board, Inc. be given the revocable designation of "tribal organization" for a period of fifteen (15) years, beginning December 29, 2021 and ending December 28, 2036, for the purposes of contracting with the United States Indian Health Service and to negotiate and enter into Title I, Indian Self Determination Act (P.L. 93-638, as amended) Contracts and Title V Self Governance Compacts pursuant to the Indian Self-Determination Act (P.L. 93-638, as amended), subject to the Terms and Conditions as found in Exhibit 1-D

- C. The Fort Defiance Indian Hospital Board, Inc. serves sixteen (16) Navajo Nation Chapters and has been endorsed by separate resolutions adopted by all the respective Chapters, as found within Exhibit 1-B.
- D. The Fort Defiance Indian Hospital Board, Inc. was previously approved by Health, Education and Human Services Committee Resolution HEHSCD-26-18, attached as **Exhibit 1-C**, as a "tribal organization" recommending to the Naabik'íyáti' Committee as the final authority for approval.
- E. The Naabik'íyáti' Committee of the Navajo Nation Council finds it to be in the best interest of the Navajo Nation, upon approval and recommendation of the Health, Education and Human Services Committee, to approve authorization of the Fort Defiance Indian Hospital Board, Inc. the revocable designation of "tribal organization" for a period of fifteen (15) years, beginning December 29, 2021 and ending December 28, 2036, for the purposes of contracting with the United States Indian Health Service and to negotiate and enter into Title I, Indian Self Determination Act (P.L. 93-638, as amended) Contracts and Title V Self Governance Compacts pursuant to the Indian Self-Determination Act (P.L. 93-638, as amended) and subject to the continuing compliance with the Terms and Conditions as approved and adopted by the Health, Education and Human Services Committee as attached in Exhibit 1-D.

SECTION THREE. APPROVAL

The Naabik'íyáti' Committee of the Navajo Nation Council, upon approval and recommendation of the Health, Education and Human Services Committee (Committee), hereby approves giving the Fort Defiance Indian Hospital Board, Inc. the revocable designation of "tribal organization" for a period of fifteen (15) years for the

purposes of contracting with the United States Indian Health Service and to negotiate and enter into Title I, Indian Self-Determination Act (P.L. 93-638, as amended) contracts and Title V Self Governance Compacts pursuant to the Indian Self-Determination Act (P.L. 93-638, as amended) and subject to the continuing compliance with the Terms and Conditions as approved and adopted by the Health, Education and Human Services Committee and herein attached as Exhibit 1-D.

AS A PURPOSES NAVAJO NATION "TRIBAL ORGANIZATION" FOR THE CONTRACTING WITH THE UNITED STATES INDIAN HEALTH SERVICE AND AUTHORIZING IT TO NEGOTIATE AND ENTER INTO TITLE I, INDIAN SELF-DETERMINATION ACT (P.L. 93-638, AS AMENDED) CONTRACTS AND TITLE V SELF GOVERNANCE COMPACTS PURSUANT TO THE INDIAN SELF-DETERMINATION ACT (P.L. 93-638, AS AMENDED), SUCH DESIGNATION OF "TRIBAL ORGANIZATION" BEING REVOCABLE AND CONTINGENT ON COMPLIANCE WITH ALL TERMS AND CONDITIONS AS REQUIRED

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Health, Education and Human Services Committee exercises oversight responsibility over all matters related to health on the Navajo Nation. 2 N.N.C. §400 (C)(1)
- B. The Health, Education and Human Services Committee exercises authority to review and recommend the authorization and designation of a for-profit or non-profit health or social services organization as a tribal organization for the purposes of contracting or compacting under the Indian Self-Determination and Education Assistance Act. 2 N.N.C. § 401 (6)(e).
- C. Navajo Nation Council Resolution CJY-33-10 authorized the previously existing Intergovernmental Relations Committee of the Navajo Nation Council to act as final approval authority, only upon a recommendation for approval by the Health, Education and Social Services Committee and each of the Navajo Nation Chapters to be served, for all additional designations of "tribal organizations."

- D. Upon reorganization of the Navajo Nation Council and Committees the Naabik'iyati Committee assumed, unless otherwise specified, all the responsibilities of the previous Navajo Nation Council's Intergovernmental Relations Committee and the Health, Education and Social Services Committee was renamed the Health, Education and Human Services Committee. CAP-10-11
- E. The Naabik'iyati' Committee of the Navajo Nation Council, only upon the recommendation for approval by the Health, Education and Human Services Committee and the approval of each of the Navajo Nation Chapters to be served, is to act as the final authority for approving the revocable designation of "tribal organization" for purposes of contracting under the Indian Self-Determination Act (P.L. 93-638, as amended), and Title V Self Governance Compacts pursuant to the Indian Self-Determination Act. (P.L. 93-638, as amended).

SECTION TWO. FINDINGS

- A. Resolution CJY-33-10 authorized contractors to be authorized as Navajo Nation "tribal organizations" for the purpose of entering into Title V, Self-Governance Compacts/Contracts pursuant to the Indian Self-Determination Act, (P.L. 93-638, as amended).
- B. The Fort Defiance Indian Hospital Board, Inc. has requested to be designated a "tribal organization" for a period of fifteen (15) years, for the purposes of contracting with the United States Indian Health Service and to negotiate and enter into Title I, Indian Self-Determination Act (P.L. 93-638, as amended) Contracts. See Exhibit A
- C. The Fort Defiance Indian Hospital Board, Inc. serves the Navajo Nation Chapters and Commissioned Governments of Cornfields, Crystal, Fort Defiance, Ganado, Greasewood Springs, Houck, Kin Dah Lichii', Klagetoh, Nahata Dzil, Oak Springs, Red Lake, Sawmill, St. Michaels, Steamboat, Tse' Si' Ani', and Wide Ruins.
- D. The Fort Defiance Indian Hospital Board, Inc. proposal for designation of "tribal organization" has been endorsed by separate resolutions adopted by all the named respective chapters. The chapter resolutions are attached and can be found in Exhibit B.

- E. The Health, Education and Human Services Committee, by Resolution HEHSCD-26-18 attached as Exhibit C, previously authorized the Fort Defiance Indian Hospital Board, Inc., as a "tribal organization" to negotiate and enter into Title I, Indian Self-Determination Act (P.L. 93-638, as amended), Contracts and Title V, Indian Self-Determination Act (P.L. 93-638, as amended) Compacts being revocable and contingent on continuing compliance with all terms and conditions as approved by the Health, Education and Human Services Committee of the Navajo Nation Council.
- F. The Fort Defiance Indian Hospital Board, Inc.'s tribal designation expires on December 28, 2021.
- G. The Health, Education and Human Services Committee of the Navajo Nation Council finds it to be in the best interest of the Navajo Nation to approve and recommend to the Naabik'íyáti Committee that the Fort Defiance Indian Hospital Board, Inc. be given the revocable designation of "tribal organization" for a period of fifteen (15) years for the purposes of contracting with the United States Indian Health Service and to negotiate and enter into Title I, Indian Self-Determination Act (P.L. 93-638, as amended) Contracts and Title V, Indian Self-Determination Act (P.L. 93-638, as amended) Compacts contingent on compliance with all terms and conditions as required in Exhibit D.

SECTION THREE. APPROVAL

A. The Health, Education and Human Services Committee of the Navajo Nation Council hereby approves and recommends to the Naabik'íyáti Committee that the Fort Defiance Indian Hospital Board, Inc. be given the revocable designation of "tribal organization" for a period of fifteen (15) years, beginning December 29, 2021, and ending December 28, 2036, for the purposes of contracting with the United States Indian Health Service and to negotiate and enter into Title I, Indian Self-Determination Act (P.L. 93-638, as amended) Contracts, and Title V, Indian Self-Determination Act (P.L. 93-638, as amended) Compacts contingent on compliance with Terms and Conditions as required in Exhibit D.

RESOLUTION OF THE FORT DEFIANCE INDIAN HOSPITAL BOARD, INC. (FDIHB) BOARD OF DIRECTORS

Respectfully Requesting that the Health, Education and Human Services Committee (HEHSC) of the Navajo Nation Council approve renewal of the Fort Defiance Indian Hospital Board Inc. as a "tribal organization" for Self-Determination contracting pursuant to P.L. 93-638, as amended.

WHEREAS:

- 1. The Fort Defiance Indian Hospital Board, Inc. (FDIHB), was approved and certified by the Navajo Nation Business Regulatory Department, Division of Economic Development, on July 31, 1995; and
- FDIHB assumed operation and management of the Fort Defiance Indian Hospital, now called the Tséhootsooí Medical Center, Nahata'Dziil health center, and related health programs on March 28, 2010, pursuant to a self-determination contract authorized by the Indian Self-Determination and Education Assistance Act, P.L. 93-638, as amended; and
- 3. Pursuant to Article IV, Section 2 of the FDIHB Articles of Incorporation, the FDIHB Board of Directors (Board) is empowered to oversee the work of FDIHB and generally guide and direct the work of the corporation in the performance of its purpose and mission; and
- 4. The Health, Education and Human Services Committee (HEHSC) of the Navajo Nation, among other duties, has responsibility, pursuant to 2 N.N.C. § 40l(C)(2), to oversee Navajo Nation policies and priorities to optimize the delivery of health services to the Navajo people, including the delivery of those services pursuant to Self-Determination contracts between the United States and "tribal organizations," as authorized by the ISDEAA; and
- 5. On December 27, 2018, the Naabik' iyati' Committee of the Navajo Nation Council passed Legislation No. NABIN-92-18, which confirmed the status of FDIHB as a "tribal organization" for purposes of ISDEAA contracting for a definite term of three (3) years, and that three-year term expires on December 27, 2021 and must be renewed; and
- FDIHB has obtained resolutions of support from all Navajo Nation chapters within its service area, some requesting that FDIHB's status as a "tribal organization" be extended

- for a term of 15 years and others requesting that it be extended for an indefinite term, which are attached as exhibits to this resolution; and
- 7. It is in the best interests of FDIHB to request that the HEHSC of the Navajo Nation Council approve and recommend to the Naabik' iyati' Committee of the Navajo Nation Council the renewal and extension of its status as a "tribal organization" pursuant to the ISDEAA for a term of 15 years.

NOW THEREFORE BE IT RESOLVED THAT:

The FDIHB Board of Directors hereby respectfully requests that the HEHSC of the Navajo Nation Council approve and recommend to the Naabik' iyati' Committee of the Navajo Nation Council the renewal and extension of its status as a "tribal organization" pursuant to the ISDEAA for a term of 15 years.

The Cornfields Chapter reaffirms its support of resolution CF/NOV2008-08 approved on November 16, 2008, to support the Fort Defiance Indian Hospital Board, Inc. to be granted the status of a Tribal Organization under P.L.93-638, Title I, as amended and to contract for all health care services of the Fort Defiance Service Unit through the auspices of P.L. 93-638, The Indian Self Determination Act, Title I, as amended.

- 1. The Cornfields Community Chapter is a duly certified chapter of the Navajo Nation, pursuant to Title 26 of the Navajo Nation Code, Sections 4001 and 4006, and is vested with authority to take action to address the needs of its people; and
- 2. On November 16, 2008, the Cornfields Community Chapter approved Resolution CF/NOV2008-08, entitled "Supporting and Propelling the Fort Defiance Indian Hospital Board, Inc. to be Granted the Status of Tribal Organization Under P.L. 93-638, as Amended, and to Contract for all Health Care Services of the Fort Defiance Service Unit Through the Auspices of P.L. 93-688, The Indian Self-Determination Act, Title I, as Amended," a copy of which is attached to this resolution; and
- 3. Resolution CF/NOV2008-08 resolved that "The Comfields Community Chapter hereby approves and support the Fort Defiance Indian Health Board, Inc. to be granted the status of a Tribal Organization under P. L. 93-638, Title I, as amended, and to contract for all health services of the Fort Defiance Service Unit through the auspices of P. L. 93-638, the Indian Self-Determination Act. Title I, as amended;" and
- 4. The request of the Cornfields Community Chapter in Resolution CF/NOV2008-08 was not time-limited in any way and was intended by the Chapter to be for a 15-year period; and
- 5. Pursuant to the request of the Cornfields Community Chapter and the other chapters within the Fort Defiance Service Unit, FDIHB was designated as a Tribal Organization by the Intergovernmental Relations Committee through IGRAU-118-09, and that designation was not time-limited in any way; and
- 6. FDIHB, acting as a Tribal Organization, assumed operation and management of the Fort Defiance Indian Hospital, now called the Tséhootsooi Medical Center, Nahata' Dziil Health Center, and related health programs on March 28, 2010, pursuant to a self-determination contract pursuant to Title One of the Indian Self-Determination and Education Assistance Act (ISDEAA), P.L. 93-638, as amended; and
- 7. FDIHB is an organization established by this chapter's community and it is staffed and operated by many of the most talented members of our community; and

- 8. During the past 10 years, FDIHB has become an important asset to the Cornfields community by providing employment opportunities for our chapter members, delivering healthcare education and outreach programs, building new facilities, such as the Wellness Center, that are the pride of our community, and lifting up and helping those members of our chapter who are sick and injured; and
- 9. FD1HB has consulted with this chapter at every step of the way as FDIHB has moved forward with the growth of its facilities and the expansion of the services it offers; and
- 10. The chapter appreciates and honors the spirit of cooperation that has characterized the relationship between FDIHB and the chapter; and
- 11. The successes of FDIHB are the successes of our community, which has taken a healthcare facility of the United States and transformed it into the Tséhootsoof Medical Center; a healthcare facility of this chapter and its members something that is uniquely ours and that is a shining example of local governance in action; and
- 8. The chapter hopes that FDIHB will continue to operate the Tsehootsooi Medical Center and the Nahata' Dziil Health Center and be a model for what each and every Navajo community can do for themselves in respect to healthcare; and

- 10. As part of this process, the Navajo Nation Health, Education and Human Services Committee (HEHSC) has asked the chapters to reaffirm their support for FDIHB as a Tribal Organization and self-determination contractor; and
- 11. The HEHSC, among other things, has responsibility, pursuant to 2 N.N.C. § 401(C)(2), to oversee Navajo Nation policies and priorities to optimize the delivery of health services to the Navajo people, including the delivery of those services pursuant to Self-Determination contracts between the United States and "tribal organizations." as authorized by the ISDEAA; and
- 12. FDIHB has requested that the HEHSC recommend that the "tribal organization" status of all Title One healthcare contractors under the ISDEEA, including FDIHB, and their self-determination contracts be extended for a 15-year term; and







RELATING TO HEALTH, EDUCATION AND HUMAN SERVICES COMMITTEE; RECOMMENDING FOR APPROVAL BY THE NAABIK' İYATI' COMMITTEE THE RENEWED DESIGNATION OF THE TSÉHOOTSOOÍ MEDICAL CENTER OF THE FORT DEFIANCE INDIAN HOSPITAL BOARD, INC. AS A NAVAJO NATION "TRIBAL ORGANIZATION" FOR A PERIOD OF THREE (3) YEARS, FOR THE PURPOSES OF CONTRACTING WITH THE UNITED STATES INDIAN HEALTH SERVICE AND AUTHORIZING IT TO NEGOTIATE AND ENTER INTO TITLE I, INDIAN SELF-DETERMINATION ACT (P.L. 93-638, AS AMENDED) CONTRACTS, DESIGNATION "TRIBAL OF ORGANIZATION" BEING REVOCABLE AND CONTINGENT ON COMPLIANCE WITH ALL TERMS AND CONDITIONS AS REQUIRED

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Health, Education and Human Services Committee (Committee) is an established Committee of the Navajo Nation Council. 2 N.N.C. \$400(A).
- B. The Health, Education and Human Services Committee exercises oversight responsibility over all matters related to health on the Navajo Nation. 2 N.N.C. \$400 (C)(1).
- C. The Health, Education and Human Services Committee exercises authority to review and recommend the authorization and designation of a for-profit or non-profit health or social services organization as a tribal organization for the purposes of contracting or compacting under the Indian Self-Determination and Education Assistance Act. 2 N.N.C. § 401 (B) (6) (e).
- D. Navajo Nation Council Resolution CJY-33-10 authorized the previously existing Intergovernmental Relations Committee of the Navajo Nation Council to act as final approval authority, only upon a recommendation for approval by the Health, Education and Social Services Committee and each of the Navajo Nation Chapters to be served, for all additional designations of "tribal organizations". CJY-33-10.
- E. Upon reorganization of the Navajo Nation Council and Committees the Naabik'iyati' Committee assumed, unless otherwise specified, all the responsibilities of the previous Navajo Nation Council's Intergovernmental Relations Committee

- and the Health, Education and Social Services Committee was renamed the Health, Education and Human Services Committee. CAP-10-11.
- F. The Naabik'iyati' Committee of the Navajo Nation Council, only upon the recommendation for approval by the Health, Education and Human Services Committee and the approval of each of the Navajo Nation Chapters to be served, is to act as the final authority for approving the revocable designation of "tribal organization" for purposes of contracting under the Indian Self-Determination Act (P.L. 93-638, as amended).

SECTION TWO. FINDINGS

- A. The Fort Defiance Indian Hospital Board, Inc. was initially designated a "tribal organization" by the Navajo Nation, August 3, 2009 by Resolution IGRAU-118-09. See Exhibit A.
- B. The term of the Fort Defiance Indian Hospital Board, Inc.'s designation of "tribal organization" was later determined by the Health, Education and Human Services, and Naabik'íyáti' Committees through Resolution NABIN-67-15, for a definite term of three (3) years. See Exhibit A-1.
- C. The Fort Defiance Indian Hospital Board, Inc. as a "tribal organization" entered into a contract with the Secretary of the Department of Health and Human Services effective October 1, 2015 for a period of three (3) years, ending September 30, 2018. See Exhibit A-2.
- D. The Navajo Nation, through Resolution NABIS-58-18, approved the Fort Defiance Indian Hospital Board, Inc. entering into a ninety (90) day contract extension, expiring December 29, 2018, with the Indian Health Service until such time as it was able to obtain the necessary Chapter resolutions approving renewal of the "tribal organization" designation. See Exhibit A-3.
- E. Fort Defiance Indian Hospital Board, Inc. has obtained the necessary Chapter resolutions and now seeks renewal of its designation as a "tribal organization" for a three year period. See Exhibit B.
- F. The Health, Education and Human Services Committee of the Navajo Nation Council finds it to be in the best interest of the Navajo Nation to Nation to approve and recommend to the Naabik'iyati' Committee that the Fort Defiance Indian Hospital Board, Inc. be given the revocable designation of "tribal organization" for a period of three (3) years,

beginning December 29, 2018 and ending December 28, 2021 for the purposes of contracting with the United States Indian Health Service and to negotiate and enter into Title I, Indian Self-Determination Act (P.L. 93-638, as amended) contracts, subject to continuing compliance with the Terms and Conditions as found attached at **Exhibit C**.

SECTION THREE. APPROVAL

- A. The Health, Education, and Human Services Committee of the Navajo Nation Council hereby approves and recommends to the Naabik'iyáti' Committee that the Fort Defiance Indian Hospital Board, Inc. be given the designation of "tribal organization" for a period of three (3) years, beginning December 29, 2018 and ending December 28, 2021 for the purposes of contracting with the United States Indian Health Service and to negotiate and enter into Title I, Indian Self-Determination Act (P.L. 93-638, as amended) contracts, such designation being revocable and subject to continuing compliance with the Terms and Conditions as found attached at Exhibit C.
- B. The recommendation of the Health, Education and Human Services Committee is contingent on there being no changes to the Terms and Conditions as found at Exhibit C without the approval of the Health, Education and Human Services Committee.



NAVAJO NATION CONDITIONS FOR DESIGNATION AS

TRIBAL ORGANIZATION FOR HEALTH CARE PURSUANT TO

INDIAN SELI-DETERMINATION ACT (P.1. 93-638 AS AMENDED)

Navajo Nation Conditions for

Designation as Tribal Organization for Health Care Pursuant to the Indian Self-Determination Act (P.L. 93-638, as amended)

The Navajo Nation and the designated "Tribal Organizations" shall cooperate under the principles of Ké to ensure that the health care needs of all Navajo citizens are fully met.

The designation of "Tribal Organization" for participation in the Indian Self-Determination Act (P.L. 93-638 as amended) is a revocable designation and is conditioned on the continued, ongoing and full compliance with the terms and conditions as set forth below:

- The designated "Iribal Organization"
 Must qualify as a participant under the Indian Self Determination Act (P.L. 93-638, as amended) as follows:
 - (A) Completing, to the satisfaction of the Health, Education and Human Services Committee and the Naabik'iyati' Committee of the Navajo Nation Council, a planning phase as described under the Act and which includes:
 - (1) Legal and budgetary research; and
 - (2) Internal tribal government planning and organizational preparation relating to the administration of health care programs.
 - (B) Requesting participation Title V, Self-Governance, by resolution of the Health, Education and Human Services Committee and the Naabik'iyati' Committee of the Navajo Nation Council; and
 - (C) Demonstrating financial stability and financial management capability for the three (3) fiscal years immediately preceding the application for Title V, Self-Governance
- The designated Tribal Organization shall maintain its eligibility for third party payments under the Centers for Medicare and Medicard Services (CMS).

- The designated 1 ribal Organization shall maintain continued accreditation by a nationally recognized accreditation program.
- The designated Tribal Organization shall operate and administer their Self-Governance Compact programs under the oversight of the Health, Education and Human Services Committee
- 5. The designated Tribal Organization shall appear before and report to the Health Education and Human Services Committee and the Naabik'iyati Committee of the Navajo Nation Council whenever requested to do so
 - 6. The designated Tribal Organization shall maintain compliance with all monitoring and reporting requirements duly established by the Health, Education and Human Services Committee, including:
 - (A) Submission to the Health, Education and Human Services Committee of copies upon receipt, of all final Federal Single Audit Act audit reports, including Audited Financial Statements, and final survey reports issued by its nationally recognized accreditation organizations(s) and all associated corrective action plans, with copies to the Navajo Nation Department of Health.
 - (B) Submission of copies of the Self-Governance Compact and all Annual Funding Agreements to the Navajo Nation Department of Health.
 - (C) Submission of copies of the designated "Tribal Organization"s." Annual Report, upon acceptance of same by the "Tribal Organization", to the Health, Education and Human-Services Committee and to the Navajo Nation Department of Health. The format, criteria and due date of the Annual report shall be determined by the Health. Education and Human Services Committee.
 - (D) Submission of a listing of the Board of Directors-identified by Chapter, description of method of selection of Board, length of term and by-laws.
 - 7. The designated "Tribal Organization" shall maintain continued compliance with all applicable Navajo Nation laws and regulations, including, but not limited to, the Navajo Preference in Employment Act and shall provide a report on employment compliance to the Health, Education and Human Services Committee annually and upon request.

- 8. The designated "Tribal Organization" shall maintain compliance with all applicable Navajo Nation Health care policies and priorities duly adopted by the Health and Social Services Committee and shall demonstrate the establishment and operation of a traditional medicine program as an integral component of the provision of health care.
- 9. The designated "Tribal Organization" will consult and cooperate with the Navajo Nation Department of Health concerning the public health needs and programs of the Navajo Nation.
- 10. The designated "Tribal Organizations" and Navajo Nation Department of Health shall timely develop and on-going written policy for consultation on matters of public health and have such policy approved by the Health, Education and Human Services Committee.
- 11. The designated "Tribal Organizations" and Navajo Nation Department of Health and Navajo Nation Department of Emergency Medical Service shall enter Memorandum of Understandings for the Navajo Nation's use and occupancy of the designated Tribal Organization's facilities as long as such use and occupancy does not interfere with direct care services
- 12. The designated "Tribal Organization", in its dealings with the federal and state government, be it lobbying, advocacy, litigation, or negotiating efforts, shall only take positions or make arguments, consistent with official published Navajo Nation positions. The designated "Tribal Organization" shall report and consult with the Health, Education and Human Services Committee prior to such undertakings.
- 13. The designated "Tribal Organization" shall not directly charge any tribal member for health care services nor charge the Navajo Nation Employee Benefit Plan or Workers Compensation Plan for health care services provided to a covered tribal member unless the Indian Health Service would be able to charge the tribal member for the same service under the same circumstances unless otherwise authorized by the Naabik'iyati' Committee of the Navajo Nation Council
- 14. The designated "Tribal Organization" shall provide direct patient care to all Native American eligible users unless otherwise authorized by the Naabik'iyati' Committee of the Navajo Nation Council.
