TITLE OF RESOLUTION: AN ACTION RELATING TO RESOURCES AND DEVELOPMENT, BUDGET AND FINANCE, AND NAABIK'ÍYÁTI' COMMITTEES, AND THE NAVAJO NATION COUNCIL; APPROVING AND ADOPTING THE NAVAJO NATION CARES FUND CHAPTER DISTRIBUTION EXPENDITURE PLAN

PURPOSE: This resolution, if approved, will establish the CARES Fund Chapter Distribution Expenditure Plan and allocate \$90,000,000 to Chapters under the 50-50 formula for COVID-19 relief, response and mitigation efforts.

This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each committee member to review the proposed resolution in detail.

19	A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §

21	B. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council

SECTION TWO. FINDINGS

- A. The World Health Organization (WHO) declared a Public Health Emergency of International Concern related to the outbreak of coronavirus (COVID-19), a highly contagious and sometimes fatal respiratory virus, on January 30, 2020; the U.S. Department of Health and Human Services declared a Public Health Emergency related to the COVID-19 outbreak on January 31, 2020; and the WHO declared a global pandemic due to COVID-19 on March 11, 2020.
- B. The Navajo Nation Commission on Emergency Management, with the concurrence of Navajo Nation President Jonathan Nez, declared a Public Health State of Emergency on the Navajo Nation on March 11, 2020 due to COVID-19. Resolution No. CEM 20-03-11. The Navajo Nation Department of Health subsequently issued numerous Public Health Emergency Orders. Public Health Orders 2020-001 through 2020-014 are incorporated by reference into this resolution.
- C. As of August 18, 2020, the Navajo Nation Health Command Operations Center has confirmed 9,486 COVID-19 cases and 484 COVID-related deaths on the Navajo Nation.
- D. The U.S. Congress on March 27, 2020, enacted the Coronavirus Aid, Relief, and Economic Security Act, Pub. L. No. 116-136, 134 Stat. 281 (2020) (the "CARES Act"), which, at Title V, §5001, entitled "Coronavirus Relief Funds," attached as Exhibit 1-A, sets aside \$8 billion in emergency aid for Tribal governments for the COVID-19 pandemic.
- E. The CARES Act provides the Coronavirus Relief Fund shall be used to cover only those costs that:
 - are necessary expenditures incurred due to the public health emergency with respect to COVID-19;

- b. are not accounted for in the Tribal budget most recently approved as of March 27, 2020; and
- c. are incurred from March 1, 2020 through December 30, 2020.
- F. The U.S. Treasury on April 22, 2020 issued "Coronavirus Relief Fund Guidance for State, Territorial, Local, and Tribal Governments" ("Treasury Guidance") related to the permissible uses of the Coronavirus Relief Fund. Exhibit 1-B.

G. On May 28, 2020, the U.S. Treasury issued "Coronavirus Relief Fund Frequently Asked Questions" ("Treasury FAQ"), attached as **Exhibit 1-C.**

 H. As of June 30, 2020, the Navajo Nation has received seven hundred fourteen million one hundred eighty-nine thousand six hundred thirty-one dollars and forty-seven cents (\$714,189,631.47) as the Nation's share of the U.S. Treasury's initial distributions of the Coronavirus Relief Fund.

- I. The Navajo Nation has determined that immediately providing funding to Navajo Nation Chapters to combat the effects of COVID-19 and mitigate the future spread at the community level is vital in sustaining a comprehensive response to the COVID-19 public health emergency and mitigating the effects of the pandemic.
- J. The purpose of the Navajo Nation CARES Fund Chapter Distribution Plan, attached as **Exhibit 2**, is to immediately provide ninety million dollars (\$90,000,000) to Navajo Nation Chapters (both LGA Certified and non-certified), through the Division of Community Development, to respond to the COVID-19 pandemic and ensure that Navajo communities have access to the funding necessary to ensure that community members are adequately protected from exposure to COVID-19 and able to comply with the Center for Disease Control (CDC) COVID-19 prevention guidance necessary to mitigate the spread of the virus.

SECTION THREE. APPROVAL AND ADOPTION OF THE CARES FUND CHAPTER DISTRIBUTION EXPENDITURE PLAN

A. The Navajo Nation hereby approves and adopts the CARES Fund Chapter Distribution Expenditure Plan, as outlined in Exhibit 2, and hereby allocates ninety million dollars (\$90,000,000) to Navajo Nation Chapters (both LGA Certified and non-certified), through the Division of Community Development pursuant to 12 N.N.C. § 820 (O)'s 50/50 Chapter Distribution formula. Subject to technical correction by the Office of Management and Budget, the amounts allocated to each Chapter are set forth at **Exhibit 3**.

- B. The Coronavirus Relief Funds are externally restricted funds and the Navajo Nation Appropriations Act, 12 N.N.C. §§ 800 *et seq.*, as applicable to externally restricted funds, shall apply to the Expenditure Plans set forth herein; detailed Expenditure Plan budgets shall not be subject to further legislative approval and shall, instead, be developed and implemented through expedited budget procedures. The Office of Management and Budget shall process the detailed budgets in the most expeditious manner available to ensure that the funds are distributed within fifteen (15) days after enactment of this resolution.
- C. As set forth in Navajo Nation Council Resolution No. CJY-67-20, the progress of all Navajo Nation CARES Fund Expenditure Plans, which shall now include the Chapter Distribution Expenditure Plan, shall be reviewed by the Budget and Finance and Naabik'íyáti' Committees during the month of October 2020. The funding for any project that has not made enough progress to demonstrate that it will be fully completed by December 30, 2020 will be reallocated to the Hardship Assistance Expenditure Plan enacted by CJY-67-20 through Naabik'íyáti' Committee resolution.

SECTION FOUR. APPROVAL AND ADOPTION OF THE CHAPTER DISTRIBUTION EXPENDITURE PLAN ADMINISTRATION

- A. All entities receiving Navajo Nation CARES Fund funding herein shall ensure that all funds allocated under the Chapter Distribution Expenditure Plan are only expended for the purposes set forth in Exhibit 2.
- B. All entities receiving Navajo Nation CARES Fund funding herein shall ensure that all funds allocated under their respective Expenditure Plans shall be incurred and expended by no later than December 30, 2020.
- C. All entities receiving Navajo Nation CARES Fund funding herein shall ensure that no funds allocated under their respective Expenditure Plans are incurred or expended for

1		costs accounted for in the approved Fiscal Year 2020 Navajo Nation Comprehensive
2		Budget approved by Navajo Nation Council Resolution No. CS-30-19.
3	D.	The Office of the Controller shall release the funding allocated under the respective
4		Expenditure Plans as soon as the expedited budget procedures are completed.
5	E.	The CARES Fund Expedited Procurement Rules and Procedures, enacted through
6		CJY-67-20, shall apply to procurement activities for the Expenditure Plan set forth
7		herein.
8	F.	The funds allocated under the Navajo Nation CARES Fund Expenditure Plan set forth
9		herein shall be used exclusively and only for the permissible uses set forth in the
10		following:
11		1. This Resolution approving the Navajo Nation CARES Fund Chapter Distribution s
12		Expenditure Plan.
13		3. The Coronavirus Relief Fund which allows only those costs that:
14		a. are necessary expenditures incurred due to the public health emergency with
15		respect to COVID-19;
16		b. are not accounted for in the Navajo Nation Fiscal Year 2020 Comprehensive
17		Budget.
18		c. are incurred from March 1, 2020 through December 30, 2020;
19		4. Consistent with the eligible uses described in the Treasury Guidance which includes
20		the following guidance:
21		a. expenditures must be incurred "due to" the public health emergency which
22		means that expenditures must be used for actions taken to respond to the public
23		health emergency; these expenditures may include expenditures incurred to
24		allow the Tribal government to respond directly to the emergency, such as by
25		addressing medical or public health needs, as well as expenditures incurred to
26		respond to second-order effects of the emergency, such as by providing
27		economic support to those suffering from employment or business interruptions
28		due to COVID-19-related business closures;
29		b. expenditures must be "necessary"; the Department of the Treasury interprets
30		this term broadly to mean that the expenditure is reasonably necessary for its

1	intended use in the reasonable judgment of the government officials responsible
2	for spending Coronavirus Relief Fund payments;
3	c. expenditures may only be made to cover costs that were not accounted for in
4	the budget most recently approved as of March 27, 2020. A cost meets this
5	requirement if either (a) the cost cannot lawfully be funded using a line item,
6	allotment, or allocation with the budget; or (b) the cost is for a substantially
7	different use from any expected use of funds in such a line item, allotment, or
8	allocation; and
9	d. expenditures must be for costs incurred during the period that begins on March
10	1, 2020, and ends on December 30, 2020. A cost is "incurred" when the
11	responsible unit of government has expended funds to cover the cost.
12	5. Consistent with the eligible uses described in the U.S. Treasury Frequently Asked
13	Questions (FAQ).
14	6. Consistent with the eligible uses as may be described in any and all future guidance,
15	rules, or regulations of the Department of the Treasury or the Department of the
16	Interior related to the Coronavirus Relief Fund pursuant to Title V of the CARES
17	Act.
18	7. Consistent with Navajo Nation laws, rules and regulations.
19	G. All entities receiving Navajo Nation CARES Act Expenditure Plan funding herein
20	expressly agree and affirm that by drawing down or receiving any of the funds allocated
21	under their respective Expenditure Plan:
22	a. the requested funds shall only be used for the purposes specified in Title V of
23	the federal CARES Act and the Navajo Nation CARES Fund Act;
24	b. the administration, management, and implementation of this Expenditure Plan
25	shall be consistent with the Navajo Nation CARES Fund Act, this legislation,
26	and other applicable laws and regulations of the Navajo Nation; and
27	c. the costs to be covered under this Expenditure Plan are not included in the
28	Navajo Nation Fiscal Year 2020 Comprehensive Budget, approved by Navajo
29	Nation Council Resolution No. CS-30-19.
30	

- I. All recipients of Navajo Nation funds from the Navajo Nation CARES Fund must follow and apply Generally Accepted Accounting Principles (GAAP), as established by the Governmental Accounting Standards Board (GASB) for governmental entities, and by the Financial Accounting Standards Board (FASB) for public and private companies and non-profits.
- J. If the Department of Justice, Office of the Controller, and Office of Management and Budget concur that a proposed expenditure in the Expenditure Plans included herein is an ineligible cost under the Navajo Nation CARES Fund, Coronavirus Relief Fund or U.S. Treasury guidance, the amount of such proposed expenditure shall be returned to the Navajo Nation CARES Fund after written notice, including analysis, to the Office of the President and Vice-President and Naabik'íyáti' Committee.
- K. The Budget and Finance Committee and Resources and Development Committee of the Navajo Nation Council shall serve as the oversight committees for the Navajo Nation Cares Fund Chapter Distribution Expenditure Plan.
- L. The Chapter Distribution Expenditure Plan and expenditures made there under shall be governed by and construed in accordance with the laws and regulations of the Navajo Nation.

SECTION FIVE. AMENDMENT

This Resolution may be amended by a two-thirds majority vote of the Navajo Nation Council subject to action of the President of the Navajo Nation under 2 N.N.C. § 221 (B) and the budget line-item veto authority delegated to the President by vote of the Navajo People in 2009.

SECTION SIX. EFFECTIVE DATE

This Resolution is effective upon its approval pursuant to 2 N.N.C. § 221(B) and the budget line-item veto authority delegated to the President by vote of the Navajo People in 2009.

SECTION SEVEN. SAVING CLAUSE

Should any provision of this legislation be determined invalid by the Navajo Nation Supreme Court, or a District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, those portions of the legislation which are not determined invalid shall remain the law of the Navajo Nation.

maximum total compensation received by the officer or employee from the air carrier or contractor in calendar year 2019; and

(3) no officer or employee of the eligible business whose total compensation exceeded \$3,000,000 in calendar year 2019 may receive during any 12 consecutive months of such period total compensation in excess of the sum of-

(A) \$3,000,000; and

(B) 50 percent of the excess over \$3,000,000 of the total compensation received by the offloor or employee from the eligible business

(b) TOTAL COMPENSATION DEFINED.—In this soction, the term "total compensation" includes salary, bonuses, awards of stock, and other financial benefits provided by an air carrier or contractor to an officer or employee of the air carrier or contractor. SEC. 4117. TAX PAYER PROTECTION.

The Secretary may receive warrants, options, preferred stock, debt securities, notes. or other financial instruments issued by recipients of financial assistance under this subtitle which, in the sole determination of the Secretary, provide appropriate com-pensation to the Federal Government for the provision of the financial assistance. SEC. 4118. REPORTS.

(a) REPORT .- Not later than November 1. 2020, the Secretary shall submit to the Committee on Transportation and Infrastructure and the Committee on Financial Services of the House of Representatives and the Committee on Commerce, Science, and Transportation and the Committee on Banking, Housing, and Urban Affairs of the Senate a report on the financial assistance provided to air carriers and contractors under this subtitie. including a description of any financial asalstance provided.

(b) UPDATE.-Not later than the last day of the 1-year period following the date of enactment of this Act, the Secretary shall update and submit to the Committee on Transportation and the Committee on Financial Services and infrastructure of the House of Representatives and the Committee on Commerce, Science, and Transportation and the Committee on Banking, Housing, and Urban Affairs of the Senate the report described in subsection (a).

SEC. 4119. COORDINATION.

In implementing this subtitle the Secretary shall coordinate with the Secretary of Transportation.

SEC. 4120. DIRECT APPROPRIATION.

Notwithstanding any other provision of law, there is appropriated, out of amounts in Treasury not othorwise appropriated. the \$32,000,000,000 to carry out this subtitle.

TITLE V-CORONAVIRUS RELIEF FUNDS SEC. 5001. CORONAVTRUS RELIEF FUND.

(a) IN GENERAL .- The Social Security Act (42 U.S.C. 301 et seq.) is amended by inserting after title V the following:

TITLE VI-CORONAVIRUS RELIEF FUND "SEC. 601. CORONAVIRUS RELIEF FUND.

"(a) APPROPRIATION .-

"(1) IN GENERAL .- Out of any money in the Treasury of the United States not otherwise appropriated, there are appropriated for making payments to States, Tribal governments, and units of local government under this section, \$150,000,000 for fiscal year 2020.

"(2) RESERVATION OF FUNDS .- Of the amount appropriated under paragraph (1). the Secretary shall reserve-

"(A) \$3.000,000,000 of such amount for making payments to the District of Columbia, the Commonwealth of Puerto Rico, the United States Virgin Islands, Guam, the Commonwealth of the Northern Mariana Islands, and American Samoa; and

"(B) \$8,000,000,000 of such amount for making payments to Tribal governments.

"(b) AUTHORITY TO MAKE PAYMENTS.

"(1) IN OENERAL .- Subject to paragraph (2). not later than 30 days after the date of enactment of this section, the Secretary shall pay each State and Tribal government, and each unit of local government that meets the condition described in paragraph (2), the amount determined for the State, Tribal government, or unit of local government, for fiscal year 2020 under subsection (c).

"(2) DIRECT PAYMENTS TO UNITS OF LOCAL GOVERNMENT .-- If a unit of local government of a State submits the certification required by subsection (c) for purposes of receiving a direct payment from the Secretary under the authority of this paragraph, the Secretary shall reduce the amount determined for that State by the relative unit of local government population proportion amount described in subsection (c)(5) and pay such amount directly to such unit of local governmont.

"(c) PAYMENT AMOUNTS .---

"(1) IN GENERAL .- Subject to paragraph (2). the amount paid under this section for fiscal year 2020 to a State that is 1 of the 50 States shall be the amount equal to the relativo population proportion amount determined for the State under paragraph (3) for such fiscal year.

(2) MINIMUM PAYMENT .-

"(A) IN OENERAL .- No State that is 1 of the 50 States shall receive a payment under this section for fiscal year 2020 that is less than \$1,250,000,000.

"(B) PRO RATA ADJUSTMENTS .- The Secretary shall adjust on a pro rata basis the amount of the payments for each of the 50 States determined under this subsection without regard to this subparagraph to the extent necessary to comply with the requirements of subparagraph (A).

"(3) RELATIVE POPULATION PROPORTION AMOUNT .- For purposes of paragraph (1), the relative population proportion amount determined under this paragraph for a State for fiscal year 2020 is the product of-

"(A) the amount appropriated under paragraph (1) of subsection (a) for fiscal year 2020 that remains after the application of paragraph (2) of that subsection: and

(B) the relative State population proportion (as defined in paragraph (4)).

"(4) RELATIVE STATE POPULATION PROPOR-TION DEFINED.—For purposes of paragraph (3)(B), the term 'relative State population proportion' means, with respect to a State. the quotient of-

"(A) the population of the State; and

"(B) the total population of all States (excluding the District of Columbia and territories specified in subsection (a)(2)(A)).

"(5) RELATIVE UNIT OF LOCAL GOVERNMENT POPULATION PROPORTION AMOUNT .- For purposes of subsection (b)(2). the term 'relative unit of local government population proportion amount' means, with respect to a unit of local government and a State, the amount equal to the product of-

"(A) 45 percent of the amount of the paymont determined for the State under this subsection (without regard to this paragraph): and

(B) the amount equal to the quotient of-"(1) the population of the unit of local govornmont; and

"(ii) the total population of the State in which the unit of local government is located.

"(6) DISTRICT OF COLUMBIA AND TERRI-TORIES .- The amount paid under this section for fiscal year 2020 to a State that is the District of Columbia or a territory specified in subsection (a)(2)(A) shall be the amount equal to the product of-

"(A) the amount set aside under subsection (a)(2)(A) for such fiscal year: and

"(B) each such District's and territory's share of the combined total population of the District of Columbia and all such territories. as determined by the Secretary.

"(7) TRIBAL GOVERNMENTS .- From the amount set aside under subsection (a)(2)(B)for fiscal year 2020, the amount paid under this section for fiscal year 2020 to a Tribal government shall be the amount the Secretary shall determine, in consultation with the Secretary of the Interior and Indian Tribes, that is based on increased expenditures of each such Tribal government (or a tribally-owned entity of such Tribal government) relative to aggregate expenditures in fiscal year 2019 by the Tribal government (or tribally-owned entity) and dotermined in such manner as the Secretary determines appropriate to ensure that all amounts available under subsection (a)(2)(B) for fiscal year 2020 are distributed to Tribal governments.

"(8) DATA .- For purposes of this sub-section, the population of States and units of local governments shall be determined based on the most recent year for which data are

made under this section to cover only those costs of the State, Tribal government, or unit of local government that

(1) are necessary expenditures incurred due to the public health emergency with roto the Coronavirus Disease 2019 spect (COVID-19);

"(2) were not accounted for in the budget most recently approved as of the date of enactment of this section for the State or govurnmont: and

'(3) were incurred during the period that begins on March 1, 2020, and ends on Decomber 30, 2020.

"(e) CERTIFICATION .- In order to receive a payment under this section, a unit of local government shall provide the Secretary with a cortification signed by the Chief Executive for the unit of local government that the local government's proposed uses of the funds are consistent with subsocion (d). "(f) INSPECTOR GENERAL OVERSIONT;

RECOUPMENT.

"(1) OVERSIGHT AUTHORITY .- The Inspector General of the Department of the Treasury shall conduct monitoring and oversight of the receipt, disbursement, and use of funds made available under this section.

"(2) RECOUPMENT .--- If the Inspector General of the Department of the Treasury detor-mines that a State, Tribal government, or unit of local government has failed to comply with subsection (d), the amount equal to the amount of funds used in violation of such subsection shall be booked as a debt of such entity owed to the Federal Oovernment. Amounts recovered under this subsection shall be deposited into the general fund of the Treasury.

"(3) APPROPRIATION .- Out of any money in the Treasury of the United States not otherwise appropriated, there are appropriated to the Office of the Inspector General of the Department of the Treasury, \$35,000,000 to carry out oversight and recoupment activities under this subsection. Amounts appropriated under the preceding sontonce shall remain available until expended.

(4) AUTHORITY OF INSPECTOR GENERAL. Nothing in this subsection shall be construed to diminish the authority of any inspector Ceneral, including such authority as pro-vided in the Inspector General Act of 1978 (6 U.S.C. App.). "(g) DEFINITIONS .- In this section:

"(1) INDIAN TRIBZ .- The term 'Indian Tribo' has the meaning given that term in section



4(e) of the Indian Self-Determination and Education Assistance Act (25 U.S.C. 5304(e)).

"(2) LOCAL GOVERNMENT.—The term 'unit of local government' means a county, municipality, town, township, village, parish, borough, or other unit of general government below the State level with a population that exceeds 500.000.

"(3) SECRETARY.-The term 'Secretary' means the Secretary of the Treasury.

"(4) STATE.—The term 'State' means the 50 States, the District of Columbia, the Commonwealth of Puerto Rico, the United States Virgin Islands, Guam, the Commonwealth of the Northern Mariana Islands, and American Samoa.

"(6) TRIBAL GOVERNMENT.—The term 'Tribal government' means the recognized governing body of an Indian Tribe.".

(b) APPLICATION OF PROVISIONS.—Amounts appropriated for fiscal year 2020 under soction 601(a)(1) of the Social Scourity Act (as added by subsection (a)) shall be subject to the requirements contained in Public Law 116-94 for funds for programs authorized under socions 330 through 340 of the Public Health Service Act (42 U.S.C. 254 through 256).

TITLE VI-MISCELLANEOUS PROVISIONS

SEC. 6001. COVID-18 BORROWING AUTHORITY FOR THE UNITED STATES POSTAL SERVICE.

(a) DEFINITIONS .- In this section-

(1) the term "COVID-19 emergency" means the emergency involving Federal primary responsibility determined to exist by the President under section 501(b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. 5191(b)) with respect to the Coronavirus Disease 2019 (COVID-19); and

(2) the term "Postal Service" means the United States Postal Service.

(1) the Postal Service may berrow money from the Treasury in an amount not to exceed \$10.000.000.000-

(A) to be used for such operating expenses; and

(B) which may not be used to pay any outstanding debt of the Postal Service: and

(2) the Socretary of the Treasury may lend up to the amount described in paragraph (1) at the request of the Postal Service, upon terms and conditions mutually agreed upon by the Secretary and the Postal Service.

(c) PRIORITIZATION OF DELIVERY FOR MED-ICAL PURPOSES DURING COVID-19 EMER-OENCY.--Notwithstanding any other provision of law, during the COVID-19 emergency. the Postal Service--

 shall prioritize delivery of postal products for medical purposes; and
 may establish temporary delivery

(2) may establish temporary delivery points, in such form and mannor as the Postal Service determines necessary, to protect employees of the Postal Service and individuals receiving deliveries from the Postal Service.

SEC. 5002. EMERGENCY DESIGNATION.

(b) TOTAL COMPENSATION DEPINED .- In this section, the term "total compensation" includos salary, bonuses, awards of stock, and other financial benefits provided by an air carrier or contractor to an officer or umployee of the air carrier or contractor. SEC. 4117. TAX PAYER PROTECTION.

The Secretary may receive warrants, options, preferred stock, debt securities, notes, or other financial instruments issued by recipients of financial assistance under this subtitle which, in the sole determination of the Secretary, provide appropriate com-pensation to the Federal Government for the provision of the financial assistance. SEC. 4118. REPORTS.

(a) REPORT .- Not later than November 1. 2020, the Secretary shall submit to the Committee on Transportation and Infrastructure and the Committee on Financial Services of the House of Representatives and the Committee on Commerce, Science, and Transportation and the Committee on Banking, Housing, and Urban Affairs of the Senate a report on the financial assistance provided to air carriers and contractors under this subtitle, including a description of any financial assistance provided.

"(B) \$8,000,000,000 of such amount for making payments to Tribal governments.

"(b) AUTHORITY TO MAKE PAYMENTS.

"(1) IN GENERAL .- Subject to paragraph (2). not later than 30 days after the date of enactment of this section, the Secretary shall pay each State and Tribal government, and each unit of local government that meets the condition described in paragraph (2), the amount determined for the State, Tribal government, or unit of local government, for fiscal year 2020 under subsection (c).

(2) DIRECT PAYMENTS TO UNITS OF LOCAL **GOVERNMENT.-- If a unit of local government** of a State submits the cortification required by subsection (e) for purposes of receiving a diroct payment from the Secretary under the authority of this paragraph, the Secretary shall reduce the amount determined for that State by the relative unit of local government population proportion amount de-scribed in subsection (c)(5) and pay such amount directly to such unit of local government.

"(O) PAYMENT AMOUNTS .-

"(1) IN GENERAL .- Subject to paragraph (2). the amount paid under this section for fiscal year 2020 to a State that is 1 of the 50 States shall be the amount equal to the relative population proportion amount determined for the State under paragraph (3) for such fiscal year.

"(2) MINIMUM PAYMENT.

"(A) IN GENERAL .- No State that is 1 of the 50 States shall receive a payment under this section for fiscal year 2020 that is loss than \$1,250,000,000.

"(B) PRO RATA ADJUSTMENTS .- The Socretary shall adjust on a pro rata basis the amount of the payments for each of the 60 States determined under this subsection without regard to this subparagraph to the extent necessary to comply with the requirements of subparagraph (A).

"(3) RELATIVE POPULATION PROPORTION AMOUNT .- For purposes of paragraph (1), the relative population proportion amount determined under this paragraph for a State for fiscal year 2020 is the product of-

'(A) the amount appropriated under paragraph (1) of subsection (a) for fiscal year 2020 that remains after the application of paragraph (2) of that subsection; and

(B) the relative State population proportion (as defined in paragraph (4)).

"(4) RELATIVE STATE POPULATION PROPOR-TION DEFINED .- For purposes of paragraph (3)(B), the term 'relative State population proportion' means, with respect to a State. the quotient of-

"(A) the population of the State; and

"(B) the total population of all States (excluding the District of Columbia and territorius specified in subsection (a)(2)(A)).

(5) RELATIVE UNIT OF LOCAL GOVERNMENT POPULATION PROPORTION AMOUNT .- For purposes of subsection (b)(2), the term 'relative unit of local government population proportion amount' means, with respect to a unit of local government and a State, the amount equal to the product of-

"(A) 45 percent of the amount of the paymont dotermined for the State under this subsection (without rogard to this paragraph); and

(B) the amount equal to the quotient of-"(1) the population of the unit of local government: and

(11) the total population of the State in which the unit of local government is located.

"(6) DISTRICT OF COLUMBIA AND TERRI-TORIES .- The amount paid under this section for fiscal year 2020 to a State that is the District of Columbia or a torritory specified in subsection (a)(2)(A) shall be the amount equal to the product of-

(A) the amount set aside under subsection (a)(2)(A) for such fiscal year; and

"(B) each such District's and territory's share of the combined total population of the District of Columbia and all such territories, as determined by the Secretary.

GOVERNMENTS .--From "(7) TRIBAL the amount set aside under subsection (a)(2)(B) for fiscal year 2020, the amount paid under this section for fiscal year 2020 to a Tribal governmont shall be the amount the Secretary shall determine, in consultation with the Secretary of the Interior and Indian Tribes, that is based on increased expenditures of each such Tribal government (or a tribally-owned antity of such Tribal government) relative to aggregate expenditures in fiscal year 2019 by the Tribal government (or tribally-owned entity) and determined in such manner as the Secretary determines appropriato to ensure that all amounts available under subsection (a)(2)(B) for fiscal year 2020 are distributed to Tribal governments.

"(8) DATA .- For purposes of this sub-section, the population of States and units of local governments shall be determined based on the most recent year for which data are available from the Bureau of the Census. "(d) USE OF FUNDS .- A State. Tribal gov-

ornment, and unit of local government shall use the funds provided under a payment made under this section to cover only those costs of the State, Tribal government, or unit of local government that

"(1) are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19):

"(2) were not accounted for in the budget most recently approved as of the date of enactment of this section for the State or government; and

"(3) were incurred during the period that begins on March 1, 2020, and onds on Decomber 30, 2020.

(e) CERTIFICATION .- In order to receive a payment under this soction, a unit of local government shall provide the Socretary with a certification signed by the Chief Executivo for the unit of local government that the local government's proposed uses of the funds are consistent with subsection (d). "(f) INSPECTOR GENERAL OVERS OVERSIONT:

RECOUPMENT .-

"(1) OVERSIGHT AUTHORITY .- The Inspector General of the Department of the Treasury shall conduct monitoring and oversight of the receipt. disbursement. and use of funds made available under this section.

Amounts appropriated under the preceding sontence shall remain available until expended.

"(4) AUTHORITY OF INSPECTOR GENERAL. Nothing in this subsection shall be construed to diminish the authority of any inspector General, including such authority as provided in the Inspector General Act of 1978 (5 "(g) DEFINITIONS .- In this section:

"(1) INDIAN TRIBE .- The term 'Indian Tribe' has the meaning given that term in section (a) of the Indian Self-Determination and Education Assistance Act (25 U.S.C. 5304(e)). "(2) LOUAL GOVERNMENT.—The term 'unit of

local government' means a county, municipality, town, township, village, parish, bor-ough, or other unit of general government below the State level with a population that exceeds 500,000.

"(3) SECRETARY .- The term 'Secretary' means the Secretary of the Treasury.

"(4) STATE .- The term 'State' means the 50 States, the District of Columbia, the Commonwealth of Puerto Rico, the United States Virgin Islands, Guam, the Commonwealth of the Northern Mariana Islands, and American Samoa.

(5) TRIBAL COVERNMENT .- The term 'Tribal government' means the recognized governing body of an Indian Tribe.".

(b) APPLICATION OF PROVISIONS .- Amounts appropriated for fiscal year 2020 under section 601(a)(1) of the Social Scourity Act (as added by subsection (a)) shall be subject to the requirements contained in Public Law under sections 330 through 340 of the Public Health Service Act (42 U.S.C. 254 through 256).

That of the amount provided under this heading in this Act, \$15,510,000,000 shall be placed in a contingency reserve to be allocated as the Secretary deems necessary to support participation should cost or participation exceed budget estimates to prevent, prepare for, and respond to coronavirus: Provided further. That of the amount provided under this



Coronavirus Relief Fund Guidance for State, Territorial, Local, and Tribal Governments April 22, 2020

The purpose of this document is to provide guidance to recipients of the funding available under section 601(a) of the Social Security Act, as added by section 5001 of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"). The CARES Act established the Coronavirus Relief Fund (the "Fund") and appropriated \$150 billion to the Fund. Under the CARES Act, the Fund is to be used to make payments for specified uses to States and certain local governments; the District of Columbia and U.S. Territories (consisting of the Commonwealth of Puerto Rico, the United States Virgin Islands, Guam, American Samoa, and the Commonwealth of the Northern Mariana Islands); and Tribal governments.

The CARES Act provides that payments from the Fund may only be used to cover costs that-

- are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19);
- were not accounted for in the budget most recently approved as of March 27, 2020 (the date of enactment of the CARES Act) for the State or government; and
- were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020.¹

The guidance that follows sets forth the Department of the Treasury's interpretation of these limitations on the permissible use of Fund payments.

Necessary expenditures incurred due to the public health emergency

The requirement that expenditures be incurred "due to" the public health emergency means that expenditures must be used for actions taken to respond to the public health emergency. These may include expenditures incurred to allow the State, territorial, local, or Tribal government to respond directly to the emergency, such as by addressing medical or public health needs, as well as expenditures incurred to respond to second-order effects of the emergency, such as by providing economic support to those suffering from employment or business interruptions due to COVID-19-related business closures.

Funds may not be used to fill shortfalls in government revenue to cover expenditures that would not otherwise qualify under the statute. Although a broad range of uses is allowed, revenue replacement is not a permissible use of Fund payments.

The statute also specifies that expenditures using Fund payments must be "necessary." The Department of the Treasury understands this term broadly to mean that the expenditure is reasonably necessary for its intended use in the reasonable judgment of the government officials responsible for spending Fund payments.

Costs not accounted for in the budget most recently approved as of March 27, 2020

The CARES Act also requires that payments be used only to cover costs that were not accounted for in the budget most recently approved as of March 27, 2020. A cost meets this requirement if either (a) the cost cannot lawfully be funded using a line item, allotment, or allocation within that budget or (b) the cost

is for a substantially different use from any expected use of funds in such a line item, allotment, or allocation.

The "most recently approved" budget refers to the enacted budget for the relevant fiscal period for the particular government, without taking into account subsequent supplemental appropriations enacted or other budgetary adjustments made by that government in response to the COVID-19 public health emergency. A cost is not considered to have been accounted for in a budget merely because it could be met using a budgetary stabilization fund, rainy day fund, or similar reserve account.

Costs incurred during the period that begins on March 1, 2020, and ends on December 30, 2020

A cost is "incurred" when the responsible unit of government has expended funds to cover the cost.

Nonexclusive examples of eligible expenditures

Eligible expenditures include, but are not limited to, payment for:

- 1. Medical expenses such as:
 - COVID-19-related expenses of public hospitals, clinics, and similar facilities.
 - Expenses of establishing temporary public medical facilities and other measures to increase COVID-19 treatment capacity, including related construction costs.
 - Costs of providing COVID-19 testing, including serological testing.
 - Emergency medical response expenses, including emergency medical transportation, related to COVID-19.
 - Expenses for establishing and operating public telemedicine capabilities for COVID-19related treatment.
- 2. Public health expenses such as:
 - Expenses for communication and enforcement by State, territorial, local, and Tribal governments of public health orders related to COVID-19.
 - Expenses for acquisition and distribution of medical and protective supplies, including
 sanitizing products and personal protective equipment, for medical personnel, police officers,
 social workers, child protection services, and child welfare officers, direct service providers
 for older adults and individuals with disabilities in community settings, and other public
 health or safety workers in connection with the COVID-19 public health emergency.
 - Expenses for disinfection of public areas and other facilities, e.g., nursing homes, in response to the COVID-19 public health emergency.
 - Expenses for technical assistance to local authorities or other entities on mitigation of COVID-19-related threats to public health and safety.
 - Expenses for public safety measures undertaken in response to COVID-19.
 - Expenses for quarantining individuals.
- Payroll expenses for public safety, public health, health care, human services, and similar employees whose services are substantially dedicated to mitigating or responding to the COVID-19 public health emergency.

- Expenses of actions to facilitate compliance with COVID-19-related public health measures, such as:
 - Expenses for food delivery to residents, including, for example, senior citizens and other vulnerable populations, to enable compliance with COVID-19 public health precautions.
 - Expenses to facilitate distance learning, including technological improvements, in connection
 with school closings to enable compliance with COVID-19 precautions.
 - Expenses to improve telework capabilities for public employees to enable compliance with COVID-19 public health precautions.
 - Expenses of providing paid sick and paid family and medical leave to public employees to enable compliance with COVID-19 public health precautions.
 - COVID-19-related expenses of maintaining state prisons and county jails, including as relates to sanitation and improvement of social distancing measures, to enable compliance with COVID-19 public health precautions.
 - Expenses for care for homeless populations provided to mitigate COVID-19 effects and enable compliance with COVID-19 public health precautions.
- Expenses associated with the provision of economic support in connection with the COVID-19 public health emergency, such as:
 - Expenditures related to the provision of grants to small businesses to reimburse the costs of business interruption caused by required closures.
 - Expenditures related to a State, territorial, local, or Tribal government payroll support program.
 - Unemployment insurance costs related to the COVID-19 public health emergency if such costs will not be reimbursed by the federal government pursuant to the CARES Act or otherwise.
- Any other COVID-19-related expenses reasonably necessary to the function of government that satisfy the Fund's eligibility criteria.

Nonexclusive examples of ineligible expenditures²

The following is a list of examples of costs that would *not* be eligible expenditures of payments from the Fund.

- 1. Expenses for the State share of Medicaid.3
- 2. Damages covered by insurance.
- Payroll or benefits expenses for employees whose work duties are not substantially dedicated to mitigating or responding to the COVID-19 public health emergency.

The prohibition on payment for abortions does not apply to an abortion if the pregnancy is the result of an act of rape or incest; or in the case where a woman suffers from a physical disorder, physical injury, or physical illness, including a life-endangering physical condition caused by or arising from the pregnancy itself, that would, as certified by a physician, place the woman in danger of death unless an abortion is performed. Furthermore, no government which receives payments from the Fund may discriminate against a health care entity on the basis that the entity does not provide, pay for, provide coverage of, or refer for abortions.

- Expenses that have been or will be reimbursed under any federal program, such as the reimbursement by the federal government pursuant to the CARES Act of contributions by States to State unemployment funds.
- 5. Reimbursement to donors for donated items or services.
- 6. Workforce bonuses other than hazard pay or overtime.
- 7. Severance pay.
- 8. Legal settlements.

Coronavirus Relief Fund Frequently Asked Questions Updated as of May 28, 2020

The following answers to frequently asked questions supplement Treasury's Coronavirus Relief Fund ("Fund") Guidance for State, Territorial, Local, and Tribal Governments, dated April 22, 2020, ("Guidance").¹ Amounts paid from the Fund are subject to the restrictions outlined in the Guidance and set forth in section 601(d) of the Social Security Act, as added by section 5001 of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act").

Eligible Expenditures

Are governments required to submit proposed expenditures to Treasury for approval?

No. Governments are responsible for making determinations as to what expenditures are necessary due to the public health emergency with respect to COVID-19 and do not need to submit any proposed expenditures to Treasury.

The Guidance says that funding can be used to meet payroll expenses for public safety, public health, health care, human services, and similar employees whose services are substantially dedicated to mitigating or responding to the COVID-19 public health emergency. How does a government determine whether payroll expenses for a given employee satisfy the "substantially dedicated" condition?

The Fund is designed to provide ready funding to address unforeseen financial needs and risks created by the COVID-19 public health emergency. For this reason, and as a matter of administrative convenience in light of the emergency nature of this program, a State, territorial, local, or Tribal government may presume that payroll costs for public health and public safety employees are payments for services substantially dedicated to mitigating or responding to the COVID-19 public health emergency, unless the chief executive (or equivalent) of the relevant government determines that specific circumstances indicate otherwise.

The Guidance says that a cost was not accounted for in the most recently approved budget if the cost is for a substantially different use from any expected use of funds in such a line item, allotment, or allocation. What would qualify as a "substantially different use" for purposes of the Fund eligibility?

Costs incurred for a "substantially different use" include, but are not necessarily limited to, costs of personnel and services that were budgeted for in the most recently approved budget but which, due entirely to the COVID-19 public health emergency, have been diverted to substantially different functions. This would include, for example, the costs of redeploying corrections facility staff to enable compliance with COVID-19 public health precautions through work such as enhanced sanitation or enforcing social distancing measures; the costs of redeploying police to support management and enforcement of stay-at-home orders; or the costs of diverting educational support staff or faculty to develop online learning capabilities, such as through providing information technology support that is not part of the staff or faculty's ordinary responsibilities.

Note that a public function does not become a "substantially different use" merely because it is provided from a different location or through a different manner. For example, although developing online instruction capabilities may be a substantially different use of funds, online instruction itself is not a substantially different use of public funds than classroom instruction.

May a State receiving a payment transfer funds to a local government?

Yes, provided that the transfer qualifies as a necessary expenditure incurred due to the public health emergency and meets the other criteria of section 601(d) of the Social Security Act. Such funds would be subject to recoupment by the Treasury Department if they have not been used in a manner consistent with section 601(d) of the Social Security Act.

May a unit of local government receiving a Fund payment transfer funds to another unit of government?

Yes. For example, a county may transfer funds to a city, town, or school district within the county and a county or city may transfer funds to its State, provided that the transfer qualifies as a necessary expenditure incurred due to the public health emergency and meets the other criteria of section 601(d) of the Social Security Act outlined in the Guidance. For example, a transfer from a county to a constituent city would not be permissible if the funds were intended to be used simply to fill shortfalls in government revenue to cover expenditures that would not otherwise qualify as an eligible expenditure.

Is a Fund payment recipient required to transfer funds to a smaller, constituent unit of government within its borders?

No. For example, a county recipient is not required to transfer funds to smaller cities within the county's borders.

Are recipients required to use other federal funds or seek reimbursement under other federal programs before using Fund payments to satisfy eligible expenses?

No. Recipients may use Fund payments for any expenses eligible under section 601(d) of the Social Security Act outlined in the Guidance. Fund payments are not required to be used as the source of funding of last resort. However, as noted below, recipients may not use payments from the Fund to cover expenditures for which they will receive reimbursement.

Are there prohibitions on combining a transaction supported with Fund payments with other CARES Act funding or COVID-19 relief Federal funding?

Recipients will need to consider the applicable restrictions and limitations of such other sources of funding. In addition, expenses that have been or will be reimbursed under any federal program, such as the reimbursement by the federal government pursuant to the CARES Act of contributions by States to State unemployment funds, are not eligible uses of Fund payments.

Are States permitted to use Fund payments to support state unemployment insurance funds generally?

To the extent that the costs incurred by a state unemployment insurance fund are incurred due to the COVID-19 public health emergency, a State may use Fund payments to make payments to its respective state unemployment insurance fund, separate and apart from such State's obligation to the unemployment insurance fund as an employer. This will permit States to use Fund payments to prevent expenses related to the public health emergency from causing their state unemployment insurance funds to become insolvent.

Are recipients permitted to use Fund payments to pay for unemployment insurance costs incurred by the recipient as an employer?

Yes, Fund payments may be used for unemployment insurance costs incurred by the recipient as an employer (for example, as a reimbursing employer) related to the COVID-19 public health emergency if such costs will not be reimbursed by the federal government pursuant to the CARES Act or otherwise.

The Guidance states that the Fund may support a "broad range of uses" including payroll expenses for several classes of employees whose services are "substantially dedicated to mitigating or responding to the COVID-19 public health emergency." What are some examples of types of covered employees?

The Guidance provides examples of broad classes of employees whose payroll expenses would be eligible expenses under the Fund. These classes of employees include public safety, public health, health care, human services, and similar employees whose services are substantially dedicated to mitigating or responding to the COVID-19 public health emergency. Payroll and benefit costs associated with public employees who could have been furloughed or otherwise laid off but who were instead repurposed to perform previously unbudgeted functions substantially dedicated to mitigating or responding to the COVID-19 public health emergency are also covered. Other eligible expenditures include payroll and benefit costs of educational support staff or faculty responsible for developing online learning capabilities necessary to continue educational instruction in response to COVID-19-related school closures. Please see the Guidance for a discussion of what is meant by an expense that was not accounted for in the budget most recently approved as of March 27, 2020.

In some cases, first responders and critical health care workers that contract COVID-19 are eligible for workers' compensation coverage. Is the cost of this expanded workers compensation coverage eligible?

Increased workers compensation cost to the government due to the COVID-19 public health emergency incurred during the period beginning March 1, 2020, and ending December 30, 2020, is an eligible expense.

If a recipient would have decommissioned equipment or not renewed a lease on particular office space or equipment but decides to continue to use the equipment or to renew the lease in order to respond to the public health emergency, are the costs associated with continuing to operate the equipment or the ongoing lease payments eligible expenses?

Yes. To the extent the expenses were previously unbudgeted and are otherwise consistent with section 601(d) of the Social Security Act outlined in the Guidance, such expenses would be eligible.

May recipients provide stipends to employees for eligible expenses (for example, a stipend to employees to improve telework capabilities) rather than require employees to incur the eligible cost and submit for reimbursement?

Expenditures paid for with payments from the Fund must be limited to those that are necessary due to the public health emergency. As such, unless the government were to determine that providing assistance in the form of a stipend is an administrative necessity, the government should provide such assistance on a reimbursement basis to ensure as much as possible that funds are used to cover only eligible expenses.

May Fund payments be used for COVID-19 public health emergency recovery planning?

Yes. Expenses associated with conducting a recovery planning project or operating a recovery coordination office would be eligible, if the expenses otherwise meet the criteria set forth in section 601(d) of the Social Security Act outlined in the Guidance.

Are expenses associated with contact tracing eligible?

Yes, expenses associated with contract tracing are eligible.

To what extent may a government use Fund payments to support the operations of private hospitals?

Governments may use Fund payments to support public or private hospitals to the extent that the costs are necessary expenditures incurred due to the COVID-19 public health emergency, but the form such assistance would take may differ. In particular, financial assistance to private hospitals could take the form of a grant or a short-term loan.

May payments from the Fund be used to assist individuals with enrolling in a government benefit program for those who have been laid off due to COVID-19 and thereby lost health insurance?

Yes. To the extent that the relevant government official determines that these expenses are necessary and they meet the other requirements set forth in section 601(d) of the Social Security Act outlined in the Guidance, these expenses are eligible.

May recipients use Fund payments to facilitate livestock depopulation incurred by producers due to supply chain disruptions?

Yes, to the extent these efforts are deemed necessary for public health reasons or as a form of economic support as a result of the COVID-19 health emergency.

Would providing a consumer grant program to prevent eviction and assist in preventing homelessness be considered an eligible expense?

Yes, assuming that the recipient considers the grants to be a necessary expense incurred due to the COVID-19 public health emergency and the grants meet the other requirements for the use of Fund payments under section 601(d) of the Social Security Act outlined in the Guidance. As a general matter, providing assistance to recipients to enable them to meet property tax requirements would not be an eligible use of funds, but exceptions may be made in the case of assistance designed to prevent foreclosures.

May recipients create a "payroll support program" for public employees?

Use of payments from the Fund to cover payroll or benefits expenses of public employees are limited to those employees whose work duties are substantially dedicated to mitigating or responding to the COVID-19 public health emergency.

May recipients use Fund payments to cover employment and training programs for employees that have been furloughed due to the public health emergency?

Yes, this would be an eligible expense if the government determined that the costs of such employment and training programs would be necessary due to the public health emergency.

May recipients use Fund payments to provide emergency financial assistance to individuals and families directly impacted by a loss of income due to the COVID-19 public health emergency?

Yes, if a government determines such assistance to be a necessary expenditure. Such assistance could include, for example, a program to assist individuals with payment of overdue rent or mortgage payments to avoid eviction or foreclosure or unforeseen financial costs for funerals and other emergency individual needs. Such assistance should be structured in a manner to ensure as much as possible, within the realm of what is administratively feasible, that such assistance is necessary.

The Guidance provides that eligible expenditures may include expenditures related to the provision of grants to small businesses to reimburse the costs of business interruption caused by required closures. What is meant by a "small business," and is the Guidance intended to refer only to expenditures to cover administrative expenses of such a grant program?

Governments have discretion to determine what payments are necessary. A program that is aimed at assisting small businesses with the costs of business interruption caused by required closures should be tailored to assist those businesses in need of such assistance. The amount of a grant to a small business to reimburse the costs of business interruption caused by required closures would also be an eligible expenditure under section 601(d) of the Social Security Act, as outlined in the Guidance.

The Guidance provides that expenses associated with the provision of economic support in connection with the public health emergency, such as expenditures related to the provision of grants to small businesses to reimburse the costs of business interruption caused by required closures, would constitute eligible expenditures of Fund payments. Would such expenditures be eligible in the absence of a stay-at-home order?

Fund payments may be used for economic support in the absence of a stay-at-home order if such expenditures are determined by the government to be necessary. This may include, for example, a grant program to benefit small businesses that close voluntarily to promote social distancing measures or that are affected by decreased customer demand as a result of the COVID-19 public health emergency.

May Fund payments be used to assist impacted property owners with the payment of their property taxes?

Fund payments may not be used for government revenue replacement, including the provision of assistance to meet tax obligations.

May Fund payments be used to replace foregone utility fees? If not, can Fund payments be used as a direct subsidy payment to all utility account holders?

Fund payments may not be used for government revenue replacement, including the replacement of unpaid utility fees. Fund payments may be used for subsidy payments to electricity account holders to the extent that the subsidy payments are deemed by the recipient to be necessary expenditures incurred due to the COVID-19 public health emergency and meet the other criteria of section 601(d) of the Social Security Act outlined in the Guidance. For example, if determined to be a necessary expenditure, a government could provide grants to individuals facing economic hardship to allow them to pay their utility fees and thereby continue to receive essential services.

Could Fund payments be used for capital improvement projects that broadly provide potential economic development in a community?

In general, no. If capital improvement projects are not necessary expenditures incurred due to the COVID-19 public health emergency, then Fund payments may not be used for such projects.

However, Fund payments may be used for the expenses of, for example, establishing temporary public medical facilities and other measures to increase COVID-19 treatment capacity or improve mitigation measures, including related construction costs.

The Guidance includes workforce bonuses as an example of ineligible expenses but provides that hazard pay would be eligible if otherwise determined to be a necessary expense. Is there a specific definition of "hazard pay"?

Hazard pay means additional pay for performing hazardous duty or work involving physical hardship, in each case that is related to COVID-19.

The Guidance provides that ineligible expenditures include "[p]ayroll or benefits expenses for employees whose work duties are not substantially dedicated to mitigating or responding to the COVID-19 public health emergency." Is this intended to relate only to public employees?

Yes. This particular nonexclusive example of an ineligible expenditure relates to public employees. A recipient would not be permitted to pay for payroll or benefit expenses of private employees and any financial assistance (such as grants or short-term loans) to private employers are not subject to the restriction that the private employers' employees must be substantially dedicated to mitigating or responding to the COVID-19 public health emergency.

May counties pre-pay with CARES Act funds for expenses such as a one or two-year facility lease, such as to house staff hired in response to COVID-19?

A government should not make prepayments on contracts using payments from the Fund to the extent that doing so would not be consistent with its ordinary course policies and procedures.

Must a stay-at-home order or other public health mandate be in effect in order for a government to provide assistance to small businesses using payments from the Fund?

No. The Guidance provides, as an example of an eligible use of payments from the Fund, expenditures related to the provision of grants to small businesses to reimburse the costs of business interruption caused by required closures. Such assistance may be provided using amounts received from the Fund in the absence of a requirement to close businesses if the relevant government determines that such expenditures are necessary in response to the public health emergency.

Should States receiving a payment transfer funds to local governments that did not receive payments directly from Treasury?

Yes, provided that the transferred funds are used by the local government for eligible expenditures under the statute. To facilitate prompt distribution of Title V funds, the CARES Act authorized Treasury to make direct payments to local governments with populations in excess of 500,000, in amounts equal to 45% of the local government's per capita share of the statewide allocation. This statutory structure was based on a recognition that it is more administratively feasible to rely on States, rather than the federal government, to manage the transfer of funds to smaller local governments. Consistent with the needs of all local governments for funding to address the public health emergency, States should transfer funds to local governments with populations of 500,000 or less, using as a benchmark the per capita allocation formula that governs payments to larger local governments. This approach will ensure equitable treatment among local governments of all sizes.

For example, a State received the minimum \$1.25 billion allocation and had one county with a population over 500,000 that received \$250 million directly. The State should distribute 45 percent of the \$1 billion it received, or \$450 million, to local governments within the State with a population of 500,000 or less.

May a State impose restrictions on transfers of funds to local governments?

Yes, to the extent that the restrictions facilitate the State's compliance with the requirements set forth in section 601(d) of the Social Security Act outlined in the Guidance and other applicable requirements such as the Single Audit Act, discussed below. Other restrictions are not permissible.

If a recipient must issue tax anticipation notes (TANs) to make up for tax due date deferrals or revenue shortfalls, are the expenses associated with the issuance eligible uses of Fund payments?

If a government determines that the issuance of TANs is necessary due to the COVID-19 public health emergency, the government may expend payments from the Fund on the accrued interest expense on TANs and unbudgeted administrative and transactional costs, such as necessary payments to advisors and underwriters, associated with the issuance of the TANs.

May recipients use Fund payments to expand rural broadband capacity to assist with distance learning and telework?

Such expenditures would only be permissible if they are necessary for the public health emergency. The cost of projects that would not be expected to increase capacity to a significant extent until the need for distance learning and telework have passed due to this public health emergency would not be necessary due to the public health emergency and thus would not be eligible uses of Fund payments.

Are costs associated with increased solid waste capacity an eligible use of payments from the Fund?

Yes, costs to address increase in solid waste as a result of the public health emergency, such as relates to the disposal of used personal protective equipment, would be an eligible expenditure.

May payments from the Fund be used to cover across-the-board hazard pay for employees working during a state of emergency?

No. The Guidance says that funding may be used to meet payroll expenses for public safety, public health, health care, human services, and similar employees whose services are substantially dedicated to mitigating or responding to the COVID-19 public health emergency. Hazard pay is a form of payroll expense and is subject to this limitation, so Fund payments may only be used to cover hazard pay for such individuals.

May Fund payments be used for expenditures related to the administration of Fund payments by a State, territorial, local, or Tribal government?

Yes, if the administrative expenses represent an increase over previously budgeted amounts and are limited to what is necessary. For example, a State may expend Fund payments on necessary administrative expenses incurred with respect to a new grant program established to disburse amounts received from the Fund.

May recipients use Fund payments to provide loans?

Yes, if the loans otherwise qualify as eligible expenditures under section 601(d) of the Social Security Act as implemented by the Guidance. Any amounts repaid by the borrower before December 30, 2020, must be either returned to Treasury upon receipt by the unit of government providing the loan or used for another expense that qualifies as an eligible expenditure under section 601(d) of the Social Security Act. Any amounts not repaid by the borrower until after December 30, 2020, must be returned to Treasury upon receipt by the unit of government lending the funds.

May Fund payments be used for expenditures necessary to prepare for a future COVID-19 outbreak?

Fund payments may be used only for expenditures necessary to address the current COVID-19 public health emergency. For example, a State may spend Fund payments to create a reserve of personal protective equipment or develop increased intensive care unit capacity to support regions in its jurisdiction not yet affected, but likely to be impacted by the current COVID-19 pandemic.

Questions Related to Administration of Fund Payments

Do governments have to return unspent funds to Treasury?

Yes. Section 601(f)(2) of the Social Security Act, as added by section 5001(a) of the CARES Act, provides for recoupment by the Department of the Treasury of amounts received from the Fund that have not been used in a manner consistent with section 601(d) of the Social Security Act. If a government has not used funds it has received to cover costs that were incurred by December 30, 2020, as required by the statute, those funds must be returned to the Department of the Treasury.

What records must be kept by governments receiving payment?

A government should keep records sufficient to demonstrate that the amount of Fund payments to the government has been used in accordance with section 601(d) of the Social Security Act.

May recipients deposit Fund payments into interest bearing accounts?

Yes, provided that if recipients separately invest amounts received from the Fund, they must use the interest earned or other proceeds of these investments only to cover expenditures incurred in accordance with section 601(d) of the Social Security Act and the Guidance on eligible expenses. If a government deposits Fund payments in a government's general account, it may use those funds to meet immediate cash management needs provided that the full amount of the payment is used to cover necessary expenditures. Fund payments are not subject to the Cash Management Improvement Act of 1990, as amended.

May governments retain assets purchased with payments from the Fund?

Yes, if the purchase of the asset was consistent with the limitations on the eligible use of funds provided by section 601(d) of the Social Security Act.

What rules apply to the proceeds of disposition or sale of assets acquired using payments from the Fund?

If such assets are disposed of prior to December 30, 2020, the proceeds would be subject to the restrictions on the eligible use of payments from the Fund provided by section 601(d) of the Social Security Act.

Are Fund payments to State, territorial, local, and tribal governments considered grants?

No. Fund payments made by Treasury to State, territorial, local, and Tribal governments are not considered to be grants but are "other financial assistance" under 2 C.F.R. § 200.40.

Are Fund payments considered federal financial assistance for purposes of the Single Audit Act?

Yes, Fund payments are considered to be federal financial assistance subject to the Single Audit Act (31 U.S.C. §§ 7501-7507) and the related provisions of the Uniform Guidance, 2 C.F.R. § 200.303 regarding internal controls, §§ 200.330 through 200.332 regarding subrecipient monitoring and management, and subpart F regarding audit requirements.

Are Fund payments subject to other requirements of the Uniform Guidance?

Fund payments are subject to the following requirements in the Uniform Guidance (2 C.F.R. Part 200): 2 C.F.R. § 200.303 regarding internal controls, 2 C.F.R. §§ 200.330 through 200.332 regarding subrecipient monitoring and management, and subpart F regarding audit requirements.

Is there a Catalog of Federal Domestic Assistance (CFDA) number assigned to the Fund?

Yes. The CFDA number assigned to the Fund is 21.019, pending completion of registration.

If a State transfers Fund payments to its political subdivisions, would the transferred funds count toward the subrecipients' total funding received from the federal government for purposes of the Single Audit Act?

Yes. The Fund payments to subrecipients would count toward the threshold of the Single Audit Act and 2 C.F.R. part 200, subpart F re: audit requirements. Subrecipients are subject to a single audit or programspecific audit pursuant to 2 C.F.R. § 200.501(a) when the subrecipients spend \$750,000 or more in federal awards during their fiscal year.

Are recipients permitted to use payments from the Fund to cover the expenses of an audit conducted under the Single Audit Act?

Yes, such expenses would be eligible expenditures, subject to the limitations set forth in 2 C.F.R. § 200.425.

If a government has transferred funds to another entity, from which entity would the Treasury Department seek to recoup the funds if they have not been used in a manner consistent with section 601(d) of the Social Security Act?

The Treasury Department would seek to recoup the funds from the government that received the payment directly from the Treasury Department. State, territorial, local, and Tribal governments receiving funds from Treasury should ensure that funds transferred to other entities, whether pursuant to a grant program

or otherwise, are used in accordance with section 601(d) of the Social Security Act as implemented in the Guidance.

NAVAJO NATION CARES FUND CHAPTER DISTRIBUTION EXPENDITURE PLAN



I. PURPOSE

The purpose of this Chapter Distribution Expenditure Plan is to allow for the use and expenditure of ninety million dollars (\$90,000,000.00) by Navajo Nation Chapters (both LGA Certified and non-certified) to respond to the COVID-19 pandemic and ensure that Navajo communities have access to the funding necessary to ensure that community members are adequately protected from exposure to COVID-19 and to mitigate the spread of the virus. Any Expenditure Plan funds that are unspent as of December 30, 2020, will revert back to the Navajo Nation CARES Fund.

Allowable expenditures include, but are not limited to: personal protective equipment, (gloves, masks, hand sanitizer, thermometers, anti-bacterial soap, first-aid supplies, employee workplace); essential sanitation items (Clorox, Clorox wipes, Lysol spray, toilet tissue, wipes, diapers, adult pull-ups, feminine hygiene, toothpaste, tooth brush, aloe-vera, lotion, shampoo, soap); essential fuel sources (wood, coal, pellets, propane, gas vouchersfuel, hand warmers, blankets); essential food items (vitamin C-EmergenC, Vitamin C tablets, water, multi-vitamin for adults and children, Gatorade, V-8, Ensure drinks, Emergency Food Care package, blue corn mush); essential services (Solid Waste Removal, Solid-waste clean-up, porta-johns, support to water haulers, livestock windmills, electric bill assistant); infrastructure projects, infrastructure upgrades, (bathroom additions, plan, design & construction -ADA must be included as needed, bathroom equipment, septic services assistance, cistern tanks, water barrels, work place implementation to meet CDC requirements, utility and water infrastructure, water wells), infrastructure equipment such as backhoe for COVID related deceased matters and other deceased matters for burial/grave digging; emergency essential support (PEP employment-special duty pay, essential pay, bathroom additions construction employee, essential delivery workers, essential workers-heavy equipment operator for road maintenance and burial, Emergency coordinator); emergency hardship assistance for electric, propane, natural gas, and groceries, payment for chapter/senior center utility bills (electric, propane, natural gas), purchase of food, personal protective equipment for elders at senior centers, upgrade at Senior Centers to include safety upgrades per CDC guidelines following ADA guidelines.

The federal CARES Act, Title V, 5001, entitled "Coronavirus Relief Funds" requires these funds be used to 1.) cover costs that are necessary expenditures incurred due to the public health emergency with respect to the COVID-19; 2.) were not accounted for in the budget most recently approved, as of March 27, 2020; and 3.) incurred during the period that begins on March 1, 2020 and ends on December 30, 2020.

II. AFFIRMATION OF FUND USE

The Division of Community Development - Administrative Service Department affirms it will use these funds in accordance with the purposes set forth in CMY-44-20 and Title V of the Coronavirus Aid, Relief, and Economic Security Act (the "federal CARES Act") as enacted by the Unites States Congress and found in Public Law 116-136 (2020).

III. ALLOCATION ASSIGNMENT

The funds are allocated to the Navajo Nation Division of Community Development -Administrative Service Department to be used for projects dedicated to mitigating or responding to the COVID-19 public health emergency and interaction with the public.

IV. IMPLEMENTATION AND MONITORING

The Division of Community Development-Administrative Service Center is responsible for implementing the Expenditure Plan and monitoring the expenditure of these funds.

V. ADMINISTRATOR OF FUNDS

The Department Manager of the Administrative Services Center is responsible for administering the Expenditure Plan and overseeing the allocated funds.

VI. MEANS OF FUNDING

The Expenditure Plan funds shall be released directly to the Division of Community Development-Administrative Service Center once the Expenditure Plan is duly adopted and expedited budgets are implemented. At the request of an LGA Certified Chapter, the Chapter and Division of Community Development may enter a Memorandum of Agreement or sub-recipient agreement under which the funds can be released directly to the LGA Certified Chapter.

VII. ACCOUNTING AND REPORTING REQUIREMENTS

Title V CARES Act Funds, as appropriated by Congress and received by the Nation, are considered federal financial assistance received by the Navajo Nation for specified uses; and are subject to the restrictions outlined in the Treasury Guidance and as set forth in section 601(d) of the Social Security Act, as added by section 5001 of the Coronavirus Aid, Relief, and Economic Security Act. The CARES Act has a CFDA No. 21.019; therefore, the funding received by the Nation is subject to GASB, Uniform Guidance/Super Circular guidelines and the Single Audit Act and any other applicable rules, regulations and guidance.

VIII. OVERSIGHT COMMITTEE

The Resources and Development Committee (RDC) and Budget and Finance Committee (BFC) shall share oversight as RDC has oversight over chapters and BFC has oversight over externally restricted funding.

IX. AFFIRMATION OF ADMINISTRATION AND MANAGEMENT

The Division of Community Development – Administrative Service Center and Chapters receiving funding affirms it will administer, manage, and implement the funds allocated to it in this expenditure plan consistent the federal CARES Act, the Treasury Guidance, as well as other applicable laws and regulations of the Navajo Nation.

We strongly voice and humbly submit the following amendment to the Legislation:

The Navajo Nation CARES Fund Chapter Distribution Fund be directly allocated and deposited into the bank accounts of Navajo Chapters who have demonstrated, in the previous 12 months, the financial/bookkeeping capacity to manage its MIP accounting system and financial obligations - the knowledge, and skills needed to make and exercise financial management decisions that best fit the circumstances of their Chapter community and providing necessary governmental services, while adhering to established fiscal policies and procedures.

Navajo Chapters who have demonstrated the capability to manage public funds, make prudent decision-making, and exhibit fiscal responsibility must be afforded the right to receive these funds directly based upon their respective expenditure plans.

A relief package for Navajo Chapters must include substantial, specific relief to meet the unique needs of each local Navajo Chapter Community and the People it serves. Navajo Chapters seek relief and response funds to help address the needs of our Navajo People and our local Chapter community who have suffered from unimaginable loss as a result of the COVID-19 pandemic. This Legislation provides much needed funds to our local Navajo communities.

We urge the Navajo Nation Council to vote affirmative for the approval of allocating \$90 million among the 110 Navajo Chapters. Subsequently, we urge the Navajo Nation President to approve the legislation without vetoing any part. The passage and approval of this legislation will undoubtedly provide certainty to our Navajo Chapters and our Navajo People during this unprecedented time.

Your understanding and support to amend the \$90M and to equally distribute & appropriate \$2.7M per chapter will be greatly appreciated.

Dear Honorable Leaders,

The Dilkon Chapter respectfully submits the attached resolution and attachments for your review and approval. This is also per request by Dr. Pearl Yellowman, Executive Director of the Division of Community Development during the District 7 Chapters Coordination Meeting on August 20, 2020.

The John's Draw Electrical Extension Project has 24 families who are listed to receive power to their homes. Dilkon Chapter was successful in obtaining funds for the planning and Right of Way (ROW) clearances. We were again successful in obtaining construction funds from the State of Arizona Indian Community Development Block Grant. This project is ready for construction by the Navajo Tribal Utility Authority (NTUA).

During the declared state of emergency on the Navajo Nation, the leadership of Dilkon Chapter completed home visit to help community members. All homes were visited and extra help was provided to families who were suffering from the effects of COVID-19. Food, water, bottled water, cleaning supplies, sanitizers, firewood and filled propane bottles were distributed by Dilkon Chapter.

The John's Draw area of Dilkon Chapter was in tremendous need due to lack of running water, waste water disposal and electricity. This need caused cases of COVID-19 within the area. The Dilkon Chapter and Navajo Nation Community Health Representatives worked cooperatively to assist the families providing temporary solutions, such as: supplying 275 gallon water tanks and water so the families would be able to wash their hands, clean and sanitize their homes. It is unfortunate that 71% of the families are low income and unable to repair or rehab their homes. 60% are unemployed and 25% are elders who are vulnerable and high risk to combat the virus.

The Dilkon Chapter completed home assessments of the 24 homes with the assistance of a local general contractor, Barton Southwest Builders, Inc. There are several local electricians and plumbers available as well as carpenters and laborers to develop several teams to work simultaneously. Concrete workers are available to complete concrete floor for modular homes and carpenters to finish them up. Dilkon is not without skilled craftsmen. A scope of work and cost estimates were determined and attached to our request. Dilkon Chapter discussed the project schedule with the contractor and confident the plans will be completed by December 31, 2020.

- 2. Pursuant to 26 N.N.C. Section 1 (B) Dilkon Chapter is vested with the authority to review all matters affecting the community and make appropriate requests to the Navajo Nation and other agencies for appropriate actions; and
- 3. The Dilkon Chapter John's Draw area do not have infrastructure for water, waste water and electricity; and
- There are 24 families who are part of the John's Draw Powerline Extension Project. The Dilkon Chapter obtained a planning grant from the Sihasin Funds and construction funds from the State of Arizona Community Development Block Grant (CDBG); and
- 5. The Navajo Tribal Utility Authority (NTUA) is in the process of securing the funds to start the construction of the powerline extension; and
- 6. The CDBG provides funds to expand public utility services to low income families, which include the Navajo Nation. The majority of the families residing within the John's Draw area of Dilkon Chapter are of low to no income status; and
- The Dilkon Chapter does not have funds to assist and the families have received little to no housing assistance for the past 50 years to prepare their homes for electrical connection; and
- 8. 9 homes are in desperate need of rehabilitation, 6 families are living in overcrowded conditions in aged small sheds, trailers, houses and hogans that are old or dilapidated and need replacement. 9 homes are in need of bathroom addition, cistern & septic installation and NTUA requirements however in better good condition for electrical connections at this time; and
- 9. There are 16 families residing within the John's Draw area that are not on the Powerline Extension Project who are also in need of housing repair and rehabilitation. 10 families live with family members in overcrowded or unsafe and unsanitary conditions who need complete homes. The cost of these homes are not included in this cost.

Dilkon Chapter approves and request the Office of the Navajo Nation President and Vice-President, the Navajo Nation 24th Council and the Navajo Nation Department of Community Development to fund the home rehabilitation, bathroom addition, house wiring, installation of cisterns and septic tanks, and new home construction cost for families living within the John's Draw area of Dilkon Chapter from the Navajo Nation Cares Fund Act Expenditure Plan, in the amount of One Million, Three Hundred Thirty-Nine Dollars (\$1,339,000.00)

- Widowed elderly parent living with two daughters and their children. Home is 40 years old with a cistern and septic system that no longer work. Home needs renovation to repair their bathroom and kitchen, replace cistern and septic systems and install service box on home. It also needs complete house wiring and plumbing work. The ADA bathroom renovation will include moving of wall to accommodate elder. Kitchen needs to be upgraded and appliances installed. Upgrade doors and windows.
- Young couple with child living in a small framed home with incomplete porch. Complete interior and exterior renovation to add bathroom and bedroom. Complete house wiring and plumbing work needed. Upgrade windows, complete fascia and porch area. Septic and cistern systems and service box needed.

- Pursuant to 26 N.N.C. Section 3 (A) the Dilkon Chapter is a duly recognized certified chapter of the Navajo Nation Government, as listed at 11 N.N.C., part 1, section 10; and
- Pursuant to 26 N.N.C. Section 1 (B) Dilkon Chapter is vested with the authority to review all matters affecting the community and make appropriate requests to the Navajo Nation and other agencies for appropriate actions; and
- 3. The World Health Organization (WHO) declared a public health emergency of international concern related to the outbreak of the coronavirus (COVID-19), a highly contagious and fatal respiratory virus on January 30, 2020. The U.S. Department of Health and Human Services declared a public health emergency related to COVID-19 outbreak on January 31, 2020. The WHO declared a global pandemic due to COVID-19 on March 11, 2020; and
- Navajo Nation President Jonathan Nez declared a Public Health State of Emergency on the Navajo Nation on March 11, 2020 due to COVID-19 and since have 9,519 confirmed COVID-19 cases and 487 COVID-related deaths on the Navajo Nation; and
- The Southwest Navajo Nation is served by the Winslow Indian Health Services who reports 454 confirmed COVID-19 cases, 21% of the total Navajo Nation cases. The death rate calculated at 19% is 92 deaths; and
- 6. The Dilkon Chapter John's Draw area have confirmed cases however do not have infrastructure for water, waste water and electricity to follow the Center for Disease Control (CDC) requirements to wash hands often, to clean and disinfect frequently is difficult when you have no clean water or waste water systems; and
- 7. 24 families are part of the John's Draw Powerline Extension Project. The Dilkon Chapter obtained a planning grant from the Sihasin Funds and construction funds from the State of Arizona Indian Community Development Block Grant (ICDBG) to bring electricity to the homes however the lack of water infrastructure, safe and sanitary homes has become a health concern for the 24 families since the declaration of the public health emergency to prevent the increase of COVID-19 within Southwest Navajo Nation and the community of Dilkon; and
- 8. 71% of the 24 families are low income, 60% are unemployed, 25% are headed by elderly head of household, 13% are considered handicapped and 13% are

Veterans. The data show the families are in the high risk category and vulnerable to Covid-19; and

- 9. There are 28 school children who attend schools in the local school districts that need infrastructure to aid their education. None of the families have received housing assistance to prepare their homes for electrical connection; and
- 10. 9 homes are in desperate need of housing rehabilitation, cistern & septic installation, 6 families are living in overcrowded conditions in aged small sheds, trailers, houses and Hogan that are old or dilapidated and need replacement with cistern & septic installation. 9 homes are in need of bathroom additions, cistern & septic installation and NTUA requirements however in better condition for electrical connections; and
- The expenditures are necessary due to the public health emergency with respect to COVID-19; and
- 12. The expenditures are not accounted for in the tribal budget most recently approved as of March 27, 2020; and
- 13. The expenditures will be incurred from March 1, 2020 through December 30, 2020.

Home needs renovation to repair their bathroom and kitchen, replace cistern and septic systems and install service box on home. It also needs complete house wiring and plumbing work. The ADA bathroom renovation will include moving of wall to accommodate elder. Kitchen needs to be upgraded and appliances installed. Upgrade doors and windows.
- Young couple with child living in a small framed home with incomplete porch. Complete interior and exterior renovation to add bathroom and bedroom. Complete house wiring and plumbing work needed. Upgrade windows, complete fascia and porch area. Septic and cistern systems and service box needed.

Renovation of home to include ceiling repair, upgrade windows and doors, replace floor, roofing, shingles, siding, ADA bathroom addition and appliances. Cistern & septic installation and service box needed.

- Adult couple and her brother living in Hogan that was recently renovated yet needs complete bathroom addition, cistern & septic installation and service pole.
- Recently widowed female living in incomplete home that needs complete interior work to include: tape & texture work, painting, finish work, and flooring. Complete exterior work to include painting, porch and concrete work. NTUA states 100 amp and meter loop however may need 200 amp due to size.

The Navajo Nation hereby adds an additional fifteen million dollars (\$15,000,000) allocation to the Broadband-Telecommunications Project Expenditure Plan adopted by CJY-67-20, attached as Exhibit 4; and amends the Purpose section of the Broadband-Telecommunications Project Expenditure Plan as follows: Fifteen Million Dollars (\$15,000,000) of the Broadband Telecommunications Expenditure Plan funds shall be used to fund non tribal owned Eligible Telecommunication Carriers (ETC) or internet service providers that are certified by the Federal Communication Commission (FCC) for the purpose of extending broadband and telecommunication infrastructure to previously unserved and underserved Chapters of the Navajo Nation by December 30, 2020 and shall fund only the deployment costs (not on-going operating costs, including administrative personnel projects) of projects that support Internet Services. Permissible broadband and

telecommunication infrastructure improvements that may be funded included the following: A. Wireless tower and other network infrastructure necessary to provide mobile and fixed broadband to residents including backhaul, system upgrades, middle mile and last mile services.

B. Middle-Mile fiber and microwave infrastructure for connectivity to schools, Chapter Houses, government facilities, and businesses.

C. Network capacities upgrades necessary to provide 4G services, such as FirstNet, Amber Alerts, and NG911, as well as Telehealth, Education, and Commerce applications to mobile and home bound residents.

The Navajo Nation Department of Information Technology (DIT) with the assistance of Navajo Nation Telecommunication and Utilities shall devise an application process for the distribution of the \$15,000,000 to non-tribal owned ETCs. ETCs shall only receive funding if it provides Internet service, which is defined as the portion of broadband service that delivers an internet connection to an end user that lacks access to a voice and broadband services at measurable speeds of 4/1 Mbps or greater for unreserved areas, and 10/1 Mbps or greater for underserved areas. After reviewing the applications for eligibility, DIT shall be responsible for selecting and monitoring the ETCs that receiving funding and the amount of such funding,

3. Increase any cumulative amounts set forth in the Broadband-Telecommunication Projects Expenditure Plan, if necessary, to account for this amendment.
