**SECTION ONE. AUTHORITY**

- A. Pursuant to 2 N.N.C. 701 (A)(1) the Naabik'iyáti' Committee has the authority to grant final confirmation of appointments to boards, commissions and colleges unless otherwise provided in law.
- B. The appointments to the Black Mesa Review Board as made by the respective Chapters require confirmation by the Naabik'iyáti' Committee. 2 N.N.C. 903(B)

**SECTION TWO. FINDINGS**

- A. The purpose of the Black Mesa Review Board shall be to advocate for fair and just compensation for Navajo families within the five Navajo Nation Chapters whose socio-economic and environmental interests are adversely affected or impacted by coal mining and related operations of Peabody Western Coal Company. 2 N.N.C. § 902

- 1 B. The Board shall include one member who shall be appointed by the Chilchinbeto  
2 Chapter. 2 N.N.C. § 903(A)
- 3 C. The Chilchinbeto Chapter has appointed Paul Madison as the Chapter member for the  
4 Black Mesa Review Board. See Exhibit A.
- 5 D. Within 30 days of appointment, each Board appointee shall be presented to the  
6 Naabik'iyátí Committee for confirmation. Such confirmation to be for four years  
7 commencing upon administration of oath of office. 2 N.N.C. § 903(B)
- 8 E. Any Board member may be appointed for consecutive terms, but shall be limited to  
9 two consecutive terms. 2 N.N.C. §903(H)
- 10 F. The Naabik'iyátí Committee of the Navajo Nation Council finds it to be in the best  
11 interest of the Diné to confirm the appointment of Paul Madison as the Chilchinbeto  
12 Chapter representative to the Black Mesa Review Board.

### 13 **SECTION THREE. CONFIRMING APPOINTMENT**

14 The Naabik'iyátí Committee of the Navajo Nation Council hereby confirms the  
15 appointment of Paul Madison as the Chilchinbeto Chapter representative to the Black  
16 Mesa Review Board for a term of four(4) years.

4. Paul Madson requested to have someone replace him, but with several announcements and no one was interested, and
5. Paul Madson decided to go for another term.

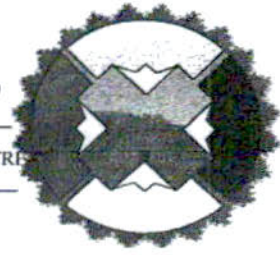

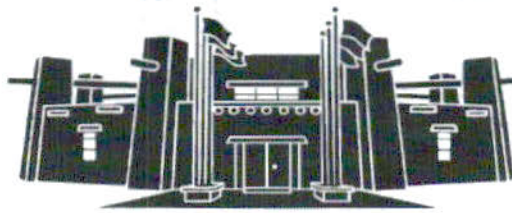
