PURPOSE: The purpose of this resolution is to allocate \$7,750,000 in Sihasin funds to the Navajo Division of Transportation for the N8066 Road Paving Project and to approve and adopt the Expenditure Plan for the Project.

D. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102(A).

E. The Navajo Nation Code provides the purpose of the Navajo Nation Síhasin Fund ("Síhasin Fund") is as follows:

§ 2502 Purpose

- A. The purposes of this Fund are to provide financial support and/or financing for:
 - 1. The planning and development of economic development and regional infrastructure supporting economic development and community development, including such infrastructure as, but not limited to, housing, commercial and government buildings, waterline, solid waste management development, powerline projects, and transportation and communication systems, within the Navajo Nation; and
 - 2. Education opportunities for members of the Navajo Nation.
- B. For the Purpose in § 2502(A)(1), Fund expenditures for infrastructure shall not be limited by 12 NNC § 1310(F) or TCDCJY-77-99.
- C. Leveraging the Fund by way of guaranteeing loans, match funding, direct funding in part, and other weighted uses of the Fund, including loan financing from the Fund, for the purposes in § 2502(A)(1), shall be favored over direct funding in whole.

12 N.N.C. § 2502, as amended by CJA-03-18.

- F. The Síhasin Fund provides that "Fund Principal" shall consist of all deposits made to the Síhasin Fund and that "Fund Income" shall consist of all earnings (interest, dividends, etc.) generated and realized by the Fund Principal, and that Fund Income shall be deposited in and added to Fund Principal until such time as a Fund Expenditure Plan is duly adopted. 12 N.N.C. §§ 2504 and 2505 (C).
- G. The Síhasin Fund provides that "Fund Principal and Income shall not be expended except pursuant to a Fund Expenditure Plan consistent with the purposes set forth

in § 2502 of this Chapter and adopted by a two-thirds (2/3) vote of all members of the Navajo Nation Council." 12 N.N.C. § 2505(A).

SECTION TWO. FINDINGS

- A. The N8066 Road Paving Project is a \$24,750,000 project, as detailed in the "N8066 - Black Mesa Project Summary and Recommendations" attached as Exhibit A.
- B. The Resources and Development Committee previously approved the N8066 project on the Navajo Nation's Tribal Transportation Improvement Program and the project was awarded \$17,000,000 in federal funds. Exhibit B (Resolution No. RDCMY-46-18). The \$17,000,000 is expected in August 2021. Because the project is estimated to cost a total of \$24,750,000 an additional amount of \$7,750,000 is needed for the project.
- C. The Navajo Division of Transportation ("NDOT") will complete design plans, environmental clearances, permitting, and construction procurement. NDOT will provide construction management for the project, and is working with the Bureau of Indian Affairs/Navajo Region Division of Transportation for BIA/NRDOT to obtain the necessary right-of-way for the project on Navajo Nation land. BIA/NRDOT will hold the right-of-way and will be responsible for operation, maintenance, and repair of the road and bridge improvements once the project is completed. Exhibit C.
- D. The Black Mesa Chapter has adopted a resolution supporting this Project. **Exhibit D**.
- E. The Acting Principal of the Black Mesa Community School has written a letter to the Navajo Nation, explaining the need for the Project and urging support for the Project. Exhibit E.
- F. The allocation of the \$7,750,000 for this Project meets the criteria for Sihasin expenditures because this Project involves "infrastructure" such as "transportation" as mentioned in 12 N.N.C. § 2502(A)(1).
- G. The allocation of the \$7,750,000 for this Project meets the preference for leveraging Sihasin funds, as mentioned in 12 N.N.C. § 2502(C), because \$17,000,000 in federal funds has already been awarded for this Project.

SECTION THREE. APPROVAL AND ADOPTION OF EXPENDITURE PLAN

- A. The Navajo Nation hereby approves and adopts the N8066 Road Paving Project Expenditure Plan, attached as **Exhibit A**.
- B. The Navajo Nation hereby approves and adopts funding for the N8066 Road Paving Project Expenditure Plan in the amount of \$7,500,000 from the Navajo Nation Sihasin Fund, in accordance with 12 N.N.C. § 2505(A).
- C. The Síhasin Funds allocated for the N8066 Road Paving Project may be further leveraged by bond or loan financing pursuant to the Navajo Nation Bond Financing Act, 12 N.N.C. § 1300 et seq., as amended, using Síhasin Fund earnings for repayment and financing costs upon the recommendation of the Budget and Finance Committee and approval by a two-thirds (2/3) vote of all members of the Navajo Nation Council.

SECTION FOUR. APPROVAL AND ADOPTION OF EXPENDITURE PLAN ADMINISTRATION

The Navajo Nation Council hereby approves administration of the N8066 Road Paving Project Expenditure Plan as follows:

- 1. The Navajo Nation Controller shall determine whether the source of the annual allocations from the total allocation of \$7,500,000 will be Síhasin Fund Principal or Income or a combination of both.
- 2. The funding for the N8066 Road Paving Project Expenditure Plan will be distributed to the Navajo Division of Transportation within ten (10) days after the effective date of this legislation. The Navajo Division of Transportation shall be responsible for administering the Project, in accordance with the N8066 Road Paving Project Expenditure Plan described in **Exhibit A**.
- 3. The funds allocated for the N8066 Road Paving Project Expenditure Plan shall be used solely to design, plan, and/or construct the N8066 Road Paving Project described in **Exhibit A**. Any and all cost-savings shall be returned to the Síhasin Fund once the project is completed.

- 4. The funds allocated for the N8066 Road Paving Project Expenditure Plan shall not lapse on an annual basis pursuant to 12 N.N.C. §820(N), however, any funds not spent or encumbered within thirty-six (36) months of the date funds are made available to the Navajo Division of Transportation shall revert to the Síhasin Fund principal, unless recommended otherwise by the Resources and Development Committee of the Navajo Nation Council and approved by the Naabik'íyáti' Committee.
- 5. The N8066 Road Paving Project shall be operated by the BIA/NRDOT, and maintenance and repairs for the Project shall be performed by the BIA/NRDOT.

SECTION FIVE. EFFECTIVE DATE

This legislation and the N8066 Road Paving Project Expenditure Plan, as set forth above, shall become effective pursuant to 12 N.N.C. § 2505.

SECTION SIX. DIRECTIVES

The Navajo Division of Transportation shall report the status of the N8066 Road Paving Project to the Resources and Development Committee, and to the Naabik'íyáti' Committee, on a quarterly basis.

N8066 - Black Mesa Project Summary & Recommendations

Project Description:

The project is in the northeast corner of Navajo County, Arizona, approximately 25 miles south of Kayenta, AZ. It is in the vicinity of Black Mesa, AZ, within the BIA Chinle Agency Jurisdiction. The roadway improvements extend for approximately 8 miles along Indian Route N8066, which runs parallel to Oraibi Wash. There are two major crossings of Oraibi Wash, one near the north end of the project and one near the south end. This project includes the N8066 School Spur and the Chapter House Access Road. An exhibit of the project is attached. The programmed budget is \$17,000,000.

The project consists of two major structures, grading, drainage, treated aggregate base, and fencing. Much of the existing dirt road will be realigned to avoid flooding issues, home sites, utilities and archaeological sites. The Bureau of Indian Affairs (BIA) prepared initial plans for this project. The Navajo Division of Transportation (NDOT) is now preparing final plans. On November 14, 2019 a meeting was held at the Chapter House to provide an update on the project.


Estimated Cost:

An Engineer's Opinion of Probable Construction Cost has been developed. The following is a breakdown of the current estimate.


Recommendations:

It is recommended the existing dirt road be realigned to avoid flooding issues, home sites, utilities and archaeological sites. As stated in the N8066 Design Criteria Report dated December 14, 2015, the current road is not sufficiently safe and does not meet AASHTO criteria. The drainage culverts are routinely overtopped, the roadway surface is muddy and slick when wet, and impassable in heavy rains. When the wash is flowing, school children are unable to get to school and Chapter members on the west side of Oraibi Wash are unable to get to the Chapter, school, or other areas within the Black Mesa Chapter. The detour is almost one hour. The improvements are needed for safety and operational efficiency. An additional \$7,750,000 is needed in order to construct everything that is in the scope of work.

Honorable Yellowhair,

Thank you for your inquiry regarding the status of the N8065 and N8066 road projects.

Regarding N8065, the project addresses six locations of N8065 where washes overflow the roadway during storms and heavy downpour. Attached is a project description with recommendations and estimated costs.

Notably, this project needs additional funds in the amount of \$1,424,705 dollars.

Regarding N8066, in general this project encompasses paving approximately eight miles of N8066, bridge construction, drainage and grading. Attached to this memorandum is a project description with recommendations and estimated costs.

For N8066, the project needs additional funds in the amount of \$7,750,000 dollars.

Both N8065 and N8066 are a part of the Black Mesa Project located near or within the vicinity of Black Mesa, Ariz.



BE IT ENACTED:

Section One. Authority

- A. The Resources and Development Committee has oversight authority over roads and transportation to oversee planning and coordination of all roads and transportation activities of the Navajo Nation. 2 N.N.C. § 500 (C)(6).
- B. The Resources and Development Committee has oversight authority over the Navajo Division of Transportation. 2 N.N.C. \S 501 (C)(1).

Section Two. Findings

- A. Pursuant to 25 C.F.R. Part 170, Subpart D of the Tribal Transportation Program, the Navajo Division of Transportation is charged with performing the critical functions in collaboration with the Bureau of Indian Affairs, local, state and federal agencies to develop a tribal transportation priority listing.
- B. The Navajo Division of Transportation prepared the FY2018 Navajo Nation Tribal Transportation Improvement Program (TTIP), **Exhibit A**, which includes projects for preliminary study which are cultural, environmental impact studies, rights-of-way, centerline surveys and design; construction engineering funds for construction administration; and, construction funds to construct roadway improvements.
- C. The Resources and Development Committee approved Tribal Transportation Improvement Program (TTIP) is to be submitted to the Federal Highway Administration.
- D. Approving the FY2018 Navajo Nation Tribal Transportation Improvement Program is in the Navajo Nation's best interest.

Section Three. Approval

The Navajo Nation hereby approves the FY2018 Navajo Nation Tribal Transportation Improvement Program as found at ${\bf Exhibit}$ ${\bf A}$.



The Navajo Division of Transportation (NDOT) is working with the BIA Navajo Region Division of Transportation (NRDOT) and Black Mesa Chapter to construct approximately 8 miles of road and bridge improvements along BIA Route N8066 within the Black Mesa Chapter. The current dirt road is not sufficiently safe, drainage culverts are routinely overtopped, the road surface is muddy and slick when wet, and impassable during heavy rains. When Oraibi Wash is flowing, school children are unable to get to school and Chapter members on the west side of Oraibi Wash are unable to get the Chapter, community school or other areas within Black Mesa Chapter. The detour is almost one hour.

The Resources and Development Committee approved the N8066 project on the Navajo Nation's Tribal Transportation Improvement Program and the project was awarded Tribal Transportation Program (TTP) federal funds for Preliminary Engineering, Construction, and Construction Engineering activities. The project was awarded \$17 million in construction funds.

NDOT will complete design plans, environmental clearance, 404/404 permitting, construction procurement and construction management for the project. These activities are fully funded using TTP federal funds. The NDOT is working with the BIA NRDOT to obtain right-of-way (ROW) for the project. The BIA NRDOT is the ROW applicant and the BIA NRDOT will be responsible for operation and maintenance of the road and bridge improvements once construction is completed.

The NDOT prepared an Engineer's Opinion of Probable Construction Cost for the N8066 road and bridge improvements and cultural resources site mitigation and the total cost is \$24,750,000.00 (see next page for cost breakdown). As mentioned above, the N8066 project has received \$17 million in TTP federal funds for construction. An additional \$7,750,000 is needed in order to construct everything that is in the scope of work. At the request of the Black Mesa Chapter leadership and community members, Delegate Jimmy Yellowhair is requesting approval of \$8



WHERE AS:

BLACK MESA CHAPTER IS RESPECTFULLY IN SUPPORT AND APPROVAL OF EIGHT MILLION DOLLARS OF SIHASIN FUNDS REQUESTED BY NAVAJO DEPARTMENT OF TRANSPORTATION (NDOT) TO SUPPLEMENT EXISTING FISCAL ALLOCATION TO COMPLETE PHASE THREE N8066 ROAD AND BRIDGE CONSTRUCTION PROJECT.

- 1. Pursuant to the "Local Governance Act," 26 N.N.C., Chapter 1, Subchapter 1, Section 3, (a) the Black Mesa Chapter is certified a local chapter of the Navajo Nation Government by the Navajo Nation Council Resolution No. 34-98; AND
- 2. Pursuant to Chapter 1, Section 131 (1) (2) of the same "Act," the chapter has the responsibility and authority to promote, protect, and preserve the interest and the general welfare of its community people and programs; AND
- 3. Pursuant to "Indian Self Determination Act (PL 93-638)" as mentioned by the U.S. Congress, the Black Mesa Chapter is entitled to support and initiate plans, make decisions, and recommendations according to the needs and desires of the community people; AND
- 4. Black Mesa Chapter acknowledges that it has great needs for paved roads and bridges to enhance the quality of life for the people, alleviate emergency response time, and greatly improve education and health services which will be made possible with the completion of N8066 Road and Bridge Construction Project. Furthermore, the chapter desires the economic growth that will be enhanced by the N8066 Road and Bridge Project; AND
- 5. Navajo Department of Transportation (NDOT) proposes to pave the road all the way to Black Mesa Community School and Black Mesa Chapter House, and construct two major permanent bridges crossing the Oraibi Wash along N8066 within the Black Mesa Chapter boundary; AND
- 6. Black Mesa Chapter is requesting approval of the supplemental funds from Sihasin Funds because this proposed undertaking will provide adequate and much needed transportation services to the community where paved roads is only seven miles; AND
- 7. Black Mesa Chapter finds it in their best interest that N8066 be paved as soon as possible because it is used as a school bus route by Black Mesa Community School, Pinon Unified School District, Pinon Community School, Navajo Head Start, and the local government entities and residents.

NOW THEREFORE BE IT RSOLVED THAT:

BLACK MESA CHAPTER IS RESPECTFULLY IN SUPPORT AND APPROVAL OF EIGHT MILLION DOLLARS OF SIHASIN FUNDS REQUESTED BY NAVAJO DEPARTMENT OF TRANSPORTATION (NDOT) TO SUPPLEMENT EXISTING FISCAL ALLOCATION TO COMPLETE PHASE THREE N8066 ROAD AND BRIDGE CONSTRUCTION PROJECT.
