18	A. The Naabik'iyati' Committee has legislative oversight authority over the Commission

28	SECTION TWO. FINDINGS	
29	A. The Commission on Navajo Government Development is established within the	
30	Legislative Branch. The Commission is a special entity created by the Navajo Nation	

Council with quasi-independent authority to accomplish the People's project of instituting reforms necessary to ensure an accountable, responsible, ethical, and equally representative government. The Commission shall be responsible directly to the Navajo Nation Council with respect to its overall activities. The Naabik'iyati' Committee of the Navajo Nation Council shall have legislative oversight authority. 2 N.N.C. § 970.

- B. The Commission consists of twelve (12) members confirmed by and serving at the pleasure of the Navajo Nation Council. 2 N.N.C. 972 (A).
- C. One member is nominated by the Student Body Government of the Dine' College. The nominee shall be a student of Dine' College so long as said nominee is a full-time student at Dine' College to serve a term of two (2) years from the date of confirmation by the Navajo Nation Council. 2 N.N.C. § 972 (A) (6).
- D. Commission members shall be chosen from among individuals who have demonstrated scholarship, strong sense of public interest, knowledge of Navajo history and cultural heritage, spiritual leadership, leadership in the Navajo government and abilities likely to contribute to the fulfillment of the duties of the commission. 2 N.N.C. § 972 (D).
- E. The Dine' College Board of Regents recommended by Resolution DC-MAR-2499-21 to confirm Ms. Natasha Goldtooth as the Dine' College Student Representative. Resolution DC-MAR-2499-21 is attached as **Exhibit A.**
- F. Ms. Natasha Goldtooth has been nominated by the Dine' College Student Body Government to fill the Student Representative position. Resolution dated March 8, 2021, is attached as **Exhibit B.** Ms. Natasha Goldtooth meets all the qualifications for the position. Her letter of interest and resume are attached as **Exhibit C.**

SECTION THREE. CONFIRMATION

The Navajo Nation Council hereby confirms the appointment of Ms. Natasha Goldtooth as the Dine' College Student Representative, to the Commission on Navajo Government Development, for a term of two (2) years from the date of confirmation by the Navajo Nation Council.

Ms. Goldtooth is a student in good standings and recommended by the College President to be the student representative for CNGD for a term of 2 years, as defined by Navajo Nation Council, which is governed by the guiding principles: Professionalism, Respect, Integrity, Culture and Tradition, and Equality; and
- 6. The mission of the Commission on Navajo Government Development and the Office of Navajo Government Development is to accomplish the Peoples' project of instituting reforms necessary to ensure an accountable, trustworthy, responsible and transparent government.

NOW THEREFORE BE IT RESOLVED THAT:

- 1. The Diné College Board of Regents hereby recommends the confirmation of Natasha Goldtooth as the Diné College Student Representative on the Commission on Navajo Government Development for a two-year term.
- 2. The Diné College Board of Regents hereby authorizes, directs, and empowers the Diné College President to perform all actions deemed necessary and proper to effectuate the purposes of this resolution.


