Dear President Begaye, Chairman Shepherd and Delegate Perry:

The purpose of this letter is to bring to your attention an issue associated with Legislation # 0201-16 "An Action Relating to Resources and Development; Confirming the Appointment of Mr. Edgar Tohtsoni to Serve on the Navajo Agricultural Products[Industry] Board of Directors for a Term of Three Years" (the "Legislation"). The intent of the Legislation is to appoint Edgar Tohtsoni to the NAPI Board as the member from the Eastern Agency, but currently there are no vacancies on the five-person Board and there is already a Board member from the Eastern Agency, Lawrence Platero. Mr. Platero's appointment was effective October 28, 2014 and will not expire until October 28, 2017.

The letter to Mr. Edgar Tohtsoni from the Office of the President and Vice President dated March 10, 2016, indicates that the term "began on October 28, 2014 and it will end on October 28, 2017. This appointment represents the Navajo people of Eastern agency of the Navajo Nation and requires a bachelor degree." Based on the dates of the term, it is obvious that this appointment is an effort to fill the remainder of Mr. Platero's term with Mr. Tohtsoni. Mr. Platero has not, however, resigned nor has he been removed. Furthermore, there does not appear to be an action to remove Mr. Platero as a director of the Navajo Agricultural Products Industry ("NAPI") Board.

The Plan of Operation provides that a Board member may be removed by a simple majority of the oversight committee members at a lawful meeting only if:

- a. Such member has failed to attend two (2) consecutive meetings of the Board without prior written approval of absence by the Chairperson of the Board. The Secretary shall report to the President of the Navajo Nation when a member has failed to attend two consecutive meetings without prior approval;
- Such member has been convicted of any crime reflecting upon such member's honesty or ability to fulfill the fiduciary obligations imposed by law upon such member;
- c. Such member has been adjudged in any action, suit, or other proceeding to be liable, suit or other proceeding to be liable for gross negligence or misconduct, in the performance of any management duties;
- d. Such member violates the Navajo Nation Ethics in Government Law;
- e. Such member commits malfeasance or misfeasance of office; or
- f. Breach of the duties of a director as set forth in Article 5(B).

Plan of Operation, Article 5(E) CJA-05-10. Article 5(B) provides:

The conduct of each member of the Board of Directors shall conform to fiduciary standards, and shall, in any event, conform to that required of members of a board of directors of a for-profit corporation under the Navajo Corporation Code, the Navajo Nation Ethics in Government Act, and other applicable Navajo law.

Mr. Platero has not conducted himself in any way that would cause him to be subject to a removal action. Curiously, there is no evidence that the Nation intends to remove Mr. Platero.

The letter from the President's Office focuses on Mr. Tohtsoni's achievement of a degree of bachelor of science. Although Article 5(C) of the Plan of Operation states that "[a]ll directors shall have at least a bachelor of science degree," Mr. Platero does not have a bachelor of science degree. The Resources and Development Committee knew that Mr. Platero did not have a bachelor of science degree when the Committee appointed and confirmed him. His resume was provided to the Committee. Mr. Platero presented his credentials and he was appointed and confirmed notwithstanding his lack of a bachelor of science degree and in accordance with the Plan of Operation. There was a vacancy on the NAPI Board of Directors for an individual from the Eastern Agency, which vacancy had existed for more than 30 days. The President had not submitted an appointee for confirmation. The Resources and Development Committee approved the appointment of Mr. Platero for a term of 3 years on Oct. 28, 2014, the term to begin immediately. Mr. Platero's term does not expire until Oct. 28, 2017.

The current appointment of Mr. Tohtsoni is not in accordance with the Plan of Operation or Navajo law. In accordance with the Plan of Operation, the President may only appoint upon the creation of a vacancy. A vacancy exists from the date of "the resignation, death, or removal of a Director. . . ." See Plan of Operation, art. 5(F)(1) and (2). Mr. Platero, has not resigned, died or been removed. Mr. Platero has not been notified of

any effort by the Resources and Development Committee to remove him. Therefore, there is no vacancy to be filled.

Such removal, without affording Mr. Platero of his due process formalities of "notice, inspection of written reports, investigation of disputed facts by a neutral third party, the right of the accused to attend a meeting at which their removal . . . is discussed, and right to provide a response prior to Board action" would be a violation of Mr. Platero's rights. See Navajo Nation Oil and Gas Co. v. Window Rock Dist. Ct., 12 Am. Tribal Law 22 (2014); Guzman-Vargas v. Calderon, 672 F. Supp. 2d 273, 291-93 (D.P.R. 2009)(plaintiff has a legitimate claim of entitlement to his board member position for a fixed term absent "just cause" for his removal). Like the charter of the Navajo Nation Oil and Gas Co., the NAPI Plan of Operation provides that "any member of the Board of Directors may be removed by a simple majority vote of the [Resources and Development] Committee." Like the charter of Navajo Nation Oil and Gas, the Plan of Operation is silent regarding a due process procedure. However, the Navajo Nation Supreme Court cautioned against reading such a provision in isolation. "Our Navajo Nation laws must be read comprehensively and in combination, not piňon picked for provisions that support a given position." Navajo Nation Oil and Gas, 12 Am. Tribal Law at (citations omitted). Mr. Platero has a property interest in his continued appointment on the Board of Directors. His appointment is not at will, "cause" as defined in the Plan of Operation is needed to remove him. Because he has received an appointment for a specific term that cannot be withdrawn without a determination of cause, Mr. Platero's property right as a Board member may not be deprived without due process of law. 1 N.N.C. § 3.

For the reasons discussed above, the NAPI Board of Directors urges the President's Office to withdraw the appointment of Mr. Tohtsoni as a NAPI Board member from the Eastern Agency, for Mr. Perry to withdraw his sponsorship of the Legislation or for the Resources and Development Committee to withdraw the Legislation.
