RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE PROPOSED
FISCAL YEAR 2022 BUDGET FOR THE GENERAL SERVICES DIVISION -
INSURANCE SERVICES DEPARTMENT, RISK MANAGEMENT/SAFETY LOSS
CONTROL, EMPLOYEE BENEFITS, WORKERS COMPENSATION**

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 300(A).
- B. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840(A).
- C. The Budget and Finance Committee has oversight of Insurance Services Department and the Insurance Commission. 12 N.N.C. § 301(B)(13).

SECTION TWO. FINDINGS

- A. The Budget and Finance Committee held a hearing and took budget testimony regarding the General Services Division - Insurance Services Department, Risk Management/Safety Loss Control, Employee Benefits, Workers Compensation, Fiscal Year 2022 Budget. 12 N.N.C. § 840(A).
- B. The Budget and Finance Committee recommends a fiscal year budget for the General Services Division - Insurance Services Department, Risk Management/Safety Loss Control, Employee Benefits, Workers Compensation. 12 N.N.C. § 840(A).

SECTION THREE. APPROVING AND RECOMMENDING THE PROPOSED FISCAL YEAR 2022 BUDGET FOR THE GENERAL SERVICES DIVISION - INSURANCE SERVICES DEPARTMENT, RISK MANAGEMENT/SAFETY LOSS CONTROL, EMPLOYEE BENEFITS, WORKERS COMPENSATION

- A. The Budget and Finance Committee hereby recommends the proposed Navajo Nation Fiscal Year Budget for the General Services Division - Insurance Services Department, Risk Management/Safety Loss Control, Employee Benefits, Workers Compensation, as provided on the Fund Type Budget Summary, attached as **Exhibit A**.
- B. The Budget and Finance Committee requests the changes to the Budget, as set forth in the General Fund Comparative Summary, **Exhibit B**, Recommended Changes to the General Fund Budget, **Exhibit C**, Recommended Conditions of Appropriation and Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs, **Exhibit E**, be incorporated into the Navajo Nation Comprehensive Budget.




