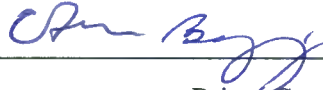

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Law and Order Committee is a standing committee of the Navajo Nation Council. The Law and Order Committee, among other powers, is authorized "to review and make recommendations to the Navajo Nation Council on proposed amendments to and enactments to the Navajo Nation Code." 2 N.N.C. §§ 600 (A), 601 (B)(14).
- B. The Navajo Nation Council established the Naabik'iyáti' Committee as a Navajo Nation Standing Committee. All proposed legislation that requires final action by the Navajo Nation Council, shall be assigned to the Naabik'iyáti' Committee. 2 N.N.C. §§ 164 (A)(9), 700 (A).
- C. The Navajo Nation Council is the governing body of the Navajo Nation and as such has the authority to promulgate rules, regulations and procedures for the conduct of its meetings and that of its committees. 2 N.N.C. §§ 102 (A),(E).

SECTION TWO. FINDINGS

- A. Rule 6 of the Navajo Nation Council Rules of Order, as amended by Resolution CJY-39-13, requires the specific order of agenda items for Navajo Nation Council Sessions, whereby announcements are placed under item "10. Close of Session; Announcements; Adjournment".
- B. Pursuant to Rule 28 of the Navajo Nation Council Rules of Order, amendments to the Rules may be made by a majority vote of the Council delegates casting a vote. *See* CJY-39-13.
- C. The Navajo Nation hereby finds that it is appropriate for announcements to be made at the beginning of a Navajo Nation Council Session.

SECTION THREE. AMENDING RULE 6 OF THE NAVAJO NATION COUNCIL
RULES OF ORDER SUCH THAT ANNOUNCEMENTS ARE
MOVED TO ITEM 1. ON THE AGENDA

The Navajo Nation Council hereby amends Rule 6 of the Navajo Nation Council Rules of Order, as amended by Resolution CJY-39-13, as follows:

Navajo Nation Council Rules of Order

Rule 6. Order of Agenda Business; Guests; Legislation Priority

A. The Order of Agenda Business for the Navajo Nation Council shall be as follows:

1. Call meeting to Order; Roll Call; Invocation; Announcements
2. Recognize Guests and Visiting Officials.
3. Review and Adopt Agenda.
4. Receive the State of the Nation Address from the President of the Navajo Nation.

1 5. Receive Report from Speaker of the Navajo Nation Council.

2 6. Oral Reports:

3 (a) Bureau of Indian Affairs (BIA)

4 (b) Indian Health Service (IHS)

5 (c) Financial Report by the Controller

6 (d) Report from Attorney General

7 (e) Report from Chief Justice of Navajo Nation

8 7. Written Reports:

9 (a) Standing Committees

10 (b) Boards and Commissions

11 (c) Bureau of Indian Affairs

12 (d) Indian Health Services Area Director

13 8. Old Business

14 9. New Business

15 10. Close of Session; ~~Announcements~~; Adjournment.

16 B. All legislation requiring a vote of two-thirds (2/3) of the Council in order to be
17 adopted shall be placed on the agenda before all of the other legislation and shall
18 be considered by the Council before all other legislation. This provision shall not
19 be subject to suspension pursuant to Rule 26.

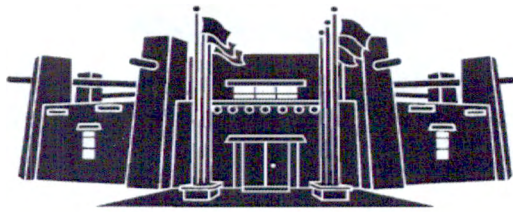

23 Council Rules of Order, Rule 28. CO-43-07.

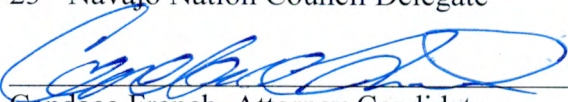

25 **SECTION 4. SAVINGS CLAUSE**

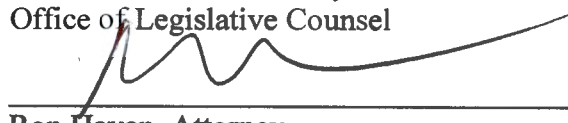
26 Should any provision of this Act be determined invalid by the Navajo Nation

The Office of Legislative Counsel recommends the appropriate standing committee(s) reviews based on the standing committees powers outlined in 2 N.N.C. §§ 301, 401, 501, 601, and 701. Nevertheless, "the Speaker of the Navajo Nation Council shall introduce [the proposed resolution] into the legislative process by assigning it to the respective oversight committee(s) of the Navajo Nation Council having authority over the matters for proper consideration. 2 N.N.C. § 164(A)(5).

Please review the proposed resolution to ensure it is drafted to your satisfaction. If you approve, please sign as "Primary Sponsor" and submit it to the Office of Legislative Services where the proposed resolution will be given a tracking number and referred to the Office of the Speaker. If the proposed legislation is unacceptable to you, please contact me at the Office of Legislative Counsel and advise me of the changes you would like to make to the proposed resolution.

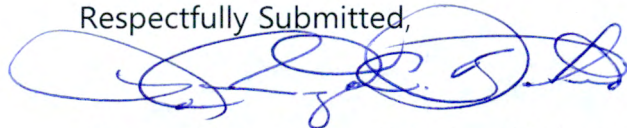
