**Section One. Findings**

A. Article III(C) of the Operating Agreement of the Navajo Transitional Energy Company provides for a Navajo Nation Membership Interest and Member Representative Group consisting of five (5) members, each appointed by the five (5) standing committees of the Navajo Nation Council. CAP-20-13.

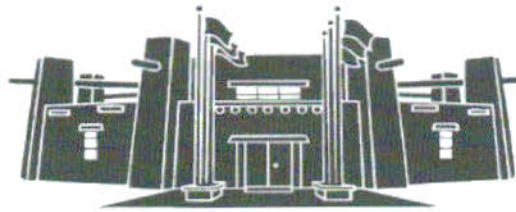
B. The Law and Order Committee is a committee of the Navajo Nation Council. 2 N.N.C. § 600.

**Section Two. Appointing Member Representative**

The Law and Order Committee hereby appoints \_\_\_\_\_, a member of the committee, as Member Representative for the Navajo Energy Transactional Energy Company.

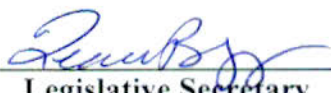
